NARRATIVE

Narrative:

On 8-7-22 around 0841 hours, I was dispatched to Eastern Idaho Behavioral Health Center (EIBHC) 2280 E 25th St. Idaho Falls, ID.

I made contact with Security Gary W. Shafto. Gary explained that patient Kathy Martinson attacked him and two other patients. Gary said he was kicked in the leg and punched in the stomach.

I then made contact with Clinical Supervisor Hailey J. Nelson. Hailey brought in 2 patients into the group room to talk with me. I first met with Valerie L. Arden. Valerie explained that Kathy punched her unprovoked in the back of the neck with a closed fist. I then spoke with the second patient Sharon J. Beard. Sharon explained she walked out of her room this morning and Kathy punched the middle of her back close to her spine. Sharon said she tried to run away and felt something touch her hair. Sharon thought Kathy tried to grab her hair.

All parties involved did not want to press charges.

I talked with Kathy who was in restraints. Kathy explained her sister died and she didn't want to live anymore. Kathy then resorted to attacking people so they would kill her. Kathy said this morning she was okay but then had a "panicky feeling". Kathy explained that she panicked and became shaky while in her room. Kathy picked up a picture of Jesus and started praying to God. Kathy said God didn't want to listen to her and got an urge to attack and hit/kick the involved parties.

I confirmed with Hailey Kathy's diagnosis. Hailey explained Kathy has Schizophrenia, homicidal ideations and developmental delays. Kathy's brother (guardian) was currently talking with the doctor about increasing the dosage to Kathy's medication. Hailey said BHC would be looking at placing Kathy under the care of Blackfoot South State Hospital. Kathy has been at BHC since 7-17-2022.

I had Valerie and Sharon write statements about the battery.
