INITIAL INVESTIGATION

This report is being written by P.O. Erik RODRIGUEZ, assigned to District One, Late Power Shift, Squad 1431, with P.O. Lafayette TURMAN.

On Friday, August 14, 2020, at 10:28 pm, Squad 1431 was at the address of 1813 E Kenilworth Pl, investigating a Theft complaint when I was approached by Patrick S TOMLINSON (W/M, 4-18-80), who stated that he was robbed.

TOMLINSON stated that at approximately 10:05 PM, he was at Chubby's Cheesesteaks, located at 2232 N Oakland Av, waiting for his order. TOMLINSON stated that he was using his Samsung S10 when suddenly he noticed someone grab his phone. TOMLINSON stated that when he didn't let go of his phone that a second subject began punching him in the face. TOMLINSON stated that the subjects were able to get his phone away from him and that they started to flee the area heading westbound on E North Av. TOMLINSON stated that he chased the subjects to the address of 1614 E North Av, McDonald's, when the subjects continued north through the parking lot and he lost sight of them.

TOMLINSON stated that he noticed 3 subjects which he described as the following:

Suspect 1 is a black male, approximately 5'9" - 5'11", approximately 180 lbs, younger, wearing a white t-shirt, short hair. Took phone.

Suspect 2 is a black male, approximately 5'9" - 5'11", approximately 180 lbs, younger, wearing a dark colored t-shirt, short hair.

Suspect 3 is a black male, approximately 5'9" - 5'11", approximately 180 lbs, younger, wearing a dark colored t-shirt, short hair.

TOMLINSON stated that the subjects made no statement prior to or during the incident. TOMLINSON stated that he does not have insurance on the phone, that he believes that he can track the phone, but that he does not know how at this time, and that his phone has approximately 30% battery remaining.

While speaking with TOMLINSON an employee of Chubby's Cheesesteaks handed me a phone that was handed to her by a customer who was no longer on scene. The phone is a black Samsung with no service and a picture of a young black male posing with a red vehicle as the background. It is believed that this may be a phone dropped by one of the suspects.

This case appears to be related to the Theft From Person at 1813 E Kenilworth Av, Case # 20-227-0185 and the Theft From Person at 2238 N Farwell Av, Case # 20-228-0001. All of which are close in proximity, close in time of incident, in each cell phones were taken, and similar suspect descriptions. There were no witnesses on scene. Chubby's Cheesesteaks does have surveillance cameras and follow-up will need to be conducted to see if the incident was captured on video.

I notified Acting Lt, Sgt HALL, and was informed that this assignment would be mine to handle. P.O. TURMAN took photos and will file a supplemental report regarding. The cell phone was placed on MPD Inventory # 20029039.

This concludes my report at this time.
