CASE REPORT

NARRATIVE

On 01-03-22023 at about 1546 hours I was dispatched to St. Luke's Episcopal Church of Idaho Falls at 270 N Placer Ave., Idaho Falls Idaho for a report of suspicious activity.

On scene, I contacted Reverend Lea Colvill (Reporting Party) Lea stated she had a member of her congregation that had spoken to her in passing regarding inappropriate feelings toward a 16-year-old.

Lea told me that she had several conversations with a person calling themselves Valerie Roundy(age 22). Lea said she believes Valeie to be a transgender female. Lea said Valerie had mentioned on several occasions that she is having feelings for a now 16-year-old whom she met when she was living on the east coast and is planning on giving this juvenile a promise ring. Lea said Valerie told her that she has regular contact over the internet with this Juvenile.

Lea went on to say that on November 6th, 2023 she received a message from a person calling themselves Duncam McDougale with a group called Kiwi Farms. This message stated that they had watched footage of a live-streamed baptism that same date and saw Valerie in the audience and believed her to be a known pedophile-Zoophile who goes by the name Connor Roundy AKA "Sappho".

According to Duncan, this "Sappho" has been posting "Vulgar content not for the casual viewer" and provided Lea with a link.

Lea said she viewed some of the material and said it was disturbing. She stated it contained cartoons of older animals having sex with baby animals.

Lea told me she then asked a friend of hers with "Tech Skills' to look into the connection between Valerie and "Sappho". This friend was able to find and provide Lea with links to several youtube videos containing the same kind of content, but was unable to conclusively link any of this to Valerie.

Lea explained that she is very concerned Valerie is sending this kind of material to the aforementioned Juvenile to groom them. She asked that our detectives follow up and see what they can uncover.

Lea provided me with all the information she had about Valerie Roundy (██████-2000) including several aliases.

The only name I could find in mobile was Valerie Arden. (Same birthday and same address that Lea gave me.)

Lea also provided me with a full written report of the interactions she had with Valerie. Including links to the videos she found. I placed this report in the supervisor's office.

I am referring this to detectives for follow-up to see if they can determine if there is any possible threat to the community from Valerie AKA "Sappho".

Later, I uploaded my bodycam footage to WatchGuard.

NARRATIVE

Lea Colvill was contacted by "Kiwi Farms" and told that a person that she knows, Valerie Arden, was actually a person named Connor Roundy who is a person that, online, goes as "Sappho". Sappho does appear to be a name of interest with several agencies around the world.

Kiwi Farms is an online group of people that "troll" or harrass people online.

I was unable to find any connection between Valerie and Sappho.

I entered Valerie's name and phone number into the ICAC Data Systems to facilitate another agency contacting me if they develop Valerie into a suspect in their jurisdiction.

I am closing this case as no crime was reported.
