**Definition of stalking, aggravated stalking and harassment:**

**Stalking:** A person commits the crime of stalking when, without lawful authority, that person willfully or maliciously engages in a course of conduct directed towards a victim that would cause a reasonable person under similar circumstances to feel terrorized, frightened, intimidated, harassed or fearful for his or her immediate safety or the immediate safety of a family or household member, and that actually causes the victim to feel terrorized, frightened, intimidated, harassed or fearful for his or her immediate safety or the immediate safety of a family or household member. NRS 200.575(1)

**Aggravated Stalking:** A person who commits the crime of stalking and in conjunction therewith threatens the person with the intent to cause the person to be placed in reasonable fear of death or substantial bodily. NRS 200.575(2)

**Harassment:** A person commits harassment when: (a) Without lawful authority, the person knowingly threatens: (1) To cause bodily injury in the future to the person threatened or to any other person; (2) To cause physical damage to the property of another person; (3) To subject the person threatened or any other person to physical confinement or restraint; or (4) To do any act which is intended to substantially harm the person threatened or any other person with respect to his or her physical or mental health or safety; **and** (b) The person by words or conduct places the person receiving the threat in reasonable fear that the threat will be carried out. NRS 200.571

**Definition of sexual assault:** A person commits sexual assault if they subject another person to sexual penetration, or forces another person to make a sexual penetration on himself or herself or another, or on a beast, against the will of the victim or under conditions in which the perpetrator knows or should know that the victim is mentally or physically incapable of resisting or understanding the nature of his or her conduct. NRS 200.366

John Doe, whose identity will be uncovered with a subpoena, is from a hate site called Kiwi Farms (KF). KF stalks random people for fun. Said site has been profiled extensively with how dangerous they are. Said site has been harassing Greer for 7 years now and they need to start facing consequences.

On March 19th, 2023, John Doe unlawfully and in bad faith accessed the "Shared Editing" feature of the International Movie Database and in bad faith, hijacked Greer's movie page, "Always Yours". John Doe stalked Greer by creating characters featuring Greer and calling him a "Drooling hunchback". Greer's face is paralyzed. After Greer was able to get the bad faith edit deleted, John Doe once again accessed Greer's movie page and called him a "rapist". This is defamation.

John Doe began to sabotage Greer's IMDB movie listing around 03/18/2023 or before. Mr. Doe added Nazi leaders to Greer's movie page, in an attempt to harass and discriminate against Mr. Greer. The Nazis were well known for killing the disabled. Mr. Greer took the unwarranted addition of Adolf Hitler to Greer's movie listing as a veiled abelist slur and action, in no way different than one who burns a cross on person of color's lawn. Mr. Greer attempted to delete the stalking actions of Doe and Doe once again added more Nazi characters to Greer's movie page, in an attempt to frighten and alarm Mr. Greer. Mr. Greer was so shaken that he could not sleep on the night of the 18th and awoke on the 19th to discover Doe had again sabotaged Mr. Greer's webpage. Greer owns the property rights to 'Always Yours' and so Doe was violating Greer's property on purpose, to stalk and intimidate Mr. Greer.

There are about 20 requests Greer sent to the IMDB staff to remove Doe's alarming hate additions.

Mr. Greer uses social media to try promoting himself and Doe created a fake profile calling Greer a "convicted murderer". Greer is not and does not even have a felony or any serious convictions. Doe was defaming Greer and stalking Greer. Greer believes Doe and the fake profile are the same because one of Doe's other additions to the IMDB page had Greer listed as a "homicidal murderer".

It is apparent that Mr. Doe has severe mental issues and Greer is afraid for his safety. He has had to have the voter division of the State make Greer's address private because he is afraid Doe will come to Greer's home and harm him.

12 was deliberate, with intent to cause fear in Mr. Greer. Doe has also changed the genre from "comedy" to

frightened and could not leave his home all day March 19th.

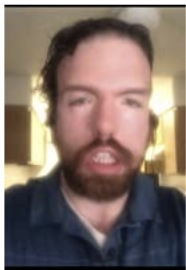
