On Friday June 14th, 2024 I Officer C. Garfat 4601 was working as A631. At 2219 hours I was dispatched to an Assault Call located at 605 Main St (Big Laugh Comedy Club). Call details stated: "cp sts she was taking pic with a comedian "sam hyde" wring white shirt and a blue shorts. When subj threw cp to the ground by her neck. Medstar ref. Unk wpns. Cp sts subj is still os and has another show very soon. Cp is inside at end of the bar wring costume. Wring hat and a vest over blk shirt. And blk jeans. Has male friend with her".

I arrived on scene at 2222 hours out at a secondary location of 609 Houston St (Dirty Murphy's bar) at the request of the complainant. Upon arrival I spoke with VIC-1 Creager, Channing W/F DOB: [REDACTED] who stated that she had been assaulted by SUS-1 Hyde, Samuel W/M DOB: [REDACTED]. I asked Channing how she knew Samuel to which she stated that he was a comedian and that she use to work for him when his career was just starting out. Samuel is a well-known comedian that goes by the name of "Sam Hyde". Channing stated that she went to Samuel's early comedy show this evening that was hosted at the Big Laugh comedy club just prior to her calling. Samuel was doing a meet and greet with fans after the show and this was when she came into contact with Samuel. Channing stated that she walked up to Samuel to get a picture with him and he immediately grabbed her by the back of her neck and forced her to the ground onto her right knee (causing her to feel pain). Channing and WIT-1 Nguyen, Daniel A/M DOB: [REDACTED] (Channing's friend) then both stated that Daniel was holding a cell phone so that he could take the picture of the meet and greet encounter, and that after Samuel pushed Channing down to the

ground that he then slapped the cell phone out of Daniel's hand. Channing then stated that Samuel then pushed her down to the ground by her neck a second time, again causing Channing to feel pain in her right knee.

I then asked Channing if she had done anything to provoke this reaction from Samuel, to which she said no. I asked Channing if her and Samuel's relationship ended on good terms since she use to work for him in the past. Channing stated that Samuel wrote her \$19,000.00 in bad checks prior to her departure from his employment. Channing stated that she was a Christian and that she felt like this would be a good time and place to make amends with Samuel and that she had no clue why Samuel reacted in this way. Channing stated that she wished to press charges for the assault. During my entire conversation with Channing she seemed to speak very slowly, almost like she was sleepy. I asked Channing if she had been drinking tonight and she said yes, but she believed that what happened still shouldn't have happened to her because she had been drinking. I asked Channing "If I told you to drive home right now, would you feel safe doing it?", to which she replied no. I took pictures of Channing before leaving dirty Murphy's.

I then went to the Big Laugh Comedy Club to speak with Samuel. I arrived on scene at the Big Laugh at 2244 hours and requested with the venue staff to speak with Samuel (who was the closing act). Samuel came out to speak with me and I asked him if he knew why I was here and he stated "probably because of the girl that I pushed". I asked Samuel to elaborate on the situation. Samuel stated that he and Channing use to be in a dating relationship about 15 years ago and that in recent years she had turned into a stalker. Samuel stated that when Channing approached him to take the meet and greet picture that he did not recognize who she was because she was dressed like a man and had fake facial hair on her face. What alarmed Samuel was that when Channing approached him, Samuel alleges that Channing said "I have a Knife". Samuel then stated that he pushed her out of a feeling of self-defense because he was scared about what the person (Channing) had just told him. Samuel stated that ever so often while on a comedy tour that you come across stalkers and that getting a restraining order usually just stirs the pot. I took pictures of Samuel.

I then went back to converse with Channing who had relocated to 515 Houston St in front of the CVS so that she could smoke a cigarette. I asked Channing why she didn't tell me that she and Samuel had dated. Channing made it out to be a small issue since it was close to 15 years ago. I then asked Channing if she stated "I have a knife" to Samuel before she attempted to take a picture with him, to which both her and Daniel both seemed to be shocked at my question. Channing stated that she did not tell Samuel that she had a knife and offered for me to search her bags. Daniel stated that they would have not called the police had they ever said or done anything like that.

I then went back to the Big Laugh to see if I could find any witness of the incident in question. I spoke with a door man who was on staff at the Big Laugh who stated that he saw Channing on the ground and thought that she had fell, but then realized that she was getting bounced out/kicked out. I then spoke with WIT-2 Lewin, Brandon W/M DOB: [REDACTED] (one of the co-owners of Big Laugh) who stated that he was present during the incident. Brandon stated that Channing and Daniel were brought in to do the meet and greet and that they stood by the bar for a while. Brandon stated that Channing was dressed as a man and also had a full facial hair disguise on her face that consisted of sideburns, goatee, and a mustache. Brandon articulated that he and many other staff members thought that they were acting strange as they waited at the bar for the meet and greet.

Brandon stated that when they brought Channing to do her meet and greet with Samuel that Samuel was able to recognize her pretty quickly and exclaimed "no, no, no, no" before he slapped the phone out of Daniel's hand. Brandon then stated that this was when he saw Channing lift up her shirt and grab something out of her waistband, which was when he saw Samuel push Channing down to the ground. Brandon stated that Channing had a "wife beater" (white undershirt) on underneath her top shirt and when she raised it he could see that she had something strapped around the white undershirt around her abdomen. Brandon stated that he could not positively identify what was strapped around Channing's abdomen, but he assumed it was a handgun/weapon due to how Samuel reacted to it. Brandon stated that Channing pulled out a handwritten sign from her abdomen, but from the view he had, it seemed that Channing still had something strapped around her abdomen even after she pulled out the sign. I asked what the sign said and Brandon stated that the only thing he saw was that it said "GAY" with an arrow that would have been pointing at Samuel. Brandon stated that there was more writing on the sign, but he couldn't see it due to the struggle.

I asked Brandon to clarify the order of events when it came to Samuel's actions. Brandon stated that once Samuel recognized who Channing was that he said "no" multiple times and that he threw both of his hands up giving the body language signs that he didn't want anything to do with the situation. Brandon stated that Samuel even started backing away from Channing. Brandon stated that only after Channing started advancing towards Samuel and Samuel already saying "no" multiple times, was when he saw Samuel push Channing down to the ground in what Brandon perceived to be self-defense.

I then spoke with another witness that went by the name of "Nick". I believe that Nick is a co-star on the comedy tour with Samuel, but I'm not entirely sure. Nick stated that he was present for the situation and he too thought that Daniel and Channing were acting strange. Nick also thought that it was strange that Channing was trying to disguise herself to look like a man, especially with the fake facial hair. I asked Nick if he heard Daniel or Channing say anything to which he replied that Daniel and Channing made weird mumbling noises and nothing else.

I then spoke with Samuel again. Samuel started his story over and stated that he was finishing up the meet and greet session after the first show of the night when he was told by his staff that there were 2 last people who had not yet gotten a picture with him. Samuel stated that he went to take the picture with Channing and that was when Channing told him that she had a knife. Samuel stated that at that moment was when he grabbed Channing from the back of her neck and pushed her away from him so that he could distance himself from her. Samuel agreed that he pushed Channing away because he was in fear for his life. Samuel stated that after he pushed Channing away was when he slapped the phone out of Daniel's hand. Samuel then stated that he stepped back from the situation because it seemed that Channing and Daniel were still scrambling to "try and fuck with me (Samuel)" and Samuel then called for Big Laugh staff to remove them from the club. I asked Samuel if he saw Channing messing with her waistband and he said yes. Samuel stated that Channing seemed jittery and that she was messing with something in her pockets/waistband area when they were about to take a picture. Samuel stated that he did observe that Channing had lumps around her lower abdomen area that did not seem natural and that she possibly had unknown items under her shirt.

Samuel then stated that Channing had been physically stalking and cyber stalking him for over 10 years now. Samuel stated that he has received everything from death threats to "I hope you die, I

hope your kids die" etc etc. Samuel stated that he does not want to get a restraining order because it would just stir the pot. I then asked if Channing had come to any other shows recently and said no, but in the last 5 years that she has showed up at his apartment building and stood outside of it. Samuel then stated that he met Channing in 2009 and that they dated on and off until 2017. I asked Samuel if there was any reason for her to come after him like this, to which Samuel replied "Because I promised her that I'd have a baby with her and she is now past the point to where she can have babies. She got [REDACTED] with someone else's baby and got an [REDACTED] and was fucked up because of it. I think she used heroin to prevent being in physical pain from the [REDACTED] that she got, and it's just a sad horrible thing". I then left the scene.

Narrative

I Detective Henderson #4059 was assigned this case for follow up. After reading the report I contacted the VIC who told me that she went to the comedy club to play a joke on her old boyfriend. VIC explained that she went their with her friend Daniel. When it was their turn for the meet and greet VIC told me that he instantly knocked the phone out of David's hand and threw her down by the neck. VIC said she then went to get up and got shoved down again. This is when the SUS told her to get her out of here to the staff at the comedy club. I then spoke with Brandon who works at the comedy club who stated that this female dress up as a man and another guy wanted to do a meet and greet with Samuel. Once they got up there he said the Samuel recognized them and said no no no and smack the phone out of Daniel's hands. He then push her away from him because he though she had a knife. Brandon said he saw something strapped to her abdomen but never found out what it was. I then tried to contact Samuel to get his side of the story but he did not answer. I left a message with Samuel to call me back. To this point I have no evidence that an assault occurred. Both independent witnesses tell different sides of the incident that happened. Their is no video surveillance where this occurred. I am pending this case until I Samuel reach back out to me.
