## Bond Supervision Order

The court, pursuant to Rule 33.01, on the basis of available information, finds the following conditions of release to be the least restrictive necessary to secure the defendant's appearance and to ensure the safety of the community or any other person and Orders:

- ☒ The court orders the following additional conditions of release [as indicated], defendant:
- ☒ Shall appear in court as required; submit to the orders, judgment and sentence and process of the court; not commit any new offenses; not tamper with any victim or witness in the case, nor have any person do so on defendant's behalf; and fully comply with all conditions of release imposed by the court;
  - ☒ Shall sign up to receive email and text "Track this Case" notifications on Missouri Case.net;
  - ☒ Shall not possess or use ☒ alcoholic beverages ☒ controlled substances unless lawfully prescribed;
  - ☐ Shall be subject to supervision by \_\_\_\_\_ and shall contact said agency at [ phone number ] within 2 hours of release; and shall pay all fees and obey all directives given by said agency or its officers;
  - ☒ Shall immediately provide all prescriptions for controlled substances to bond supervisor or if none, to the court if requested;
  - ☒ Shall submit to blood, breath or urinalysis testing upon request of the court, a law enforcement officer or bond supervisor at his/her expense; shall provide a sample for testing that is not diluted or tampered with in any way; shall consent to release the results of the tests to the parties and the court; shall agree that if he/she tests "positive" test for the presence of alcohol or a controlled substance, he/she may be taken into custody until a confirmation of the drug test can be obtained or a hearing can be held to review the violation; and shall agree that a diluted sample will be considered a "positive" test;
  - ☐ Shall have installed a ☐ GPS ☐ SCRAM monitoring device at his/her expense prior to release from custody and be subject to continuous such monitoring while on bond; shall pre-pay a minimum of one month of monitoring; and shall agree that if he/she violates such monitoring he/she may be taken into custody until a hearing can be had on the alleged violation. The monitoring device shall be set up to alert for the following area(s) of exclusion: \_\_\_\_\_;
  - ☒ Shall observe a curfew at his/her residence from 10:00 p.m. to 6:00 a.m. unless for employment or a medical emergency;
  - ☐ Shall be confined to his/her residence with the exceptions of going to work, to medical or treatment appointments, visiting his/her attorney, attending court appearances, meeting with his/her bond supervisor, or going immediately to or therefrom;
  - ☐ Shall have no contact of whatsoever kind or nature with: \_\_\_\_\_;
  - ☒ Shall not operate a motor vehicle unless licensed to do so;
  - ☒ Shall not possess a firearm, ammunition or dangerous weapons;
  - ☒ Other: Defendant shall obtain a substance abuse evaluation within 7 days from release of confinement and follow all aftercare directives; Defendant shall submit the results to the court weekly UA (chemical analysis) to verify he is not consuming controlled substances.
