**ORDER
IN FURTHERANCE OF
ORDER GRANTING IN PART
PLAINTIFF'S AMENDED MOTION FOR PROTECTIVE ORDER**

The Court references its Order Granting in Part Plaintiff's Amended Motion for Protective Order [DIN 208], dated September 15, 2025

Yesterday, October 20, 2025, the Court received in chambers an original paper copy of the deposition of Michael T. Flynn. The Court has sent for filing the cover letter.

The Court's September 15, 2025, Order, set forth a specific procedure to follow to address any specific concern about the disclosure of testimony to be filed within 7 calendar days of General Flynn's receipt of the deposition transcript. The cover letter and the deposition indicate that the deposition transcript was tendered to counsel for General Flynn on October 8, 2025. There is no filing within the Court's docket indicating any identified page and line number of any information that may need to be exempted from public access.


As the Court cannot be sure whether the October 8, 2025, date is correct as to the date the transcript was tendered without giving General Flynn an opportunity to respond, the Court will allow him through and inclusive of 4 p.m. tomorrow, October 22, 2025, within which to comply with decretal paragraph 4 of the Court's September 15, 2025.

IT IS ORDERED:

1. In the event there is no filing made pursuant to decretal paragraph 4 on or before 4:00 p.m. tomorrow, October 22, 2025, the Court's September 15, 2025, protective order will expire and no party will be further bound by it. In that event, counsel for Defendant can make arrangements to have the deposition transcript returned.

2. In the event there is a filing made pursuant to decretal paragraph 4 on or before 4:00 p.m. tomorrow, October 22, 2025, the Court's September 15, 2025, protective order will remain in effect and Defendant will then need to comply with decretal paragraph 5.
