

Content warning for gruesome details regarding death and child endangerment. All information provided is alleged, and the core subject discussed in this document is innocent until proven guilty in a court of law. Do not contact or harass anyone mentioned in this document, even those affiliated.

I (sygnasableye) am creating and sharing this document because I firmly believe that the public, especially Team Ari's fanbase, deserves to know the truth of what happened. Additionally, I am now experiencing harassment in the form of people impersonating me and attempting to spread misinformation about my character regarding this situation, and I now feel it necessary to clear the air. I do not condone or claim any actions that are taken by those wishing to impersonate me.

## THE MAIN INFORMATION

The following screenshots provided are messages detailing information from Team Ari's Discord server that were supposedly discussed in a private channel only members of the dev team could access, given to me by members of the team. I will be keeping these devs' names anonymous for privacy reasons, however the messages themselves appear to be from CorpseSyndrome's ex-partner ogniK. Timestamp is roughly around 12/22/2025, four days after the incident took place.

@everyone I didn't think this is something I would ever need to write or address in my life but here we are.

With a heavy heart I regret to inform that CorpseSymdrone(Jessica) is currently in custody.

Here's the information I know and the sequence of events that transpired on how the information was told to me/discovered.

### Events

- On Thursday at 1am there was a house fire at her residence. One male was airlifted to hospital whereas the other was taken to the hospital. Jessica was also taken however with minor burns.
- Around 6am Thursday she got access to a police woman's phone and placed a call to my dad telling him that she had a disagreement with one of her housemates. She mentioned that she lost it and messed up and there was a fire. At this time, my dad nor I actually thought there was a house fire. We assumed it was going to just be an arson charge and we didn't know other people were in hospital.
- On Friday there was new articles found about the incident. This is the first time we actually knew the severity of the situation and that people were in hospital. No one knew the status of Link(her dog) at this time.
- Later Friday, the detective came and asked for me to give a statement based on me and Jess' previous relationship. He informed me that the two people in the hospital were still alive and getting treated for burns. He also mentioned Jess had received 7% of her body burnt and was getting treatment. He also informed me that Jess was in custody. At this point link was still considered missing.
- On Sunday I had received a call from child protection to make sure [REDACTED] was okay and how she was doing given the situation. I was informed that one of the men in the fire had passed away in the hospital and that Jess is looking at a murder charge for that. The only good news here is the link was confirmed safe

### Closing

What does this mean? I don't know. So far no one knows how to process what's going on or what to do. This is a lot for everyone here and a very scary time.

What's happening to Jess? At this point I don't know for certain. I don't see how Jess wouldn't be blamed for this given she admitted to it on a police womans phone in a call. Reality is we won't know the exact details until sentencing

### Sum up

I'll post updates in here as stuff is found out. I'll answer anything I know the answer too and this is a hard time for everyone, we all have had different relationships with Jess but news like this is always hard.

I'd prefer if we keep this private for the time being. I'm planning on a public announcement once we have more things confirmed and in stone. I know some people have expressed leaving and if you wish to do so just let me know. Currently wanting to figure out the nicest way to go about doing that so people don't go bugging you. As for the future of where ari is going and whats happening, there's some ideas brought up but we all can figure shit out

She told me she threw isopropyl alcohol on the person and didn't realise she had the lighter in her hand  
Okay here's some things from Jess herself  
She doesn't know anyone died  
She thinks she's going to get out  
To talk to her or see her we need to make an appointment with the detective  
Regardless of how it's viewed if she accidentally lit someone on fire or not, she did throw IPA onto them before lighting the fire....  
She IS getting a public defender  
She is unaware of links status  
She doesn't know the damage of the property  
Under very close watch  
They have gotten a lot of mental health history  
Oh right i'm like... shits really fucking hitting now but fuck... she mentioned the right side of her is burnt, collar bone down and needed skin grafting surgery and will have some burn scars but  
holy shit I just wow...  
Oh, another detail is she apparently already had the interigation but she's trying to claim that she was hopped up on too many drugs so she thinks she can fight whatever she said because she wasn't lucid  
however that doesn't change the fact about the phone calls she had  
I don't know what to think god  
Well regardless if they use the interigation recording or not, it doesn't matter because of what she said on the phone and just... everything  
If the other person who got burnt SAW what jess did well.... you have witnesses too  
I mentioned how horrible the child must feel and how traumatic it would be that she lost everything and her response was "she's gone through worse"

The following screenshot was taken by a dev member and sent to me at a later time, timestamp unknown.

**SUMMARY:** On 12/18/2025 at around 1:45 in the morning, CorpseSyndrome (aka Jessica Cruz-Guzman) was involved in a house fire

that resulted in the injuries of two men and Corpse herself. An additional woman, a child, and Corpse's support dog were also present but thankfully unharmed in the fire. However, one of the men injured ended up passing away later in the hospital, resulting in Corpse's incarceration.

Allegedly, Corpse argued with the man that passed in regards to his daughter leaving a mess around the house they lived in. After being told that "at least he had a daughter," Corpse snapped and grabbed isopropyl alcohol and a lighter to threaten the man before throwing both onto him, setting him ablaze. At the time of writing this document it's unclear whether or not she's been officially charged, but according to the screenshots above, she's likely to face a murder charge. Later, Corpse's ex-partner spoke with her via phone call and expressed sympathy for the victim's daughter, to which Corpse replied that "she's gone through worse."

Hey @everyone, this is going to be the last update we post on the situation regarding CorpseSyndrome. There's been a lot and quite recently a lot of the details have been confirmed.

### **What Happened?**

On December 18th 2025 @ 1:45am there was a fire at her residence. At this residence resided Jessica, the two males, a mother and her daughter and Jessica's dog.

At the time, two men were severely burned and needed to be taken to hospital ASAP, one was air lifted. The mother, the child and the dog were unharmed. Jessica also went to hospital as she suffered burns on the right side of her body however she was also under custody whilst being taken and at the hospital.

The reason for this is because the fire was seen as suspicious rather than an accident. It was believed to be intentional. Over the next few days an investigation was opened to find out what started the fire and the reasoning behind this. The Arson and Explosives Squad were the ones investigating this.

Over the next few days/weeks there was information being drip fed and being changed as we tried to actually get confirmed details on what was going on. Only until a few days ago police finally published a statement on how bad everything actually was.

Jessica appeared in court on the 3rd of January 2026 with several charges placed against her. She is being charged or Murder, Attempted Murder, Arson, Property damage and many more charges. I'm going to spoiler this next part as it describes the actual alleged crime and it can be quite triggering to many people. It was alleged that she poured an accelerant or a flammable liquid over the male and setting hit alight. Jessica had admitted over the phone that she indeed do this and had attempted to justify it.

One of the males who had suffered burns had passed away and it was believed to be the father of the daughter but I have not personally been able to confirm this.

So what's next for Jess at this point? She's behind bars until her next court hearing in May.

### **What does this mean for Ari?**

The ownership has been transferred as mentioned in a previous message so it's purely up to them. I think it's fair to say that everyone needs to just take a lil breather to see what's going on.

I also want to stress that no matter what the outcome is from court, Jessica is no longer going to be part of Team Ari. Her actions are unforgivable and her justifications are too appalling to even consider her to be anywhere near here. We want to keep this as a safe and inclusive space however Jessica is not a safe or inclusive person, they will not return and they do not belong. They have already been and will stay permanently banned

I know a lot of you don't know how to feel or emotions are strong. Not many people deal with these types of feelings and no one really knows what you are supposed to move through this. Take it one step at a time and let yourselves heal

This concludes the section of the most important information regarding CorpseSyndrome's incarceration. The rest of this document will detail my involvement with this situation and is not pertinent to the case; it is merely to clear my name of actions I have not taken.




## MY INVOLVEMENT



I was friends with CorpseSyndrome in mid-2025 and ended up commissioning her for artwork later on. Because I'm friends with a few devs on Team Ari, I was told about the incident regarding Corpse and expressly asked to not speak about it until the team came forward with it publicly.

However, I became increasingly angry with the revelation because I had warned the team about something Corpse was partaking in and was universally ignored for it.

The following screenshots are taken from Team Ari's public Discord server on 9/17/2025. Names have been redacted for privacy reasons; the most important user to note is in yellow, who is/was a probationary dev for Team Ari aged 15 at the time of capturing these screenshots. I will refer to this user as Yellow going forward.

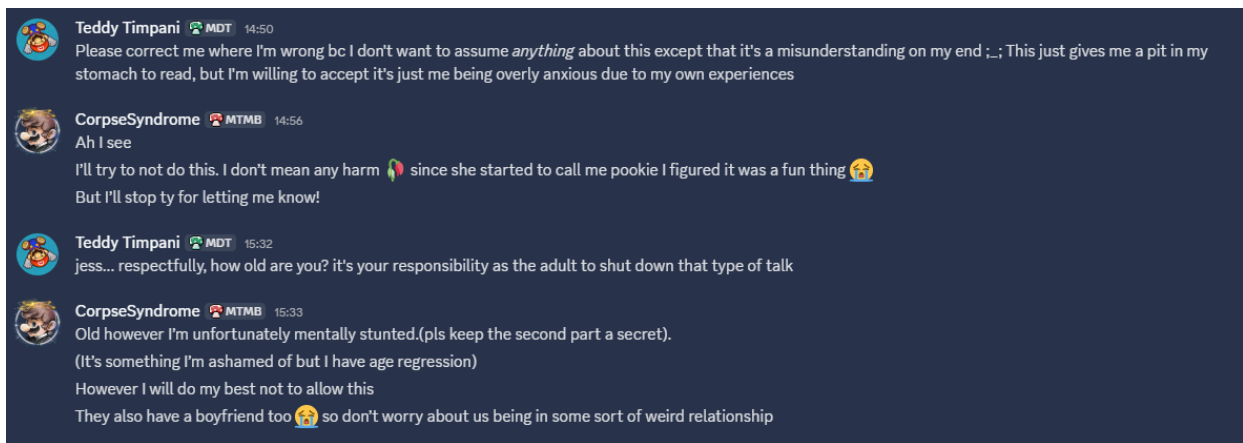
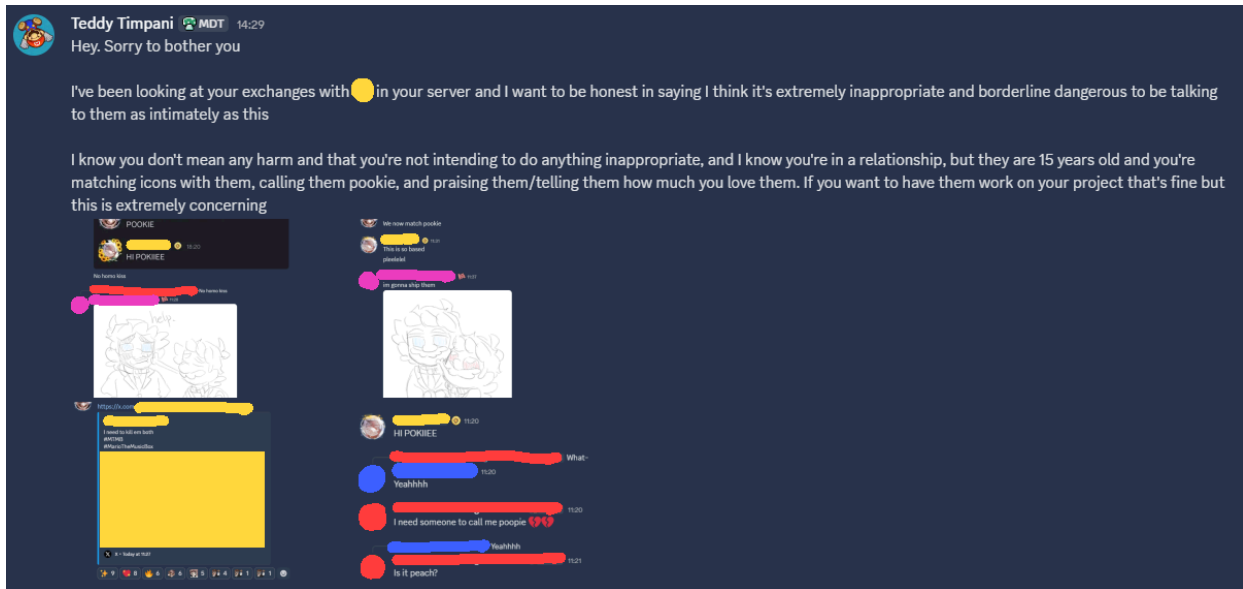

Because Yellow is 15, I felt it was inappropriate to be speaking to them so familiarly given Corpse is almost 30 years old, and I expressed this to her in DMs.

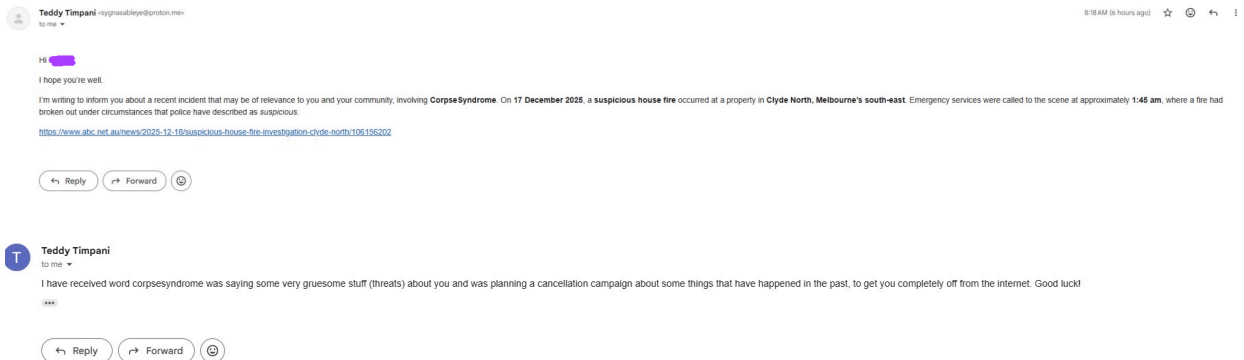
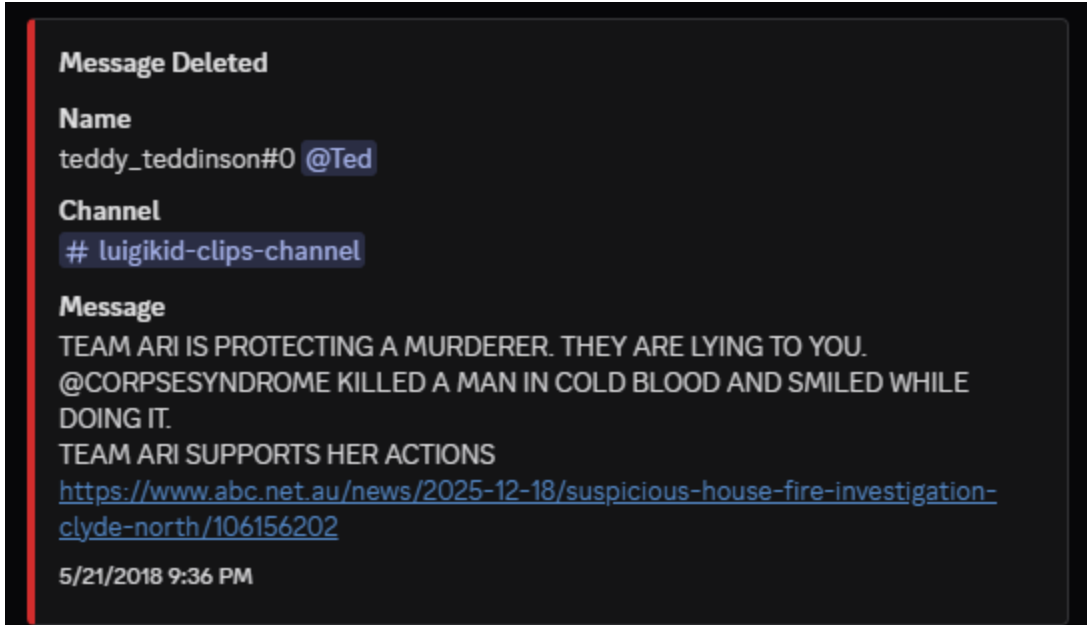


Given Corpse's response, I was alarmed and wanted to look further into this. I believe both Corpse and I are CSA survivors – something she has mentioned before publicly in the Team Ari server. Unfortunately, it is all too common for those who experience abuse in their lives to later go on and abuse others in the same way, and I firmly believed that Corpse's nonchalant response to this was (and still is) an indication that proper boundaries are not being put in place to protect the younger members of the dev team. However, upon reaching out to several different members of the dev team, they all denied any such possibility, and I dropped the subject both for a lack of leads and my own mental health.

When I found out about the house fire, I was furious because I was brushed aside for my concerns long before anything criminal had taken place. Even now, I am still angry and devastated, but I acknowledge that this incident in particular has nothing to do with the house fire and that the likelihood of the dev team themselves being able to do anything to prevent the crime is very low. However, there was room for the team to investigate the clear lack of boundaries and inappropriate mingling with younger members of the Discord server, and they willfully chose not to in the name of preserving their friendships with Corpse. Since this incident, the dev team has disliked me greatly for obvious reasons.

I need to reiterate with complete clarity that what I was alarmed about was the possibility of grooming within the dev team and server, not that Corpse herself was grooming anyone or that she was a pedophile. While I find her behavior with Yellow abhorrent, ***I do not believe – and have never believed – that she is a pedophile, and I do not have any proof that she or or anyone else on the team is grooming anyone.***

The reason I bring this up at all is because on 12/26/2025, I ended up having a mental breakdown and posted the links to the news article discussing the house fire to Team Ari's Discord server. I was promptly banned afterward and have since made no attempt to return or post the articles publicly. However, on 12/28/2025, I was notified that someone has begun entering Discord servers and emailing people under my name, claiming to be me and reposting the news articles.



**These messages are not from me.** My Discord username is sygnasableye, and I do not use Proton Mail as my email domain. If you receive any messages from a different username claiming to be me, or if you receive any email from me at *all* (*because I do not contact people via email unless it is about commissions*), you are speaking to someone else entirely. I do not know who is responsible for this, and I don't want to assume it's someone from Team Ari, but I am aware of the team supposedly looking for my information online following my ban. **While I believe Team Ari is willfully hiding information from the public to preserve their reputations, I do not believe that Team Ari supports or encourages any of Corpse's alleged actions, and I do not condone harassment or threats made against them or anyone else.**
