

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.^[22] A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be ██████████, who was previously known as ██████████. ██████████ met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when ██████████ was a 16-year-old spa attendant.^[22] She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".^{[22][63]}

Maxwell has repeatedly denied any involvement in Epstein's crimes.^[51] In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".^{[58][64]}

Giuffre asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. ██████████ sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in Giuffre's favour,^[65] with Maxwell paying ██████████ "millions".^[66]

██████████ v Epstein and Maxwell (2017)

In 2017, ██████████ filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.^{[9][48][67][68]}

Affidavit filed by ██████████ (2019)

On 16 April 2019, ██████████ went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, Annie, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. Farmer's affidavit was filed in support of a defamation suit by ██████████ against Alan Dershowitz.^[69] According to the affidavit, ██████████ had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.^{[70][71]} Farmer reported the incident to the New York Police Department and the FBI.^{[52][72]} Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, ██████████, to his New Mexico property where he and Maxwell molested her on a massage table.^{[73][74]}

Farmer was interviewed for CBS This Morning in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.^[75]

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.^[26] In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.^[29] He began playing the piano when he was five.^[30] He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.^{[31][32]} Later that year, he attended classes at Cooper Union until he changed colleges in 1971.^[31] From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.^{[31][32]}

Career

Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.^{[31][33]} Donald Barr, who served as the headmaster until June 1974,^{[34][35][36]} was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.^{[33][37][38]} Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.^[38] Epstein allegedly showed inappropriate behavior toward underage students at the time.^{[33][37]} He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.^[35] In June 1976, after Epstein was dismissed from Dalton for "poor performance",^{[33][39][40]} Greenberg offered him a job at Bear Stearns.^{[30][41]}

Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.^[42] He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.^{[32][43][44]} Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.^[42]

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".^{[45][32][30]} Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.^[42]

Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),^[46] which assisted clients in recovering stolen money from fraudulent brokers and lawyers.^[30] Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.^{[30][47]} Spanish actress and heiress ██████████ was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.^[48]

Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year".^[110] It resulted in a 53-page indictment in June 2007.^[71] Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,^[111] to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed "potential co-conspirators". According to the *Miami Herald*, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The *Miami Herald* said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."^[1]

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".^{[52][53][112]} Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.^{[1][89]} The plea deal was later described as a "sweetheart deal".^[113]

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".^{[114][115]}

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.^[116]

Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,^[117] he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.^[100]

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs were destroyed per the department's "records retention" rules (although inexplicably the Stockade visitor logs were not).^[118] He was allowed to use his own driver to drive him between jail and his

The Youth Housing Project, Port Pirie was submitted to the Port Pirie Council who proceeded to submit the project to the South Australian Housing Commission who then proceeded to submit it to the South Australian Government. It was then reviewed and considered but was rejected for funding and development by the South Australian Government, but i was not made aware of the reasons behind the project being rejected.

In several instances, these suggestions have received positive feedback and, where possible, were implemented within the relevant district councils and development boards. However, several have not been submitted or received the attention they deserve and therefore remain open to development and implementation.

I am well aware of your remarkable interest and contributions to community projects, worldwide issues and scientific research and therefore upon your interest i am able to submit four concepts for your consideration, which have been constructed into executive summaries, taking advantage of my qualifications and expertise in the field of Small Business Management and Business Administration, hoping that they will be of interest to you and your foundation to the extent that you would consider them for development in Australia and/or other countries.

The projects include: a Youth Housing Project ; a Food Waste Management Project ; a Decontamination Project to prevent microbial infections ; and a Targeted Human Cell Administration Project with the objective of directly targeting cancer cell masses within the body, with the potential of advancement to address other medical issues.

As the proposed projects are of a Confidential nature, i will request your confidentiality on the concepts and information provided if considered for your review and upon submitting.

Weatherill is married to Melissa, and they have two young daughters.^[86] He is a supporter of the Port Adelaide Football Club.^[87]

He was reported to have contracted COVID-19^{*} at a school reunion event in Norwood, South Australia on 27 November 2021.^{[84][88]}

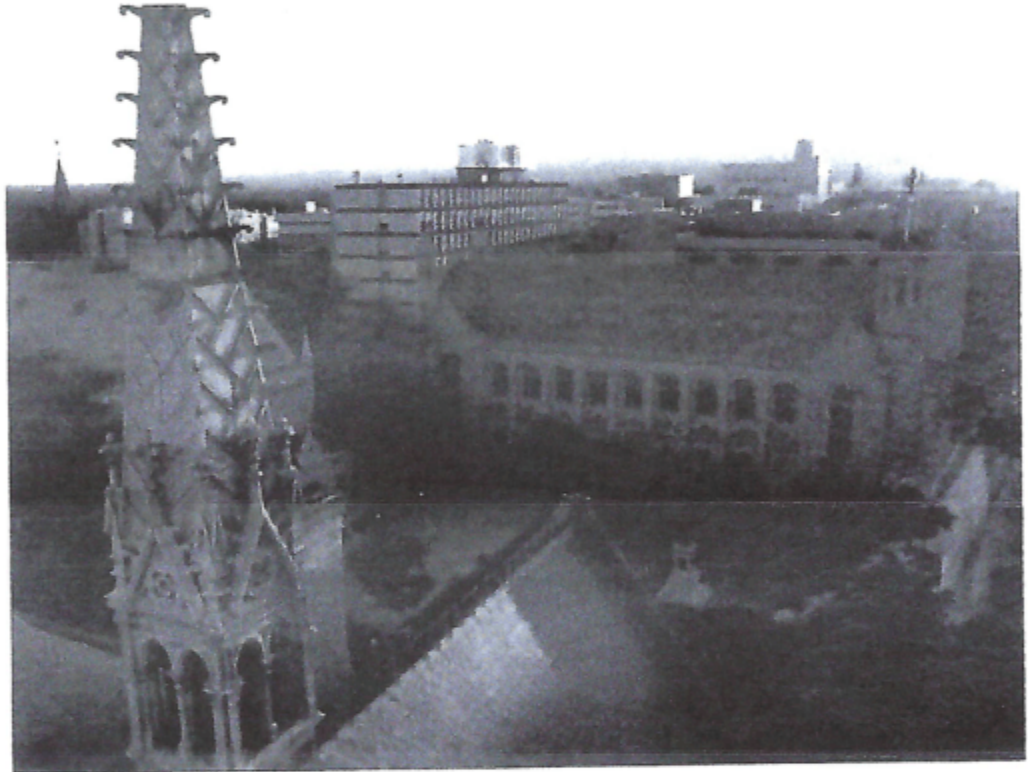

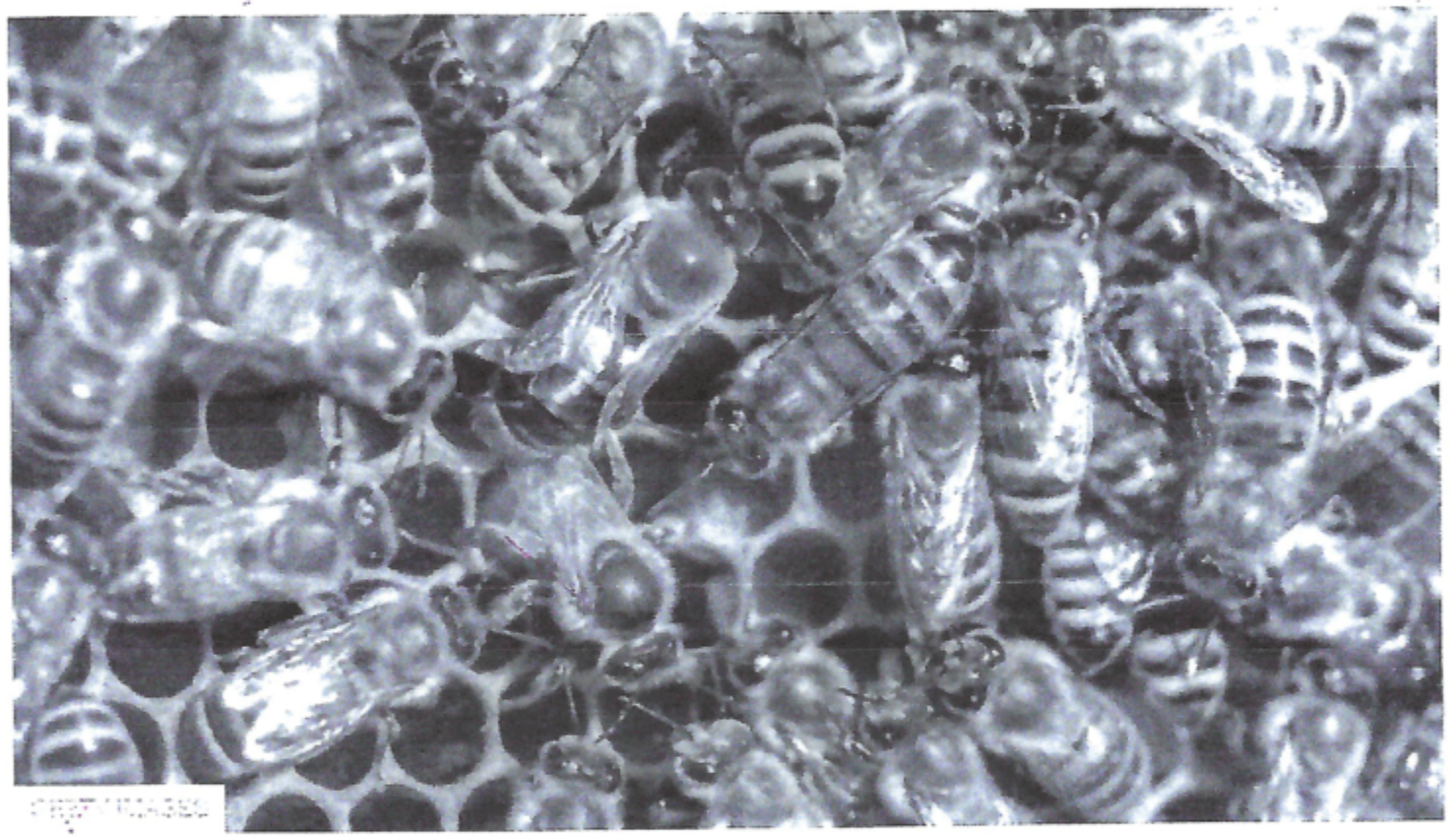

The only publicly known billionaire client of Epstein was Leslie Wexner, chairman and CEO of L Brands (formerly The Limited, Inc.) and Victoria's Secret.^{[30][59]} In 1986, Epstein met Wexner through their mutual acquaintances, insurance executive Robert Meister and his wife, in Palm Beach, Florida. A year later, Epstein became Wexner's financial adviser and served as his right-hand man. Within the year, Epstein had sorted out Wexner's entangled finances.^{[32][60]} In July 1991, Wexner granted Epstein full power of attorney over his affairs. The power of attorney allowed Epstein to hire people, sign checks, buy and sell properties, borrow money, and do anything else of a legally binding nature on Wexner's behalf.^[61]



Epstein managed Wexner's wealth and different projects such as the building of his yacht the Limitless.^[30]

By 1995, Epstein was a director of the Wexner Foundation and Wexner Heritage Foundation. He was also the president of Wexner's Property, which developed part of the town of New Albany outside Columbus, Ohio, where Wexner lived. Epstein made millions in fees by managing Wexner's financial affairs. Although never employed by L Brands, he corresponded frequently with the company executives. Epstein often attended Victoria's Secret fashion shows, and hosted the models at his New York City home, as well as helping aspiring models get work with the company.^{[60][61]}

In 1996, Epstein changed the name of his firm to the Financial Trust Company^[32] and, for tax advantages, based it on the island of St. Thomas in the U.S. Virgin Islands.^[32] By relocating to the U.S. Virgin Islands, Epstein was able to reduce federal income taxes by 90 percent. The U.S. Virgin Islands acted as an offshore tax haven, while at the same time offering the advantages of being part of the United States banking system.^[62]

In 2003, Epstein bid to acquire New York magazine.^[63] Other bidders included advertising executive Donny Deutsch, investor Nelson Peltz, media mogul and New York Daily News publisher Mortimer Zuckerman, and film producer Harvey Weinstein. The ultimate buyer was Bruce Wasserstein, a longtime Wall Street investment banker, who paid US\$55 million.^[63]

In 2004, Epstein and Zuckerman committed up to US\$25 million to finance Radar, a celebrity and pop culture magazine founded by Maer Roshan. Epstein and Zuckerman were equal partners in the venture. Roshan, as its editor-in-chief, retained a small ownership stake. It folded after three issues as a print publication and became exclusively an online one.^[64]

Liquid Funding Ltd.

Epstein was the president of the company Liquid Funding Ltd. between 2000 and 2007.^{[65][66]} The company was an early pioneer in expanding the kind of debt that could be accepted on repurchase, or the repo market, which involves a lender giving money to a borrower in exchange for securities that the borrower then agrees to buy back at an agreed-upon later time and price. The innovation of Liquid Funding, and other early companies, was that instead of having stocks and bonds as the underlying securities, it had commercial mortgages and investment-grade residential mortgages bundled into complex securities as the underlying security.^[65]

Bishop was born on 17 July 1956 in Lobethal, South Australia. She is the third of four children born to Isabel Mary (née Wilson) and Douglas Alan Bishop; she has two older sisters and a younger brother.^[6] Bishop has described her parents as "classic Menzies Liberals". Her father was a returned soldier and orchardist, while her mother's family were sheep and wheat farmers.^[1] Both her mother and grandfather William Bishop were active in local government, serving terms as mayor of the East Torrens District Council.^[6]

Bishop grew up on an apple and cherry orchard in Basket Range. The year before she was born, it was burned to the ground in the Black Sunday bushfires. Bishop began her education at Basket Range Primary School and later attended St Peter's Collegiate Girls' School in Adelaide.^[6] She was the head prefect in her final year.^[7] Bishop went on to study law at the University of Adelaide. She worked two part-time jobs as a barmaid while at university—one at Football Park and one at a pub in Uraidla.^{[6][7]} She graduated with a Bachelor of Laws degree in 1978.^[8]

Professional career

After graduating law school, Bishop joined Wallmans, an Adelaide-based law firm, as its first female articulated clerk.^[9] She left after less than a year, in part due to an incident where a senior partner asked her to perform waitressing duties.^[6] In 1982, aged 26, she became a partner in the firm of Mangan, Ey & Bishop.^[6] The following year, she married West Australian property developer Neil Gillon, and moved to Perth.^{[10][11]}

On arriving in WA, Bishop joined Robinson Cox as a solicitor specialising in commercial litigation, and was made a full partner in 1985.^[12] According to Kerry Stokes, "in the legal profession she was a very determined, reasoned person [...] there's not been much written about what a good executive Julie was—responsible for administering and running a partnership, not just a lawyer".^[1]

In the late 1980s, Robinson Cox was hired by CSR Limited to defend against compensation claims brought by asbestos mining workers, who had contracted mesothelioma while working for Midalco, a subsidiary of CSR. Bishop was part of the team assigned to the case, which developed an argument that a company was not legally responsible for the actions of its subsidiaries. The Supreme Court of Western Australia eventually decided to pierce the corporate veil and hold CSR liable for Midalco's actions; the lead litigant died before the conclusion of the case, which lasted eight months.^[13] After becoming a public figure, Bishop was accused by opponents of acting immorally by involving herself in the case. She has said she conducted herself ethically and professionally,^[12] and in accordance with procedural advice given by barristers Robert French and David Malcolm (both future judges).^[14]

As a legal advisor to the Western Australian Development Corporation, Bishop assisted in the incorporation of several new government enterprises, including Gold Corporation (the operator of the Perth Mint), LandCorp, and Eventscorp (a division of Tourism Western Australia).^[12] Robinson Cox merged into the larger firm of Clayton Utz in 1992, and she was made managing partner of the firm's Perth office in 1994.^[8] In the same year, she took up an appointment as chair of the state government's Town Planning Appeal Tribunal, serving a three-year term.^[15] In 1996, Bishop attended Harvard Business School for eight weeks to complete the Advanced Management Programme for senior managers.^[16] She has credited one of her lecturers there, George C. Lodge, with inspiring her to enter public life.^[17] In 1997, she was elected to the senate of Murdoch University and appointed as a director of the Special Broadcasting Service (SBS).^[8] *

Malcolm Bligh Turnbull AC (born 24 October 1954) is a former Australian politician who served as the 29th prime minister of Australia from 2015 to 2018. He held office as leader of the Liberal Party of Australia.

Turnbull graduated from the University of Sydney with a Bachelor of Arts and a Bachelor of Laws, before attending Brasenose College, Oxford as a Rhodes Scholar, earning a Bachelor of Civil Law. For more than two decades, he worked as a journalist, lawyer, merchant banker, and venture capitalist. He served as Chair of the Australian Republican Movement from 1993 to 2000, and was one of the leaders of the unsuccessful "Yes" campaign in the 1999 republic referendum. He was first elected to the Australian House of Representatives as a member of parliament (MP) for the division of Wentworth in New South Wales at the 2004 election, and was Minister for the Environment and Water in the Howard Government from January 2007 until December 2007. - MEDICAL BUSINESS PLAN

After coming second in the 2007 leadership election, Turnbull won the leadership of the Liberal Party in a leadership spill the following year and became Leader of the Opposition. However, his support of the Carbon Pollution Reduction Scheme proposed by the Rudd Government in December 2009 led in turn to a leadership challenge by Tony Abbott, who defeated Turnbull by a single vote. Though initially planning to leave politics after this, Turnbull chose to remain and was later appointed

* Minister for Communications in the Abbott Government following the Liberal-National Coalition's victory at the 2013 election.

Two years later, citing consistently poor opinion polling, Turnbull resigned from the Cabinet on 14 September 2015 and challenged Abbott, successfully reclaiming the leadership of the Liberal Party by ten votes. He was sworn in as Prime Minister the following day. The Turnbull Government initiated the National Innovation and Science Agenda as its key economic priority, working to promote STEM education, increase venture capital funding for new start-ups, and launch an "ideas boom".^[1] Turnbull also pursued "city deals" with local and state governments to improve planning outcomes and encourage investment in major infrastructure projects such as the Western Sydney Airport.^[2] In 2016, Turnbull led the Coalition to a narrow victory in a double dissolution election.^[3] In his second term, Turnbull initiated and campaigned for the "Yes" side

Rann was born in Sidcup, Kent.^[1] His father was an electrician who had served at El Alamein in World War II. His mother was employed in an armaments factory.^[2] Most of Rann's childhood was spent in the care of his father in South London. In 1962, when he was nine, his family emigrated from Blackfen to Mangakino, a small town north of Taupo on the Waikato River in New Zealand. His family then moved to Matamata, then to Birkenhead, New Zealand on Auckland's North Shore where he attended Northcote College.^[3]

He completed a Bachelor and a Master of Arts in political science at the University of Auckland. He was Vice President of the New Zealand Campaign for Nuclear Disarmament and editor of the student newspaper *Craccum*. As a member of Princes Street Labour, he also spent considerable time working on New Zealand Labour Party campaigns including that of Mike Moore. After university, Rann was a political journalist for the New Zealand Broadcasting Corporation. Haydon Manning has stated that "it was reported that" Rann "struggled with being an objective reporter".^[3]

Rann visited his brother Chris in Adelaide during 1977. Shortly afterwards he moved to that city, to carry out a position with then Premier Don Dunstan's Industrial Democracy Unit. He subsequently worked as Dunstan's press secretary, speech writer and adviser, and went on to serve Labor premiers Des Corcoran and John Bannon after Dunstan's retirement from politics. Manning has stated that one commentator reported that Rann was "frankly inspired by Dunstan's idealism" as opposed to "Bannon's cool electoral pragmatism". Rann sometimes talked during this period of his ambitions to one day become Premier himself. Meanwhile, Rann wrote speeches on, and assisted in policy development for, civil liberties, Aboriginal land rights, gay and women's rights, and opposition to uranium mining. Revealing a vein of idealism, his early predilection was left of centre.^{[3][4]}

Parliament

Rann was elected to Parliament as the Member for the safe Labor seat of Briggs in north Adelaide at the 1985 election. After the 1989 election, he entered the ministry, becoming Minister for Employment and Further Education, Minister of Youth Affairs, Minister of Aboriginal Affairs and Minister assisting in Ethnic Affairs.

As Minister for Employment and Further Education he established the Kickstart employment scheme, the South Australian Youth Conservation Corps,^[5] presided over a large expansion of TAFE, and signed an agreement in 1992 between Le Cordon Bleu, the Swiss Hotel Association and the Regency College of TAFE to establish an international hospitality and cooking school.^[6] He introduced the legislation in 1991 to establish the new University of South Australia, now the

week before the 2010 election for not being willing to publicly refuse challenging Redmond for the leadership and faced accusations, particularly by Hamilton-Smith, of derailing the Liberal campaign, with "Chapman Could Challenge" posters hung beneath many of the Liberal "Redmond is Ready" posters.^[6]

Chapman was reappointed deputy opposition leader on 4 February 2013, and chose to announce she would rule out challenging new leader Steven Marshall.^[7]

Upon the fourth consecutive Liberal loss at the 2014 election, Chapman suffered a 1.5-point two-party swing but still retained Bragg with a comfortably safe 68.7 percent two-party vote.

Chapman lost a vote of non-confidence as Deputy Premier in the South Australian Parliament on 18 November 2021 after a parliamentary inquiry found her conflict of interest as Minister for Planning and Local Government and recommended for her to be found guilty of contempt of parliament for misleading the house.^[8] She resigned as Deputy Premier on 22 November 2021.^[9]

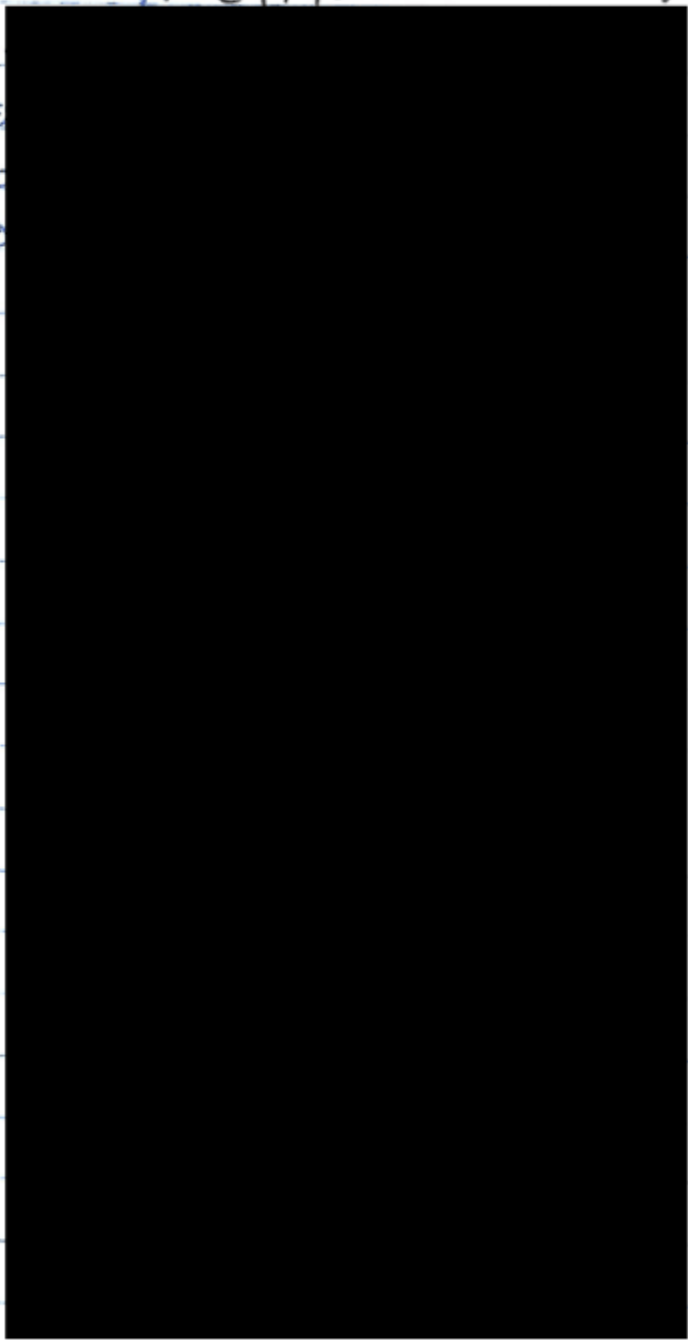

FEDERAL Assistant Minister for Community Housing, Homelessness and Community Services Luke Howarth and Member for Grey Rowan Ramsay visited Kadina on Tuesday, September 29.

The pair met with Copper Coast Council mayor Roslyn Talbot, YP Community Transport general manager David McDonald and Copper Coast Salvation Army Captain Karen Armstrong to talk about community housing, mental health and homelessness on Yorke Peninsula.

"Everyone needs to understand a lot of homelessness in the area is situational and if we give people the required help when they need it, they can

"Salvation Army will also contribute \$5m and build more community housing," he said.

"We know homelessness is more hidden in regions and a lot of people either couch surf or live with other people causing severe overcrowding.

"We'd love to see this government money come into regions — being here (in regions) is a great way to talk to community groups and service providers to better work together."

Mrs Talbot said the visit was an opportunity to highlight for affordable housing in the area. "While it (homelessness) isn't a core function of council, he (Mr Howarth) has given us some suggestions of ways to advocate for solutions for our area," she said.

"We are a growth area and we are trying to encourage more people here but affordable housing is a real issue.

"I also highlighted the need for accessible information for people, to have more Copper Coast-specific connections. Mrs Armstrong said she wanted the assistant minister to know the region had a lack of

Trump was the only president to never reach a 50% approval rating in the Gallup poll dating to 1938. The approval ratings showed a record partisan gap: 88 percent among Republicans, 7 percent among Democrats.^[693] Until September 2020, the ratings were unusually stable, reaching a high of 49 percent and a low of 35 percent.^[694] Trump finished his term with a record-low approval rating of between 29 percent and 34 percent (the lowest of any president since modern polling began) and a record-low average of 41 percent throughout his presidency.^{[693][695]}

In Gallup's annual poll asking Americans to name the man they admire the most, Trump placed second to Obama in 2017 and 2018, tied with Obama for most admired man in 2019, and was named most admired in 2020.^{[696][697]} Since Gallup started conducting the poll in 1948, Trump is the first elected president not to be named most admired in his first year in office.^[698]

A Gallup poll in 134 countries comparing the approval ratings of U.S. leadership between the years 2016 and 2017 found that Trump led Obama in job approval in only 29, most of them non-democracies,^[699] with approval of US leadership plummeting among US allies and G7 countries. Overall ratings were similar to those in the last two years of the George W. Bush presidency.^[700] By mid-2020, only 16% of international respondents to a 13-nation Pew Research poll expressed confidence in Trump, a lower score than those historically accorded to Russia's Vladimir Putin and China's Xi Jinping.^[701]

C-SPAN, which has surveyed presidential historians on presidential leadership each time the administration changed since 2000,^[702] ranked Trump fourth-lowest overall in their Presidential Historians Survey 2021, with Trump rated lowest in the leadership characteristics categories for moral authority and administrative skills.^{[703][704][1]}

* Social media

* Trump's social media presence attracted attention worldwide since he joined Twitter in 2009. He frequently tweeted during the 2016 election campaign and as president, until his ban in the final days of his term.^[705] Over twelve years, Trump posted around 57,000 tweets, often using Twitter as a direct means of communication with the public and sidelining the press.^[706] In June 2017, a White House press secretary said that Trump's tweets were official presidential statements.^[707] Trump often announced terminations of administration officials and cabinet members over Twitter.^[708]

After years of criticism for allowing Trump to post misinformation and falsehoods, Twitter began to tag some of his tweets with fact-checking warnings in May 2020.^[709] In response, Trump tweeted that "Social Media Platforms totally silence conservatives [*sic*] voices" and that he would "strongly regulate, or close them down".^[710] In the days after the storming of the United States Capitol, Trump was banned from Facebook, Instagram, Twitter and other platforms.^[711] Twitter blocked attempts by Trump and his staff to circumvent the ban through the use of others' accounts.^[712] The loss of Trump's social media megaphone, including his 88.7 million Twitter followers, diminished his ability to shape events,^{[713][714]} and prompted a dramatic decrease in the volume of misinformation shared on Twitter.^[715] In May 2021, an advisory group to Facebook evaluated that site's indefinite ban of Trump and concluded that it had been justified at the time but should be re-evaluated in six months.^[716] In June 2021, Facebook suspended the account for two years.^[717] Later in June, Trump joined the video platform Rumble^[718] and began to post the messages of his website blog on the Twitter account of a spokesperson.^[719] Trump's attempts to re-establish a social media presence were unsuccessful. In May 2021 he launched a blog that had low readership and was closed after less than a month.^[720]

Relationship with the press

Some of Trump's falsehoods were inconsequential, such as his claims of a large crowd size during his inauguration.^{[741][742]} Others had more far-reaching effects, such as Trump's promotion of unproven antimalarial drugs as a treatment for COVID-19 in a press conference and on Twitter in March 2020.^{[743][744]} The claims had consequences worldwide, such as a shortage of these drugs in the United States and panic-buying in Africa and South Asia.^{[745][746]} Other misinformation, such as misattributing a rise in crime in England and Wales to the "spread of radical Islamic terror", served Trump's domestic political purposes.^[747] As a matter of principle, Trump does not apologize for his falsehoods.^[748]

Despite the frequency of Trump's falsehoods, the media rarely referred to them as lies.^{[749][750]} The first time *The Washington Post* did so was in August 2018, when it declared that some of Trump's misstatements, in particular those concerning hush money paid to Stormy Daniels and *Playboy* model Karen McDougal, were lies.^{[751][750]}

In 2020, Trump was a significant source of disinformation on mail-in voting and misinformation on the COVID-19 pandemic.^{[752][753]} His attacks on mail-in ballots and other election practices served to weaken public faith in the integrity of the 2020 presidential election,^{[754][755]} while his disinformation about the pandemic delayed and weakened the national response to it.^{[472][752]}

Some view the nature and frequency of Trump's falsehoods as having profound and corrosive consequences on democracy.^[756] James Pfiffner, professor of policy and government at George Mason University, wrote in 2019 that Trump lies differently from previous presidents, because he offers "egregious false statements that are demonstrably contrary to well-known facts"; these lies are the "most important" of all Trump lies. By calling facts into question, people will be unable to properly evaluate their government, with beliefs or policy irrationally settled by "political power"; this erodes liberal democracy, wrote Pfiffner.^[757]

Promotion of conspiracy theories

Before and throughout his presidency, Trump has promoted numerous conspiracy theories, including Obama birtherism, the Clinton Body Count theory, QAnon, the Global warming hoax theory, Trump Tower wiretapping allegations, a John F. Kennedy assassination conspiracy theory involving Rafael Cruz, linking talk show host Joe Scarborough to the death of a staffer,^[758] alleged foul-play in the death of Antonin Scalia, alleged Ukrainian interference in U.S. elections, and that Osama bin Laden was alive and Obama and Biden had members of Navy SEAL Team 6 killed.^{[758][759][760][761][762][763]} In at least two instances Trump clarified to press that he also believed the conspiracy theory in question.^[760]

During and since the 2020 presidential election, Trump has promoted various conspiracy theories for his defeat including dead people voting,^[764] voting machines changing or deleting Trump votes, fraudulent mail-in voting, throwing out Trump votes, and "finding" suitcases full of Biden votes.^{[765][766]}

Racial views

Many of Trump's comments and actions have been considered racist.^[767] He repeatedly denied this, saying: "I am the least racist person there is anywhere in the world."^[768] In national polling, about half of respondents said that Trump is racist; a greater proportion believed that he has emboldened racists.^{[769][770]} Several studies and surveys found that racist attitudes fueled Trump's political ascent and were more important than economic factors in determining the allegiance of Trump voters.^{[771][772]} Racist and Islamophobic attitudes are a strong indicator of support for Trump.^[773]

most of his properties to pay down his debts, including personally guaranteed loans, allowing him to avoid personal insolvency.^{[56][57]}

In 1996, Trump acquired the mostly vacant 71-story skyscraper at 40 Wall Street, later also known as the Trump Building, and renovated it.^[58] In the early 1990s, Trump won the right to develop a 70-acre (28 ha) tract in the Lincoln Square neighborhood near the Hudson River. Struggling with debt from other ventures in 1994, Trump sold most of his interest in the project to Asian investors, who were able to finance completion of the project, Riverside South.^[59]

Mar-a-Lago

In 1985, Trump acquired the Mar-a-Lago estate in Palm Beach, Florida.^[60] In 1995, he converted the estate into a private club with an initiation fee and annual dues. He continued to use a wing of the house as a private residence.^[61] In 2019, Trump declared Mar-a-Lago his primary residence.^[54]

Atlantic City casinos

In 1984, Trump opened Harrah's at Trump Plaza, a hotel and casino in Atlantic City, New Jersey, with financing and management help from the Holiday Corporation.^[62] It was unprofitable, and Trump paid Holiday \$70 million in May 1986 to take sole control.^[63] Trump had earlier bought a hotel and casino in Atlantic City from the Hilton Corporation for \$320 million. On completion in 1985, it became Trump Castle. His wife Ivana managed it until 1988.^{[64][65]}

Trump bought a third Atlantic City venue in 1988, the Trump Taj Mahal. It was financed with \$675 million in junk bonds and completed for \$1.1 billion, opening in April 1990.^{[66][67]} It went bankrupt in 1989.^[68] Reorganizing left him with half his initial stake and required him to personally guarantee future performance.^[69] To reduce his \$900 million of personal debt, he sold his failing Trump Shuttle airline, his megayacht, the Trump Princess, which had been leased to his casinos and kept docked, and other businesses.^[70]

In 1995, Trump founded Trump Hotels & Casino Resorts (THCR), which assumed ownership of Trump Plaza, Trump Castle, and the Trump Casino in Gary, Indiana.^[71] THCR purchased the Taj Mahal in 1996 and went bankrupt in 2004, 2009, and 2014, leaving Trump with 10 percent ownership.^[72] He remained chairman until 2009.^[73]

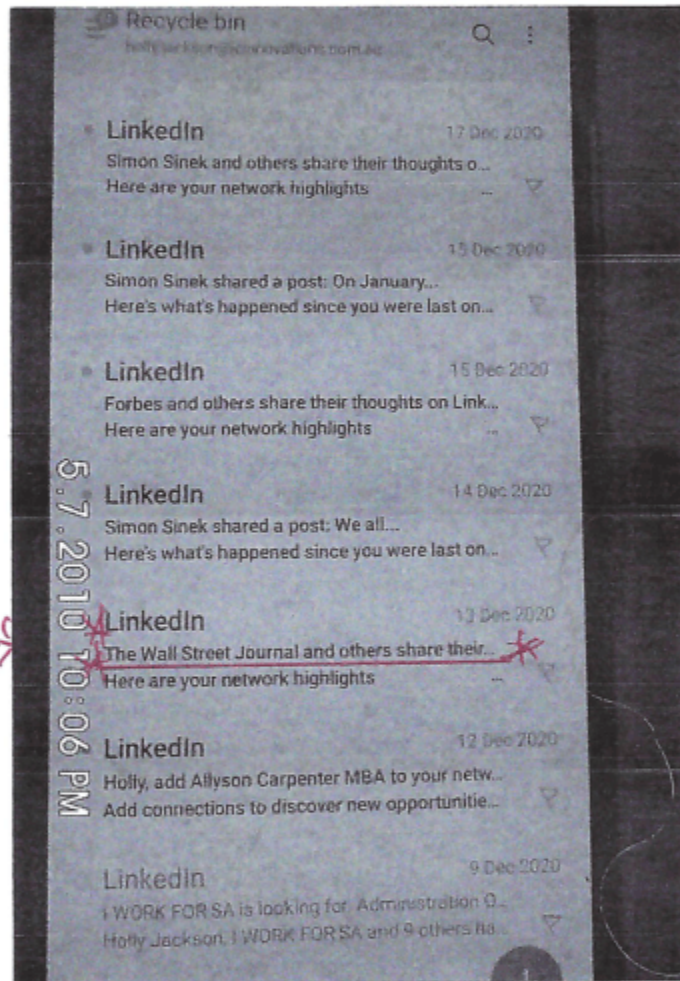
Golf courses

The Trump Organization began building and buying golf courses in 1999.^[74] It owns fourteen and manages another three Trump-branded courses worldwide as of July 2020.^{[74][75]}

Trump visited a Trump Organization property on 428 (nearly one in three) of the 1461 days of his presidency and is estimated to have played 261 rounds of golf, one every 5.6 days.^[76]

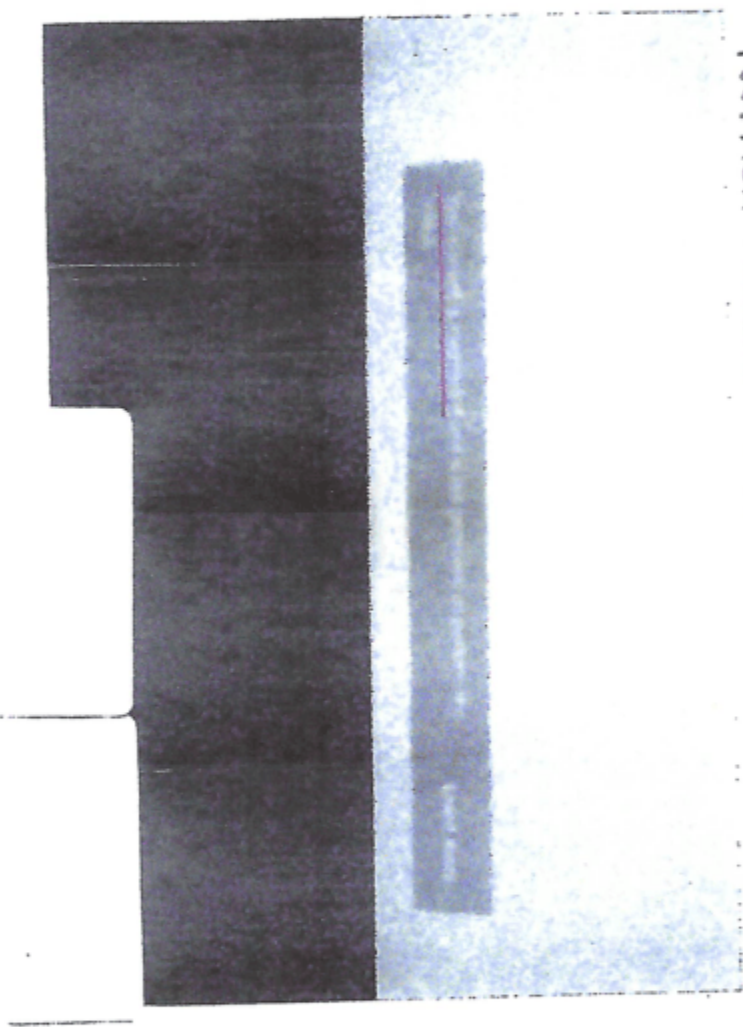

"It captures the faith that sustains me, which I believe sustains America. And I hope and I hope I can provide some comfort and solace," he told the crowd before reciting the hymn. "And he will raise you up on eagle's wings, bear you on the breath of dawn. Make you to shine like the sun and hold you in the palm of his hand."

Biden ended with this: "And now, together — on eagle's wings — we embark on the work that God and history have called upon us to do."

Earlier in his speech, given outside the Chase Center in Wilmington, Delaware, Biden quoted from the book of Ecclesiastes: "The Bible tells us that to everything there is a season * a time to build, a time to reap, a time to sow. And a time to heal. *

"This is the time to heal in America."

During the campaign, President Donald Trump accused Biden of being "against God" despite the devout Catholic's frequent references to his faith. Biden, who has often talked about how his Catholic faith helped him survive the death of his first wife and their daughter in a 1972 car crash, dismissed Trump's comments as an attempt at making a cynical appeal to religious conservatives.

As he wrapped his remarks on Saturday, Biden recalled his grandfather telling him to * "keep the faith" * before adding that his grandmother chimed in, "no Joey, spread it. Spread the faith." *
