

## The UltrakawaHD Files

**Document composed by baconmonke, quadrakyro, and two anonymous associates.**

This document aims to prove that Ultrakawa has no issue presenting pornographic material to minors, which is proven by a multitude of medical studies to be harmful to dopamine production, sexual expectation, sexual performance, and sexual development. In this document, thousands of pornographic images, available to the general public of twitter, will be shown as evidence of the presentation.

We conclude, therefore, that Ultrakawa at the very least has some inclination to pedophilic tendency, as she was well aware of the ages of multiple minors she spoke to in a sexual manner. Throughout this document, Ultrakawa is depicted allowing minors into pornographic spaces WITH FOREKNOWLEDGE, and directly engaging in conversations with minors in these spaces, for example her private 18+ Twitter account and her NSFW channels in her Discord server. This is very problematic and is illegal under the law of not only Brazil, but also applicable nations of the victims.

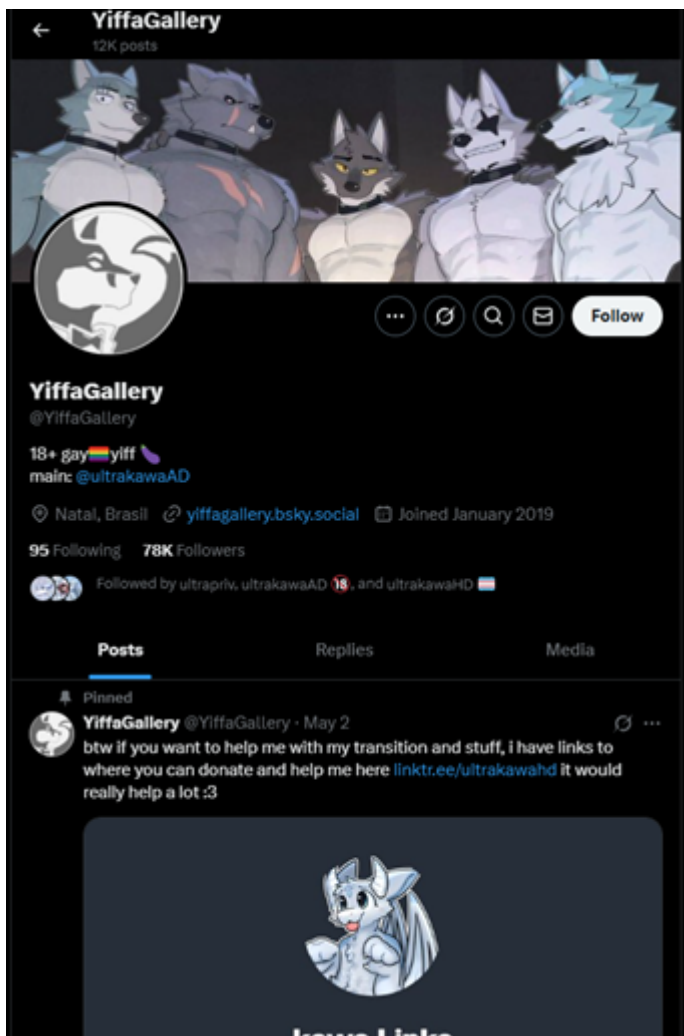

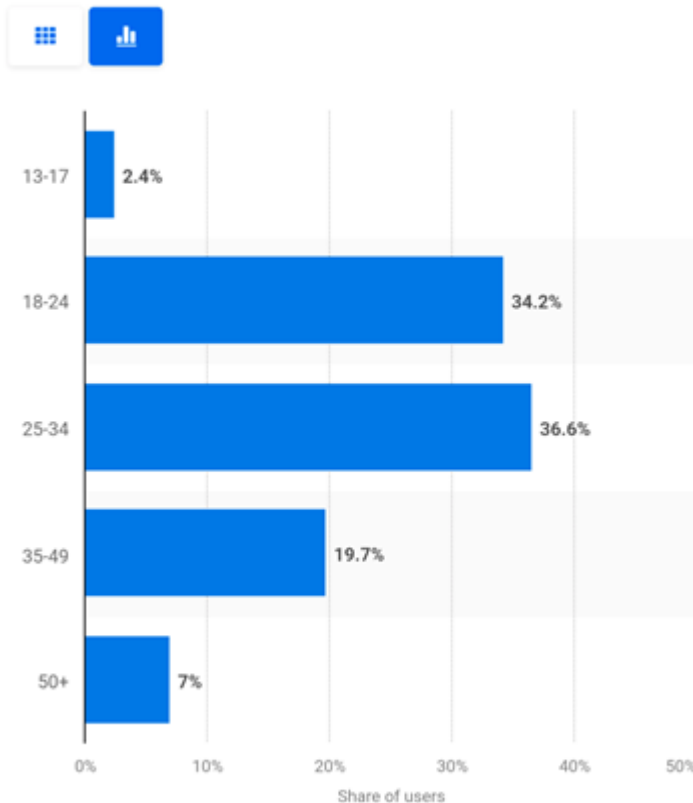

## Confirmed minors following Ultrakawa's NSFW accounts:

This will be an evidential argument made on twitter statistics. Keep in mind that these may be skewed in any direction, and since Twitter limits you to seeing only the 100 most recent followers of any given account, it is not a large enough sample size to be 100% accurate. However, assuming just a small number of minors are following Ultrakawa is completely incorrect.

If we conservatively take the number of minors that follow Ultrakawa's public porn accounts and multiply it by Twitter's age distribution chart as of April 2024, we can conclude that Ultrakawa is followed by ~1933 minors across the public porn accounts that we can confirm she own, and liberally, assuming the other porn accounts to be Ultrakawa's, Ultrakawa is followed by ~2976 minors. Ultrakawa is vincibly exposing at least ~1933 minors to pornography, and at most ~2976. This is immensely problematic, and it is obvious that Ultrakawa has made no attempt to moderate the followers of these accounts.

## **ADDRESSING THE MINORS FOLLOWING THESE ACCOUNTS:**

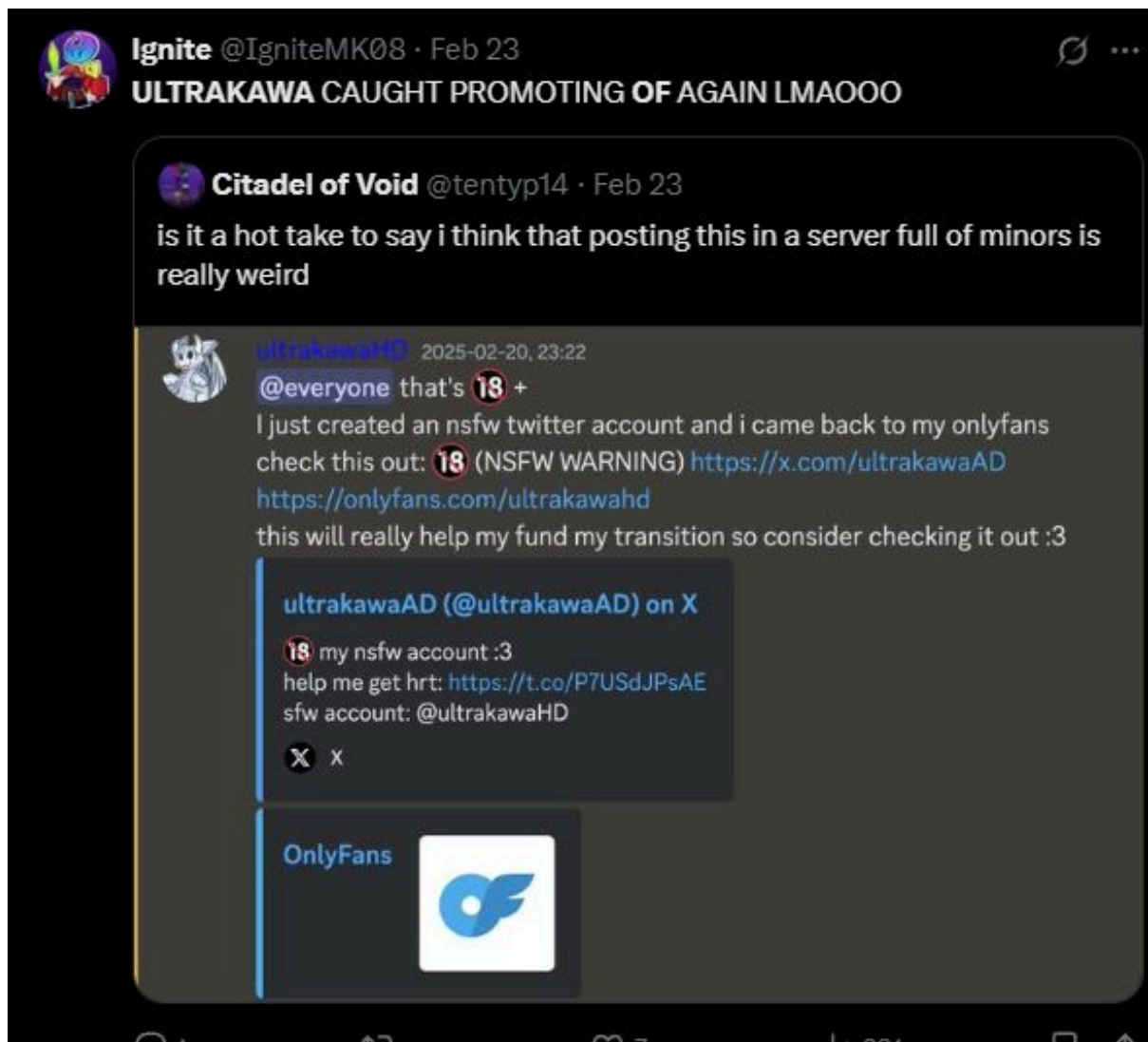
\_However, we must consider that Ultrakawa has no way of reasonably limiting the number of minors that follow her, unless she were to abandon sex work entirely. This is not what we are suggesting. The issue at hand is that Ultrakawa is advertising her porn accounts through her main source of fame, Geometry Dash, which is a game dominated by children. Ultrakawa is using her success in a children's game to promote her pornography. Given that 11.3k people follow @ultrakawahd (Ultrakawa's GD account), we can safely assume that a much larger portion of those individuals are minors, and when taking into account a sample size of 100 followers, we can conclude that Ultrakawa's Geometry Dash following is composed of roughly 43% minors. Therefore, we can conclude that Ultrakawa is advertising her OnlyFans and free NSFW twitter account (not private) to at the very least, roughly 4859 minors. This is highly problematic and frankly detestable. The kind of person it takes to use fame from a children's game to promote one's own pornography to minors is certainly not one that I believe most of the GD community would like within it.

**TO NOTE: THESE VALUES ARE PURELY ESTIMATES AND SHOULD NOT BE TREATED AS 100% FACT. THIS IS TO PUT INTO CONTEXT HOW MANY PEOPLE ARE EXPOSED TO THE CONTENT ULTRAKAWA SHARES.**


## PROOF OF ULTRAKAWA EXPOSING THIS CONTENT TO MINORS:

Here I will be outlining the proof of Ultrakawa, in most cases, knowingly displaying sexual content to minors. If not knowingly, she failed to check the ages of these people, as I found no evidence of them lying to say they are 18 just to gain access to private channels.

Proof of Ultrakawa promoting her OnlyFans in a server full of minors, no less with an @everyone ping. Additionally, in the same message, she promoted her NSFW account @ultrakawaAD, which is fully public as of writing this, with zero restrictions to stop a younger audience from viewing it. This displays a clear ignorance of the safety and wellbeing of children.

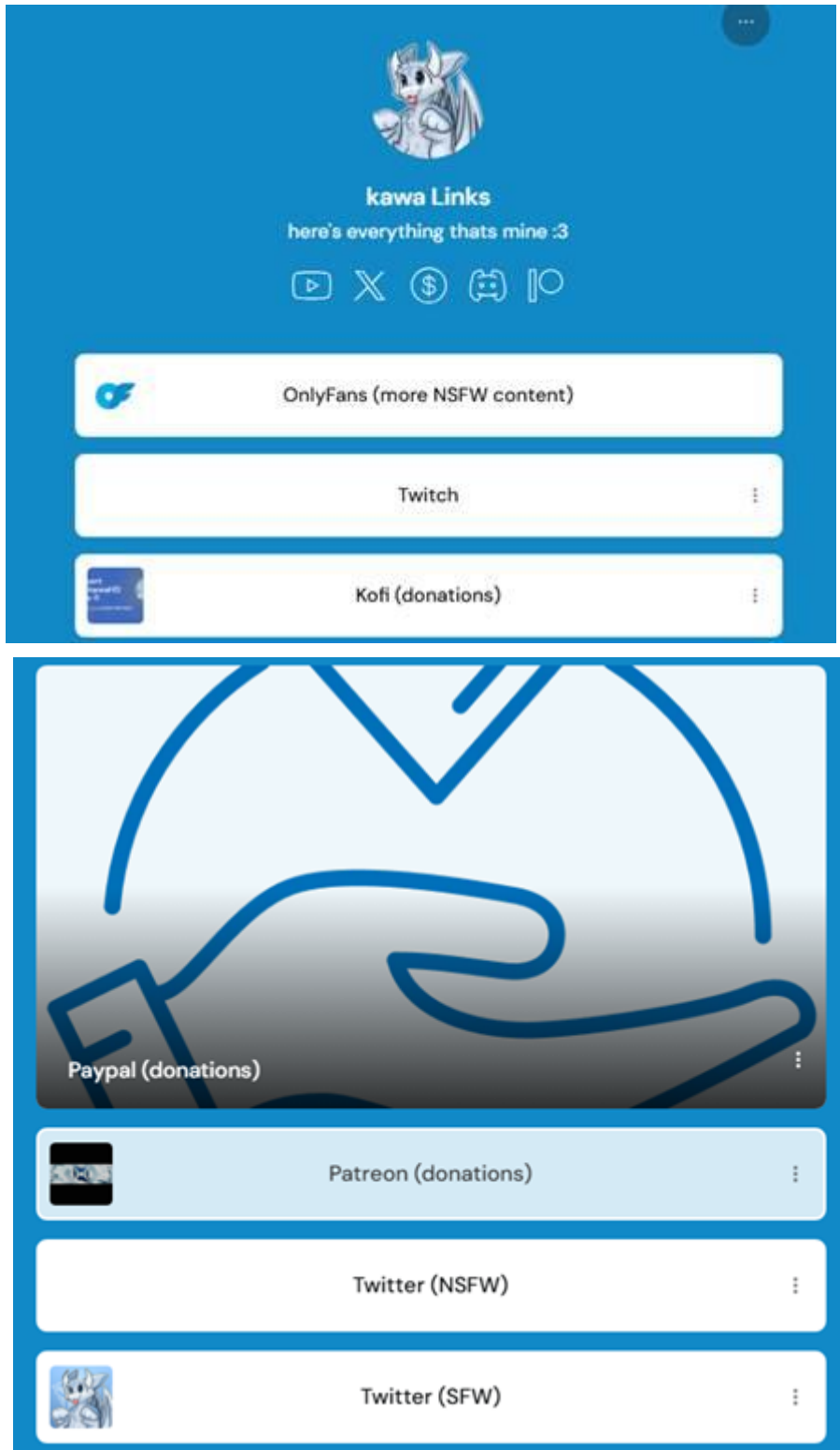


The UltrakawaAD account is comprised heavily of her own dick pics, which no minor should be able to stumble across. Even given the big 18+ sign, they are able to access it.



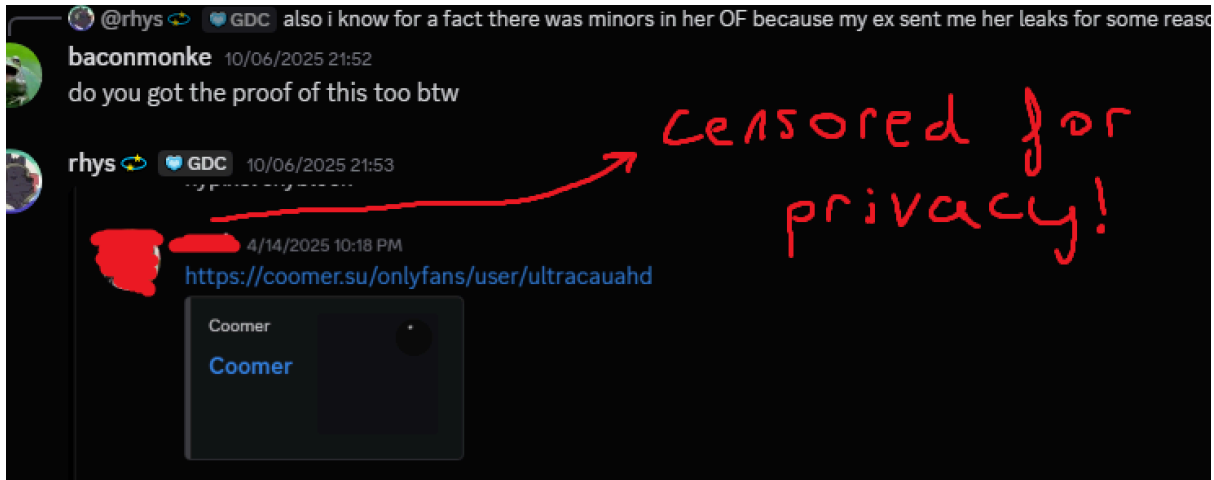

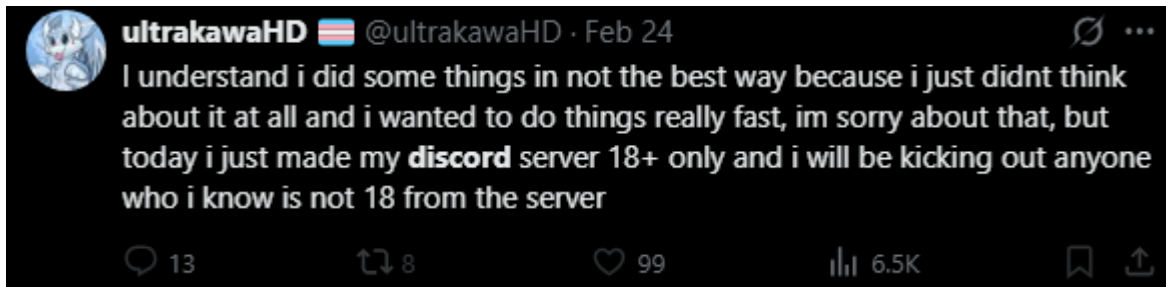


## Misconduct concerning Ultrakawa's Discord server

Proof that minors were on Ultrakawa's OnlyFans page. This is likely caused by Ultrakawa's initial hype around her Acu completion with her penis, which was a huge talking point on GD Twitter for a while. I personally (baconmonke) was exposed to this video at the age of 15/16, which I never should have laid my eyes upon, and wish I never saw.




Ultrakawa admitting the server was not 18+ at the time of posting. This is blatantly a severe lapse in judgement that she should still be held accountable for instead of saying "I will be kicking out anyone who I know is not 18 from the server," which either never happened to the extent that it should have, or the server is clearly unmoderated. If Ultrakawa wants the server to die, so be it, but first the NSFW channels should be made completely private to prevent minors from even being able to access them.



I had to do nothing to access these channels immediately after joining the server, which even includes not having to verify my phone number just to view the messages.

There are still many minors in the server, including these 5 accounts that I have found in approximately 5 minutes of searching. Two of these people are under the age of 15.





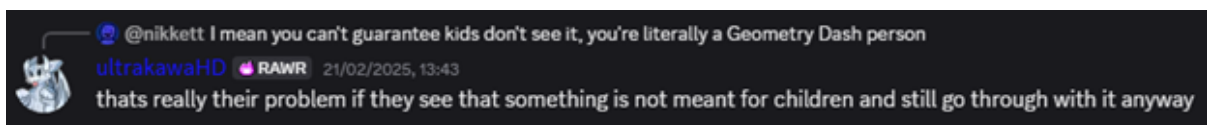
Ultrakawa admits to lying about her age in the past to affirm that it wasn't so bad to do so, claiming its "always better to lie your age." Of course, this is in the context of Twitter, however she acknowledges that others do the same thing, meaning she should be able to properly verify the age and/or identity of people that request to follow her private account otherwise she risks letting minors in.



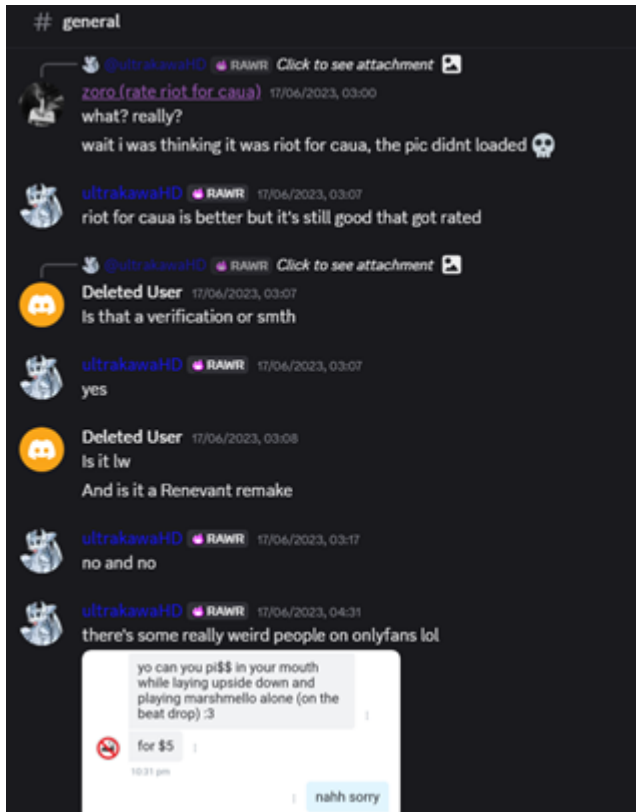
Ultrakawa admits to using Geometry Dash as a platform to advertise her OF, and states that it's okay to use Twitter despite already having a large audience of children on her main account that may view these posts.




Ultrakawa claims that the minors themselves are at fault for viewing her OF. This is obviously ridiculous to say, blaming the people that cannot legally consent to seeing this content AT ALL is bewildering to me when there is clearly an alternative PRIVATE account to be used where all users can be verified to be 18.



Ultrakawa posting in general about her OF with a screenshot of a very sexual request made by a subscriber. The user zoro was a minor at the time of the messages and should not even be in the same channel as this conversation, let alone same screenshot.



Talking about posting on OnlyFans behind the scenes of a stream to someone who was 17 years old at most. I can't even elaborate on this, like this should be painfully obvious by now that TOO MANY MINORS were able to see things like this, and even were directly interacted with about sexual content/acts.

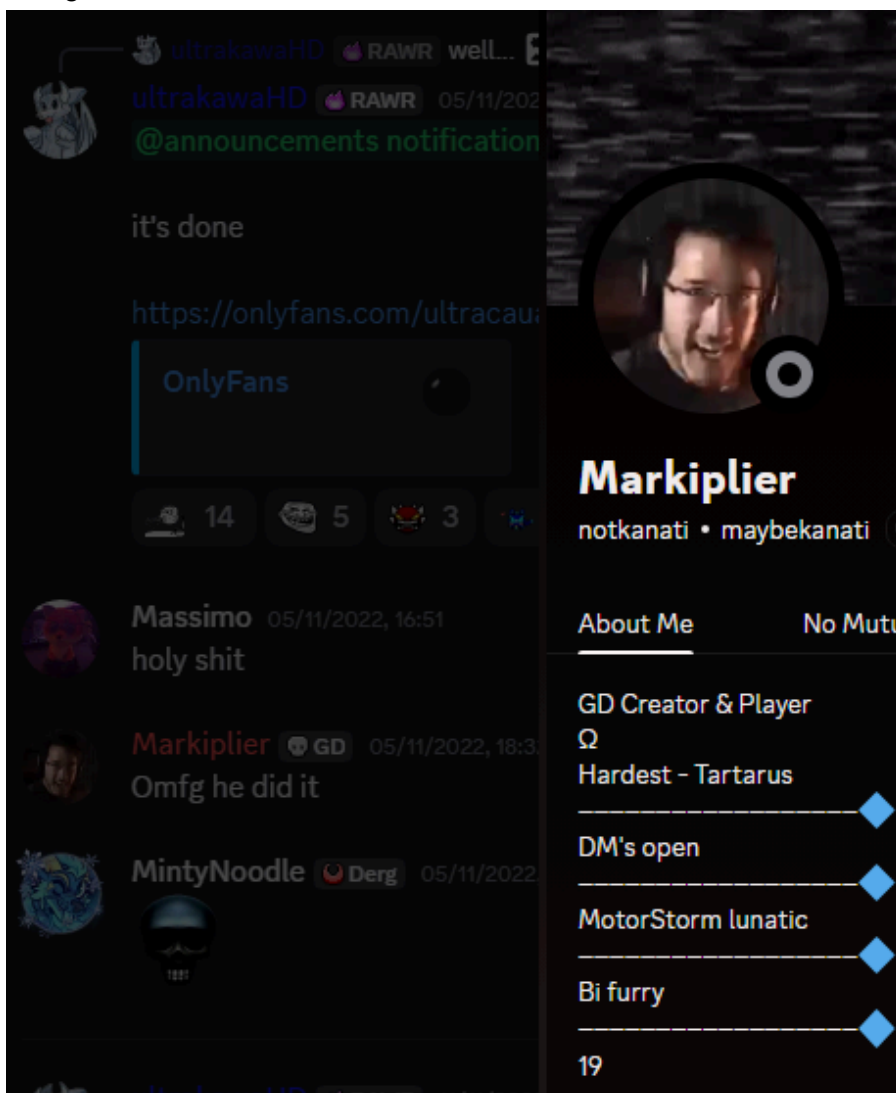
Again, Ultrakawa is talking about sexual topics with M98X, this time talking about penis size?? M98X then later says they are 17 where Ultrakawa is seen a few messages later not even referencing it. Also, this entire conversation was in the general channel, NOT the NSFW channel.



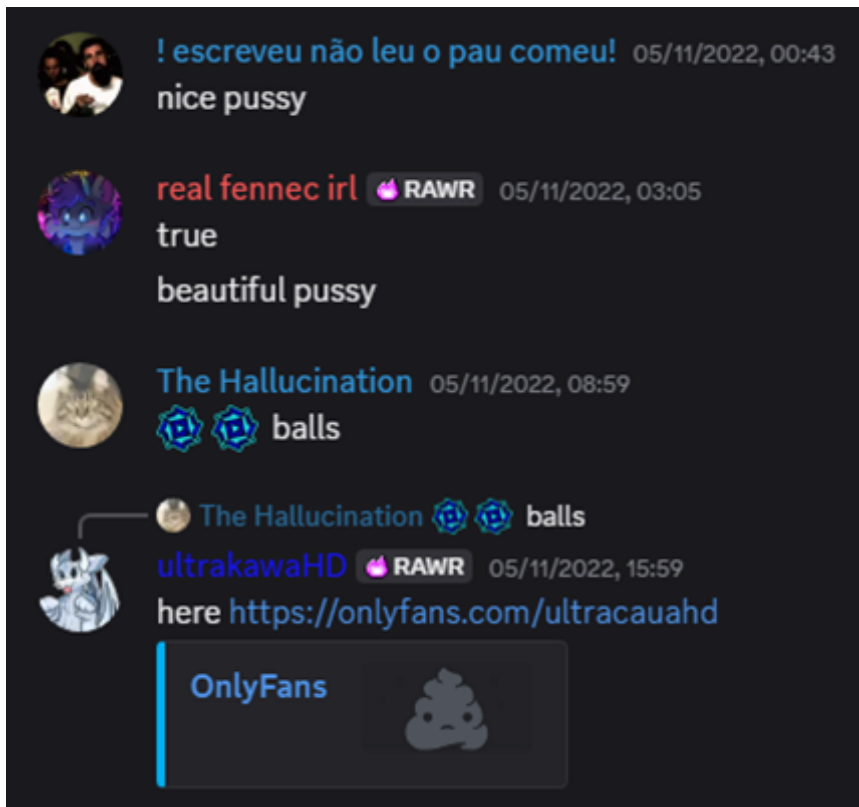
OnlyFans obviously exposed to minors via cursed, who was a minor at the time. This displays that being in the Geometry Dash community and using it to her advantage directly exposed more children to Ultrakawa's OnlyFans.



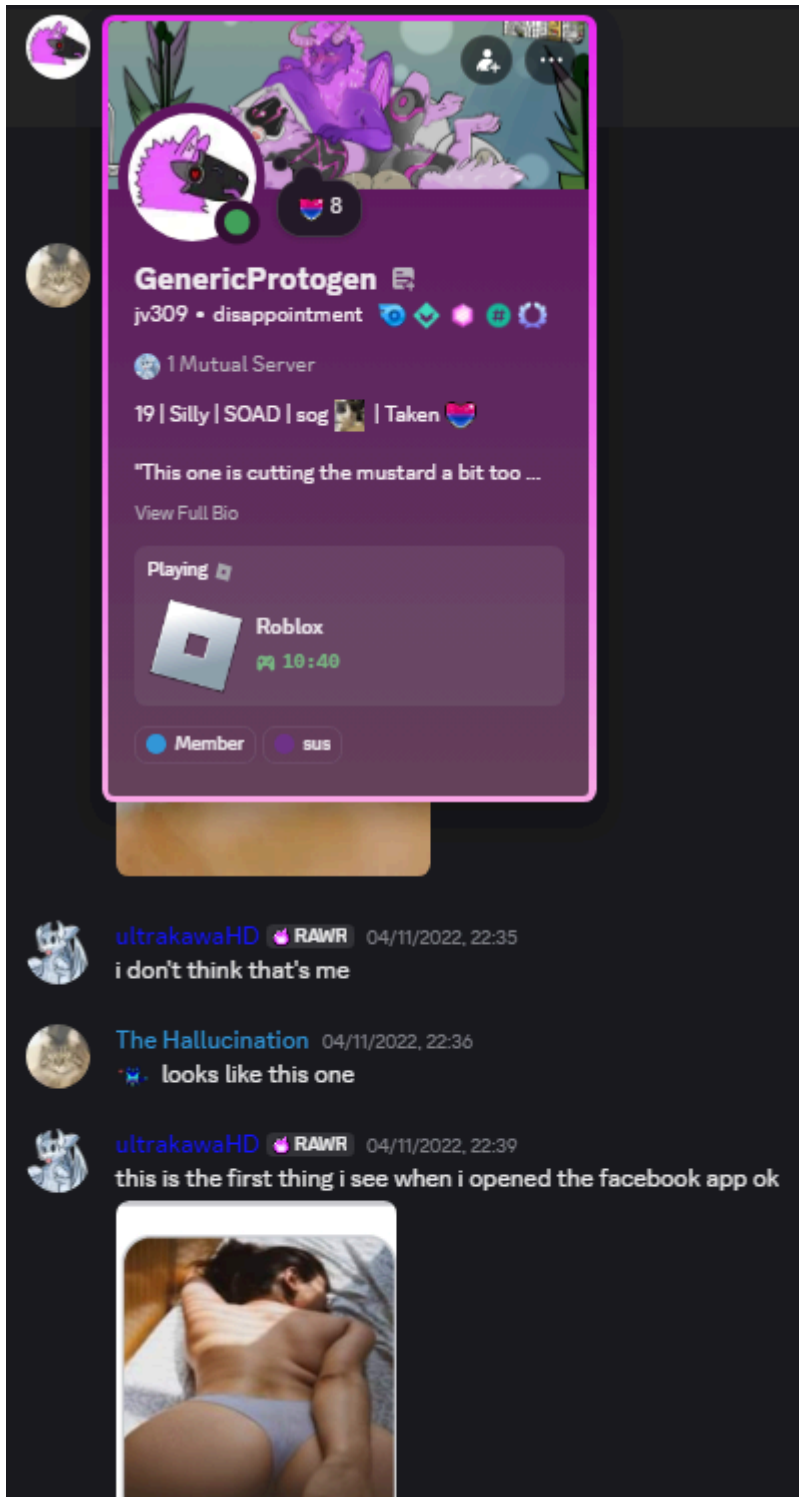
Here is notkanati, an individual who was maximum 17 at the time, who by "he did it" (Ultra went by he/him at this time) implied that they were already in the know about the OnlyFans and anticipating it. No minor should be anticipating somebody's OnlyFans without that person stepping in and stopping the behaviour, or at least trying to prevent this person from seeing it.



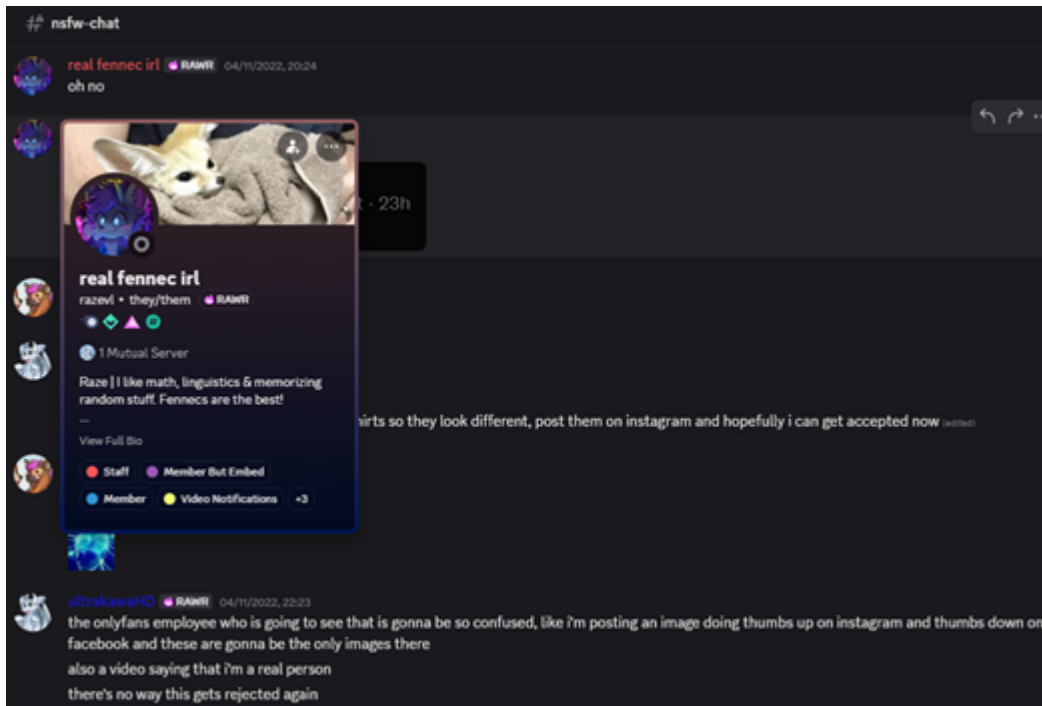
Ultrakawa straight up sending an OnlyFans link just 2 messages after a minor had messaged in the general chat. (razelgas/real fennec irl was a minor at the time)



This individual was also maximum 17 at the time, this one is much worse, no 18+ anything just straight ass. This all happened in NSFW chat where there were children present (again).



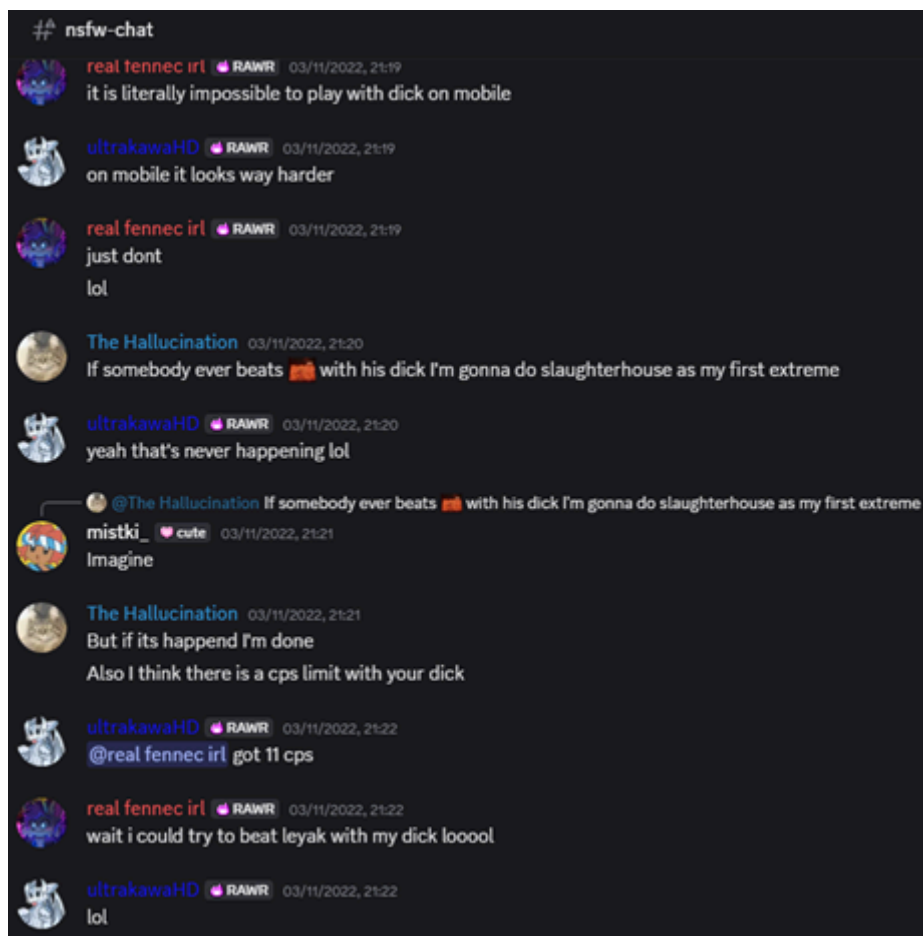
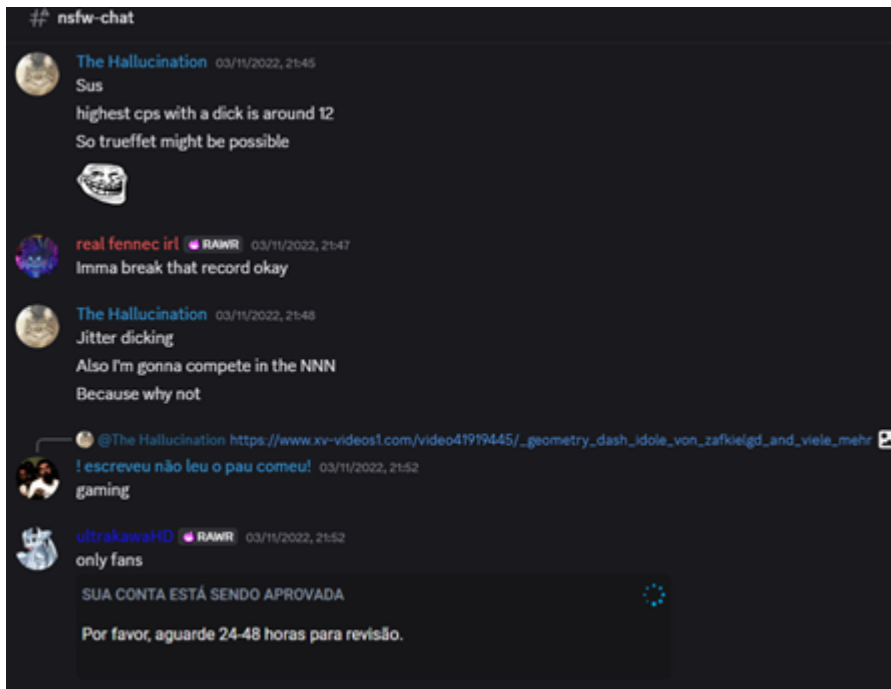
Raze is razelgas on twitter, aka real fennec irl. They are proven under 18 at the time, yet Ultrakawa is again talking to them about her OnlyFans, and allowed them into the NSFW chat.

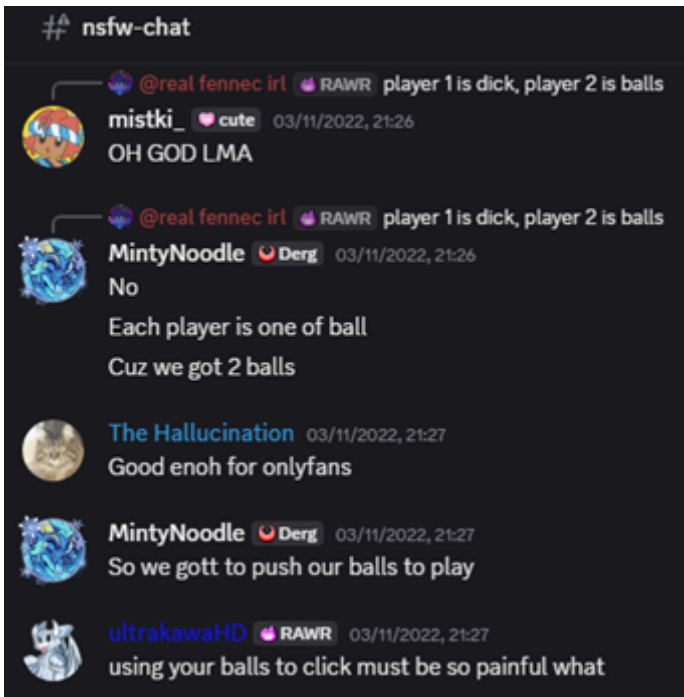


Horizon was 16 at the time and ultra did nothing to discourage them from this.

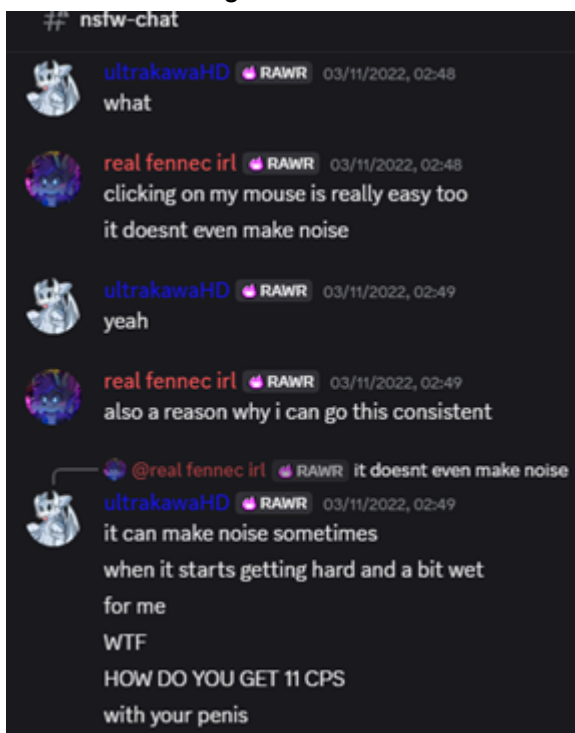


Razel, again in NSFW chat as a minor, where Ultrakawa engages in a conversation with them about cps with their penis.

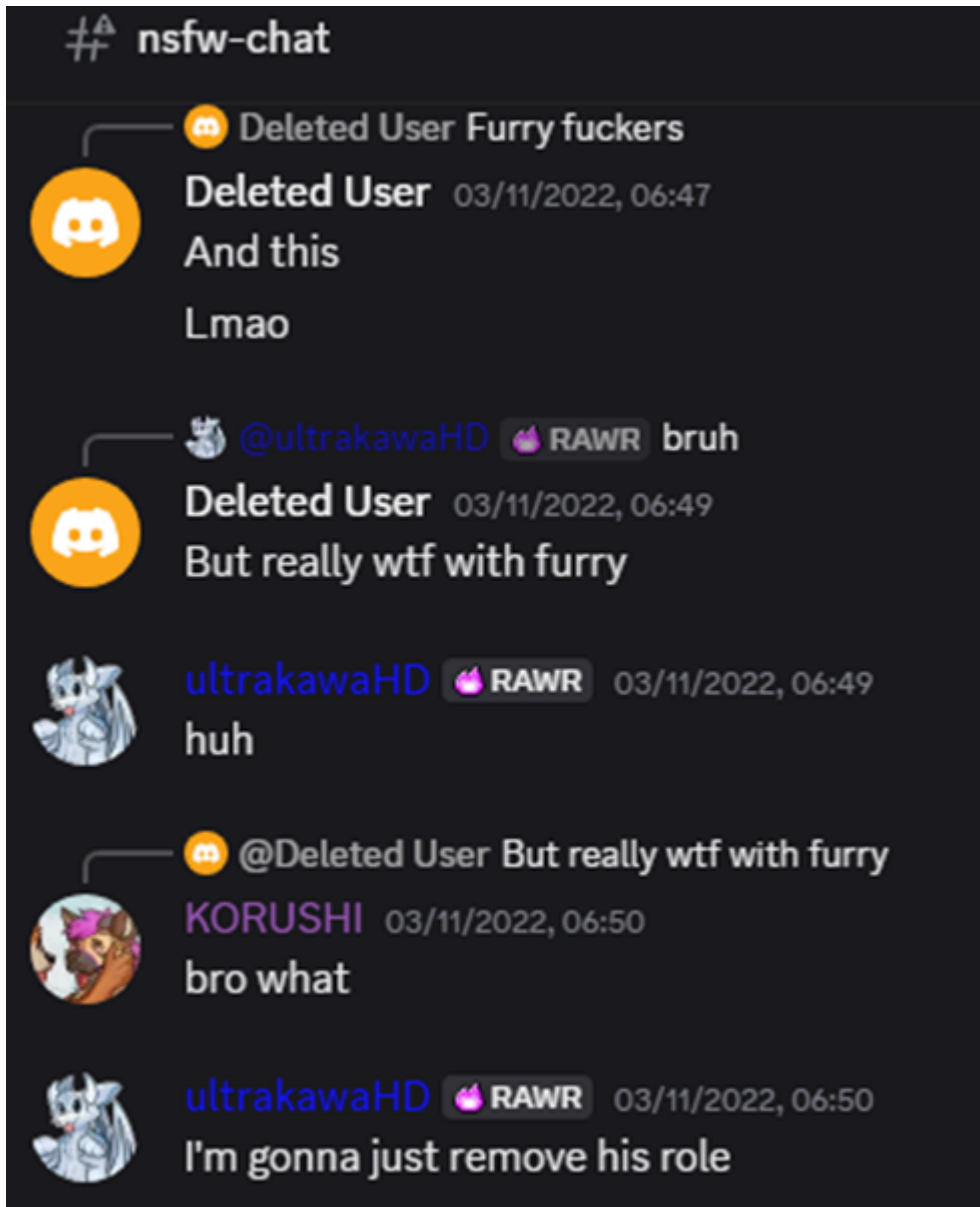




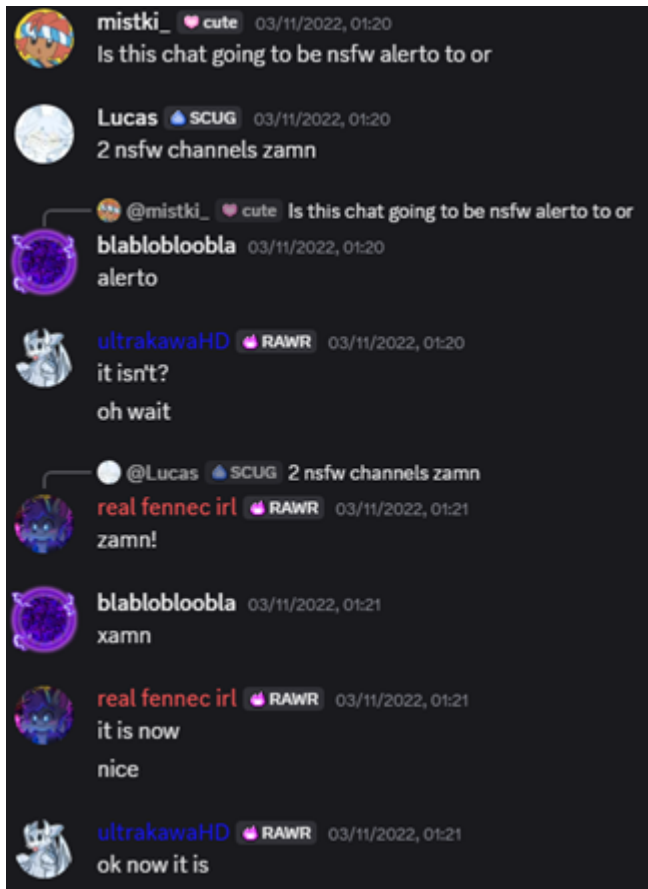
This is easily one of the most disgusting things I've ever personally seen be said to a minor, where Ultrakawa states that "it can make noise sometimes when it gets hard and a bit wet." Absolutely foul behaviour, and is arguably way too explicit for even most adults to be comfortable talking about, let alone Ultrakawa conversing with a child about it.



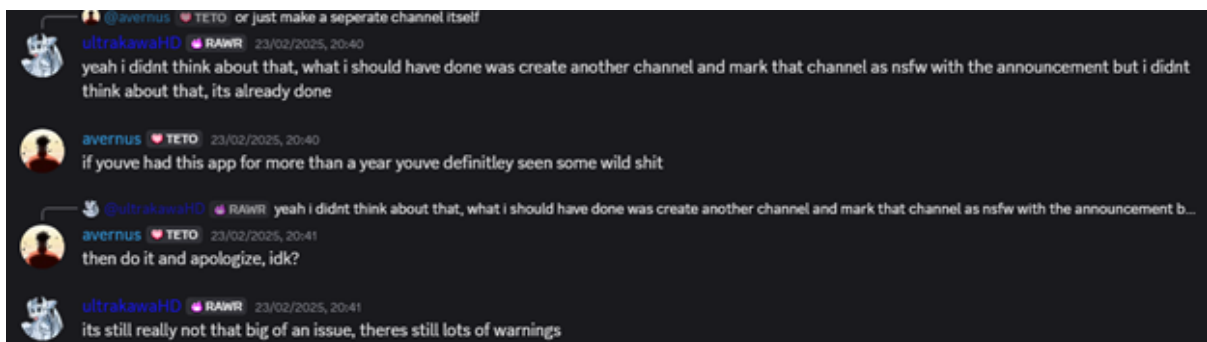
This is proof that the NSFW chat was only visitable with a role given by Ultrakawa. Nobody can argue that the child happened to stumble into that chat, given that Ultrakawa must have personally admitted them. Ultrakawa let a child into this NSFW chat without taking the proper precautions to verify people's ages.



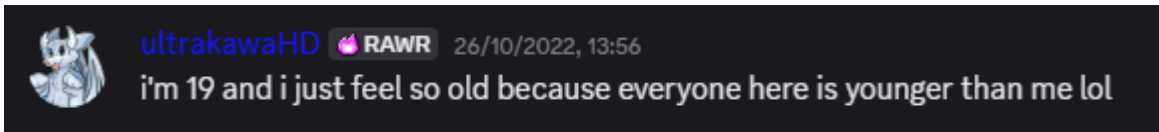
Proof that anything from before this didnt actually have an NSFW warning to enter the channel, meaning children could have just stumbled into the NSFW chat without even knowing what NSFW means.



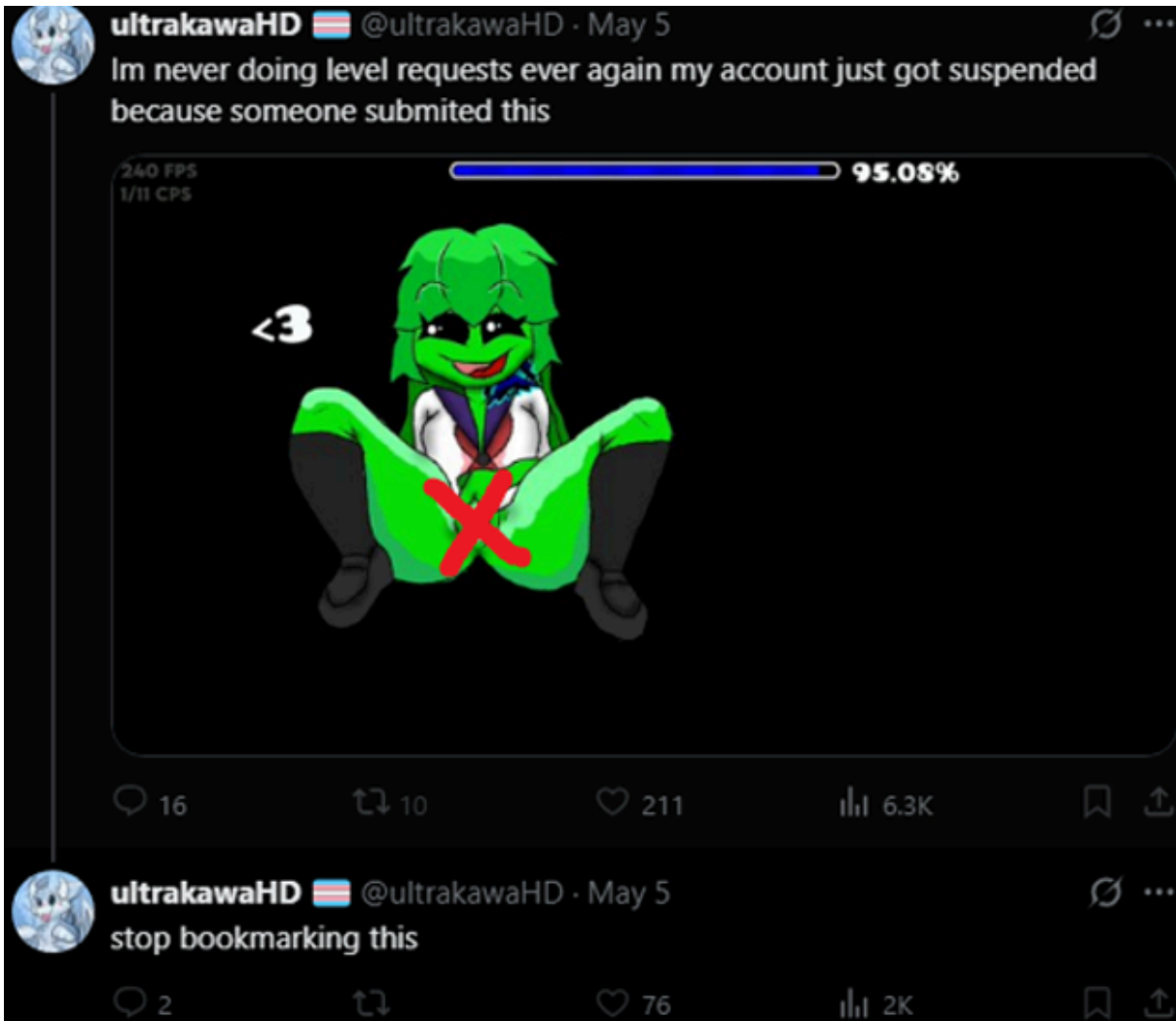
Ultrakawa claims that this is "still not really that big of an issue" while a minor is literally in the chat at the time (real fennec irl)



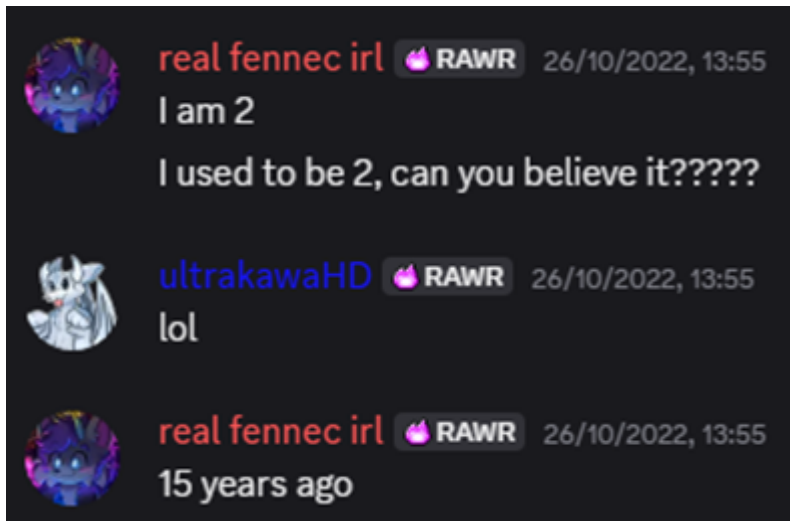
Ultrakawa is completely aware of having a younger audience.



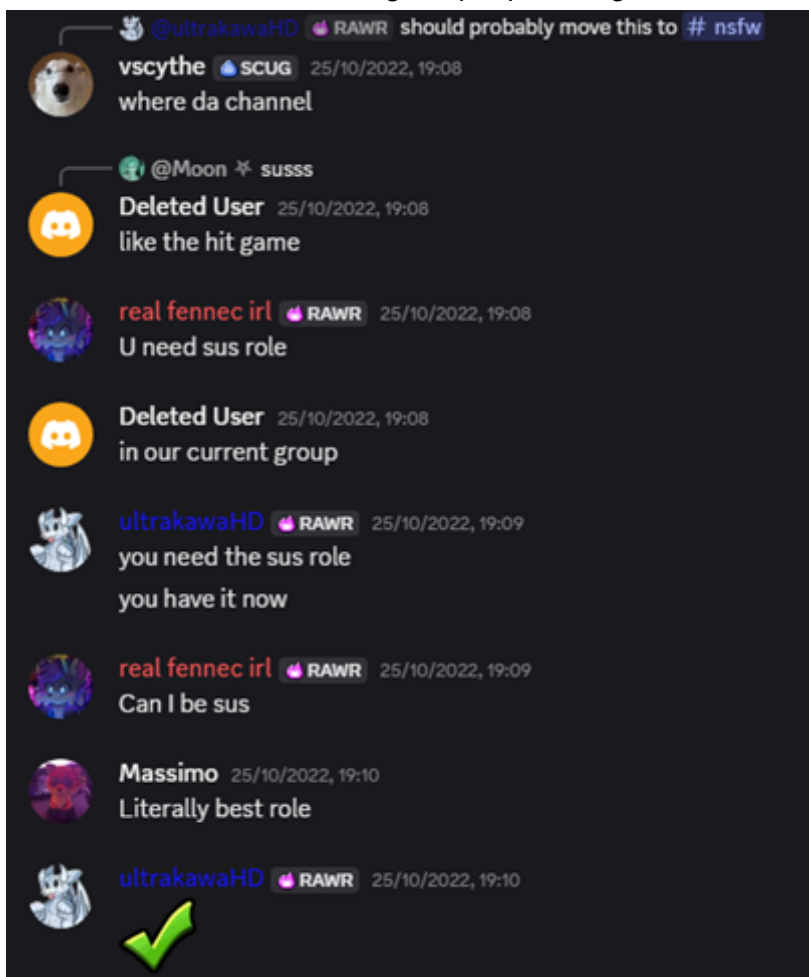

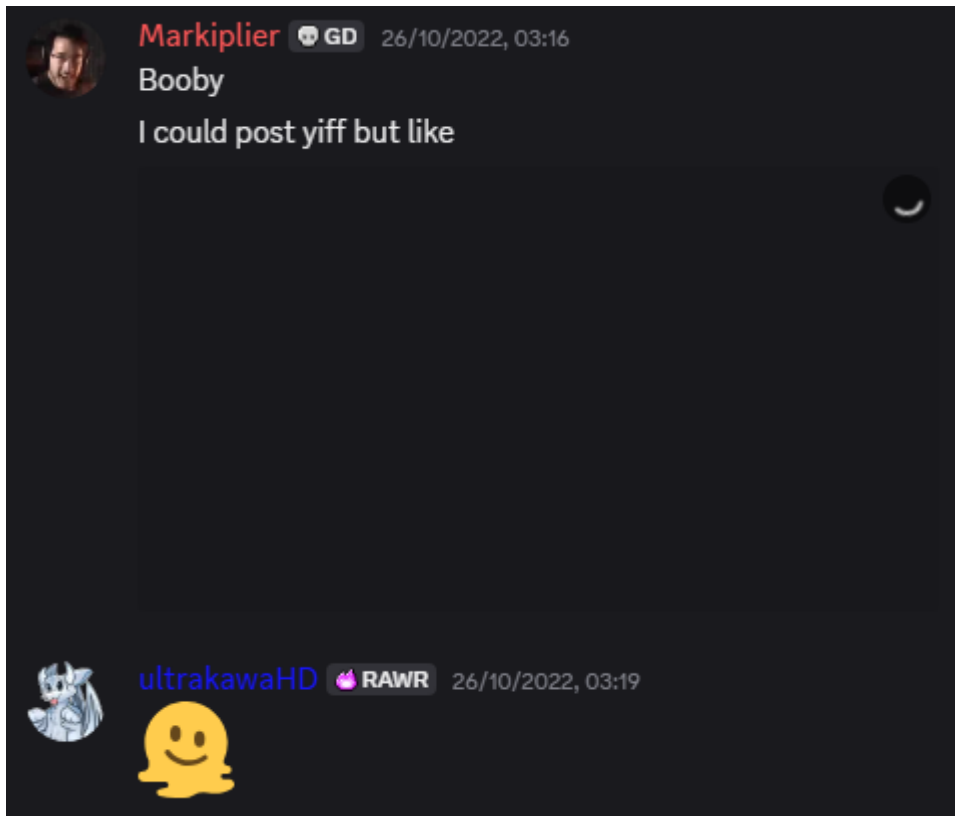

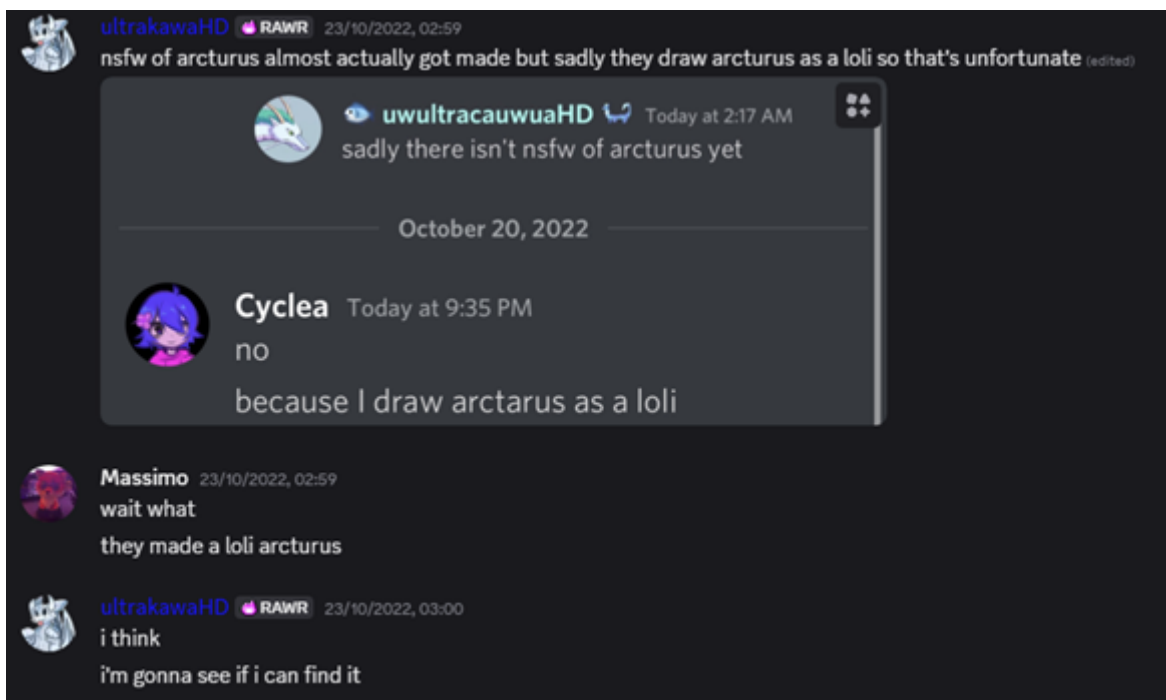
Proof kawa didn't check the age of people she gave the NSFW access role to (sus role).

M98X makes another appearance! Ultrakawa comments on the boobs of an AI image directly to a minor.



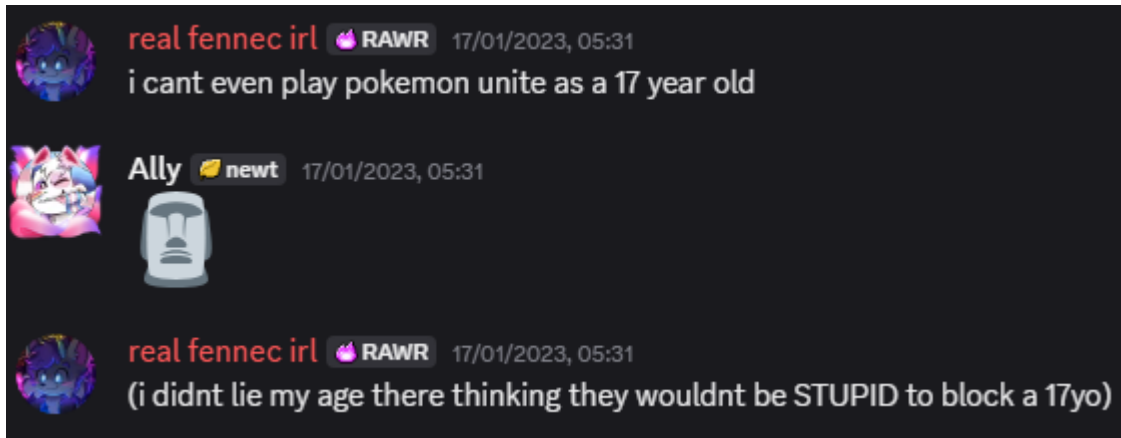
There is also excessive AI hentai in Ultrakawa's server, again featuring M98X. Here is just one example of its publicity.



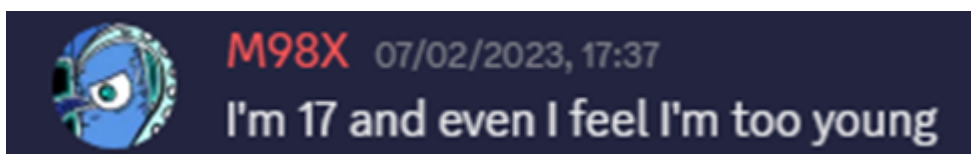
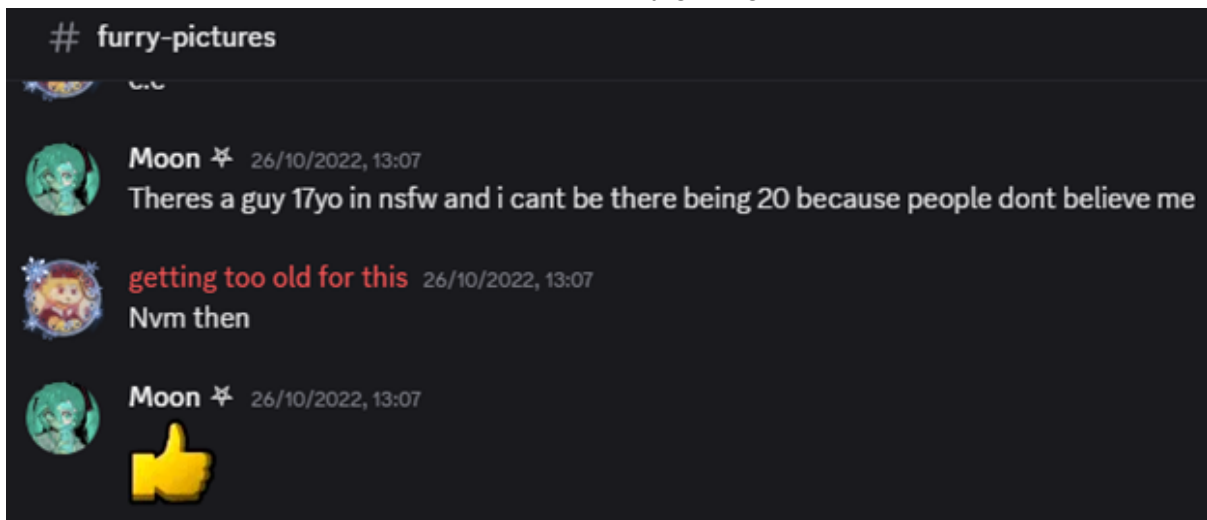

This just depends on when their birthday is (I could not find this information so don't take this as 100% solid evidence for speaking to minors).



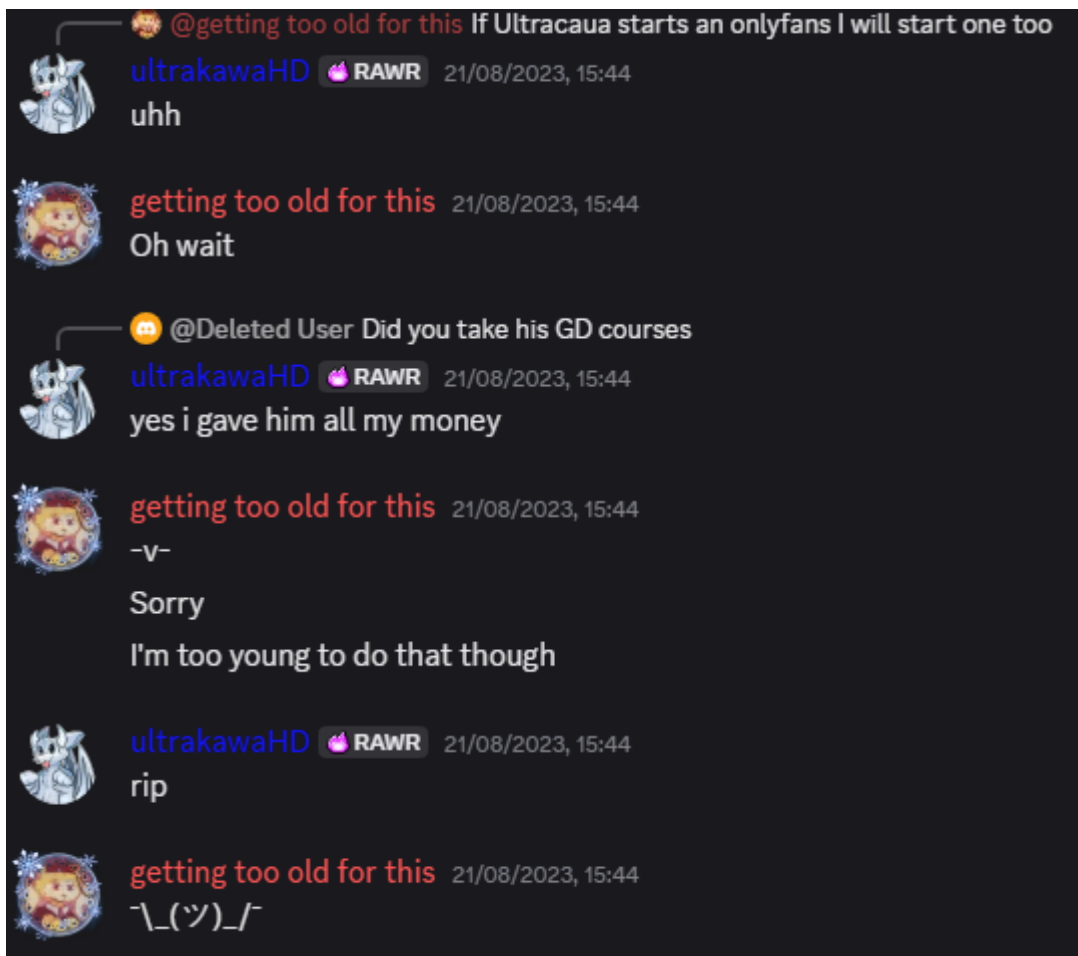
Further proof of real fennec irl being 17 despite Ultrakawa engaging in multiple sexual conversations with them.



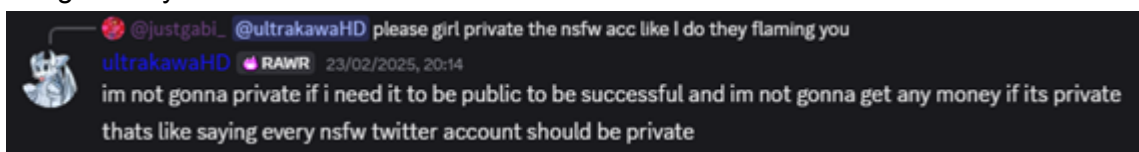
More evidence of minors in nsfw chat. This is really getting out of hand.

Ultrakawa saying that privatizing the porn (making it largely inaccessible to minors) would prevent her from making as much money, clearly outlining her intentions as greed instead of being morally sound.



Warning after warning and Ultrakawa still produces porn that is in the reaches of minors, and even minors which Ultrakawa knew were minors, and still vincibly presented pornography to them. We don't like it, so we made this document.
