### What happened

This complaint details a systemic failure by Reddit, Inc to comply with federal consumer protection laws. For over 11 hours, Reddit has hosted unredacted judicial documents, including the handwriting of a New York State Judge and the hand signatures of private citizens: https://www.reddit.com/r/youtubedrama/comments/1q8rfq1/infamous\_scammers\_lillee\_jean\_and\_laur\_trueman/. This data is being utilized by a known international stalking syndicate to facilitate Aggravated Identity Theft and Search Engine Poisoning, causing irreparable harm to the victim's consumer reputation and physical safety. Violation of the Fair Credit Reporting Act (FCRA) (15 U.S.C. § 1681) Platform: Reddit (r/youtubedrama); The thread authored by "RedRidingHood89" publishes detailed financial data, including OTDA loan records, dentist lawsuit specifics, and tax debt allegations. FTC Nexus: Reddit is functioning as a "de facto" credit reporting agency by allowing the dissemination of private financial "reports" used to deny the victim housing and employment. This is a willful breach of consumer privacy protections. 11 Hours Ago (Reddit): The thread r/youtubedrama/comments/1q8rfq1/ is published. It contains the handwriting of a Judge and the hand signature of the victim's mother. Transcribed Intelligence: User Leif\_Henderson transcribes the Judge's orders into searchable text. This allows botnets (Tencent/HostPapa) to scrape the text and link it to explicit search results. Search Poisoning: Simultaneously, explicit keyword stuffing (Lillee Jean XXX) is triggered on Bing and Google. This is a "Technical Squeeze" intended to ensure that any consumer searching the victim's name sees "Eviction" and "Pornography" as the primary results. Monetization: The thread drives traffic to the Cleoreybt (VAT 63.910 - Web search portal) nodes and the Kyle Keane LLC, and Lolcow, Farm - monetized YouTube videos, fulfilling the corporate "Stalking-for-Profit" model. NOTE: The Reddit thread explicitly acknowledges the victim is a "Jane Doe" in court proceedings. By outing her identity and linking it to the Judge's handwriting, Reddit is facilitating Witness Intimidation. The FTC must intervene to prevent platforms from becoming tools for "Doxing-as-a-Service."

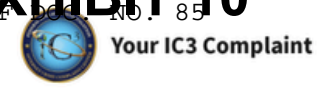

### In your own words, describe the conduct or situation you are complaining about.

This complaint details the failure of a major publicly traded entity (YouTube's parent company) to disclose material risks and liabilities arising from its active or passive complicity in an organized, for-profit criminal harassment campaign. This failure constitutes a potential violation of the Securities Exchange Act of 1934 (Rule 10b-5) by concealing material facts that expose the company to massive, undisclosed financial and regulatory penalties. The company is facilitating and profiting from the campaign, which includes: deepfake nudes, graphic violence, criminal threats, and potential links to the Dark Web. The Material Failures and Undisclosed Investor Risks

#### A. Monetization of Criminal Content and Reputational Harm

YouTube is generating significant revenue from a dedicated, multi-year campaign targeting my identity and likeness. This extends to my entire family. The duration and severity of the content prove that this is not an isolated incident but a systemic failure of moderation and internal controls. Explicit Commercial & Malicious Intent: Perpetrators, as documented, have stated their goal is to "...make money off her [victim] because ultimately, that's what pisses her off the most," thereby confirming the malicious, for-profit nature of the content (tied to a Belgian media firm, CleoreYTB, a Wales firm Curtis Price, connected to a Michigan corporation Kyle Keane LLC. "Primink", to a Maine firm called Turkey Tom by Thomas Hanson, and Caleb Phelps "Oompaville". Violent and Abusive Content Refused Removal: The platform has refused to remove videos that show my face with bruises and tombstones, and depictions of me being shot. This refusal to act on graphic, violent, and non-consensual content exposes the company to extreme public backlash, regulatory fines, and civil liability. Complicity & Siding with Criminals: Despite being notified, the platform is ignoring all legitimate legal claims (copyrights, criminal years long harassment) and has actively sided with criminals currently under NYPD and FBI investigation. Their X account has tweeted to them publicly, endorsing stolen IP, and criminal harassment, and in videos it can be shown them emailing to the corporations they will "help" them. This choice to protect malicious revenue streams over compliance creates an immediate and severe liability. Breakdown of Internal Controls and Aiding and Abetting Harassment: The company's actions demonstrate a fundamental breakdown of internal controls that goes beyond negligence and borders on complicity: Failure to Protect Privacy and Safety: YouTube has ignored multiple complaints containing my residential address within videos, directly endangering my safety and showing contempt for its own policies. Aiding Criminal Threats on X (Twitter): YouTube, through its corporate presence on X (formerly Twitter), has helped aid the campaign and directed harm against me, which has led directly to death threats and a clear pattern of criminal harassment. NYPD Subpoena and Deepfakes: The NYPD was



forced to subpoena the Discord server of one of the YouTubers the platform publicly championed because deepfake nudes were mentioned on the server. This confirms that the criminal activity is known to law enforcement and directly tied to the content being monetized on the platform. Undisclosed Risk of Dark Web Activity and Data Security Flaws  
The content and users on YouTube are being used to feed criminal activities, posing an unquantified security and compliance risk to the company's integrity: Content and user activity on YouTube are being used to facilitate and advertise illicit activity on the Dark Web. This relationship exposes the company to investigation by federal agencies (including the DOJ) focused on organized crime, money laundering, and illicit trade. Insider Access and Data Scraping: The timing of the harassment campaign coincides with: A known pattern of data scraping linked to TENCENT/ACE/ACEVILLE (entities with advanced data access), raising major security concerns. Confirmed access to my personal online profiles (website, LinkedIn) by YouTube employees both before and during the escalation of the criminal campaign. The company's failure to address this pattern — which includes platform complicity, insider access, and a clear connection to criminal and Dark Web activity — represents a material failure to disclose systemic operational, compliance, and legal risks to its investors.

I request that the SEC initiate an investigation into YouTube's parent company for potential securities violations, specifically concerning the failure to disclose the material liabilities and risks associated with: Revenue Generated from Criminal Activity: Profiting off non-consensual deepfakes, threats, and harassment.

Internal Controls Deficiency: The repeated, documented failure to remove legally federally actionable content and complicity in targeted harassment, which exposes the company to massive regulatory and legal fines.

Undisclosed Security Risks: The nexus between data scraping, employee access, and the use of the platform's users to fuel criminal activity including the Dark Web such as LOLCOWFARM, KIWIFARMS.NET
