On July, 12, 2020 I was working as a uniformed Commissioned Transit Officer (T/O) for Spokane Transit Authority (STA) located at 701 West Riverside Spokane, Washington (STA Plaza).

At approximately 0758, Fixed Route Dispatch informed me of a "fight" in front of Bank of America (BOA). I responded to the area with Security Officer (S/O) Attwood. Upon arrival I observed Subject1 Jennessa Magner (known from previous contacts) standing on a bench in the BOA courtyard yelling something the sounded like "fuck you, fuck you" at Subject 2 Lucas Werner (later self-identified), with the middle finger on both her hands fully extended. The Werner was yelling something but I was unable to make it out due to the volume of Magner. S/O Attwood instructed the two to stop yelling and separate, the Werner complied and backed away from Magner who continued to yell. I asked the Coach operator who had called in to dispatch if they had just been yelling. The Coach operator and four other patrons informed me that it had just been yelling and that Magner had started yelling first. I contact the Werner who informed me that Magner had walked up to him and when he requested that she step back or put on a mask (due to COVID-19) Magner had called him a "retard" and told him to "go fuck myself". I attempted to talk to Magner but she was uncooperative and informed me that she was not on the bench and that she was not yelling. I warned Werner about yelling at the Plaza and returned to the Security Window to complete and exclusion for Magner.

Due to Magner's behavior I issued her a 29 day Plaza only exclusion for violating STA ROC #9) Disturbing others by engaging in loud, raucous, unruly, aggressive, violent, harmful, or harassing behavior (RCW 9.91.025/SMC 10.10.100/ADA). I issued and explained Magner her exclusion as she walked around me and yelled things like "Fuck you." and "I can do whatever I like". I attempted to hand Magner her copy of the exclusion and she bent forward and bit the affidavit of service and ripped a corner of it off and spat it back
