## Violations of the PACT Act by Kiwi Farms users and its administrator, Joshua Moon.

This section is regarding potential violations of 18 U.S. Code § 48, colloquially, the Preventing Animal Cruelty and Torture Act (as amended by Public Law 116-72) by Joshua Conner Moon, the administrator and current owner and custodian of “Kiwi Farms” (kiwifarms.net, kiwifarms.top, kiwifarms.st, kiwifarms.is, kiwifarms.ru, kiwifarms.tw, kiwifarms.hk, kiwifarms.pl, kiwifarmsaaf4t2h7gc3dfc5ojhmqrw2nit3uejrpiagrxeuxiyxycd.onion, et al.) Specifically, Moon is engaged in the distribution of animal crush videos, hereinafter referred to as the “zoosadism content” using means of interstate and foreign commerce via the internet using the aforementioned “Kiwi Farms” website. The zoosadism content was originally uploaded to Kiwi Farms by a user of the site, which implies Section 230 protection, but was later manually downloaded, archived, and copied to the /archive/ directory by administrator Joshua Moon, causing him to become the publisher of the materials and the individual responsible for its wide distribution. Collectively, the zoosadism content consists of sexual abuse and torture of various animals. A brief list and description of the zoosadism content in question can be found below.

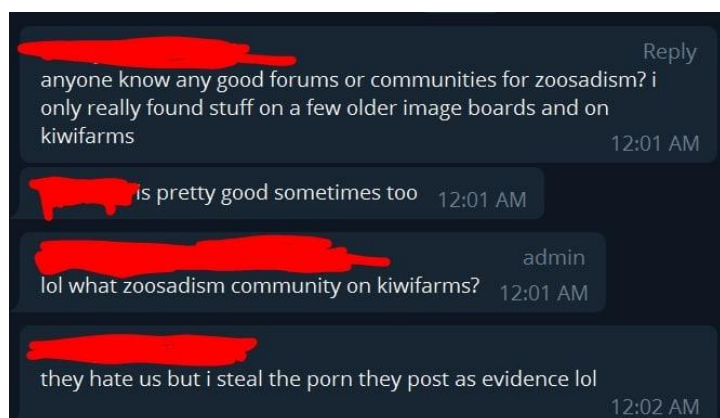

## Use of Kiwi Farms by zoosadists for the purpose of obtaining crush videos

On at least one documented occurrence, a person looking for animal crush videos has directly mentioned Kiwi Farms as a good source of such content.



## Hosting of extremist content, promotion of domestic terrorism by Kiwi Farms

Kiwi Farms and its administrator host extremist content and propaganda which promotes acts of domestic terrorism. Perhaps most infamously, it is known for hosting both the livestream and manifesto of Brenton Tarrant, who is known as the perpetrator of the 2019 Christchurch mosque shootings. Joshua Moon openly flouted a request from the New Zealand Police, who were investigating the matter, and continued to host and archive this content. This is well documented and in the public record.

## Harassment against vulnerable groups

Kiwi Farms and its administration are known for and cited as being involved in the perpetration of harassment, stalking, and violence against vulnerable groups including but not limited to: individuals with mental or physical disabilities, individuals based on their transgender status, human rights activists and journalists. They were refused service by providers in the past, who cited an extreme risk to human life. Members of the site falsely label multiple individuals as pedophiles, zoophiles (animal sexual abusers), and other such titles to encourage harassment against them.

## Request For Intervention

Based on the facts specified in this document, this investigator calls upon law enforcement and regulatory bodies within the United States (both local and federal) to take decisive action against the

site, its administrator and its most abusive members. Additionally, an additional call of action is made to internet service providers, domain registrars, financial institutions, and domain registries who do business with Kiwi Farms or Joshua Connor Moon to sever ties and refuse to provide services to a platform used for violence and hatred. This investigator believes that the substantiated allegations enumerated in this document provide sufficient probable cause to warrant the opening of a criminal investigation against Moon and the activities of his website.

This document is authorized for distribution to: relevant federal and local law enforcement and regulatory agencies within the United States, Internet Service Providers doing business with Kiwi Farms or Joshua Moon, Domain name registrars and/or registries responsible for any known domain named used by Kiwi Farms, international law enforcement agencies as approved by this document's author.
