MOTION FOR CHANGE OF VENUE

COMES NOW the Defendant, Matthew Moulton who moves this Honorable Court to: Change the venue from Volusia county, Florida to Walla Walla county, Wash. based on the following factors:

1. The adverse party has undue influence over local inhabitants representing a locally elected sheriff with pervasive local media presence which he uses for televised, scripted arresting events in which he makes direct accusations in absence of evidence against defendants like myself.
2. The before mentioned media influence was used to directly defame me with presumptions of guilt while insinuating I was mentally disturbed and belonged in a mental hospital for threatening to kill the elected sheriff when no such threat was ever made.
3. My public defender informed me on the 12th of September that if my case were dismissed or if I were acquitted that I'd be stranded in Florida, thousands of miles from home with no ID, no phone, no money, no friends, no family and no means of return.

4. The distance would better alleviate the irrational accusations of the sheriff who fears 'men of God' are trying to kill him with free expression and free exercise of religion.
5. With better imagined protection for the cowardly sheriff I could get a more reasonable bond and could stay at home to take care of my elderly mother as her live-in aid while awaiting trial.
6. This would also remove incarceration costs for Volusia county and free up space at their severely over crowded correctional facility.
7. The e-mail was physically typed in Washington and only existed electronically in Florida. To clarify, electrons are not physical, but a form of energy capable of influencing physical matter. They have no physical presence, much like the sheriff's accusations which only exist as a result of his own irrational emotional influence.

For these reasons I request a change of venue; to return me home and allow me an impartial trial free from single sided political and media influence.

WHEREFORE, Defendant prays this Honorable Court grant this Motion.

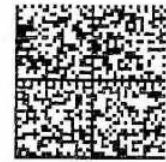
