# Addressing The Dupe Allegations.

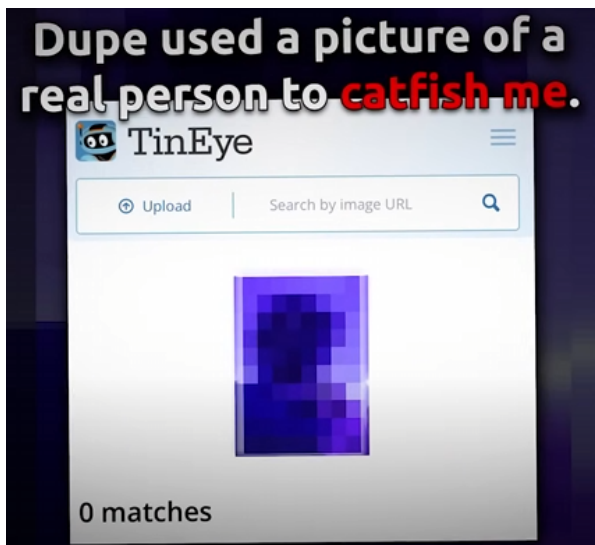
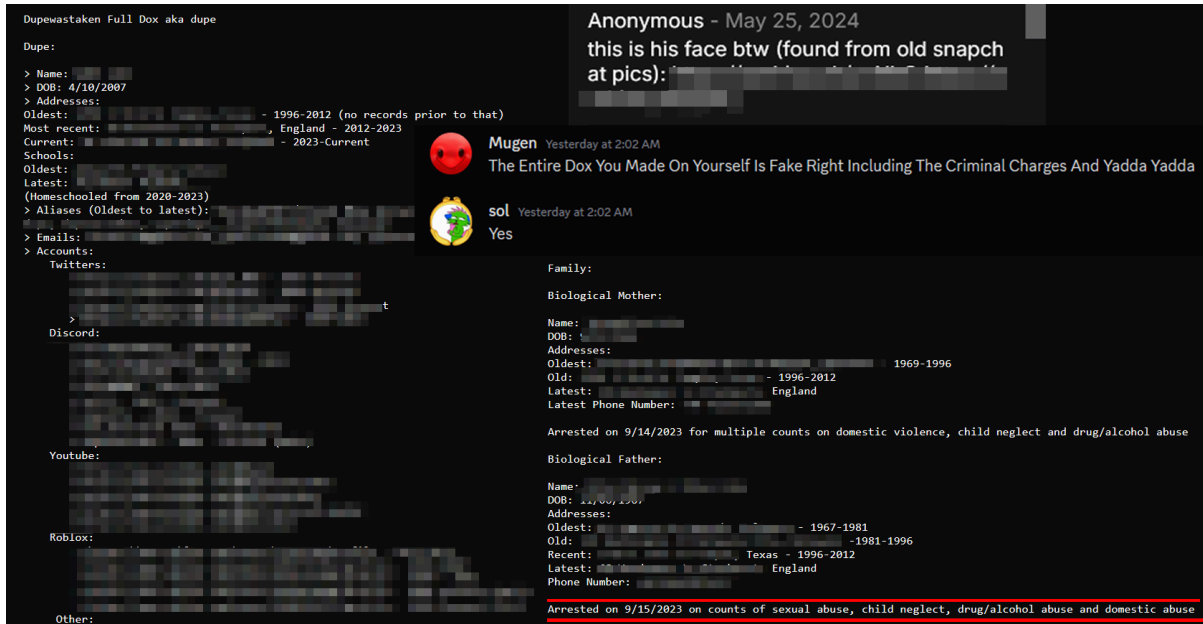


The believed age gap between Dupe and me was **1 year 11 months**.

Dupe created fake doxbins of himself with fake doxxed archive links of his face to push the idea that he was older than he actually was.



The image could not be reverse searched.

The selfie cemented my belief that Dupe was 17 at the time.

Dupe admitted the dox was fake, and joked about it being used to 'fool' me.

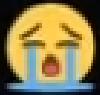

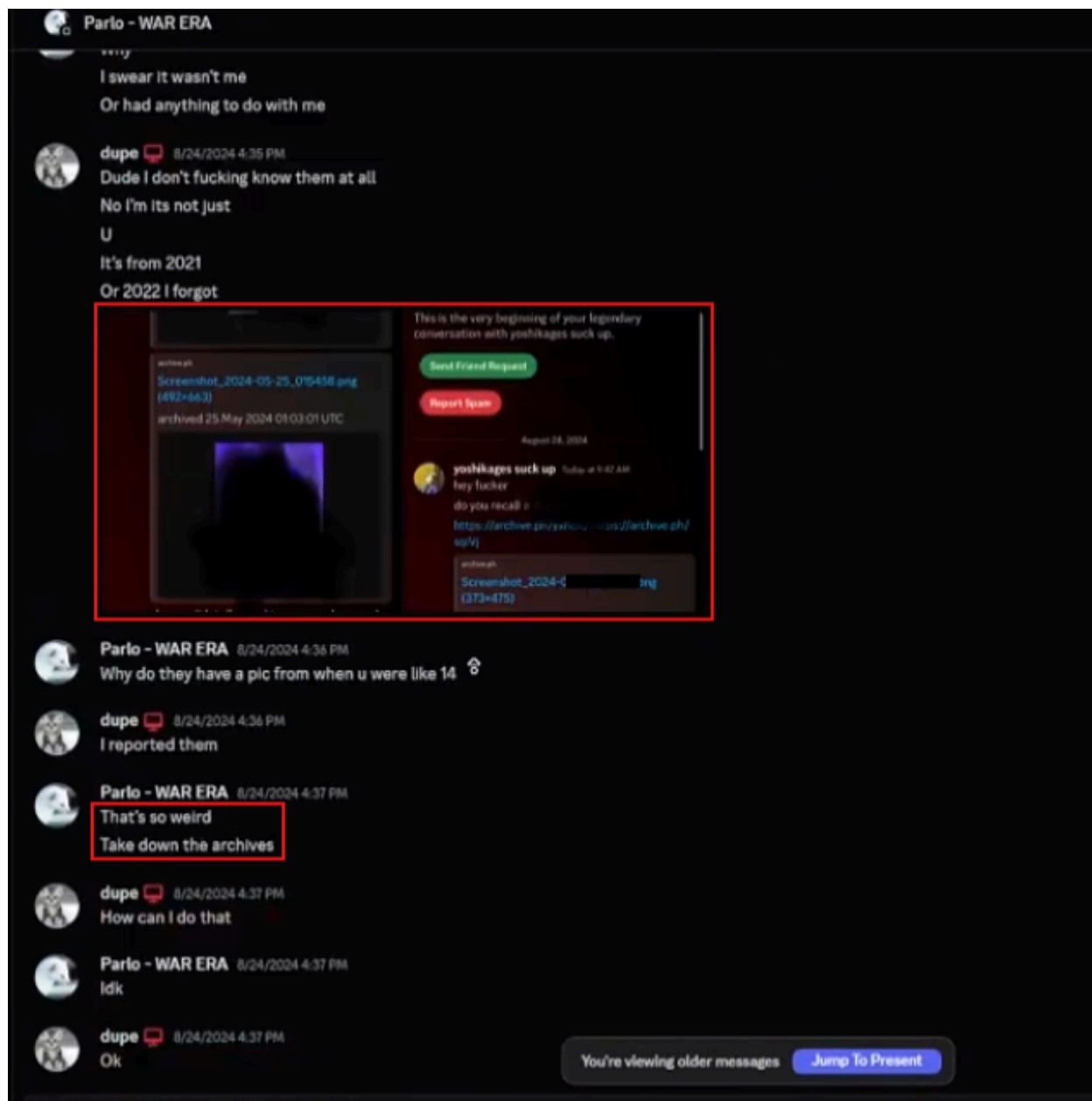

Dupe had pretended as if his real face and images from SnapChat had been leaked [SnapChat images from 2021 / 2022], when I had believed him to have been 14 at that time, 17 in 2024.

The purple selfie image on the left I was under the belief that it was of Dupe recently, and it was posted and brought up to me in **August 2024**, 1 month after we started 'dating'. I was under the belief that I knew what he looked like, cementing the idea that I believed him to be a 17 year old teen, with the same mental capacity as me. This was objectively a form of catfishing.

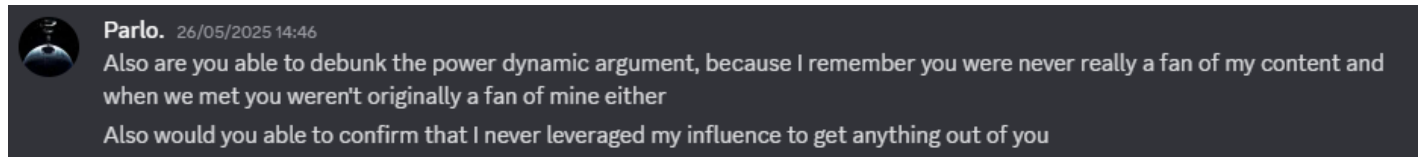
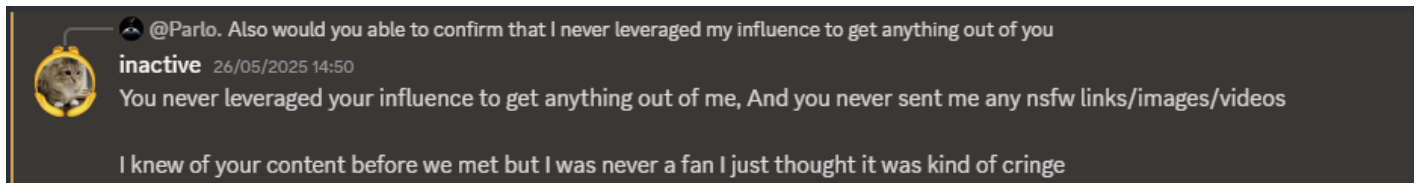
On March 29th 2025, Dupe admitted he lied about his age and was 12 turning 13. He acknowledged how much this would have affected me, and apologised for lying to me. He stated that what he did was 'absolutely reprehensible'.

After Dupe disclosed his age, I deleted all prior sexual messages after being aware of the situation, and **ceased contact**. Only opening it up, to re-engage with Dupe when he maliciously started spreading screenshots against me and in order to access old dms with his account.



On May 25th 2025, Dupe engaged with one of my old accounts, and took accountability for the situation. Affirming the fact that I did not groom or manipulate him under any circumstances. In actuality, he had manipulated me in regards to lying about his age. Dupe **was not coerced** into this statement.

Dupe confirms that I never once leveraged my influence, or power from my platform to solicit him, groom him or abuse him.



He also confirms that I never sent him NSFW content, as I was under the belief he was 17, and it would still possibly derive legal complications if I had sent NSFW content, even with a 17-19 age gap.

Dupe states he knew of my content before, but was never a fan, so the idea that my platform was used to pry Dupe into engaging with me is not true.

Dupe confirms that I never once made him feel uncomfortable and that when I was under the belief that he was 17, I respected his boundaries, never pushed him or coerced him and that I always made sure I had his consent, when I had believed him to be 17. Dupe denies the false pretense that there was emotional manipulation.

Now in February 2024, I had sent self harm to Dupe when I was 18, and he was believed to have been 16 on one occasion. This was **not a form of emotional manipulation** to coax Dupe into doing anything for me or to guilt him, Dupe acknowledges this himself. It was an isolated incident that is inexcusable regardless, and I have apologised for directly to Dupe. I have not replicated such behaviour since. For crucial context, me and Dupe mutually vented about our personal struggles and Dupe had personally stated that I saved him from suicide in late 2023.

In February 2024, I was undergoing a very severe self destructive mental breakdown this was discerned by my shaking, erratic behaviour, and my suicidality at the time in which clouded my judgment and processing skills pathing the way for me to have done and said things at the time which are not excusable. This has all been complicated by many undiagnosed mental illnesses due to CAMHS refusing to have allowed me through a diagnosis process in 2022, again these are not excuses, it is crucial context to the lead up of the situation.

I understand the gravity of the situation and how it would affect an individual who one is close to, and for that exact reason, I took decisive action to ensure that I never replicated such behaviour again and had apologised profusely to Dupe in 2024, I understand even more so how Dupe actually being 12 in this situation exacerbates the severity of the situation. Keep in mind however, the apology I issued can only be accepted by the person who it is directed to. Outside malicious actors have attempted to discredit its legitimacy by using **AI programs** to break down the semantical basis of my apology to make it seem self fulfilling and inherently narcissistic when that is not the truth whatsoever. They attempt to dismantle the apology to try and prove it to be insincere to then use it as a pretense to consistently bring the situation back up for their own personal benefit, without consulting the victim affected whatsoever.

Dupe has made it evident that he wishes to move on from the situation and not have malicious actors attempt to instigate the situation for their own personal benefit.

My behaviour was **gravely impulsive and reckless**, however there were no underlying malicious motives. I have made it perfectly clear that I should be openly criticised for not verifying Dupe's age by asking for a provisional driver's license or some form of personal identification and moving forward I will do my best to ensure that happens. There was no form of emotional manipulation as confirmed by Dupe, and a power dynamic was never in play in reference to influence being exerted to take advantage of him.

Dupe was **not coerced or manipulated into making his statement to me on May 26th 2025**, he stated himself that he wished to make things right with me and answer any of my questions before he deactivated his account and left. There is no evidence whatsoever to prove that he was manipulated into that admission.

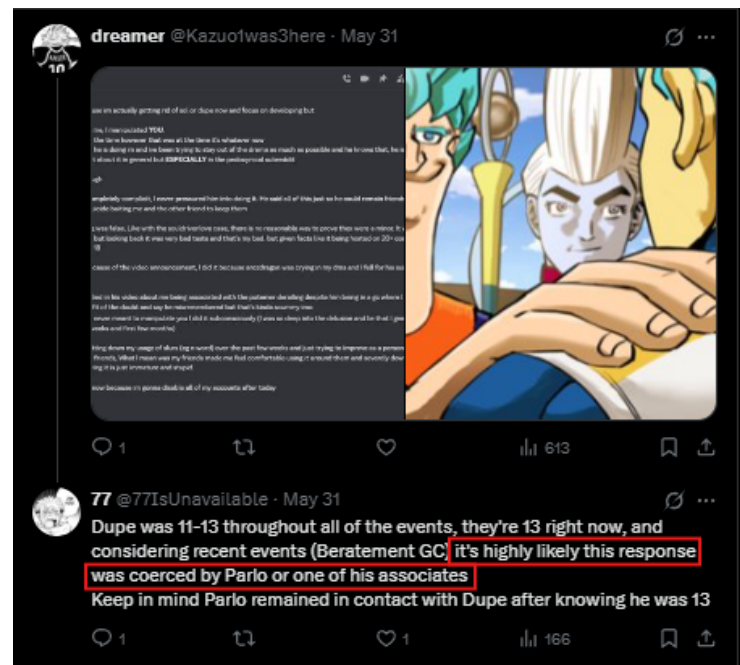
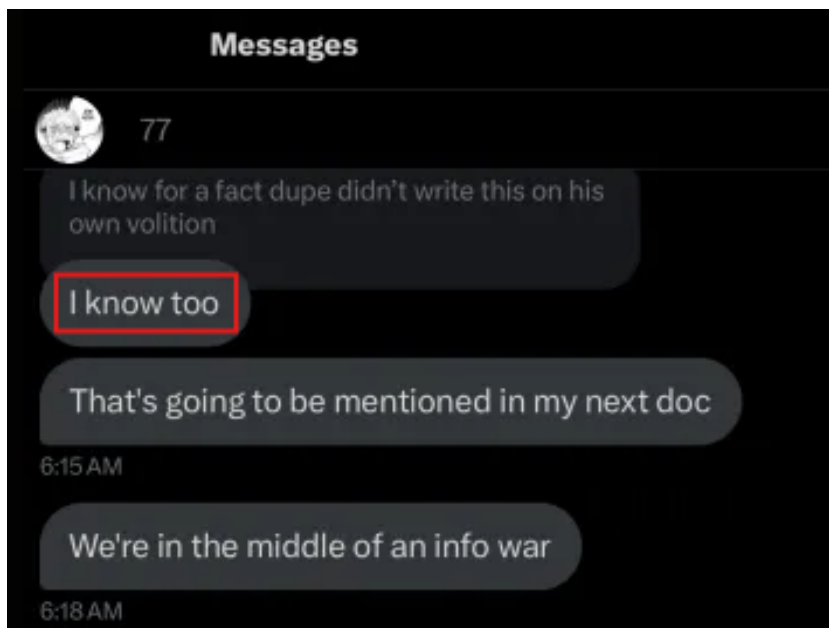
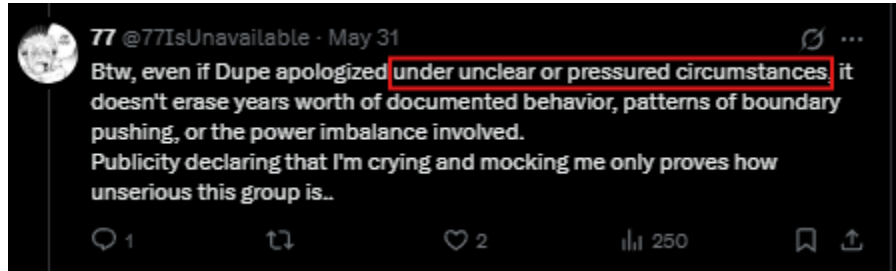

Dupe made it known on 11th May 2025, that he was planning to leave the internet regardless at the end of the month and wanted to make one last statement about me. After Dupe came to terms with how malicious and manipulative 77 was, Dupe was seen making a final statement to me on 26th May on his own volition, clearing up many details and then promptly deactivating his account. This adds significantly more credibility to the fact that Dupe was NOT coerced or manipulated.

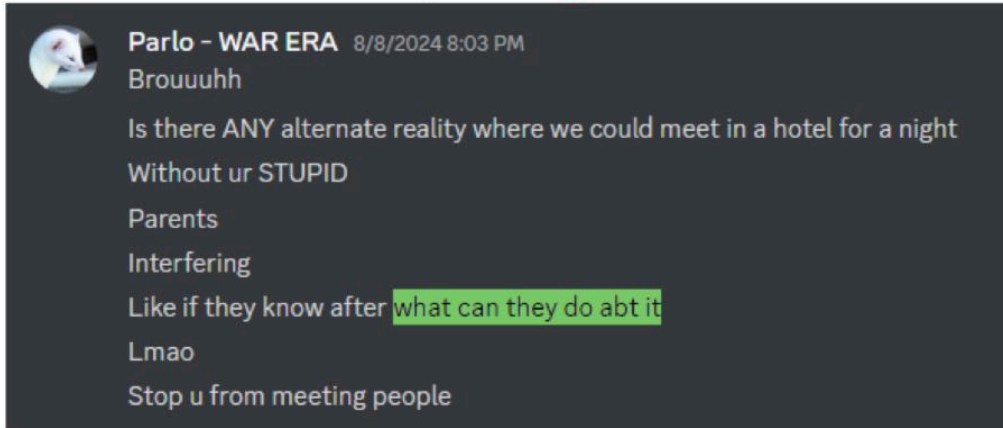

77 is conflating poor judgment with criminal intent. Grooming requires sustained predatory behavior, not a mistake based on lies. 77 attempts to show a non-existent pattern of predatory behavior by conflating debunked and addressed allegations in tandem with the Dupe situation. It is deliberate.

Dating someone under false pretenses they created does not make you a groomer. Grooming requires knowing deception, not being deceived. No examples of isolation, gaslighting or emotional manipulation was present in any circumstances which are hallmarks of grooming.

- **Parental obstruction as an Obstacle, not a boundary:**

Parlo openly complains about Dupes “stupid parents” interfering and blocking their ability to meet. **He even suggests that if parents don’t find out, “what can they do abt it,” treating parental protection as an inconvenience. That is a huge red flag.**



77 is seen showing a screenshot maliciously taken out of context. I had sent this message having been under the impression Dupe was 17, and having been in contact with him for over 1 year.

I stated that it was illogical for Dupe’s parents to be overtly controlling and stop them from meeting people.

Dupe would often talk about how controlling and restrictive they were and I was extremely angry at the idea that they were doing this to Dupe despite him being apparently 17 at the time, less than a year away from adulthood. I believed the idea that his parents weren’t granting Dupe some form of independence to be stupid.

All context however is cropped. And is now shifted to the idea that somehow I knew Dupe was 13, and that I wanted to meet him without his parents knowledge. When this was said when I was under the idea he was 17, while I was 19. This was included to severely hint at non-existent grooming behaviour.

## Reasonable Belief

There has been considerable misinformation spread about the Reasonable Belief Clause that is a perfectly legally valid defense for the Dupe situation.

Many people have been using the retort that if the [“victim”] is below the age of 13, the reasonable belief defense would not apply, this is completely untrue.

This is an example of people who do not understand the UK law, conflating the laws of Sexual Communication with a Minor, with laws in regards to IRL Sexual Abuse of a minor.

It is extremely easy to discern in an IRL relationship that someone under 13 would appear underaged and pre-pubescent. Hence why reasonable belief would not work in a situation pertaining to an IRL situation, it would be implausible for someone to believe someone >13 years is +16.

In situations pertaining to Sexual Communication with a Minor, this takes place online, meaning a lot more factors need to be collectively considered. It is significantly easier for someone to fabricate their persona online, catfish others and lie about their age. Hence why there is no age exemption pertaining to that specific crime.

## What is sexual communication with a child?

The offence of **engaging in communication with a child** under the age of 16 for the purpose of obtaining **sexual** gratification came into force in April 2017 by the introduction of **section 15A of the Sexual Offences Act 2015**.

The offence is committed where:

*"A person aged 18 or over intentionally communicates with a child under 16, who the adult does not reasonably believe to be 16 or over, if the communication is sexual or if it is intended to encourage the child to make a communication which is sexual."*



For example, the law requires the individual to 'reasonably believe' that the victim was **under 16**. If you genuinely did not believe that the person was under this age, you are innocent. However, the whole context of the communication would need to be investigated before this would be a valid point to make.

People have been conflating the charge with the wrong offence. It was not sexual activity, it was sexual communication as it never was in real life, it was chat messages online.

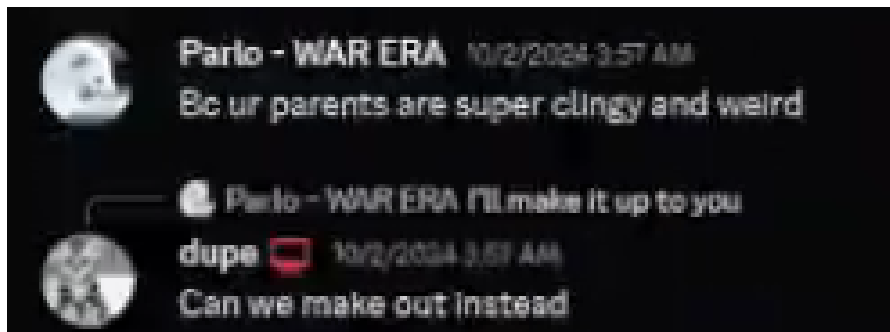
**Sexual activity with a child**

- (1) A person aged 18 or over (A) commits an offence if—
- (a) he intentionally touches another person (B),
  - (b) the touching is sexual, and
  - (c) either—
    - (i) B is under 16 and A does not reasonably believe that B is 16 or over, or
    - (ii) B is under 13.
- (2) A person guilty of an offence under this section, if the touching involved—
- (a) penetration of B's anus or vagina with a part of A's body or anything else,
  - (b) penetration of B's mouth with A's penis,
  - (c) penetration of A's anus or vagina with a part of B's body, or
  - (d) penetration of A's mouth with B's penis,
- is liable, on conviction on indictment, to imprisonment for a term not exceeding 14 years.
- (3) Unless subsection (2) applies, a person guilty of an offence under this section is liable—
- (a) on summary conviction, to imprisonment for a term not exceeding 6 months or to a fine not exceeding the statutory maximum or both;
  - (b) on conviction on indictment, to imprisonment for a term not exceeding 14 years.


**[F1 15A Sexual communication with a child**


- (1) A person aged 18 or over (A) commits an offence if—
- (a) for the purpose of obtaining sexual gratification, A intentionally communicates with another person (B),
  - (b) the communication is sexual or is intended to encourage B to make (whether to A or to another) a communication that is sexual, and
  - (c) B is under 16 and A does not reasonably believe that B is 16 or over.
- (2) For the purposes of this section, a communication is sexual if—
- (a) any part of it relates to sexual activity, or
  - (b) a reasonable person would, in all the circumstances but regardless of any person's purpose, consider any part of the communication to be sexual;
- and in paragraph (a) "sexual activity" means an activity that a reasonable person would, in all the circumstances but regardless of any person's purpose, consider to be sexual.
- (3) A person guilty of an offence under this section is liable—
- (a) on summary conviction, to imprisonment for a term not exceeding [F2 the general limit in a magistrates' court] or a fine or both;
  - (b) on conviction on indictment, to imprisonment for a term not exceeding 2 years.]


When comparing the Reasonable Belief Clauses of Sexual Activity and Sexual Communication, you can clearly see that Sexual Communication does not have a clause stating; "unless B is under 13", this is done because someone online has many more avenues to lie about their age, fabricate their persona and catfish, irregardless of their age.







Now many people attempt to use the false claim that I was doing age-play with Dupe, and that I received sexual satisfaction pretending to be different ages. This is factually untrue, albeit the comments are extremely embarrassing, tone-deaf and unprofessional, they were dark humour jokes made between me and Dupe. For context, we often made jokes about our ages and changed them consistently. I would make comments about being 15, 16, 20, 21, 23, Dupe would make comments about being drastically older [16, 24, 45]. On one occasion I had claimed to be 23, and he had stated 13. **This was not proof of me having known he was 13**, I assumed this to have been yet another example of Dupe joking around and lying about his age. That age held as much credibility and truth as the numerous other examples of Dupe openly lying about his age too, as in actuality at that time, he was 12.

This was the humour we had in DM's with one another. The egregious claim that this was age-play lacks critical evidence, is unsubstantiated and is categorically untrue. The fact this was dark-humour does not underscore the fact that these messages should not have been sent due to how unprofessional they are. And for that I do take accountability.



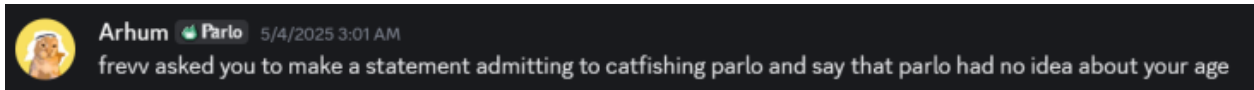
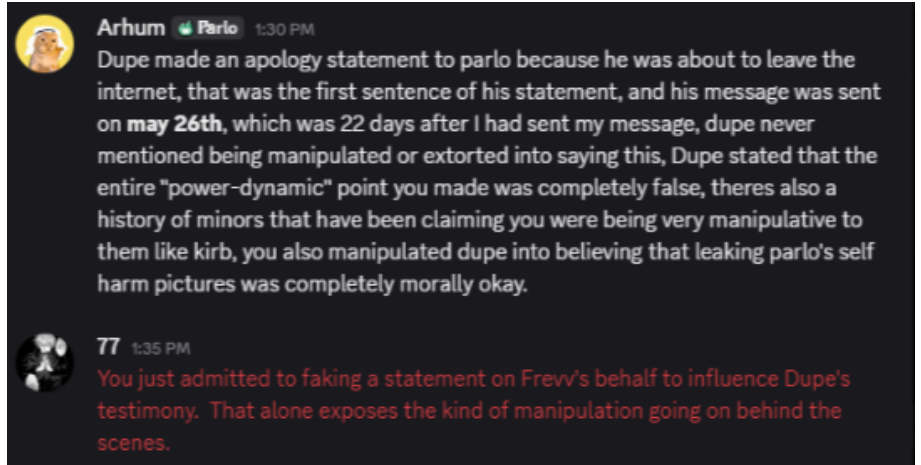
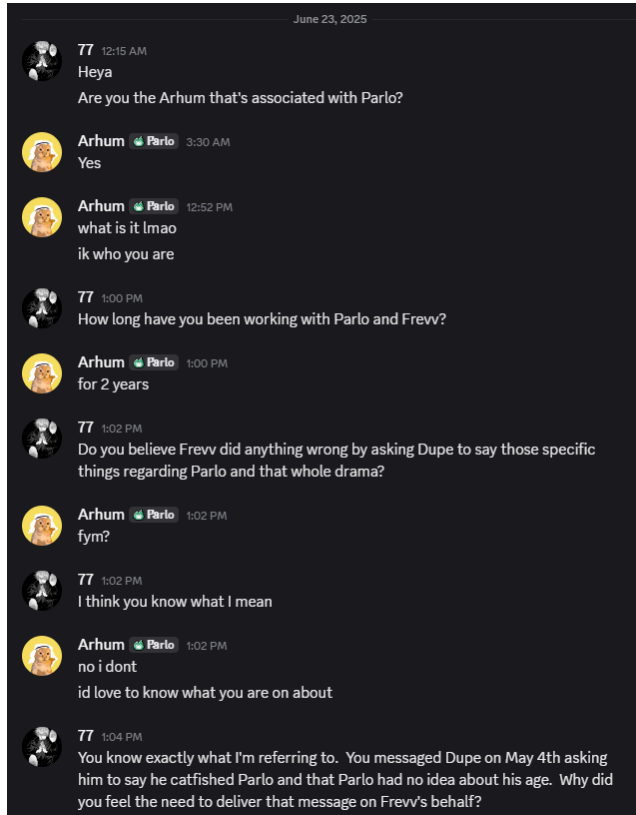

My reply with an image of Ayatollah Khomeini with the caption; 'Am I daddy material', should be another large giveaway.

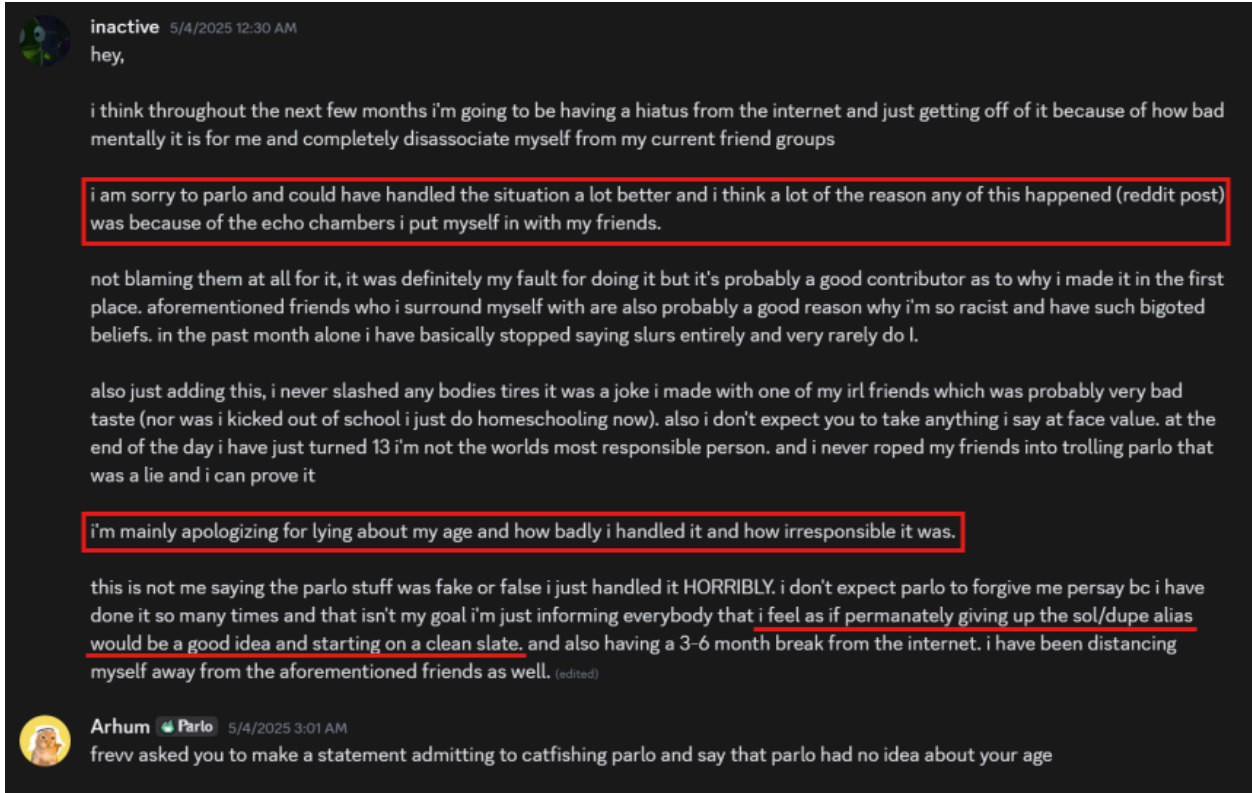

This tweet was made before Arhum was pushed and pressed on information, it shows that 77 had his intent set on trying to push forward a false narrative that Dupe was coaxed and coerced into a false admission.

77 heavily relies on this idea, because Dupe's aforementioned statements he made on his own volition on May 26th 2025, **fundamentally broke down 77's entire false document created by AI programs**. It is therefore in 77's best interests to scramble any disjointed proof as possible to invalidate Dupe's statements because he never cared for the commentary or say of the victims to begin with [case and point- Kirb].



Dupe consulted me on May 26th 2025, many weeks after Arhum's comment to him proving that he remained unchanged and unbothered by what Arhum had stated. The situations were mutually exclusive events. 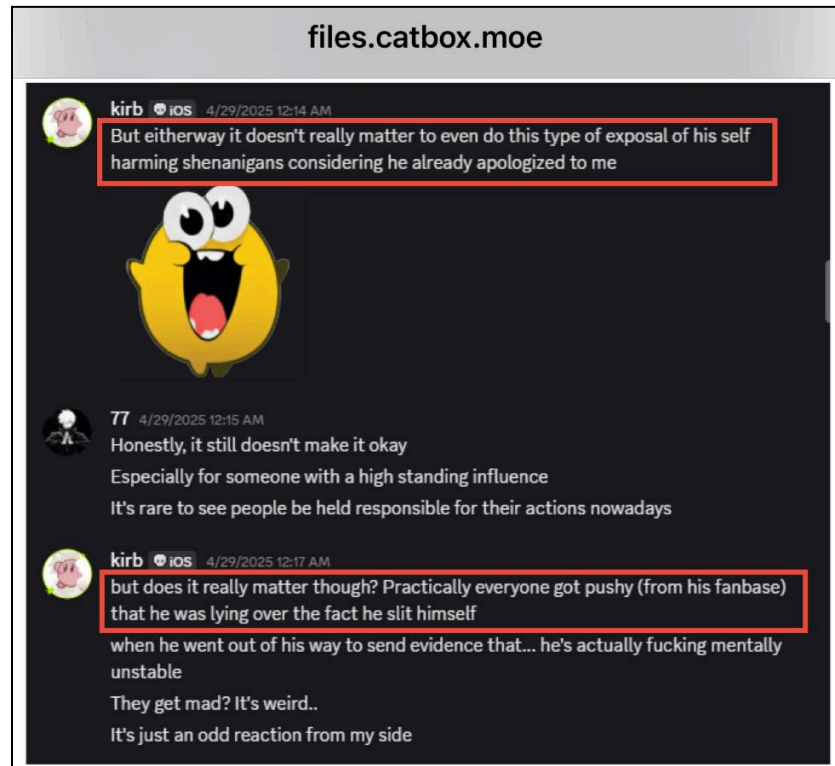
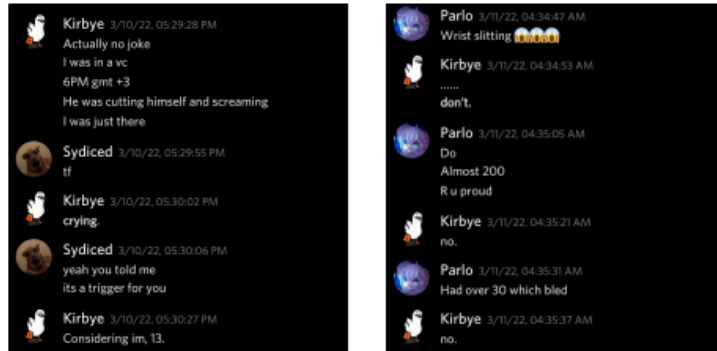
## Parlo's Self Harm Fiasco

Before I get into Parlos DM's with Dupe, we need to address a disturbing (and often overlooked) part of his behavior: His repeated act of sending graphic self harm images to others in his community, including a 13 year old named Kirb, back in 2022.

What you're about to read is not a one time lapse in judgement. It's a disturbing pattern of emotionally volatile and dangerous behavior that has had real world consequences for those involved. While Parlo has attempted to reframe these moments as mental breakdowns or mistakes from a worse time, that does not change the fact that he involved children, people younger, more vulnerable, and legally and developmentally less equipped to handle trauma like this.

This section will primarily focus on the documented case involving Kirb. While Parlo was 16 at the time, Kirb was only 13. That age gap combined with Parlo's influence and emotional instability created a situation like the one you are about to witness.

**This cannot be brushed aside as drama, this is serious and should be treated as such.**



77 highlights the situation to do with Kirb and leaks messages of this minor completely without his content. This was specifically after Kirb has stated that the situation was directly addressed by me numerous times in private beforehand and that I had apologised.

77 attempts to push and pry the minor into revitalising the situation and hypocritically stating that people have not been held responsible for their actions, while he is seen attempting to defend people who committed far more egregious actions by shilling for their apologies [such as HairyTwinkle].

Kirb is seen directly questioning whether it matters regardless, questioning the point of bringing this up when all parties have moved on. Further

highlighting the extremely serious undertones this situation contains as it pertains to my seriously bad and egregious mental state that I was in during 2022 when I was 16. Highlighting how I was pushed into a stage of an emotional mental breakdown due to people casting doubts on my mental state. Again, this is not an excuse, but crucial context.

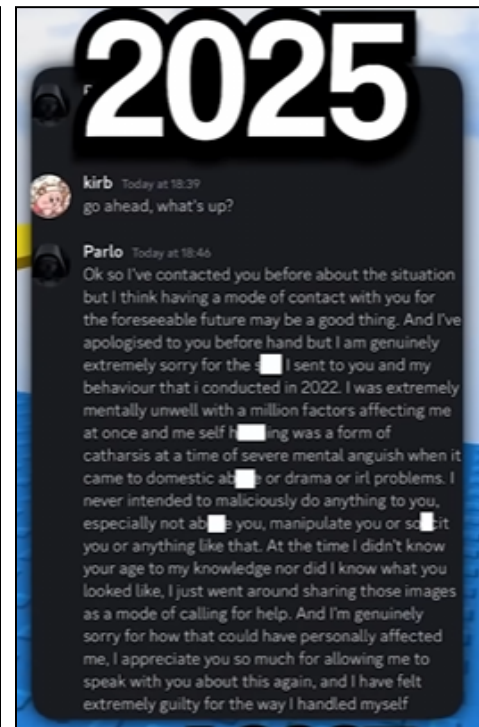
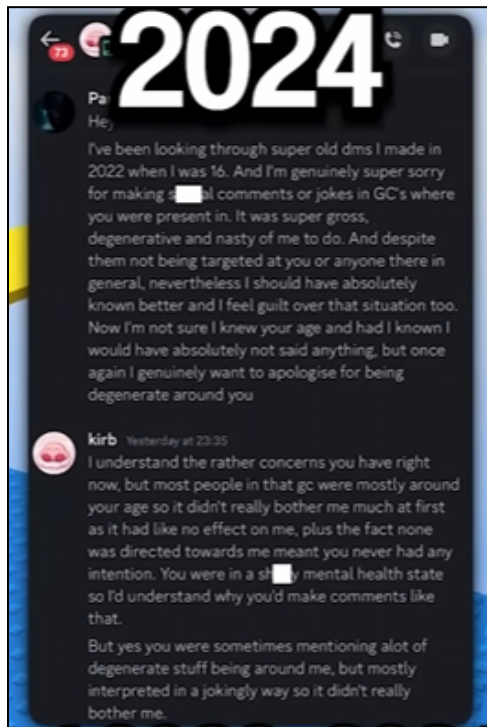
During a suicidal breakdown, the brain's prefrontal cortex (responsible for impulse control and judgment) is severely impaired. What I did, while impulsive and while having adverse ramifications to which I fully took accountability for and addressed, was a distorted cry for help, not a deliberate attempt to harm others such as Kirb.

Many teens lack the tools to articulate suicidal pain in a healthy way and when I was 16, it was no different. For the lead up to the situation, I was consistently doubted and claimed to have been a suicide-baiter, this amalgamated to me trauma dumping on anyone and everyone, not coming to grasp with the ramification of my actions, it was done because I was internally suffering and

wanted people to take my cries for help seriously. I felt isolated and had no way to communicate, and the way I did regardless, was extremely regrettable.

In a mental crisis as I was undergoing, I could not foresee the consequences. A 16-year-old's brain is still developing empathy and risk-assessment skills (especially under extreme distress).

I have ensured that none of these factors act as a defense or shield for what I did, however they explain and paint a larger picture for this situation. I took accountability for the situation towards Kirb and have shown growth and change as a person and that was attested by Kirb himself. The disjointed 2024 Dupe situation may be referenced as a counter by 77, however there was no pattern present or correlation between the 2 distinct situations. I have fully taken accountability and issued apologies to both Dupe and Kirb.

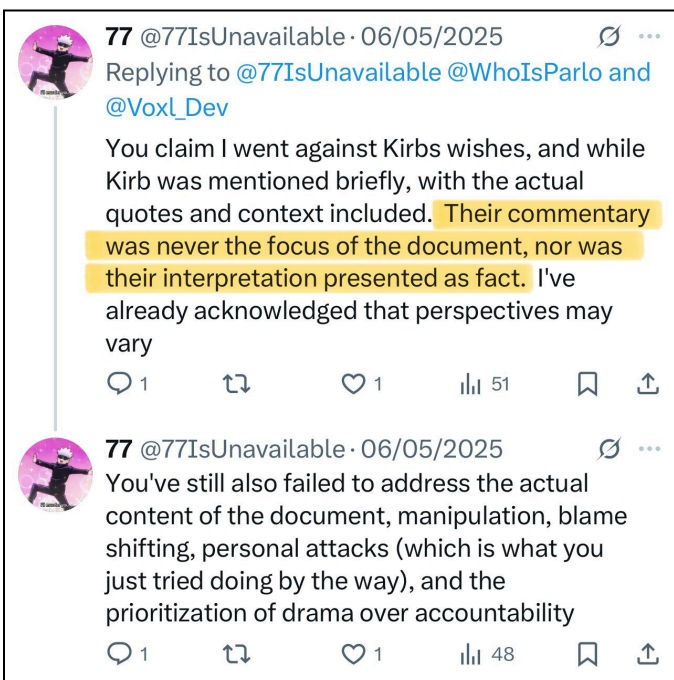


Numerous apology statements I had sent to Kirb spanning throughout 2023, 2024 and 2025. Showing an expressed change in character and me taking accountability for what I did.

77 **leaked** messages of Kirb, (a minor) and **goes against their wishes** to reignite a resolved situation from 3 years ago. 77 uses an extremely serious and possibly triggering situation from 3 years ago and wedges it in his document at the time filled with misinformation when it best suits him to benefit from it. This proves that he categorically does not care about victims and will lie and twist situations to make them seem more malicious when the opportunity best suits him. Kirb was even seen attesting himself that 77 was manipulating the situation, insinuating that self harming was a form of sympathy baiting.



77 was then seen stating that the minor's commentary was **never** the focus of the document, 'nor was their interpretation presented as fact'. Showing a complete disregard for what Kirb had to say entirely. 77 prides himself on caring and fighting for victims, however as soon as they express vitriolic disgust in what he is doing, 77 will throw them under the bus, demean and neutralise their input and opinion to benefit himself.

In this section of the document, he shifts attention away towards a minor named Kirb, and claims that I “reignited a resolved situation from three years ago” and did so against Kirb’s wishes. He then weaponizes Kirb’s frustration as a way to undermine the entire Parlo

Mega Document, presenting it as reckless, vengeful, and inconsiderate for real victims.

**But like many other points in Parlo’s defense, this one falls apart under scrutiny.**

**So here’s what actually happened.**

Kirb is in fact mentioned briefly in the Parlo Mega doc, not to dredge up trauma or use them as a pawn, but to illustrate a *pattern*. The inclusion was relevant because Kirb had been involved in past situations involving Parlo, and it demonstrated how Parlo responded when his behavior was questioned, even years ago.

In fact, the leaked messages between Kirb and Parlo prove something very different than what Parlo claims

Kirb says:



That’s not denial of an event. It’s frustration at it being mentioned again.

But Kirb’s upset alone doesn’t invalidate the point. The document doesn’t misrepresent what happened either. It **shows Parlo’s behavior over time**, especially when being confronted about harm. It isn’t about relitigating the past, **but showing that Parlo’s patterns did not start with Dupe.**

**So.. what is Parlo really trying to do with this section?**

### Parlo’s Real Goal: Emotional Blackmail

More telling is how Parlo frames me(77) as a malicious actor who doesn’t care about victims:

- He minimizes
- He reframes
- He accuses others of being malicious or unstable
- And finally, he claims that any criticism is a personal attack against his character or mental health.

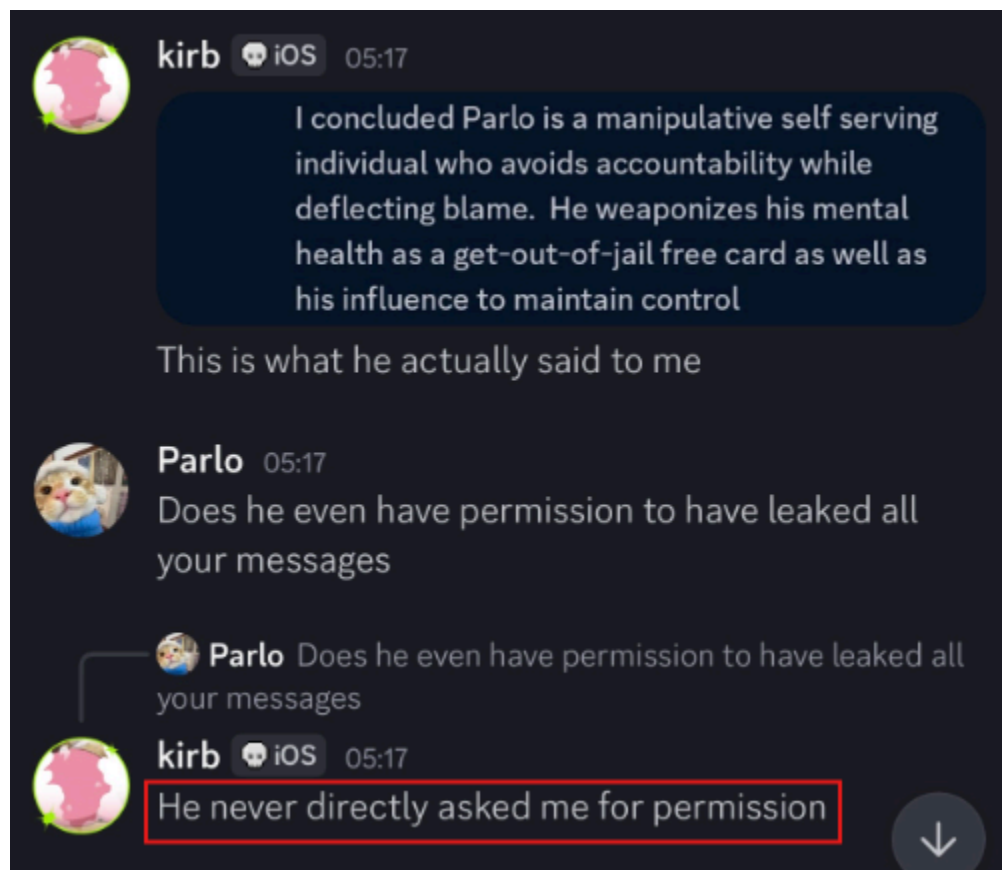
**This is not accountability, but gaslighting.**

In his counter document he completely avoids even addressing the fundamental argument made. He sidesteps criticism and uses blanket terms once again such as “emotional blackmail” in the wrong context to demonise and brush off the justified criticism levied his way to his mistreatment of who he claims to be victims.

There was no emotional blackmail present. He leaked a victim’s words and screenshots completely without their consent, played down and suppressed their problems and completely brushed it off. He never actually cared about victims, he cared about how he could benefit off of them and use them as a point to propel himself into popularity by creating shitty google documents filled with AI generated paragraphs.

All the bullet points he uses are semantical blanket terms. Again, in an immature fashion he wishes to take the bare minimum amount of accountability as possible, and deflect as much as he can. (Extremely Hypocritical)

Kirb's frustration was never weaponized, it reflected a justified criticism he has in regards to the way 77 weaponised suicidality against me, he used wordplay manipulation to create a narrative that the situation was inherently insidious and he continued to press the situation after the minor [Kirb] expressed his discomfort and unwillingness to have this situation become public.

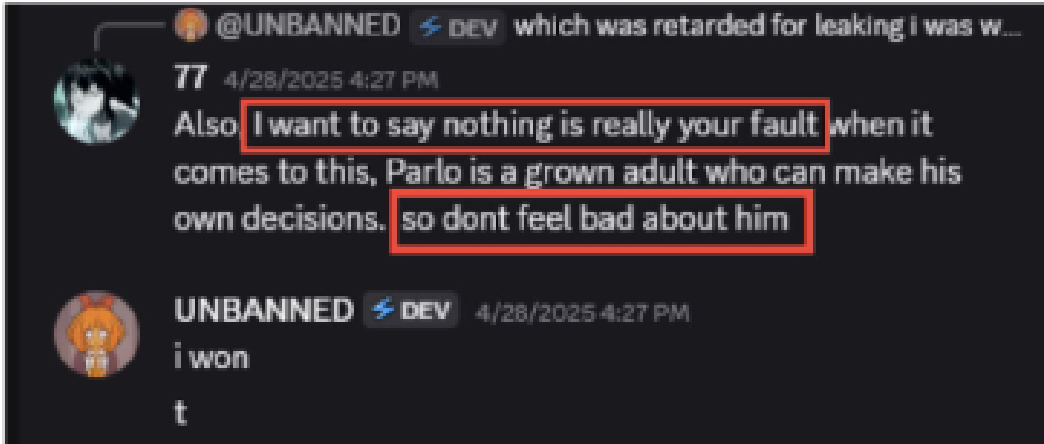

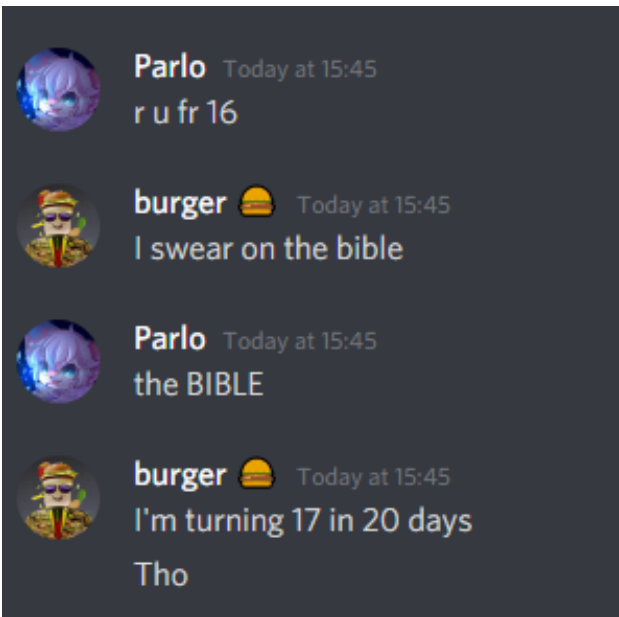
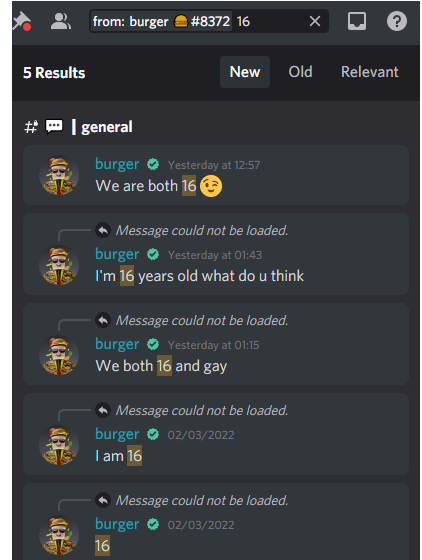
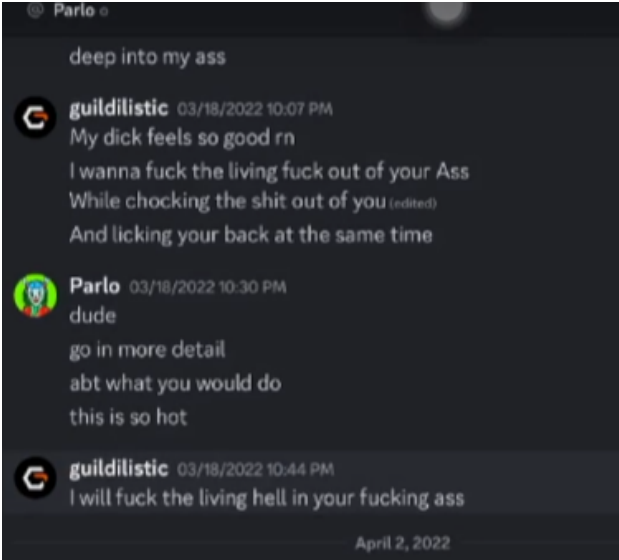


77 conflates 2 different situations together, to give the impression to the viewer that the direct sexual messages I made under the discord account with the Joker PFP was to Shawty who stated their age being 13.

Person 1 is 17 years 0 months 0 days old, while Person 2 is 16 years 10 months 18 days old.

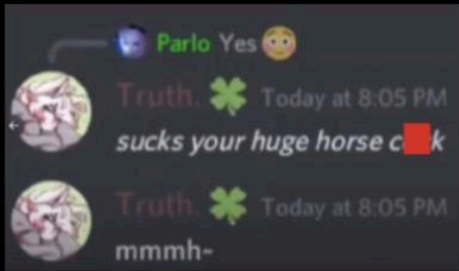
On numerous occasions I had verified Burger's age, he turned 17 in March 2022, and I turned 17 in May 2022.

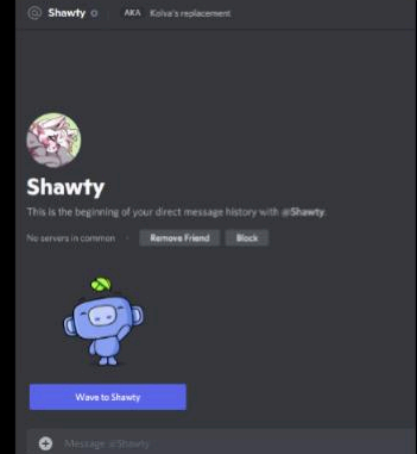
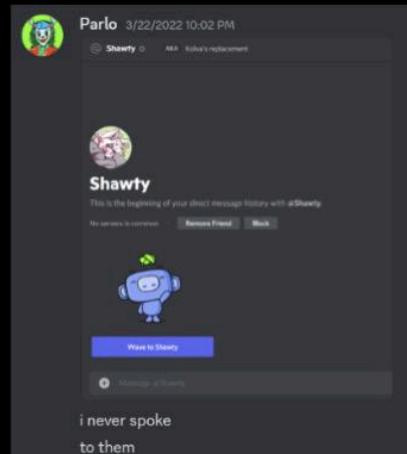
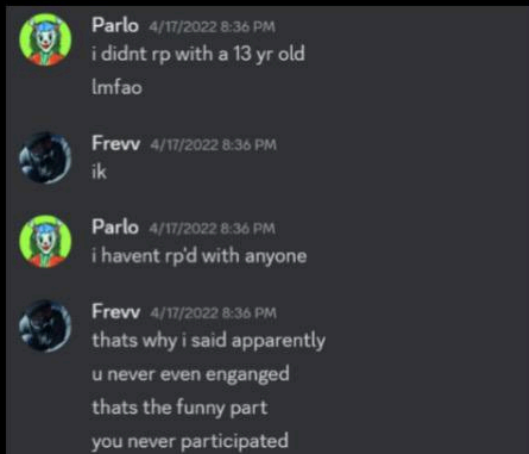


Me agreeing to VC. Which was misinterpreted by Shawty.

It was by miscommunication that Shawty continued to speak s██ly, believing that he had the green light to engage the way he did. Despite Parlo having jokingly said "Yes 🤔", and nothing more. Shawty stated "I take that as a yes", getting a false impression, not confirmed by Parlo at the time. This being proof that Parlo never explicitly stated he wanted Shawty to act the way they did. I never knew the age of Shawty or had any malicious intent in regards to them. I knew literally nothing about them as a person and only had sent 'Yes' in response to the VC proposal. When the conversation got sexual **I shut it down**.


Shawty concedes that they were never groomed, abused, manipulated or taken advantage of, because they literally did not contact Parlo whatsoever exempt from this situation. They also state that the age gap dynamic is not pedophilic either, contrary to the bad actors who lied about the situation.


Parlo did not know the age of Shawty (Truth), and he never knew of them before the situation had taken place. They were a random person who behaved relatively erratically at the start and then divulged to being inappropriate. Parlo never had plans to solicit, engage, meet up, abuse, groom or take advantage of this person. Parlo has no idea who they looked like, or even where they were from.



Now the age gap between me and Shawty seemed to have been **less than 3 years**. I was born on **02/05/2005**, and they stated **they were turning 14 'soon' as of mid March**. Since the age gap was **>3 years**, that would **NOT** be indicative of a pedophilic age gap.

Parlo was 16 in March 2022, and he turned 17 in May.

**Keep in mind Parlo had absolutely no idea how old Truth was at the time**, and their exact birthdate is still unknown. The age gap is believed to have been probably less than 3 years.

The DSM-5 requires that a person must be at least 16 years old, and at least five years older than the prepubescent child or children they are aroused by, for the attraction to be diagnosed as pedophilic disorder. Similarly, the ICD-11 excludes sexual behavior among post-pubertal children who are close in age.

So already this situation cannot be legally distinguished as a pedophilic age gap dynamic or situation. Especially when considering the fact that the age gap was 3 years at most or perhaps even less. However it is dependent on the accuser who levies the proof, that evidence is shown that the person accused knew the age, however still continued and showed sexual malicious intent. Which is simply not present in these two screenshots. 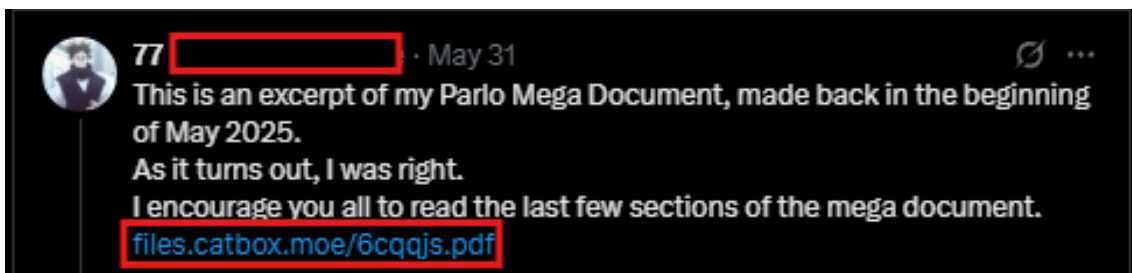

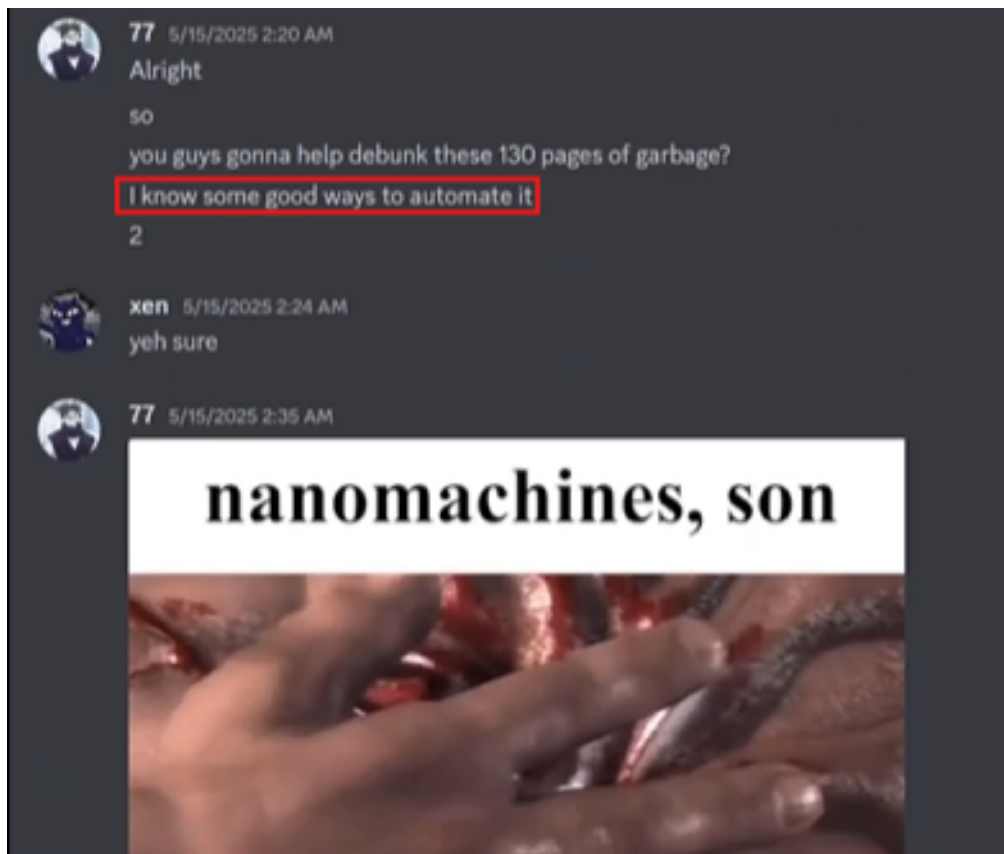
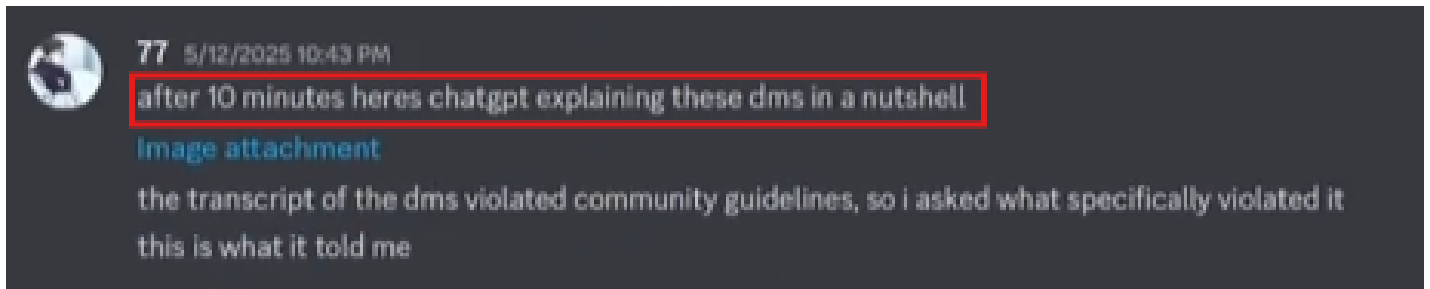

- **DISCUSSIONS OF TRAUMA, GUILT TRIPPING, AND VICTIM BLAMING.**

The creator of this document 77, has engaged in a defamation and harassment campaign against me recently. They have recently released a document **structured by AI**, to desperately attempt to insinuate that I am a groomer without explicitly stating it to avoid backlash.



77 is seen stating that he knows 'ways' to 'automate' a method to debunk a large defense document I had created, heavily of course, alluding to the use of ChatGPT and AI.

77 admits along with his associates that he used AI to create most of the document. This is inherently malicious as you are able to openly feed ChatGPT messages and then proceed to instruct the program or prompt it to decipher the chat exchanges and present my intentions in the worst and most nefarious way possible. 77 isn't actively doing decisive research into the situation, he is using artificial intelligence to manipulate and recontextualise the situation to his personal benefit, so he can make me look in the worst possible light. Then he presents this all as information that he has gathered himself so people congratulate him for work he never even did himself. He is a fraud who got caught out by the same minor he was manipulating - Dupe. Who proceeded to provide me and others with the logs exposing 77's true intent.


### **77 slandering me**

77 and his associates are also seen making comments in private joking about me being a '**pedophile**' and '**sex offender**'. Disrespecting the individuals who they claim to be the victims as they are watering down the severity of the allegations and trivialising it as jokes while also proving themselves to be incapable of handling these types of situations by not taking the situation seriously.

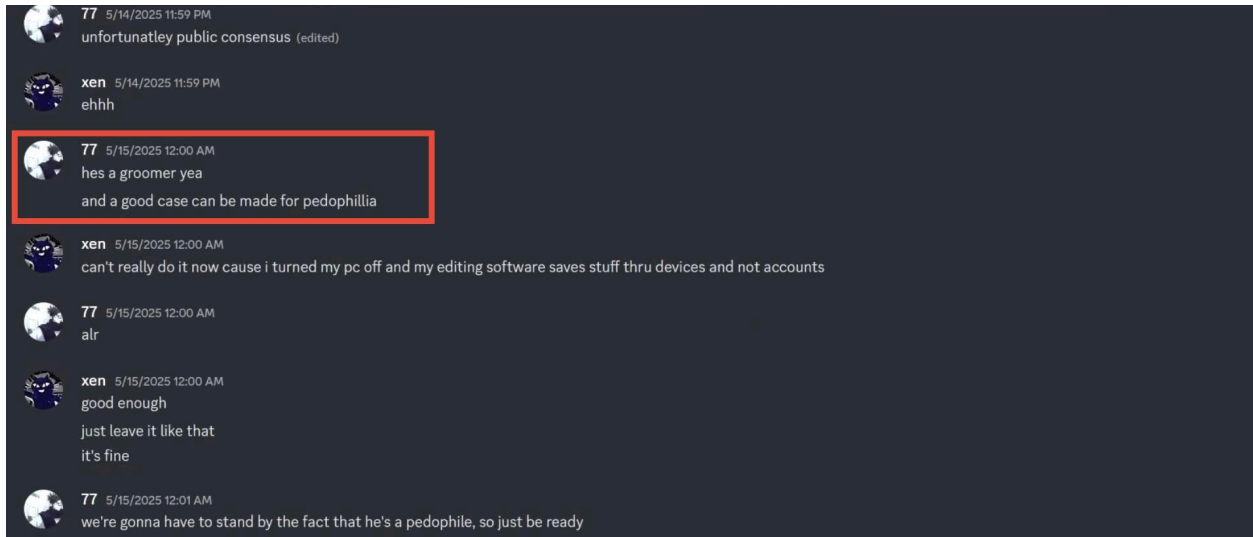
77 is seen posting mock YouTube thumbnails defaming me as a pedophile, this was also followed with 77 posting meme songs on Cosmodore who was a groomer and pedophile who dated a 15 year old and sent them loli porn while he was 19. 77 states the lyrics are accurate to my situation, with no clear indication on how the two situations are similar whatsoever, considering Dupe admitted to lying about his age. This is just succinct proof that 77 is purposely malicious in private and wishes to conflate this situation with an actual egregious case of pedophilia because he is inherently bad faith and malicious.

His associate Xen is also seen making jokes about me being part of the 'sex offender registry', and that I am the modern day version of Epstein, even joking that he wouldn't be surprised if I had a private island. Making light of Epstein's sex trafficking and the numerous victims who were brought to Little St. James Island.

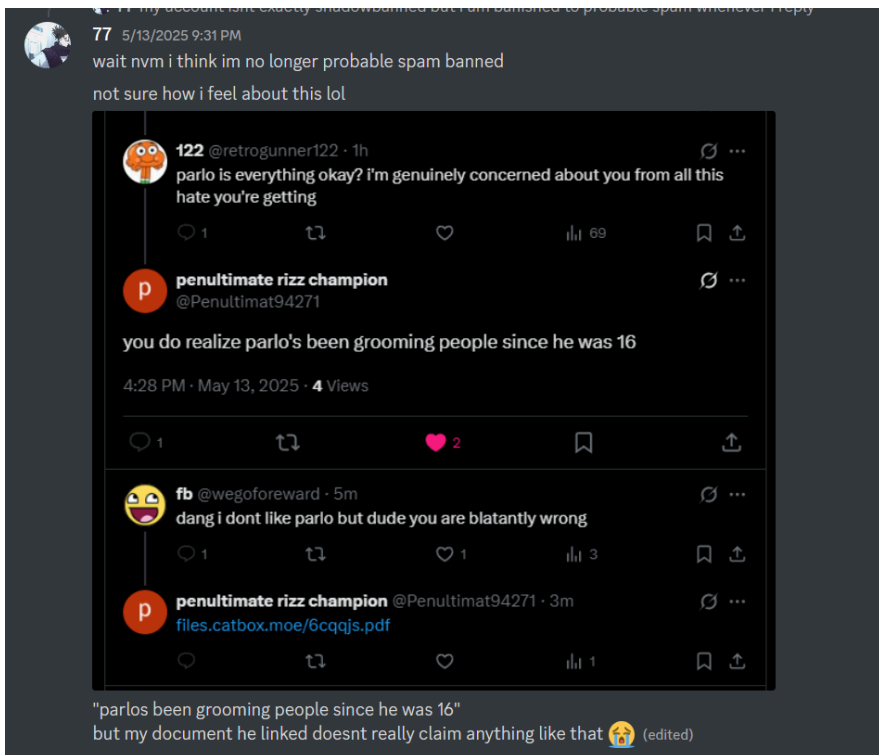
77 is seen entertaining Xen's behaviour and participating in the immature jokes accusing me of being a pedophile by stating 'REAL' and 'yea'. He doesn't dissuade others from making these comments, he is actively complicit and participates in them.

Xen was seen giving Xero a YouTube thumbnail with the word pedophile in it describing me. Xero states that unfortunately YouTube doesn't allow him to include that word 'sadly', despite having **no succinct explanation** on how I am a predator.





Both 77 and his associate Xen were consistently making comments stating that I was a pedophile verbatim **with no evidence behind their claims** whatsoever. “He fits the description”, however they are more than aware that **Dupe lied about his age** and I ceased all sexual contact with him after, even deleting sexual messages I had made beforehand which 77 maliciously framed as “purging evidence”, and “tampering with evidence”, when it should be common knowledge to remove any problematic messages once coming to terms that someone you sexually communicated with was significantly younger than they stated they were.

77 additionally stated that I was a groomer in private expecting these messages to never be leaked. 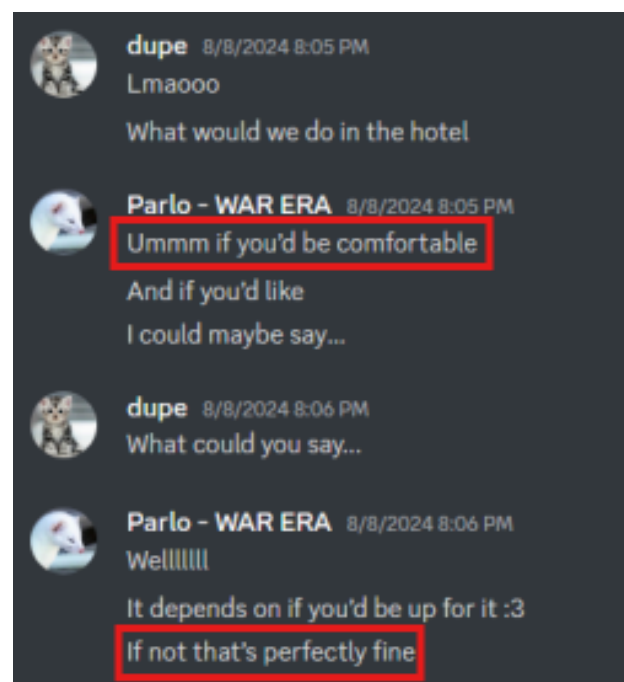
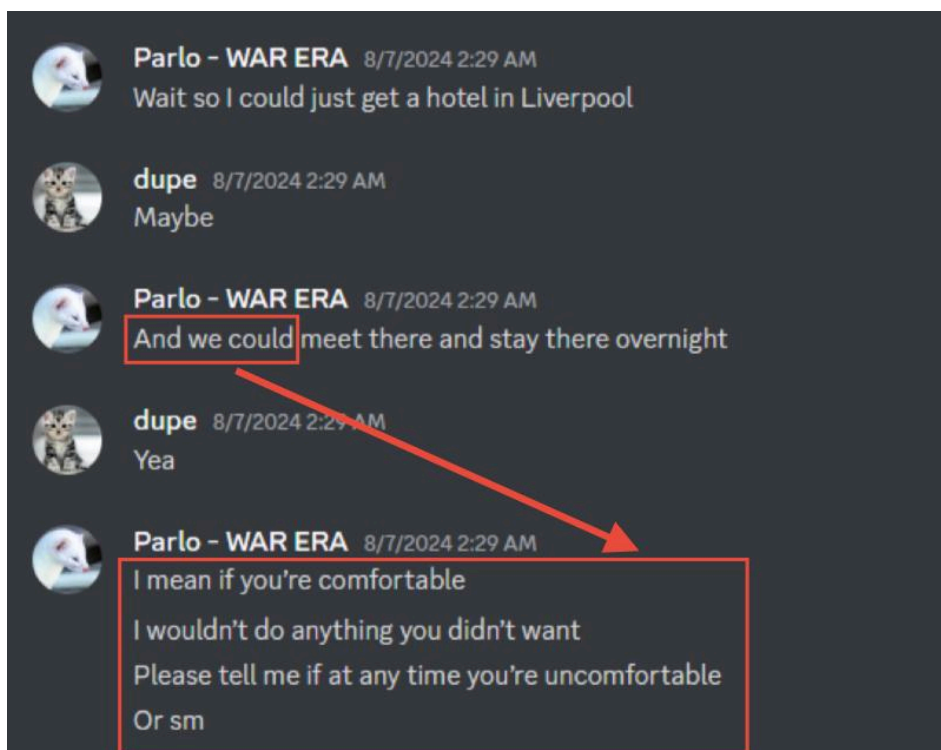
Parlo repeatedly engaged in sexually explicit fantasies, including discussions about meeting up, kissing, making out in femboy clothing, and specific kinks like degradation, CNC, and piss play. These are not abstract or indirect. He expresses things *directly* to Dupe, and continues the behavior without even being able to confirm his age. This is not teasing, in fact, it can be seen as **sexual grooming** disguised as "openness"

It is extremely evident to decipher that 77 is attempting to entirely push the narrative that the dynamic between me and Dupe was predatory and was grooming. Again he wishes to leave an area of wiggle room in front of him to use the excuse that he wasn't explicitly claiming I was one. However this excuse runs dry when he was caught in private defaming me as a pedophile and a groomer with no evidence. ### Context;

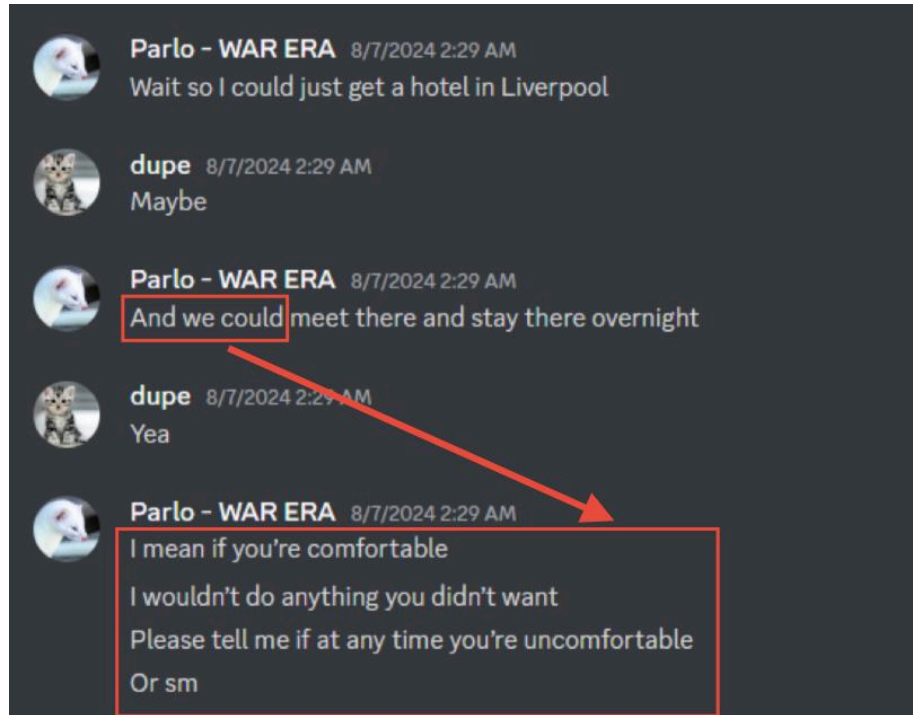

The comment was sent **19 hours after** a conversation about us meeting up was initiated. This is a malicious example of deliberate conflation that 77 does to paint a narrative that I was 'coercively suggesting' despite them being 2 individually different conversations.

### 3. Power Imbalance Misrepresented

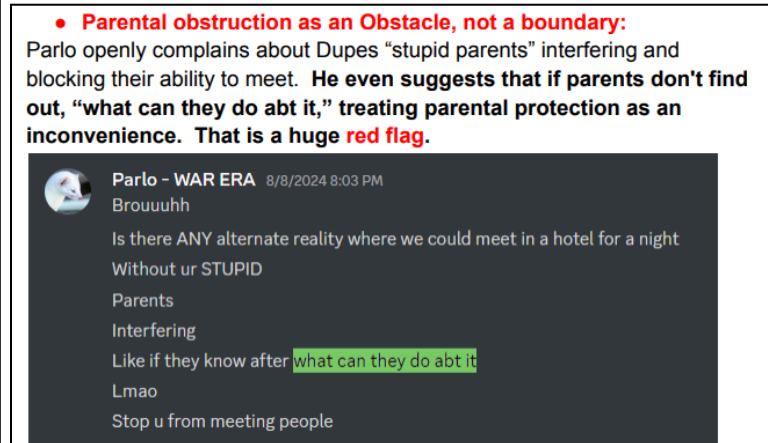
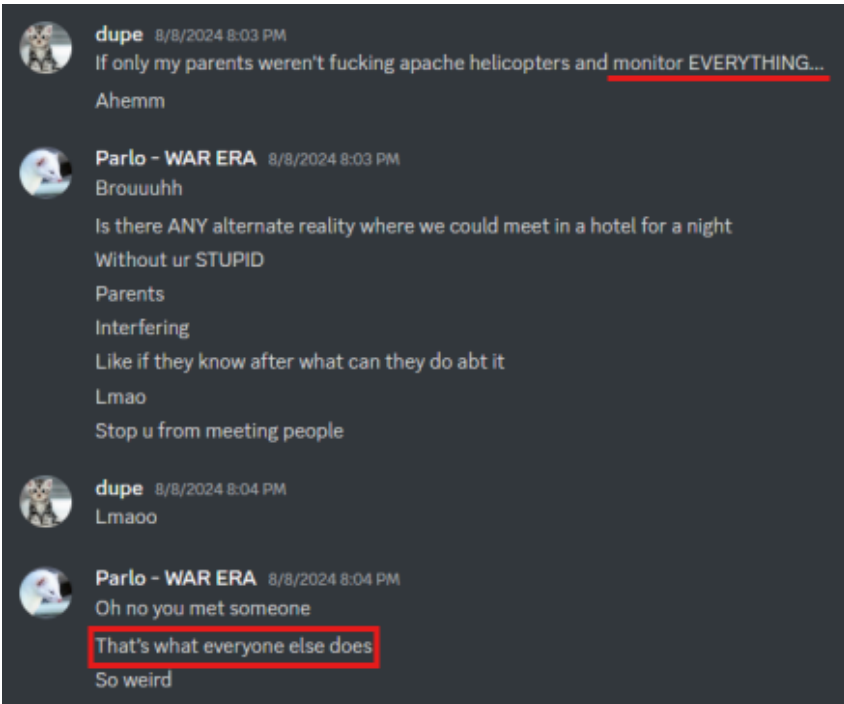
- While I was 19 and Dupe lied about being 17, the messages do not exploit any perceived power dynamic, **even attested by Dupe himself.**

- This is not grooming behavior; it’s a frustrated response to Dupe’s own complaints about strict parents.

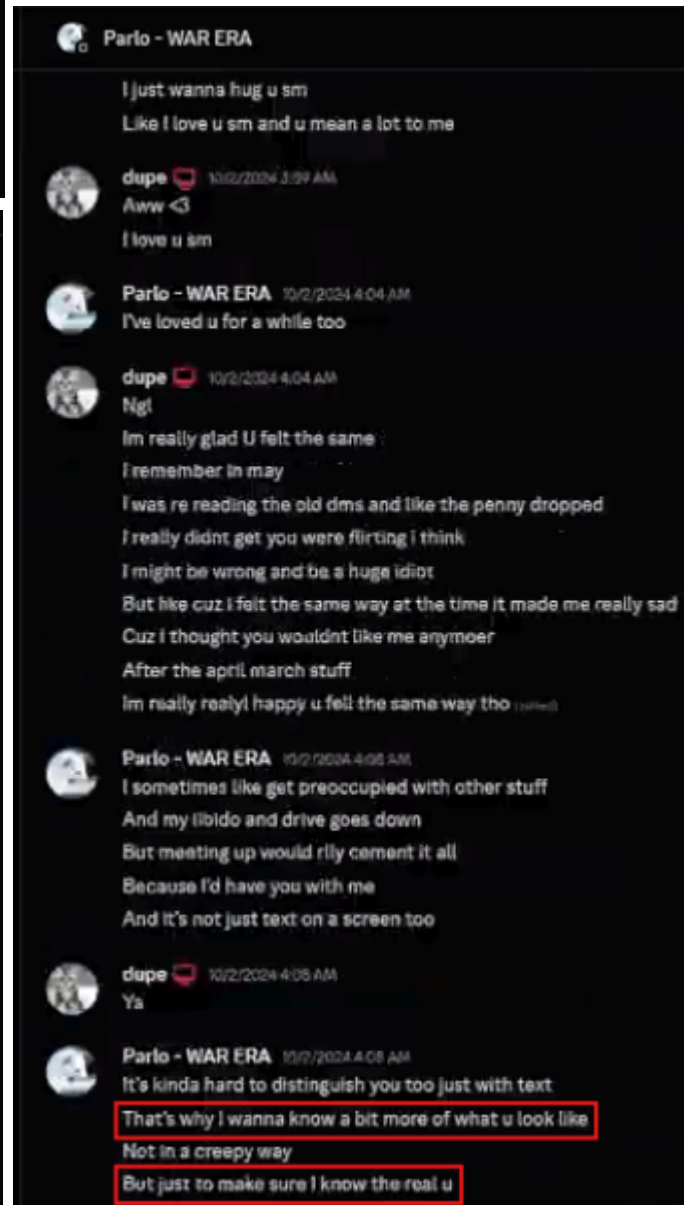
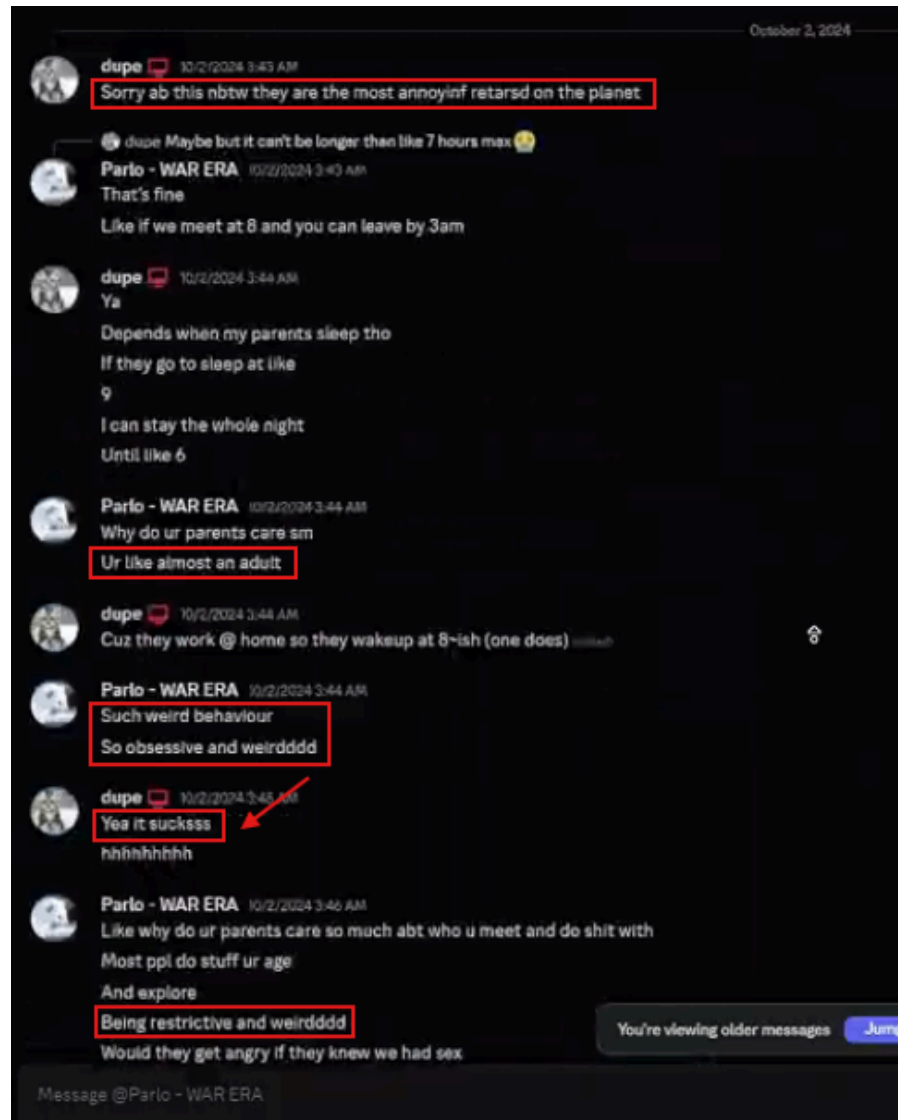
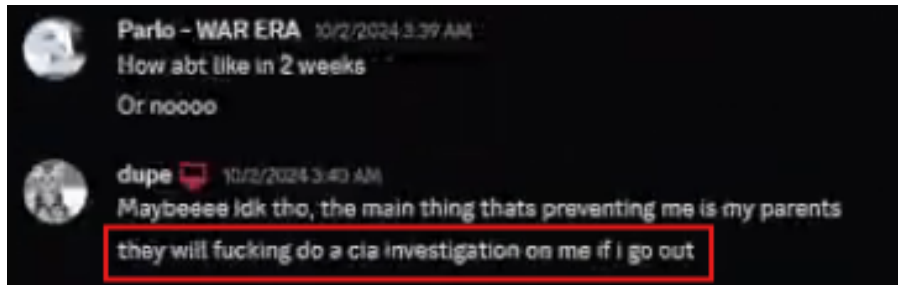

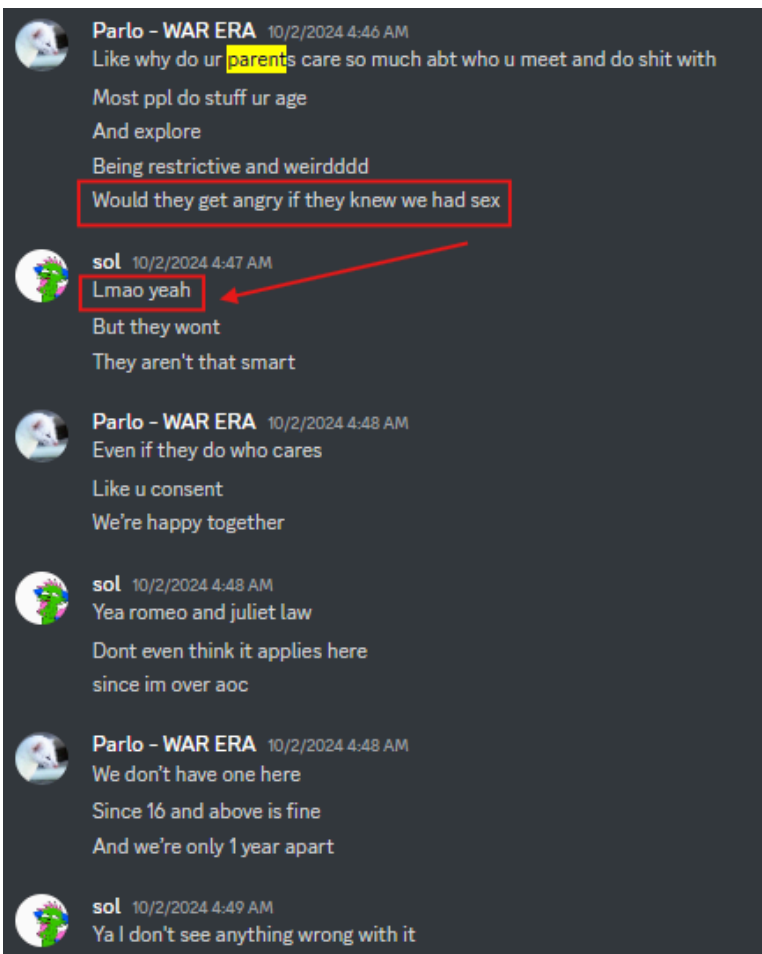
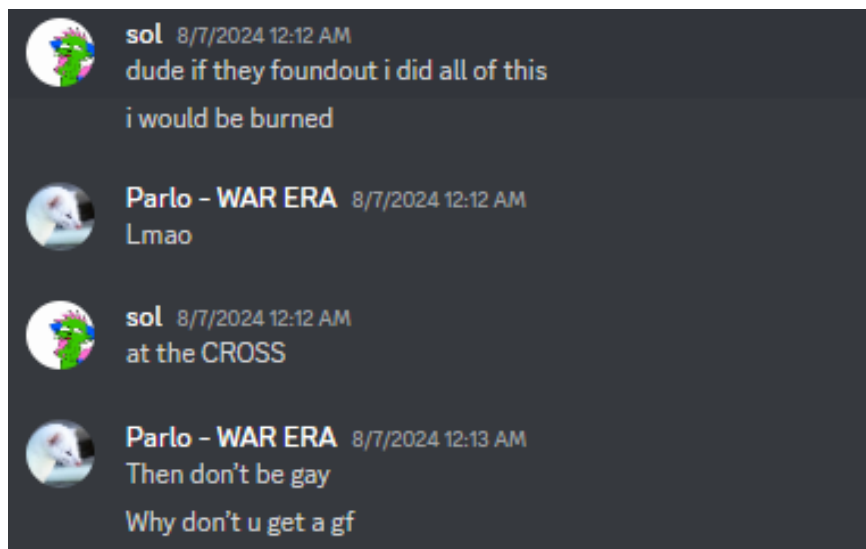
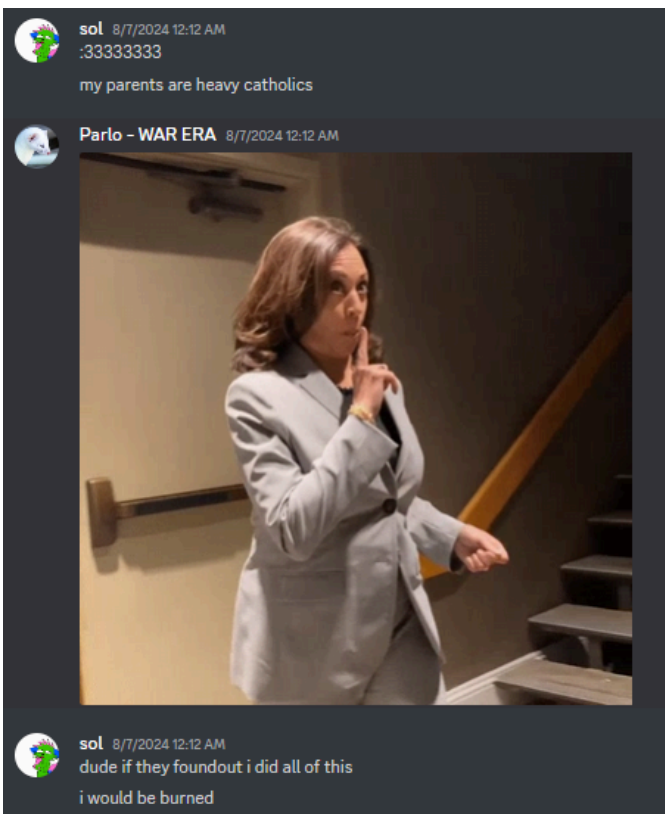
- **Omitted Context:** Dupe’s own frustration with his parents, making my response seem less aggressive. [Dupe consistently vented about his parents in other messages too].

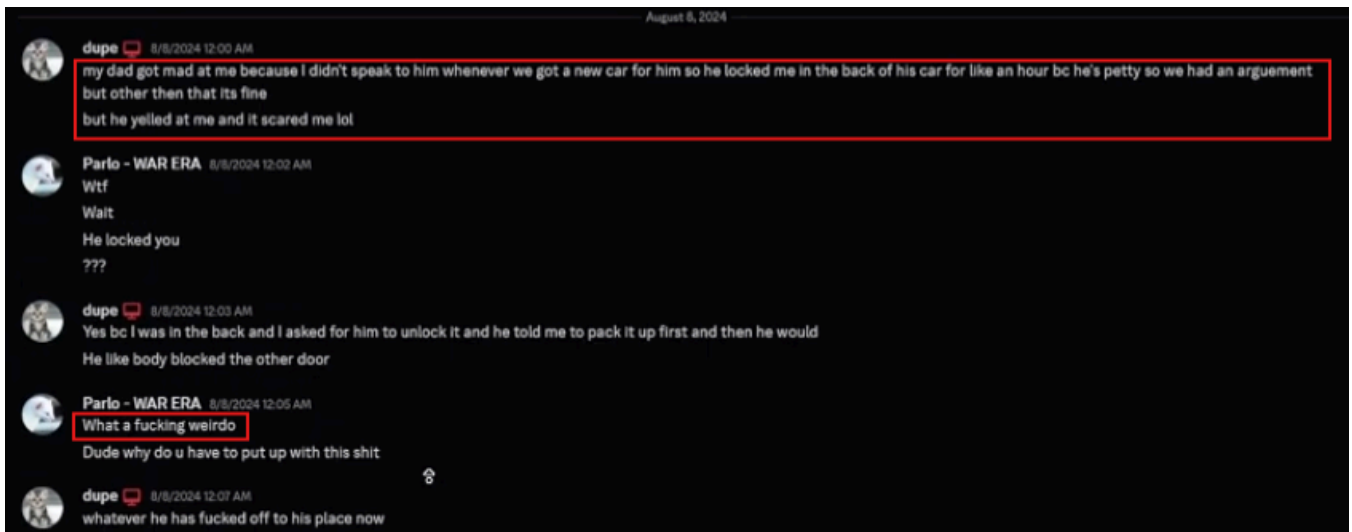
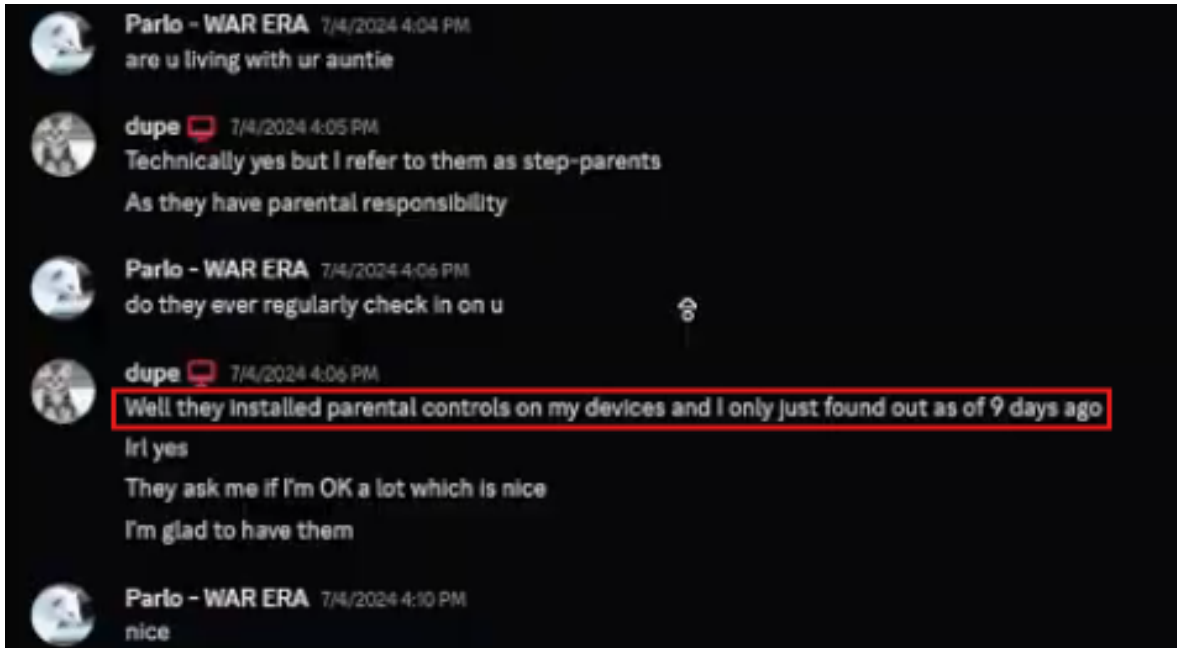
Dupe has consistently expressed beforehand how controlling and restrictive his parents had been, I stated that theoretically there would have

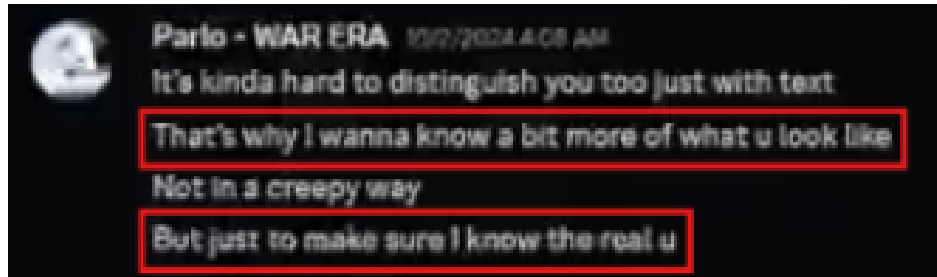

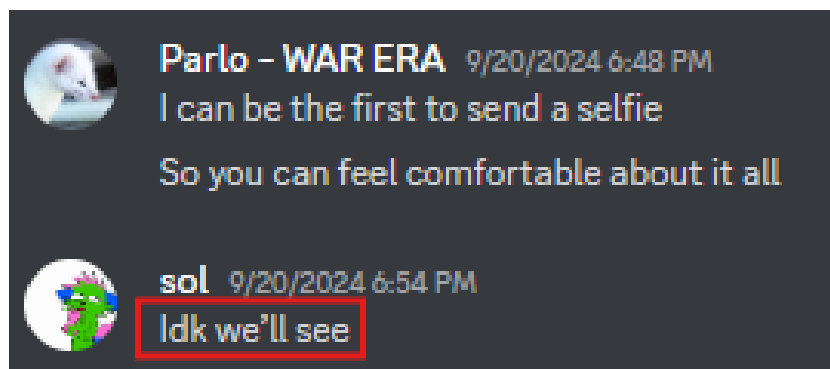
control all his devices and do 'investigations' on when he goes out was extremely disturbing and made me wonder if there was possible abuse that was taking place.

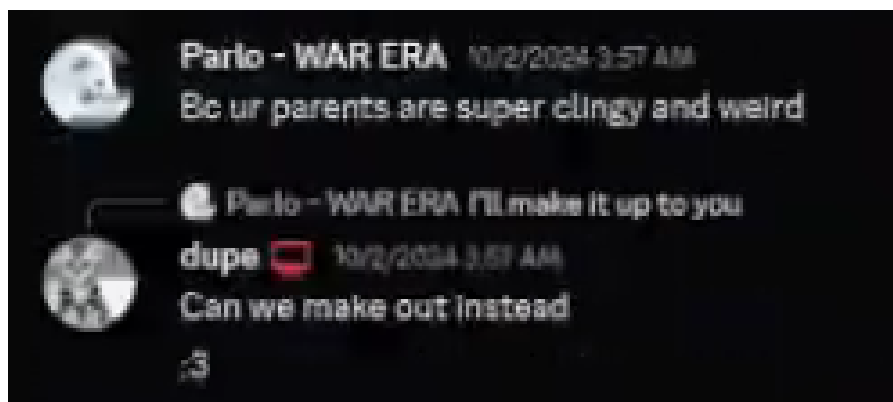


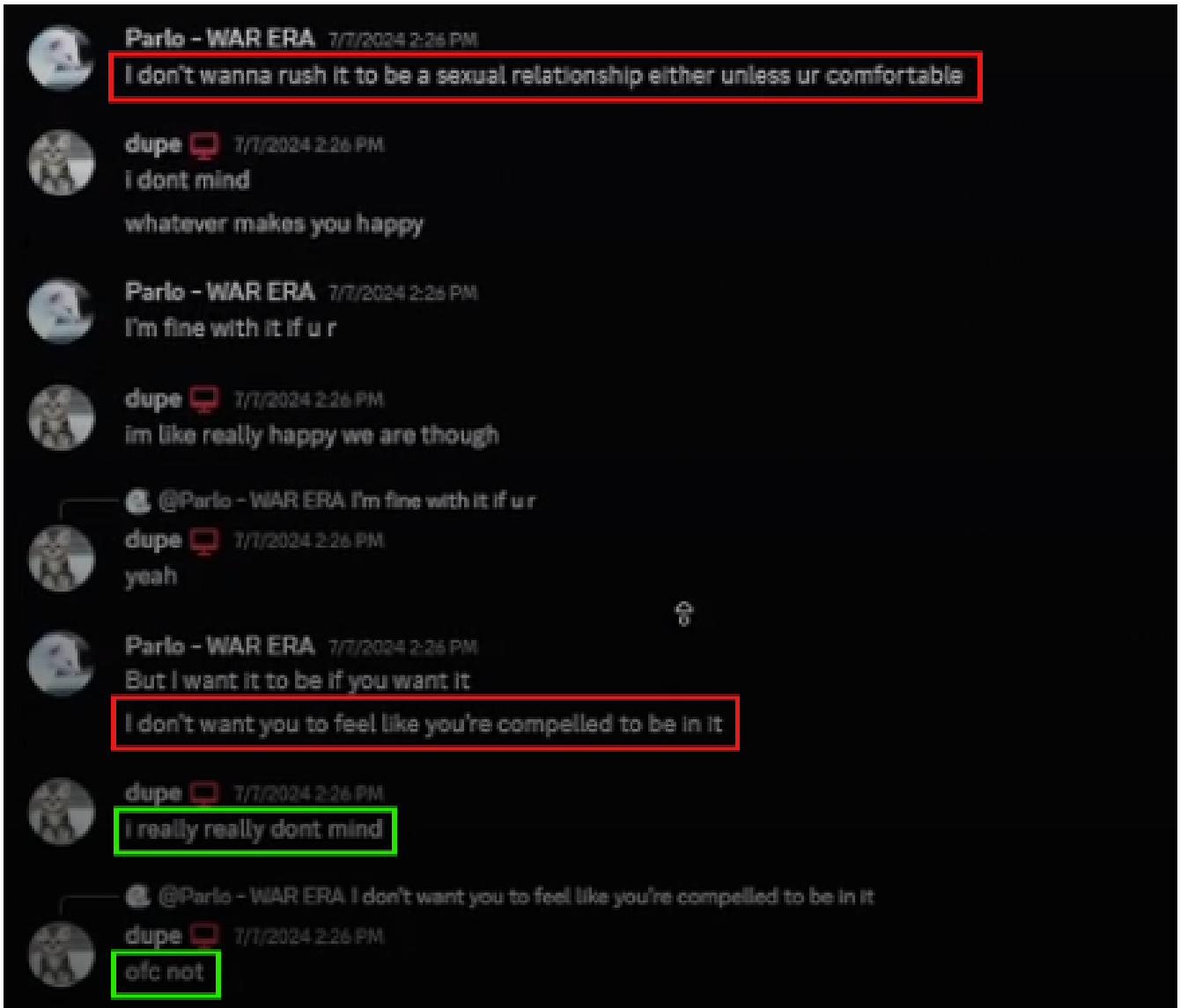
Dupe was even seen highlighting that his parents track his location consistently and that against his knowledge his father had set up essentially a virus to monitor everything he did.

Once again I expressed why this was necessary under any circumstances as he was almost an adult, and it confused me why they didn't treat him like one.



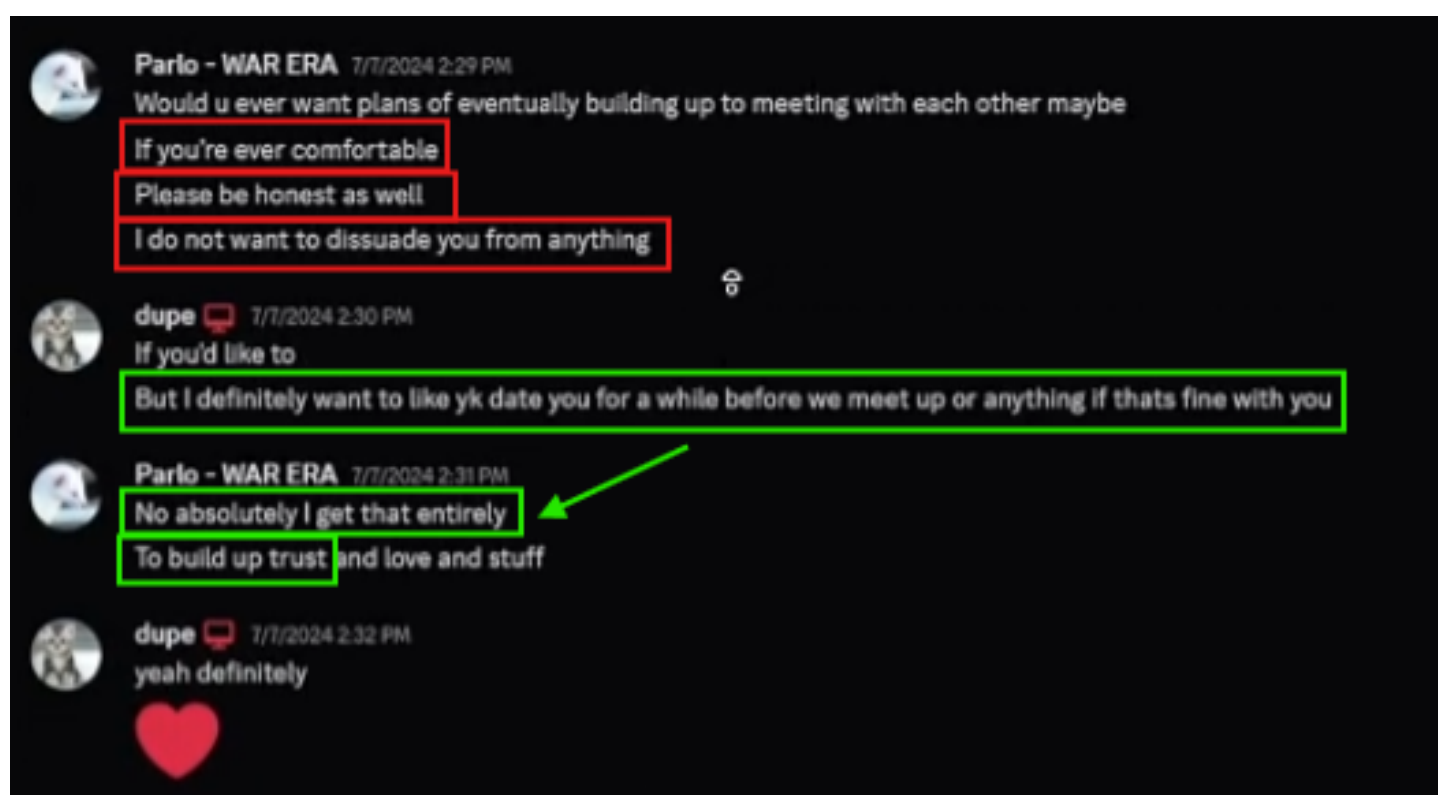

Keep in mind, the relationship did not get officialised until 7th July 2024, in which is when it started getting sexual. This is 10 months after I started messaging him. I was seen stating verbatim to Dupe, who I had believed to be 17, that I did not feel comfortable getting in a sexual online relationship with him unless he expressed that he wanted to reciprocate and that he was comfortable with it. I ensured that I had his consent before building on our relationship. He was not pressured, he was not coerced, and it was not meticulously done. I stated that I did not wish for Dupe to feel compelled to be in a relationship with me, to which he quickly retorted that he really 'did

not mind', and that he did not feel compelled to engage. Dupe openly expressed that he was fine engaging at the time, there was no manipulation brought into this, it was me respecting who I believed to be a 17 year old and their boundaries. Of course in actuality 12-13 year olds cannot consent, however this doesn't not fundamentally change the fact that I believed him to have been 17 and was being told directly by him that he was comfortable with the progression of the relationship. To meticulously strip that context away from this situation, is inherently disingenuous.



I had also highlighted the idea of if Dupe [who I believed to be 17 at the time], was interested in meeting up eventually. I had prefaced the fact that I would only ever be willing to do this if they were ever comfortable. I urged Dupe to be honest with what he said because I did NOT want him to feel as if he should ever feel forced to this idea, and I certainly did not want to make him feel discomfort or dissuade him.

Dupe highlights how if we do, it should be a while after we officially start dating. I of course agree, because I would not want to meet up until I could

entirely verify what he looked like. Despite me entirely trusting him and his age being 17, I wanted to ensure that he was not a catfish.

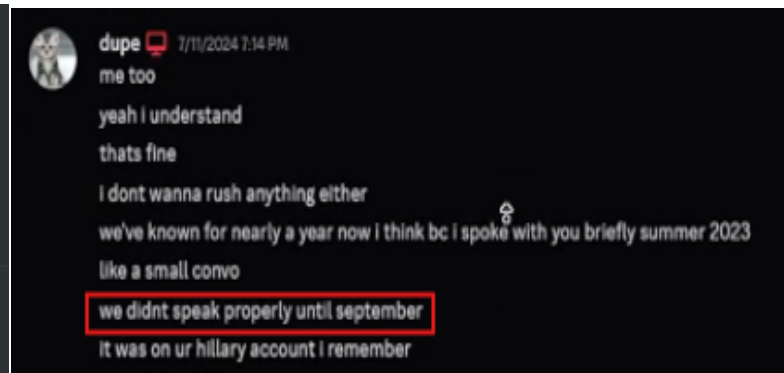
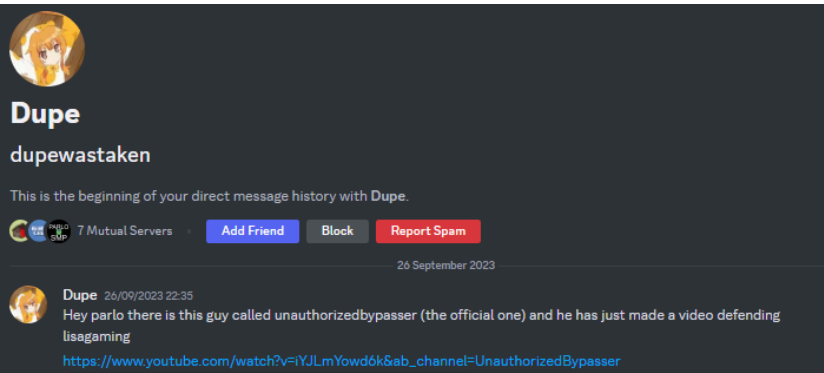
77 has always necessitated his desperate need to focus on proving the 'power dynamic' factor in order to hit it home that there was 'grooming' behaviours in which were taking place.



This would be a nothing factor regardless as he attempts to callously use history revisionism to almost invalidate the fact that I was under the idea that Dupe was 17, almost blaming me and pinning me as having retroactively known. And yet the situation is further invalidated by Dupe himself stating I never leveraged my influence to solicit him or GET anything out of him. No NSFW was sent to him, no images were solicited from him, no NSFW content was sent to him under any circumstances. 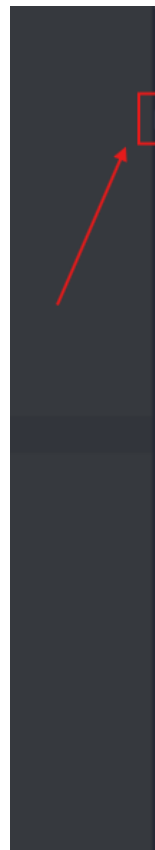
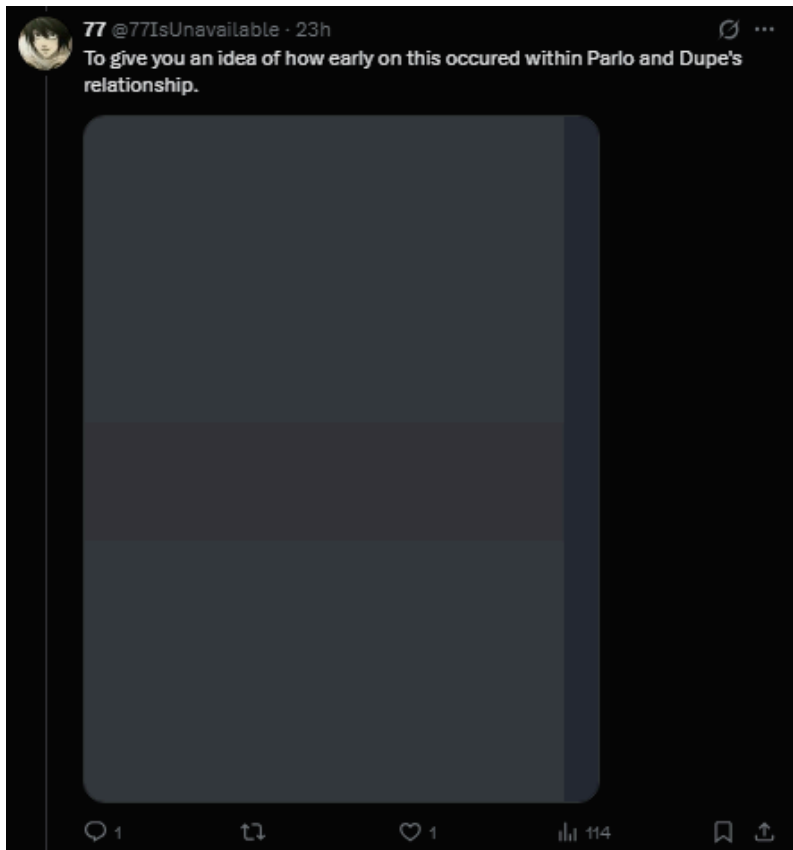
# Dupe's Suicidality + Mental Health



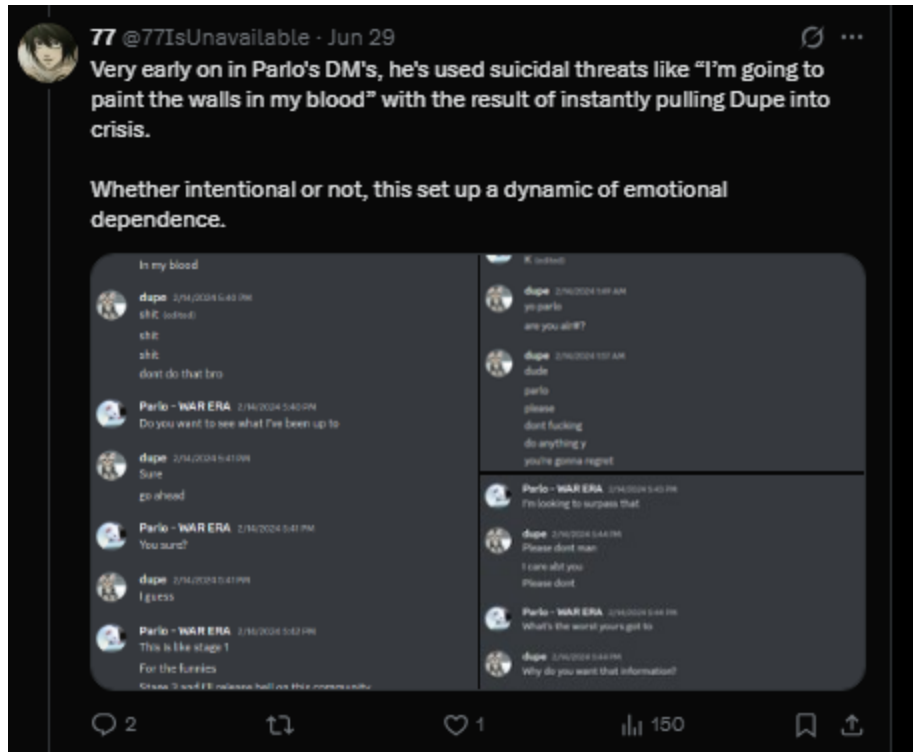
## **Warning: discussions of suicide, relapsing, anorexia, SH**

I had originally met Dupe on Discord by another user [Natz], and was introduced to them in September of 2023. An ex-mutual of another friend named Natzpop had me in a gc with them.

In late September 2023 we started speaking in private DMS.



77 openly lies and reframes the situation on his thread covering the Dupe allegations. He attempts to imprint the notion that the self harm situation of February 2024, was almost intentionally done in the earlier stages of me and Dupe's 'relationship'. This is an evident example of 77 negating the fact that I initially started speaking to Dupe in Sept / Oct 2023, **5 months before** this situation transpired. This was on an older account.



Now since my Self harm situation and personal, very private venting has been blasted to the public via Dupe in April 2025 and 77, with no contextual background information being presented highlighting my side of the story necessarily. I feel I need to share this information to help you understand the bigger picture behind the entire situation. **Keep in mind 77 has deliberately sidestepped addressing this segment numerous times.** It is in his best favour to negate these aspects of the dynamic, to flatten down what truly happened and make it seem far more nefarious and one sided. Keep in mind under these circumstances, I believed Dupe to have been 16 in 2023, 17 in 2024. I was 18 in 2023, 19 in 2024.

I just resonated very much with Dupe's position, and could empathize with them quite a lot, not entirely however, as they had a much more troubled upbringing than me,

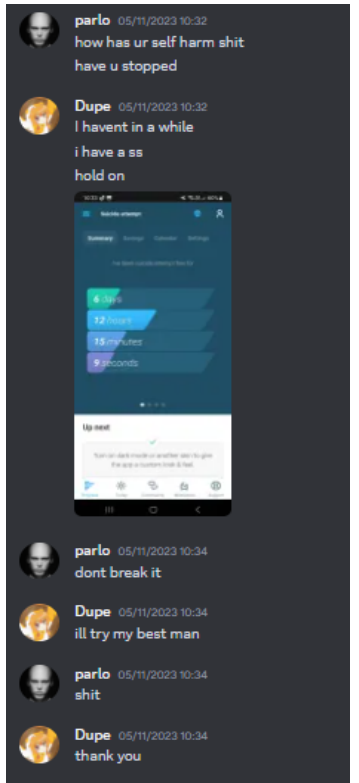
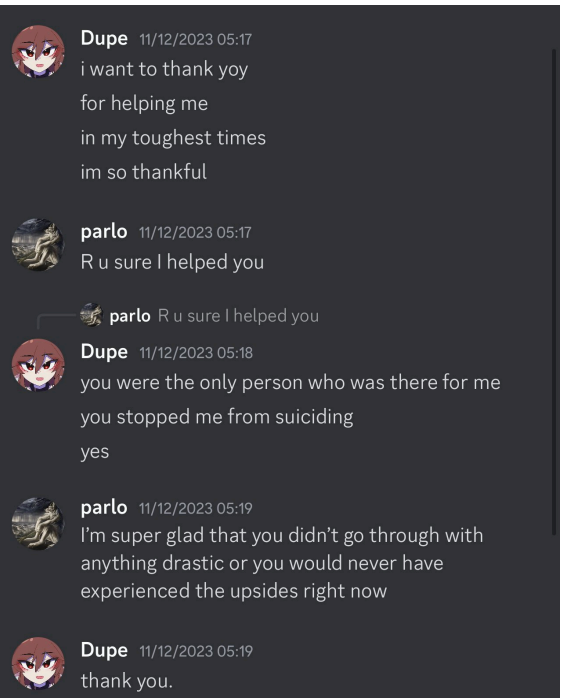
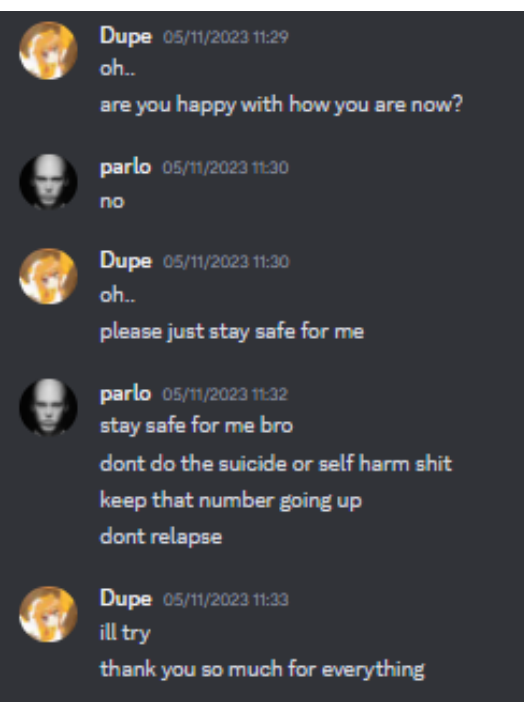
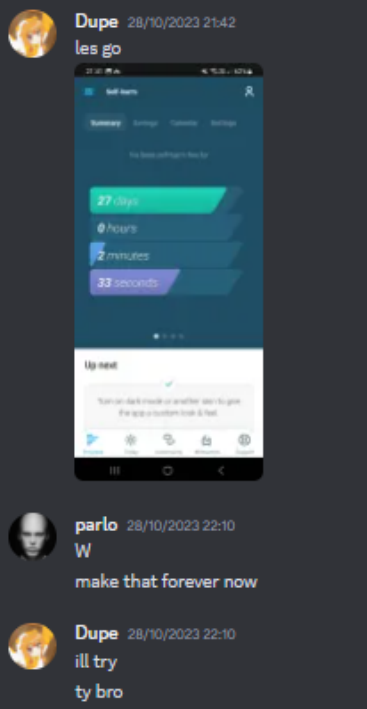
although my domestic abuse/ parents divorce situation has been extremely emotionally damaging and taxing, it's pretty incomparable to his homelife from what he discussed with me.

It's just genuinely very hard to find and speak to someone and have them essentially understand the horrible stuff you were suffering from, because no one really understands the position I was in or pretty much cares, no one is willing to necessarily sit by and listen to a Roblox Drama YouTuber, rant and rave and rationalize his problems and situation. A therapist has never worked, I have done therapy for years and it has never worked. In 2022 after my hospital situation, I was forced to go to therapy, and it clearly did not pan out the way my parents intended it to. For some people therapy just simply does not work. It doesn't make me comfortable at all, an adult cannot understand the complexities of the modern day internet's problems on someone like me, unless it is someone my age who understands the position I am in, someone who understands the troubles I go through, and doesn't pretend to care, just so they can get their weekly payment. An adult doesn't truly understand the terms 'YouTube Drama', or 'Doxxing', or 'Expose videos', or 'Cyberstalker'. I feel that paying someone so they can pretend to care about your problems for a specific time limit is extremely disingenuous and makes me sick personally. A true friend, for example, cares about the other person and will listen knowing they will gain nothing that will benefit them personally, because they are there merely for the benefit of the other person and to help them and guide them and give assurances and support. I barely even speak to my parents, because the thought of them reminds me of the horrific shit I had to face in 2022, it's just solely internet communication with a small group of friends who I believe I can trust. You see people only know half the story with what transpired in 2022, but it was truly one of the worst years of my life.

I try venting to moderators of mine, or friends, but oftentimes, they do not care, play it down, tease me or belittle me, and my vent posts are often grabbed and posted to other people so I continue to be mocked at. I developed RYC for example, to be at first, a YouTuber hangout server, but it more or less divulged into a rant/vent server for me and perhaps a mini echochamber and safe bubble for me, ever since 2023, as it was conjoined with the Homotopia venting situation too. However, RYC then became a server filled with secretive people who take screenshots of what I say, and provide it to detractors, inherently violating my privacy and giving me innate trust issues.

Dupe was conjoined in the same boat of mental disparity as me, and I didn't necessarily wish to drag people down a depressing loathsome hole that I was situated in for the past 2 years. If anything I actively went out and tried to help Dupe overcome their situation, because it was even more so depressing, so see someone **at 16** [to which I believed], not even an adult yet, engage in relapsing behavior in real time, when I could have the ability to try and prevent it and at least be the person who will listen to their

venting, or help them increase their social interactions, to then encourage them to get friends in real life. Since that would truly benefit them mentally.

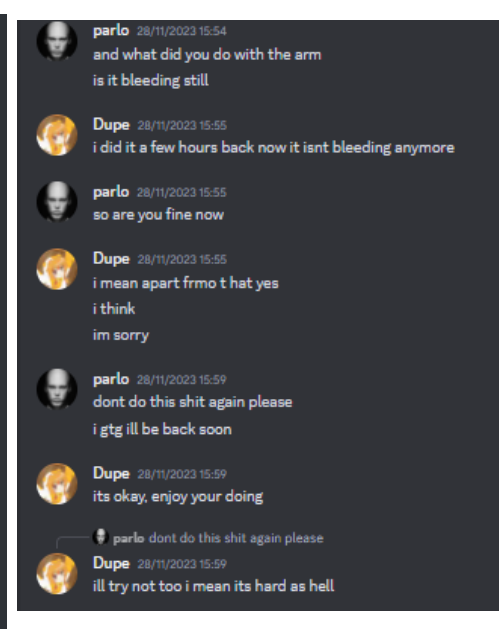
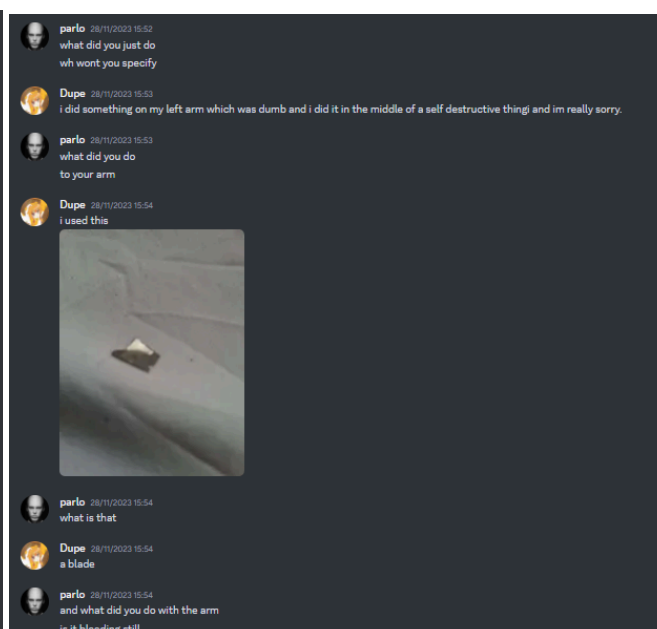
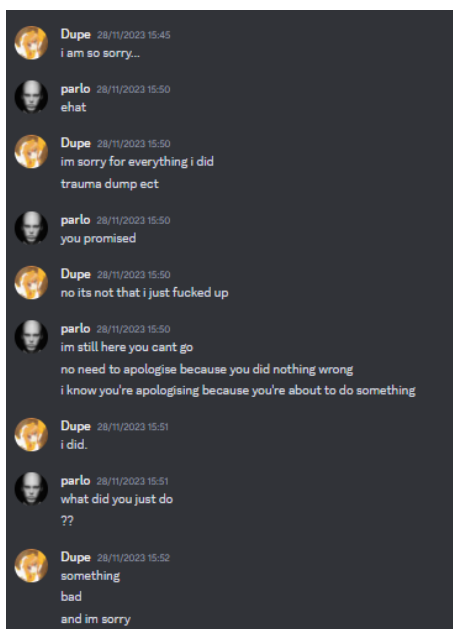


Dupe claims I was “the only person who was there for them”, and “I stopped them from attempting suicide”, those statements made me feel really happy, that somehow, some reason, my presence made it so someone wanted to live on this planet full of shit, a little longer. That somehow I may be actually helping someone.

I actively spoke to Dupe in dms regarding their relapse timer, and if they were clean to try and coax them out of harming themselves, and being more open and speaking to people more often as it would take their mind off of depression.

Whenever Dupe needed to vent about personal, very private things, I would listen and be there for them, no matter how serious it was.

On the 28th November they literally vented to me about a horrific self harm situation that they had engaged in, which subsequently broke their relapse timer.

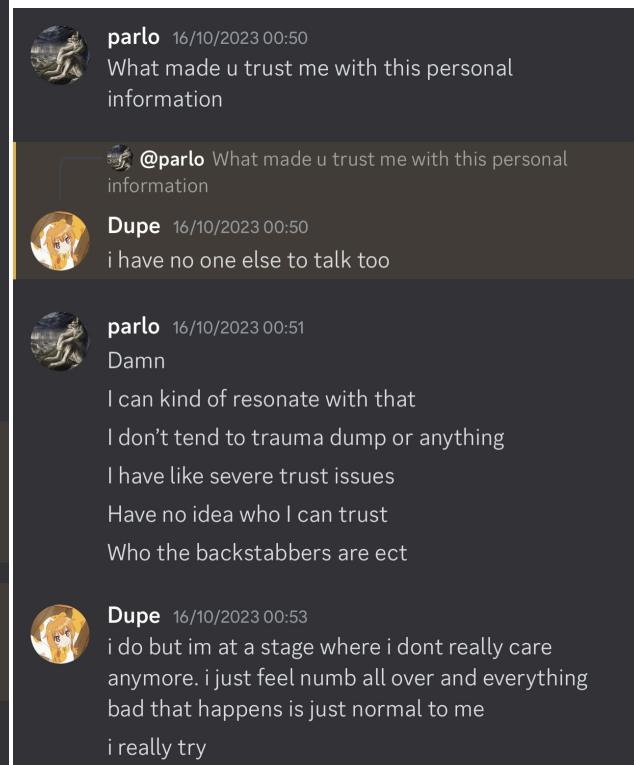
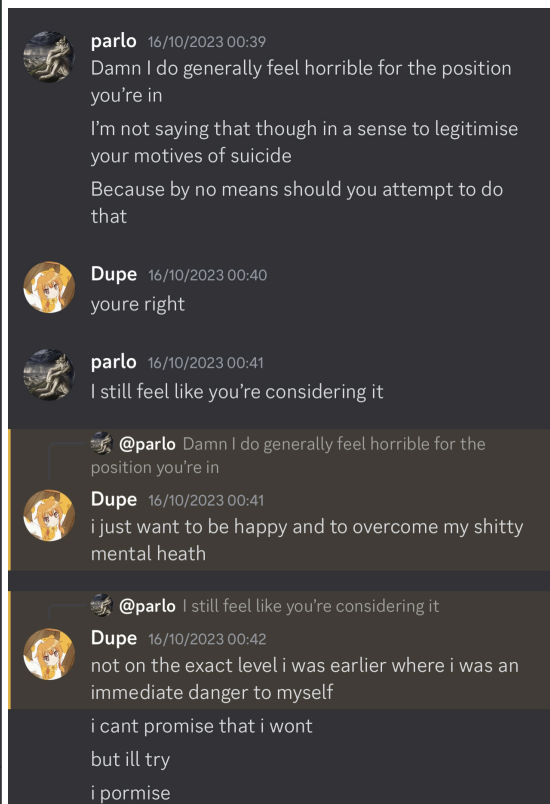
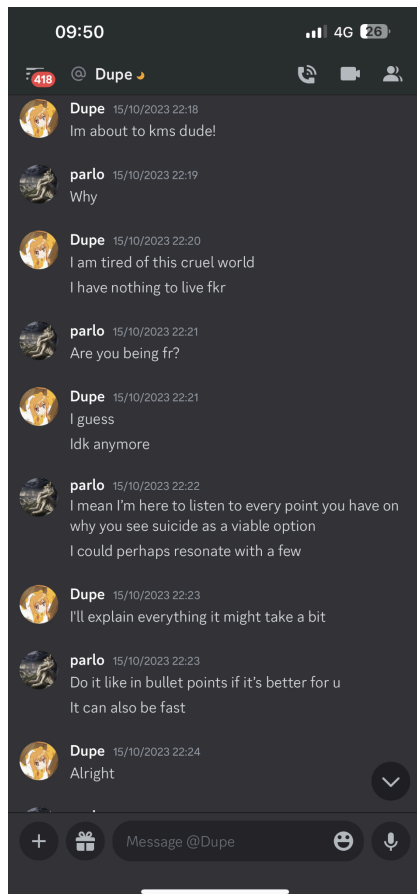


This situation made me feel really uncomfortable since I ended the conversation with “don’t do this again, I gtg”. However not once did I ever have the audacity to post this publicly at time time, nor even my February 25th live stream as some exposal point to try and somewhat attack and villainise the other person, and I’m not going to do that now.

Dupe was going through horrible mental health episodes which made it so essentially self harm was their only method of escapism that they felt was necessary. Not once did I feel the need to make this public or tell their detractors about this situation, however now I am quite literally obligated to release this information to prove how our mutual friendship played out, and to prove how this happened essentially both ways. His self harm situation played out differently to mine, on different calibers, however we both essentially self harmed for the same reasons.

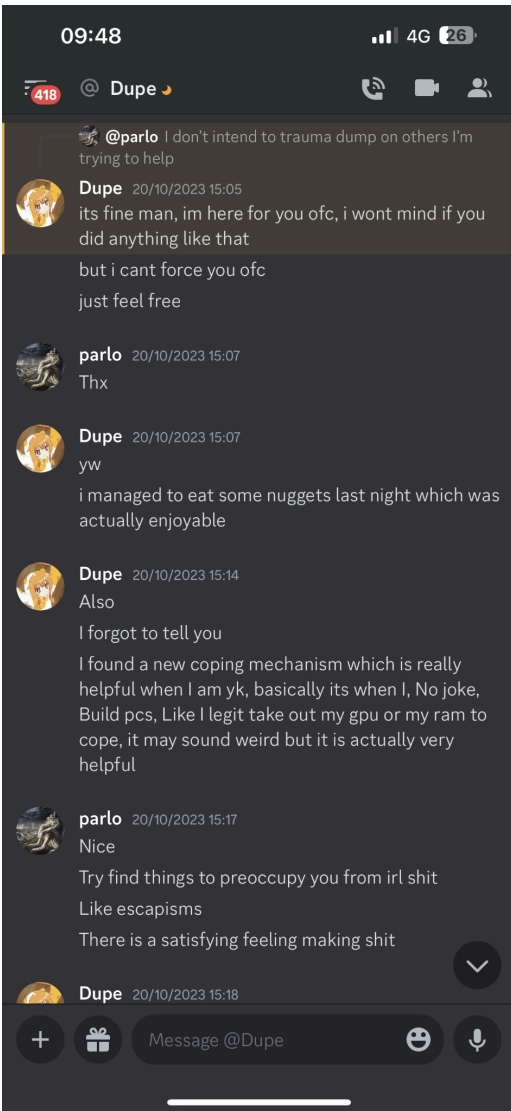
I was always there to help him though, and actively sought for his self betterment, and I can fully understand, resonate and empathize with the mental struggles he was going through.

I thought we had the mutual understanding of not releasing each other's personal struggles online, however he violated my trust to do that, and it has caused irreparable emotional damage to me in the process.



We both had no one else to really talk to or vent about our respective situations other than each other, so we spoke about very personal things pertaining to our struggles in life. Since we didn't have therapists, we shared our struggles with each other, and tried to consult and help each other.

I listened to them, and they listened to me. It seemed that we had some sort of mutual trust, and with me typing this, it really does feel pretty sad that it all did pan out the way it did.



We were free to discuss with each other about personal situations, we were allowed to mutually discuss trauma, and we checked in on each other's mental health seemingly every week. I always asked for updates with their personal life to see how far they progressed from the late 2023 lows, and they gradually got better as our interactions progressed which was a massive positive.

Self harm and anorexia and lack of social skills was something we both faced, and something we could absolutely resonate with each other in regards to. In eventuality Dupe got progressively mentally better, while I started gradually getting worse, as it has been a continuous low for me ever since March 2022, however I hadn't relapsed since November 2022 to my knowledge.

I have shown most of the crucial dms to help you understand the crucial context behind why we spoke, what we discussed, and the mood of the conversations as they gradually progressed. In Dupes' own words I helped them, and as their mental health got progressively better, mine continued to hit rock bottom. And no one really seemed to help nor care.

This all eventually broke down on February 14th 2024, Valentines day. This involved 2 friends in private who knew about the self harm I had conducted that day, both I trusted to keep the very private, and emotional situation secret, decided to release it publicly and make it public knowledge, violating my trust entirely. I wished for my venting to remain private so that people would leak my vulnerabilities to malicious actors, so I could be mocked for it, attacked for it, and harassed for it. Every person deserves an element of trust with those they care[d] about in the sense of privacy.



Trust was developed and was reciprocal on both sides, and I had consistently pushed Dupe to speak to his friends more and increase his social life. I did not wish for Dupe to fall in the same pit-trap I was in, with regards to the social stagnation that I very much had in 2024.

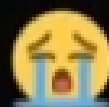

**This was not a case of isolation and control**, it was a case of me and someone I believed to be a peer in the same boat close in age, communicating and helping each other through objectively bad times.

I overstepped the mark and took full accountability for the self harm situation, but in no means does an isolated incident restructure the nature of the conversation and to undermine it as 'guilt tripping', is an example at recontextualising the situation and watering down the severity of my suicidality. I was seen consistently asking Dupe on whether they had found any more friends or spoke to family more.

***Grooming typically involves isolation, secrecy, and control—yet I repeatedly urged Dupe to seek support from others, which directly contradicts grooming behavior. Below is a systematic breakdown of why this demonstrates good-faith care, not manipulation.***

---

## 1. Grooming Requires Isolation – I Did the Opposite

Definition of Grooming Isolation:

Predators prevent victims from speaking to others to:

- Maintain control.
- Avoid exposure.
- Create dependency.

My Actual Behavior:

- I explicitly told Dupe to talk to more people:
  - "Do you have anyone else to speak to about this?" (5/05/2024)
  - "Social contact is always good." (1/12/2023)
- Never discouraged Dupe from confiding in friends/family.

Conclusion:

I wanted Dupe to have a support network—the antithesis of grooming. The false quasi-retort that I will immediately shut down is the idea that I was simply asking to somehow 'ensure' that he was isolated. This is a lie, immediately discredited by my

aforementioned messages where I urged Dupe to not only improve his diet, but affirmed that more social context for him is good.

## 2. I Never Enforced Secrecy

Grooming Red Flag:

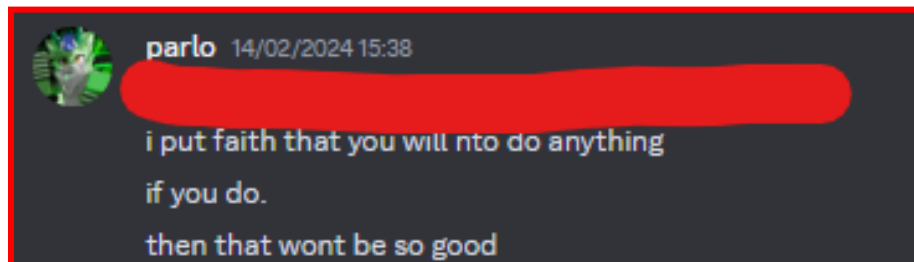

My Behavior:

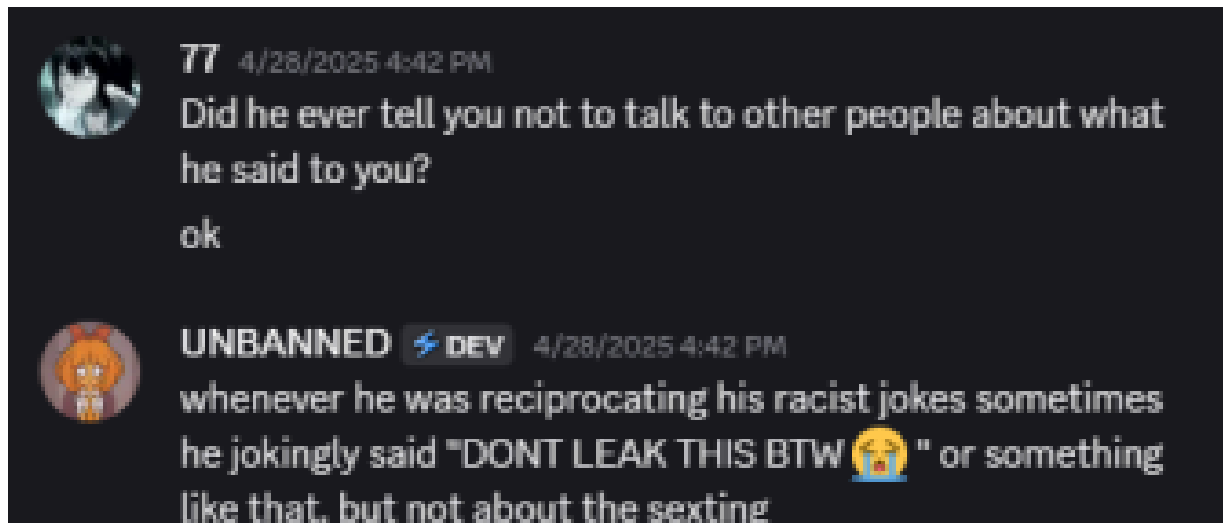

Dupe confirmed this, I was only 'secretive' jokingly in reference to the dark humour jokes made, and I had not wanted Dupe to have leaked my venting messages or contacted the police regarding my suicidal mental breakdowns because I could not deal with the mental stress that would ensue once again being stuck in a mental ward and being isolated even more, I had ensured all my friends who I vented to, did this too such as Maple [17 when I was 18].



I especially did not want my vent messages to be leaked out of discomfort for if bad faith actors would make fun of me and harass me for them, in which they have been documented to have done before. I was extremely vulnerable and people have taken advantage of my venting and breakdowns before.



### 3. My Intent: Reducing Dependency, Not Creating It

Groomers force emotional reliance on themselves. I, instead:

- Encouraged Dupe's independence:
  - *"Don't feel obligated to speak to me unless you want to."* (2024 reconciliation)
- Checked if Dupe had other support systems.
- Did not monopolize Dupe's emotional outlets.

Why This Matters:

A groomer would not push their victim toward other sources of help—they'd hoard control.

---

### 4. Dupe's Own Words Confirm No Coercion

Before 77's influence, Dupe never described feeling:

- Controlled.
- Isolated.
- Pressured into secrecy.

Instead, he:

- Voluntarily engaged in conversations.
- Thanked me for my support, the same support which has been openly documented in this Google Document. The same support that 77 has maliciously obfuscated as it would clash with his own narrative.
- Admitted to manipulating Parlo ("*I manipulated YOU*").

77's Fallacy:

Retroactively framing normal support as "grooming" is intellectually dishonest.


The intent here is subtle:

This is **emotional coercion**.

He implies (knowingly or not) that by holding him accountable, Dupe has:


- **"Taught him" to not be vulnerable**

- **Makes criticism feel like cruelty, again, because "he already hates himself."**
- **Deflects anger, turning it into pity.**
- **Builds a buffer "I'm already punishing myself, so you don't need to."**

## 6. Post Apology: Monitoring, Guilt, and Obsession

After apologizing, Parlo immediately pivots to worrying about how he's perceived:



**This undercuts THE ENTIRE APOLOGY. True accountability doesn't ask for emotional reciprocation. It doesn't say:**

- "I'm sorry, but you also hurt me."
- "I'm sorry, but now I'm scared and isolated."
- "I'm sorry, do you still respect me?"

**This ultimately shows that the apology was not unconditional, it was a negotiation.**

## 7. Conclusion: This is not a *real* apology.

### It's a bid for redemption.

Let's be clear with what we've observed thus far:

Parlo does not seem to understand the core of what he did wrong, that being sharing self harm in graphic detail with an 11 year old while knowing his influence and their mental state.

Instead, he reframes the entire situation as:

- A mutual friendship gone wrong
- A mental health spiral
- A misunderstanding
- A betrayal by said 11 year old

He wants the narrative to be:

**"I was unstable and hurtful, but sincere and misunderstood."**

But the reality is:

**He KNOWINGLY involved a younger, vulnerable person in his psychological collapse, exposed them to graphic trauma, and repeatedly invalidated their later reactions by pointing to their momentary forgiveness.**

## Deconstructing 77's "Apology Analysis" as Bad-Faith Rhetoric

77's dissection of Parlo's apology is a textbook example of manipulative framing, designed to manufacture culpability by:

1. Selective Quotation: Isolating phrases to strip context (e.g., ignoring Dupe's reciprocal venting).
2. Pathologizing Normal Behavior: Labeling vulnerability as "manipulation" and self-reflection as "self-centrism."
3. Imputing Malice to Ambiguity: Treating my mental health struggles as calculated coercion to play into the larger claim of 'grooming', to which he tip-toes around the definition of.

Key Fallacies in 77's Argument:

---

### 1. "Apologetic Self-Centrism" – A False Dichotomy

77 claims my apology was "self-centered" because it included explanations of his mental state. This ignores:

- The Nature of Mental Health Crises: During breakdowns, individuals often lack the capacity to articulate others' pain with clinical precision. Parlo's focus on his own confusion ("*I cannot think clearly*") reflects honesty, not narcissism.

When you're in the position I was

You cannot think clearly and you don't have the mental cognitivy to process what you were doing was wrong

The explanation was context to the causation of the self harm situation, it was not indicative of self preservation or an excuse and it was never illustrated as such. It was explained in the manner of allowing Dupe to understand my mindset at the time and it is objectively true.

- Dupe's Own Admissions: Dupe confirmed I never manipulated him and that their dynamic was mutually supportive. 77's assertion that I "ignored Dupe's pain" contradicts Dupe's testimony AS WELL as excerpts of my apology that he CROPPED OUT AND DID NOT ADDRESS DELIBERATELY.

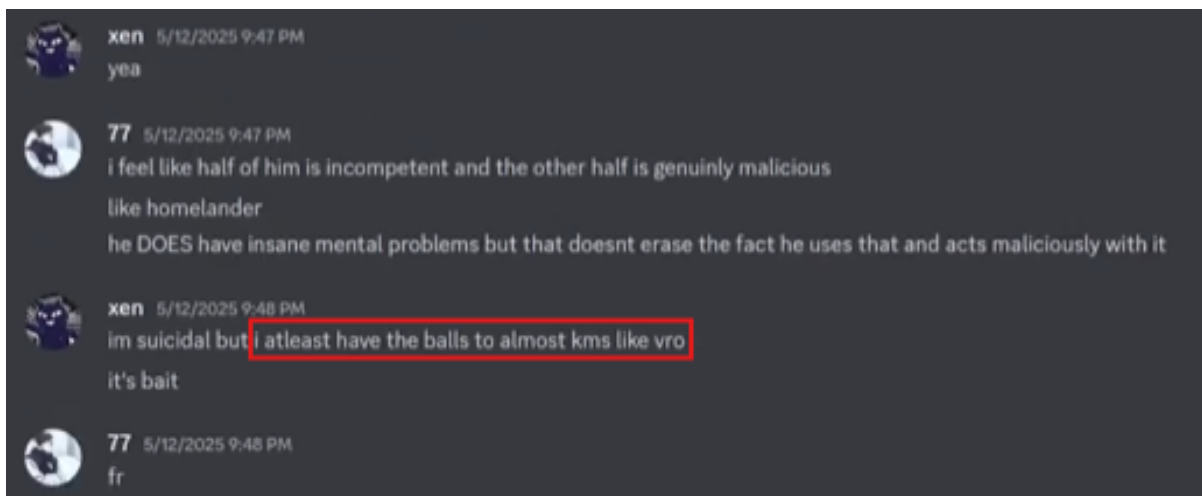
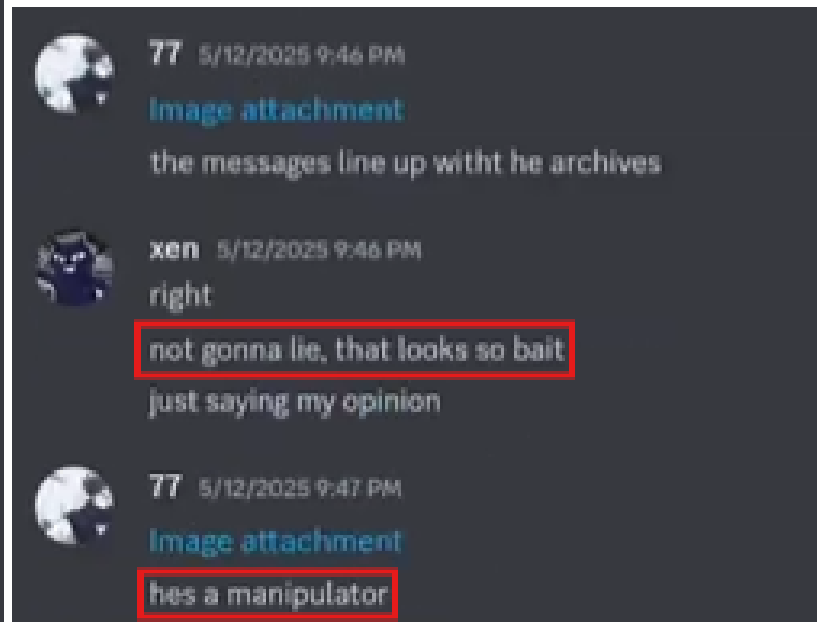
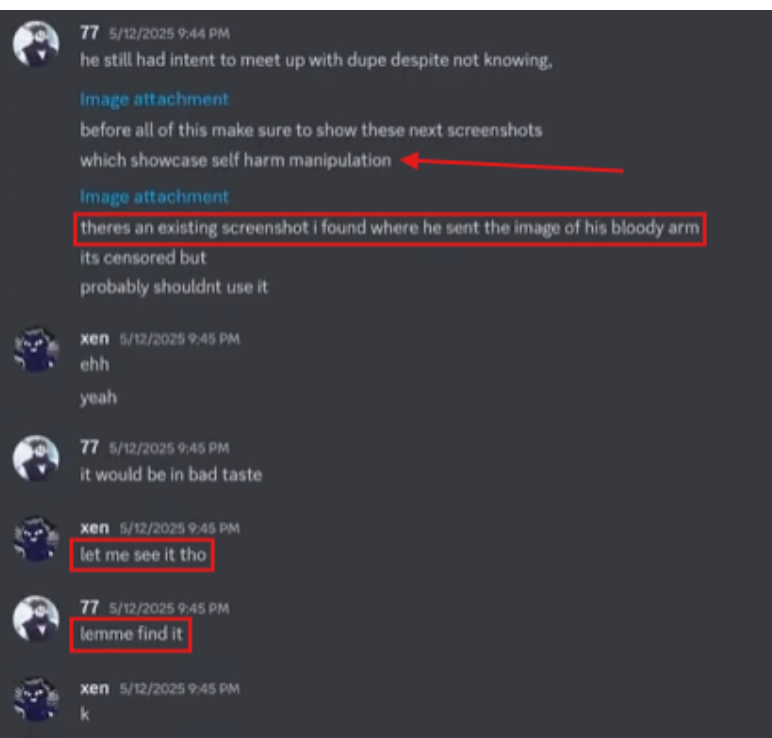

## 2. "Weaponized Self-Loathing" – A Strawman

77 frames my self-criticism ("*I'm hated for just reasons*") as a "guilt trip." This is absurd:

- Self-Loathing ≠ Manipulation: Depressed individuals vocalizing shame isn't coercion—it's a cry for help. By 77's logic, *any* expression of guilt becomes

"emotional blackmail," which silences mental health discourse and 77 along with his associates have made their intentions crystal clear in this matter- to directly submerge the discourse surrounding my mental health, pluck aspects of it to feign the idea of it being manipulation, or use buzzwords to make it seem malicious and to make fun of it.



## Analysis of 77 and Xen's Malicious Behavior

These screenshots reveal deeply unethical conduct from 77 and his associate Xen, demonstrating:

1. Mockery of Mental Health
2. Bad-Faith Character Assassination
3. Hypocrisy and Exploitation of Suicide for Clout

Let's break down the severity of their actions.

### 1. Mocking Mental Health & Suicide

Xen's Statement:

*"I'm suicidal but I at least have the balls to almost [take my own life]... it's bait."*

- Disgusting Implications:
  - Gatekeeping Suffering: Xen implies that *real* suicidal people "have the balls" to attempt, while dismissing my struggles as "bait." This is textbook victim-blaming, reinforcing harmful stereotypes that only *visible* self-harm is valid.

- Suicide is not a competition. Xen and 77 weaponize survivorship bias to delegitimize my pain—a tactic used to silence vulnerable people.

## 2. False "Manipulator" Allegations

77's Claim:

*"He's a manipulator."*

Reality Check:

- Dupe's Own Words: *"You never groomed or manipulated me. I manipulated YOU."*

Earlier, 77 claimed:

Yet he still circulated the screenshot, proving:

- Exploitation: Using my self-harm imagery as shock value to reinforce his narrative.

This is the definition of hypocrisy.

#### **5. Xen's Role: The Orbiter**

77 openly lies in his document, sidestepping key aspects of the apology to only include systematically cropped aspects of my messages to push forward a broken narrative. He claims that I 'do not seem to understand the core of what I did wrong', but this is immediately discredited by a major portion of my apology in which he purposefully does not include where I am seen stating verbatim that the behaviour was repulsive on my part and I will ensure that I NEVER make that mistake or error again. 77 undercut the sincerity of my apology to openly pin me as a non-apologetic manipulator.

- Dupe confirmed that I respected boundaries **post-apology** ("*you never made me uncomfortable*"). This would also be corroborated by numerous messages I made ensuring that I always seeked his

77's methodology exposes his bias:

After apologizing, Parlo immediately pivots to worrying about how he's perceived:



**This undercuts THE ENTIRE APOLOGY. True accountability doesn't ask for emotional reciprocation. It doesn't say:**

- "I'm sorry, but you also hurt me."
- "I'm sorry, but now I'm scared and isolated."
- "I'm sorry, do you still respect me?"

**This ultimately shows that the apology was not unconditional, it was a negotiation.**

Ironically, this is 77's main attempt to undercut my apology, however it has gone about so maliciously, that it is easily able to be dismantled. I was sincere in my apology and I did regret my actions, me following up with the statement, 'but the post you made hurt', is **not now asking for emotional reciprocation**. It me being transparent at a point where I was being honest and truthful, it is not intended to underscore or elicit a form of

reciprocation statement, it was to tell Dupe how I did not appreciate what he had done in regards to his own actions. The bullet points provided by his ChatGPT analysis have no relevance to the situation and are **absurd / disenfranchised comparisons** to what was actually stated.

The apology was **not a negotiation**, that is a word 77 implemented with no diagnostic or definitive rigor to undermine my apology.

#### IV. Conclusion: The Truth vs. 77's Fabrications

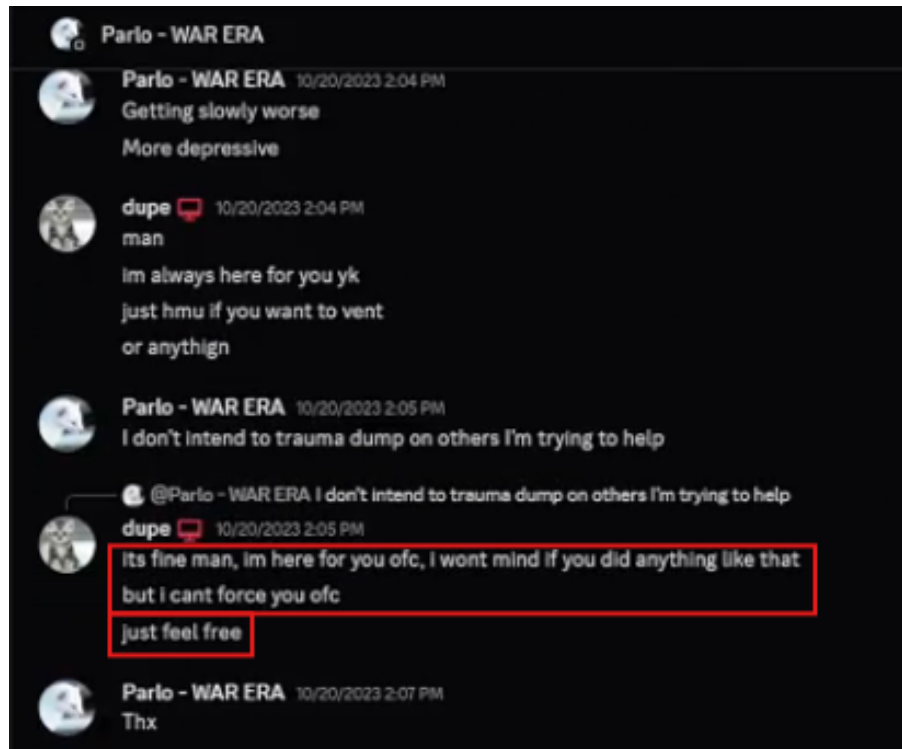
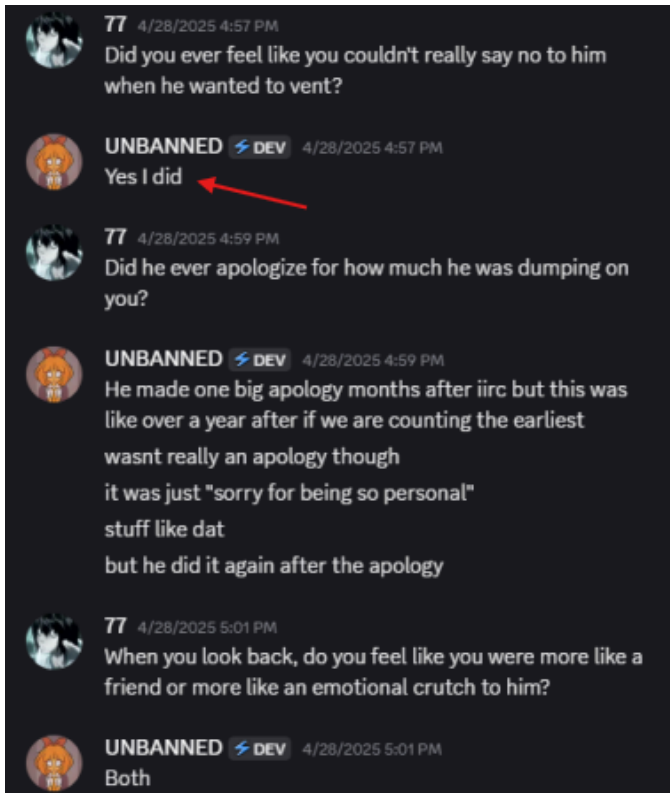
- My apology was flawed and the structure was bad (as all human apologies are) but I was genuine and extremely emotional and sorry, evidenced by my changed behavior and Dupe's vindication.

Xero was 15 and making crude and inappropriate comments directly to him which 77 further pushes and affirms, despite the severity of the situation they clearly were not taking it seriously.



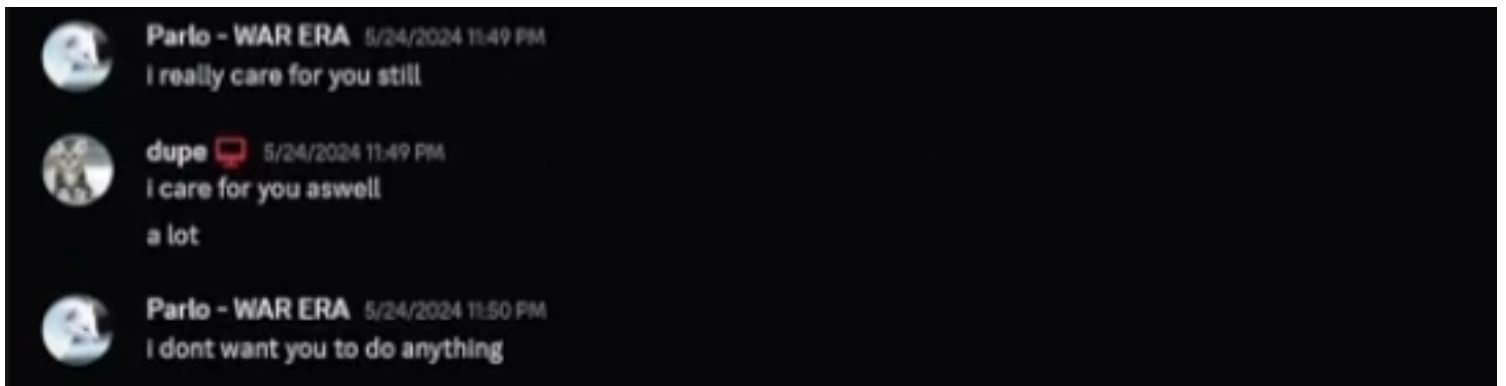
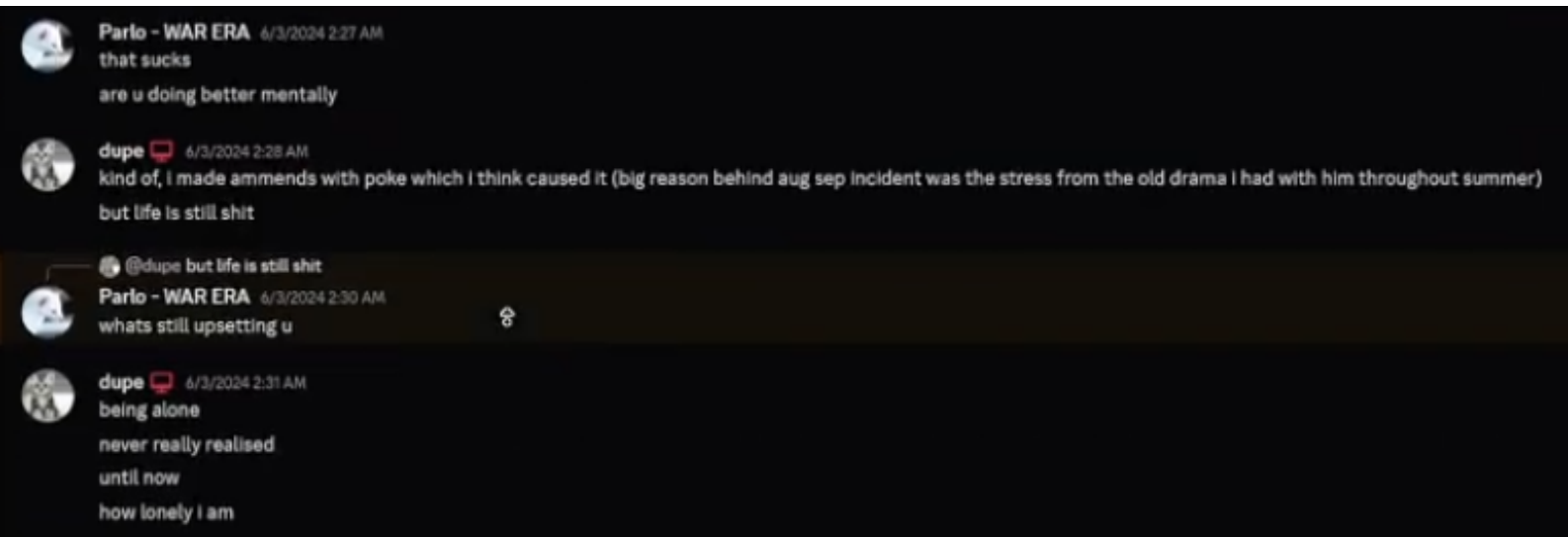


## Weaponized Vulnerability

This is not about shaming someone for having mental health struggles. The issue is with how those struggles were weaponized. Instead of fostering mutual support, Parlo created one sided emotional dependencies, where others felt responsible for his well being, but got little to no support in return.

This was an egregious misrepresentation of the dynamic that me and Dupe had in DM's, exacerbated by the fact that 77 had access to the entire chat logs, but openly chose to selectively crop out numerous messages that went against his malicious framing and narrative.

The statement that Dupe got 'little to no support in return', is an open lie, 77 knew that I had personally helped Dupe in numerous instances, telling him to improve his diet, trying to push him out of anorexia, trying to ensure that he never took drugs and even trying to push him to increase his social ability with other people. This was written in my first Dupe counter document but was cropped out of 77's 'counter' document to it.

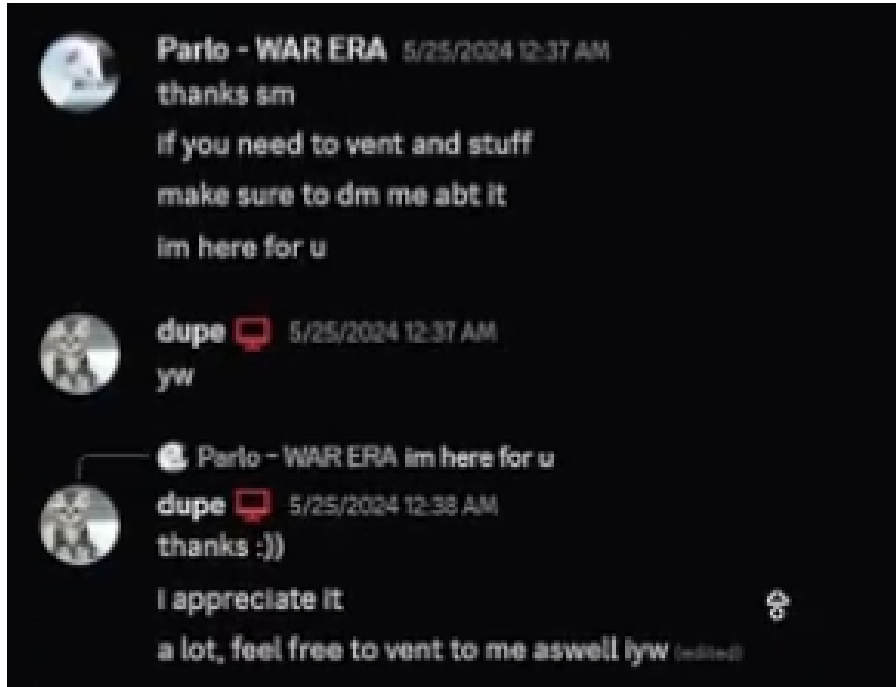

## Rebuttal to 77's Misleading Characterization of Parlo and Dupe's Relationship

The screenshots provided by 77 cherry-pick and distort the nature of Parlo and Dupe's interactions, framing a mutually supportive but flawed friendship as one-sided emotional manipulation. Below is a point-by-point deconstruction of these claims, backed by evidence and context.

### 1. Dupe's Contradictory Statements & Retrospective Bias

#### a. Dupe's Initial Gratitude vs. Later Accusations

- Prior to May 2025, Dupe repeatedly thanked me for my support:
  - "you were the only person who was there for me, you stopped me from committing suicide." (11/12/2023)
  - "Thanks for helping me in my depressive times." (24/12/2023)
- Yet in April 2025, under 77's leading questioning, Dupe suddenly claims:

- *"Nearly every time [I felt drained]."*
- *"I guess he used me as an emotional outlet."*

Analysis:

- Dupe's earlier messages show no resentment—only appreciation.
- His later claims contradict his own words, **suggesting** coercion by 77's narrative framing. Dupe was seen openly having told me that our dm's were a safe space for discussion about mental health and to vent, and he had utilised messages with me to vent about his situations too. The fact that all examples and mentions of this have been obfuscated paints a one-sided dynamic in this relationship that was simply not true.
- The dynamic was co-dependent and I vented to someone I believed to be a peer and someone near the same age as me, negating the idea of me retroactively knowing that there was a large age gap dynamic between us.

b. Dupe's Admission of Manipulating Parlo

- In May 2025, Dupe admitted:
  - *"You never groomed or manipulated me. I manipulated YOU."*
  - *"I dated you out of free will." - Corroborated by July messages in which prove that he was not pressured into a relationship.*
- This directly undermines 77's claims of Parlo being the manipulator. Dupe was able to maturely take accountability when necessary, 77 seeks to degrade that admission by making unsubstantiated claims to poison the well to his personal benefit.

Conclusion:

Dupe's April 2025 statements appear retrospectively skewed by 77's agenda, while his May 2025 apology confirms my lack of malicious intent, at any opportunity when I have discussed to Dupe if he was uncomfortable, he had openly stated that there was no problem.

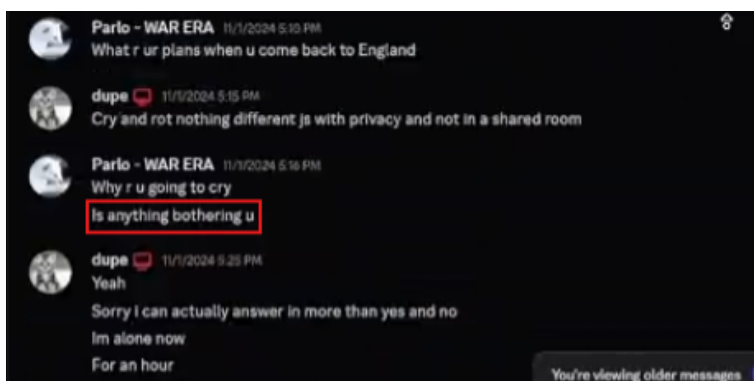
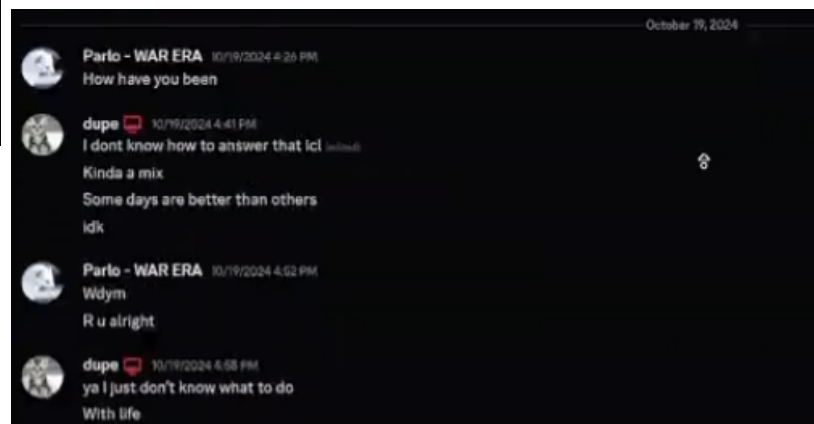
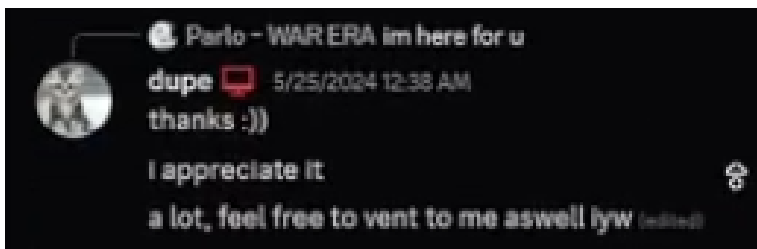
2. Debunking the "Weaponized Vulnerability" Narrative

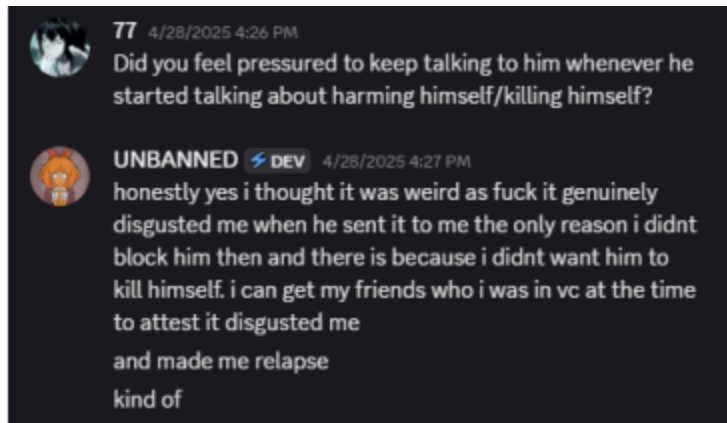
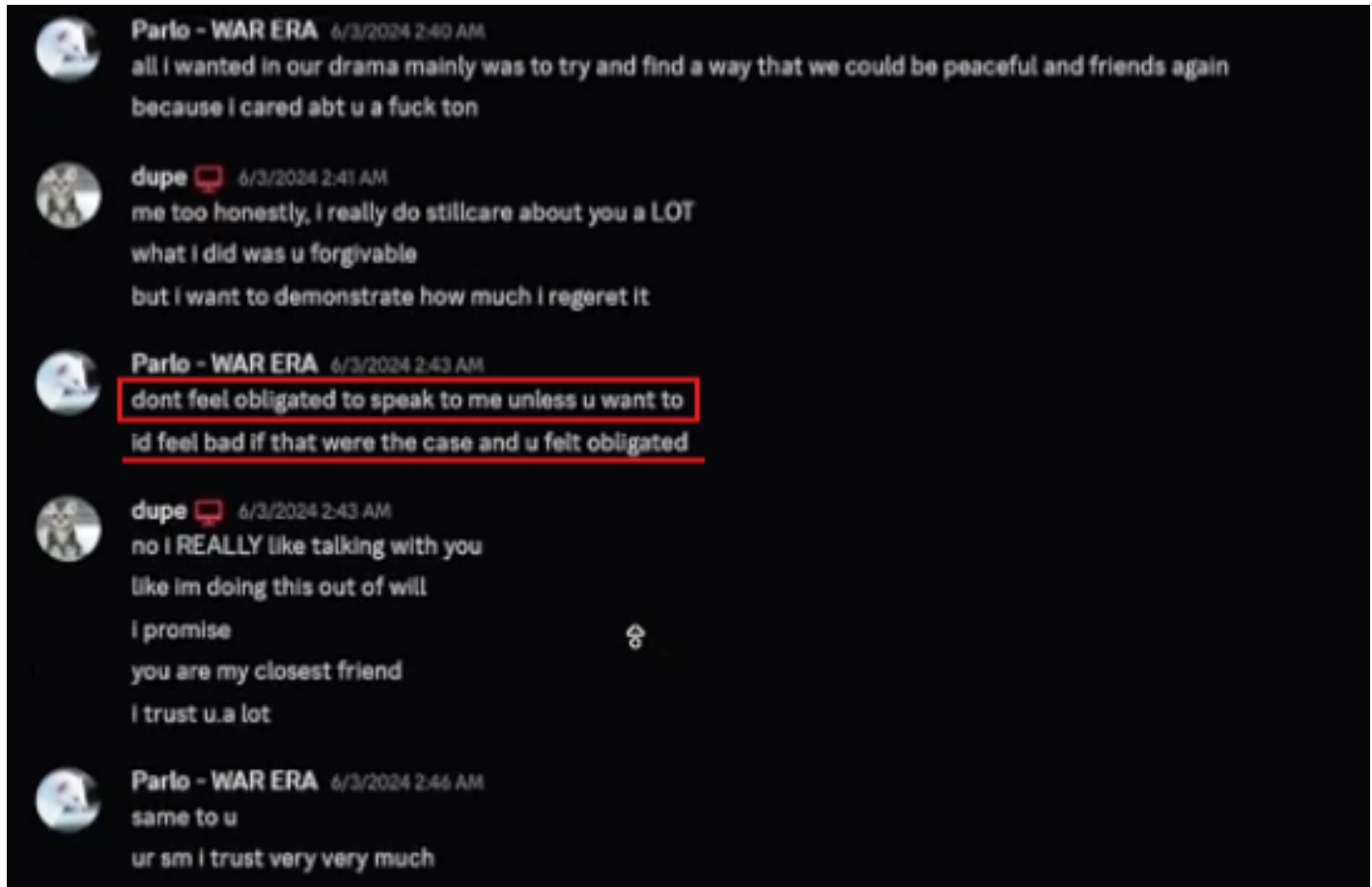
a. Mutual Venting, Not One-Sided Exploitation

- I did vent about my struggles and so did Dupe:
  - Dupe: "I want to go so badly it's all I want." (29/10/2023)
  - Parlo: "I don't want to discuss that [my mental state]." (1/12/2023)
- We BOTH engaged in emotional exchanges, yet 77 only blames me, re-contextualised the entire situation and pins it as malicious isolationary statements made to entice and restrict someone - This is a complete lie.

I was unable at the time to know that Dupe was lying about his age, and his perhaps 'true' opinions when it came to what seemed to be mutual vent posts. It was my responsibility to ask for ID verification and I took accountability. The effect may be different in the case of Dupe handling serious and emotionally taxing information, but in no means does this degrade the fact that I was lied about in regards to his age, and now that suddenly strips my negligence and twists it to a malicious nature.






The actual DM's between me and Dupe present an entirely different story. I had openly told Dupe to not feel obligated to speak to me unless he personally wanted me to. I respected his boundaries and was very much sorry for the self harm situation that transpired a week beforehand. Instead he was seen stating. 'I am doing this out of will, I promise', along with stating that he 'REALLY liked talking with me'.



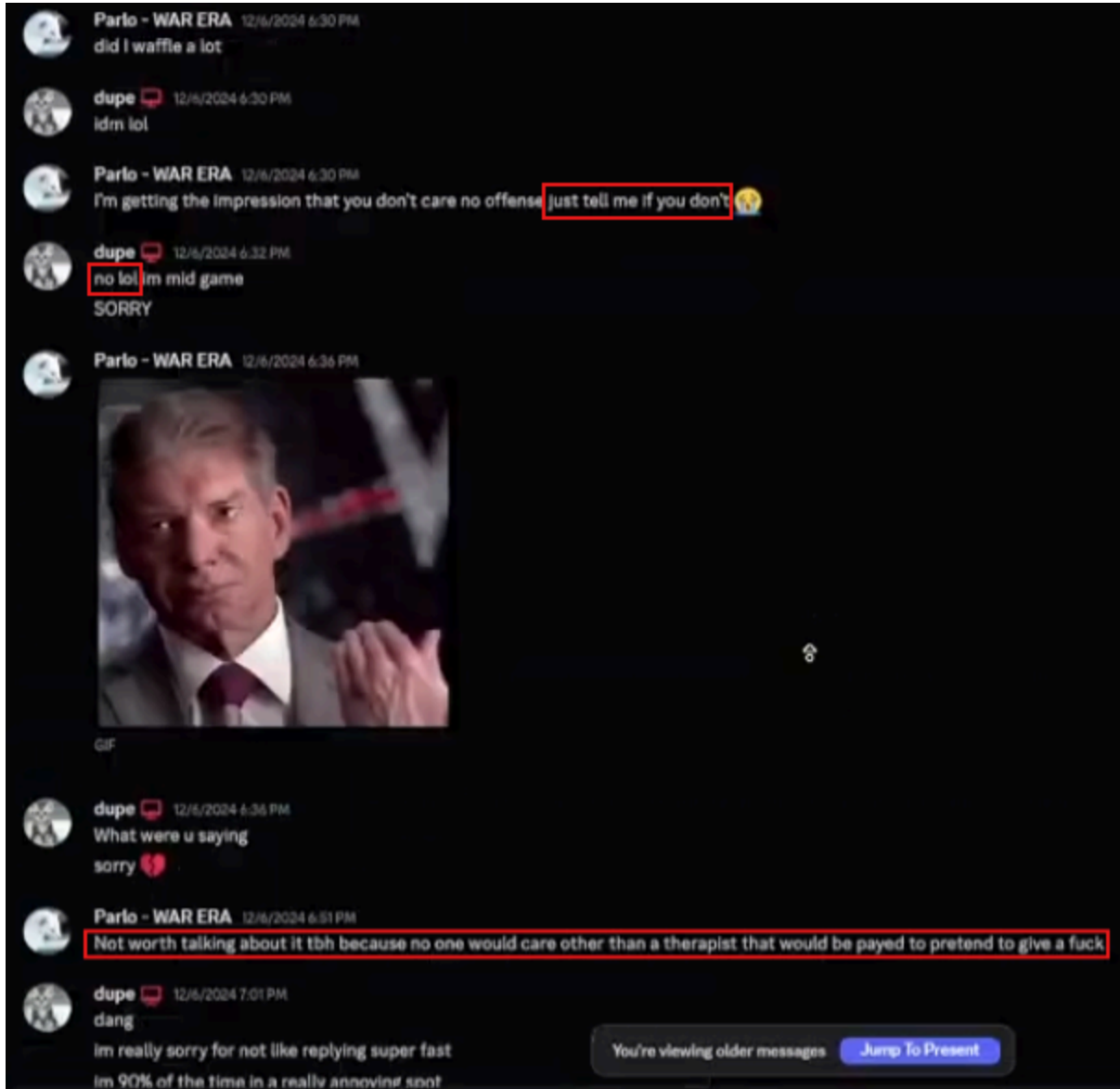

I will not be bashing Dupe in this document. I will instead, correct some more misinformation in which he had stated to 77. This of course, is discredited by his messages at the time which enforce his willingness to actually hear what I wanted to say, despite me telling him to be transparent.



Again, I should have absolutely done more to ensure that I knew Dupe was 100% 17. However, I did not under any circumstances know that Dupe was personally affected by these messages because in numerous instances, he had affirmed that he did wish to hear and that I was not making him uncomfortable.

I don't deny that the venting posts have absolutely negatively affected him considering he was in actuality 12 - 13. But to frame this as a carefully calibrated example of grooming and one-sided manipulation is so unbelievably callous and pathetic.

- Dupe lied about his age for two years, yet 77 never holds him accountable. This factor has MASSIVE implications on the entire subject, as much as 77 attempts to brush it off as it not.
  - 77 has a sustained habit of comprehensively ignoring or employing intense mental gymnastics to play down or sidestep the behaviour of people who have done objectively bad things, if it means it complicates his own twisted narrative.





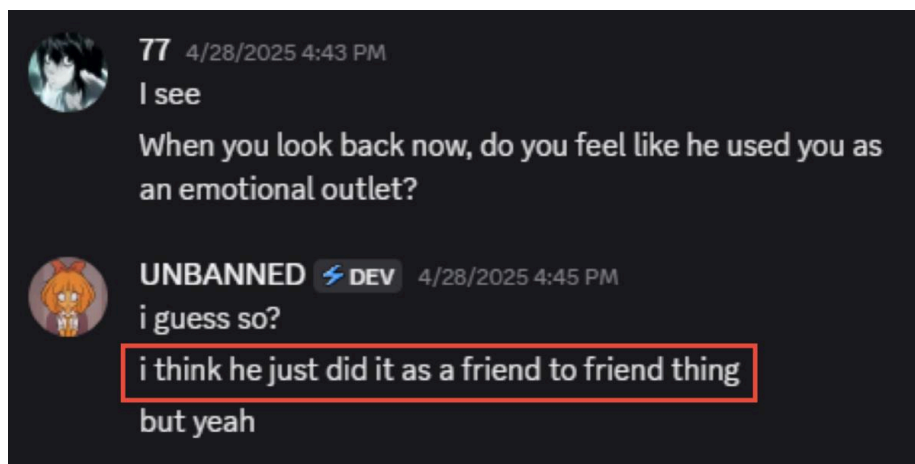


Dupe had even confirmed [when he disliked me on April 28th 2025] that the self harm situation of early 2024 was a “**one off incident**”, that I apologised for and addressed. This does not nullify the situation, but instead corroborates my aforementioned statement that this was never replicated again.

77 attempts to pry Dupe for any information that I “told him to not talk to other people about what I said to him”, to which Dupe affirms that I did not, only in regards to the “racist jokes”, which is a completely **unsubstantiated** allegation.

77 ultimately **fails at having any basis that I was secretive** in what I was doing or was forcing Dupe to remain silent about my interactions.





77 attempted to maliciously spin the situation and asked Dupe if he was used as an “emotional outlet”. Dupe stated verbatim himself that while yes he felt that I vented many times resulting in him feeling in that position, he stated I did it as a friend to friend thing. Which is objectively true, in 2024 especially I had a very little amount of people to speak to, me and Dupe were both mutual in terms of venting about our problems, he seems to omit that detail, but it was **certainly not one sided**.

There were **no instances** or guilt tripping, and once again this was more malicious framing of venting posts I had made, that Dupe ended up **leaking** nonetheless.

The claim that I attempted to “override parental boundaries”, is said nefariously to add on to the idea they are heavily pushing that I was a malicious predator.

However I had suggested meeting regardless of his controlling parents’ knowledge, because Dupe had consistently **vented** about how they were extremely restrictive on his ability to socialise and meet other people, this was **omitted** from the document however to make me seem nefarious and predatory.

Dupe had vented about his personal problems and so did I, however only my vent messages were presented to make the situation seem more **one sided** in a malicious way to **reframe** and **restructure** the dynamic of the relationship.

77 then attempts to claim that this behaviour was “calculated”, as if this was some pre planned mission to take advantage of a minor, when it was **under the idea** to have been a 1-2 year age gap between two sexually interested teenagers. Dupe has revealed his age to have been 12 turning 13 in March 2025, weeks to months after the idea of Hotels was brought up, to which I disengaged shortly after. Any inference that I knew he was significantly younger and yet engaged sexually is completely **false**.

Boundaries were not tested, they were **respected** by **constant affirmations** made by me on whether the topic of discussions made him uncomfortable or if he wished to continue. These again, were not malicious, it was sexual talking and discussions. They never escalated to nude exchanges or sharing of pornographic content. Because despite me believing he was 17, soliciting nude content would have still been illegal. I still conformed to the bounds of legality and never had an envisionment to want to take advantage of Dupe, as attested by his own messages when he still claimed to have been 17.

## 1. Definitional Collapse: What Grooming Actually Requires

Grooming, as a legal and psychological concept, necessitates:

- Intentional exploitation of power asymmetry (e.g., age, authority, influence) to condition a victim for abuse.
- Systematic erosion of boundaries through secrecy, isolation, or coercion.
- A clear predatory trajectory (e.g., sexualization escalating to exploitation).

Parlo's interactions fail these criteria:

- No power asymmetry was leveraged. Dupe was not a fan of Parlo's content, nor was he influenced by Parlo's platform (as confirmed by Dupe: *"I just thought it was kind of cringe"*).
- No evidence of boundary erosion. Parlo repeatedly emphasized consent (*"if you're comfortable"*) and respected stated limits.
- No predatory escalation. Sexual discussions occurred only after Dupe falsely claimed to be 16–17 (UK age of consent), and Parlo explicitly framed them as contingent on mutual interest.

## 2. Dupe's Agency and Deception

- Dupe admitted to initiating the lie about his age (claiming 16–17 to "impress" peers) and perpetuating it for years.
- He confirmed Parlo never solicited explicit content or leveraged influence (*"You never sent me any risky links/images/videos"*).
- Their romantic/sexual discussions were reciprocal (Dupe volunteered kinks like CNC/BDSM unprompted).

## 3. Legal vs. Moral Context

While UK law permits sexual discourse with 16+, the core issue is Dupe's actual age (11–13). However:

- Moral culpability hinges on knowledge. Parlo operated under the *reasonable belief* Dupe was 16–17, which Dupe reinforced for *two years*.
  - Grooming requires intent. Parlo's actions align with peer-level intimacy, not predation.

## II. The Self-Harm Incident: Debunking "Emotional Manipulation"

### 1. Context of the February 2024 Exchange

- Parlo's messages during the self-harm episode were reactive distress, not coercion. Examples:
  - "*Please dont man / I care abt you*" → Concern, not control.
  - "*Dude any self harm is bad*" → Disapproval of harm, not guilt-tripping.
- Dupe himself stated the incident was isolated ("*that was at the time it's whatever now*") and denied manipulation.

### 2. 77's Narrative Fallacies

- Cherry-picking: 77 conflated the self-harm incident (a mental health crisis) with later sexual discussions (months apart) to fabricate a "pattern."
  - Ignoring reciprocity: Dupe *also* vented suicidality to Parlo ("*I don't want to be on this planet anymore*"), proving mutual dependency—not unilateral coercion.
  - False causality: No evidence suggests Parlo's venting "forced" Dupe to trust him. Trust developed organically, as Dupe attested ("*I dated you out of free will*").

## III. 77's Bad-Faith Tactics

### 1. Intellectual Dishonesty

- Strawmanning: 77 framed Parlo's *ignorance* of Dupe's age as *negligence*, despite Dupe's deliberate deception.
- Context stripping: Isolated messages (e.g., "*blood wall progression*") were presented as "proof" of abuse, omitting Dupe's own self-harm disclosures.
- Pseudoscientific labeling: Terms like "grooming" and "power imbalance" were weaponized without rigor (e.g., no platform influence was ever proven).

## 2. Malicious Motives

- Defamation by omission: 77 excluded Dupe's exonerating statements ("*You never groomed or manipulated me. I manipulated YOU*").
- Projection of bias: 77's "document" presumed guilt by default, violating basic principles of evidence-based critique.
- Exploitation of outrage: By conflating legal (age of consent) and moral frameworks, 77 engineered a narrative of "predation" for clout.

## 3. Hypocrisy

77's own tweets (e.g., "*emotional venting used to create guilt*") ironically describe his tactics:

- He pathologized normal venting between two troubled individuals.
- He ignored Dupe's agency to paint Parlo as a puppet-master.

77's narrative collapses under scrutiny because it:

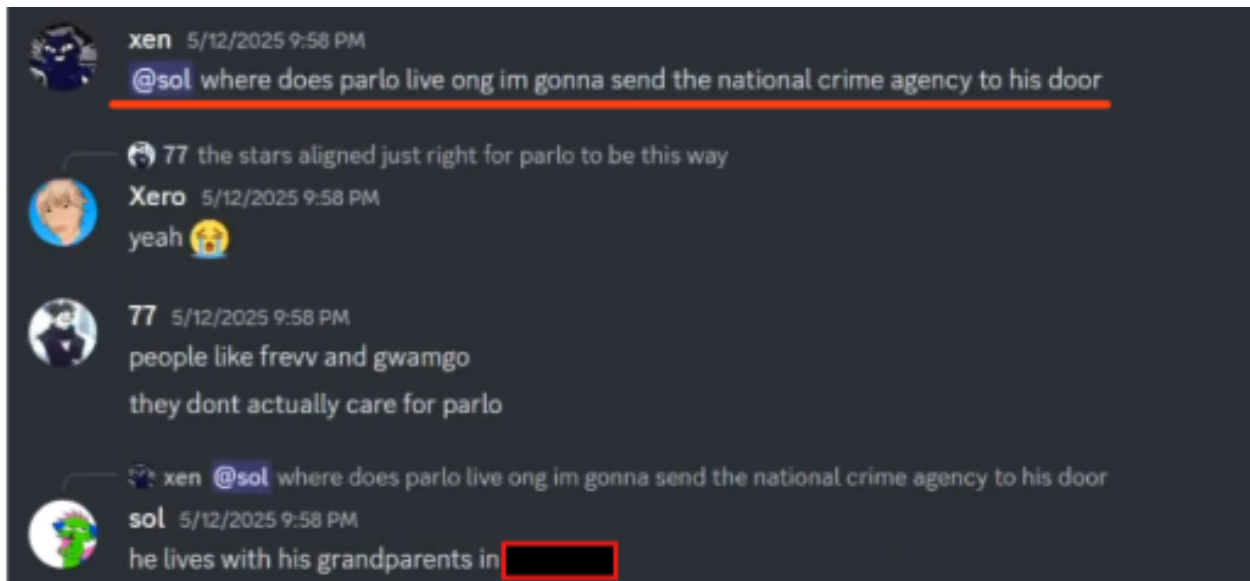
1. Misrepresents grooming by conflating it with *unknowing* interactions with a liar.

This is not activism—it's libelous opportunism. The record shows:

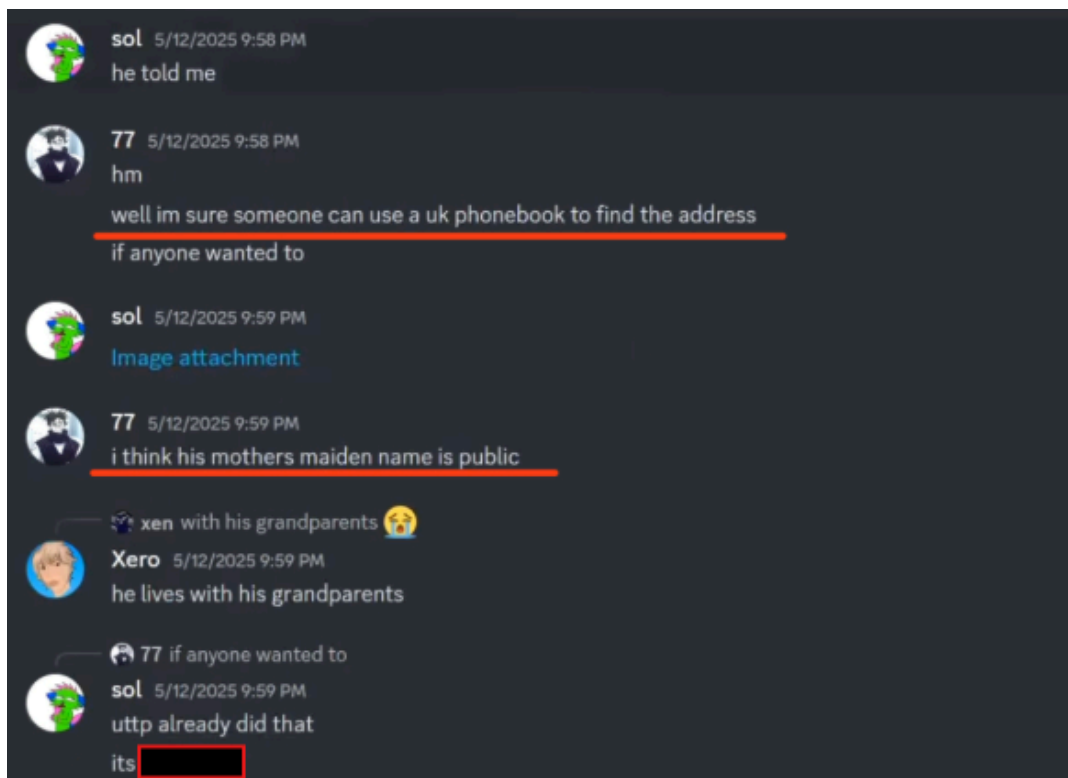
- Parlo acted in good faith under false pretenses.

Final Judgment: 77's argument is a house of cards—structurally unsound, morally bankrupt, and transparently malicious.

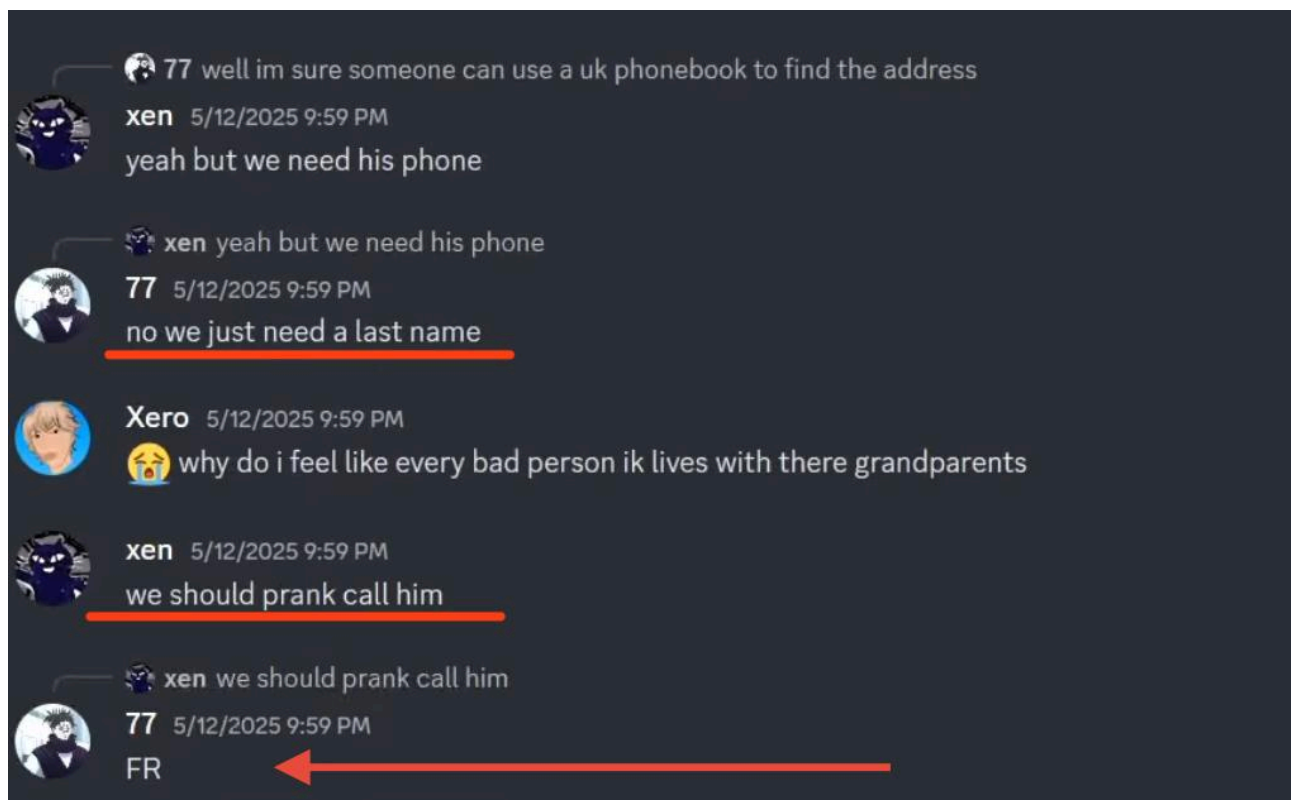
## 77 is a doxxer



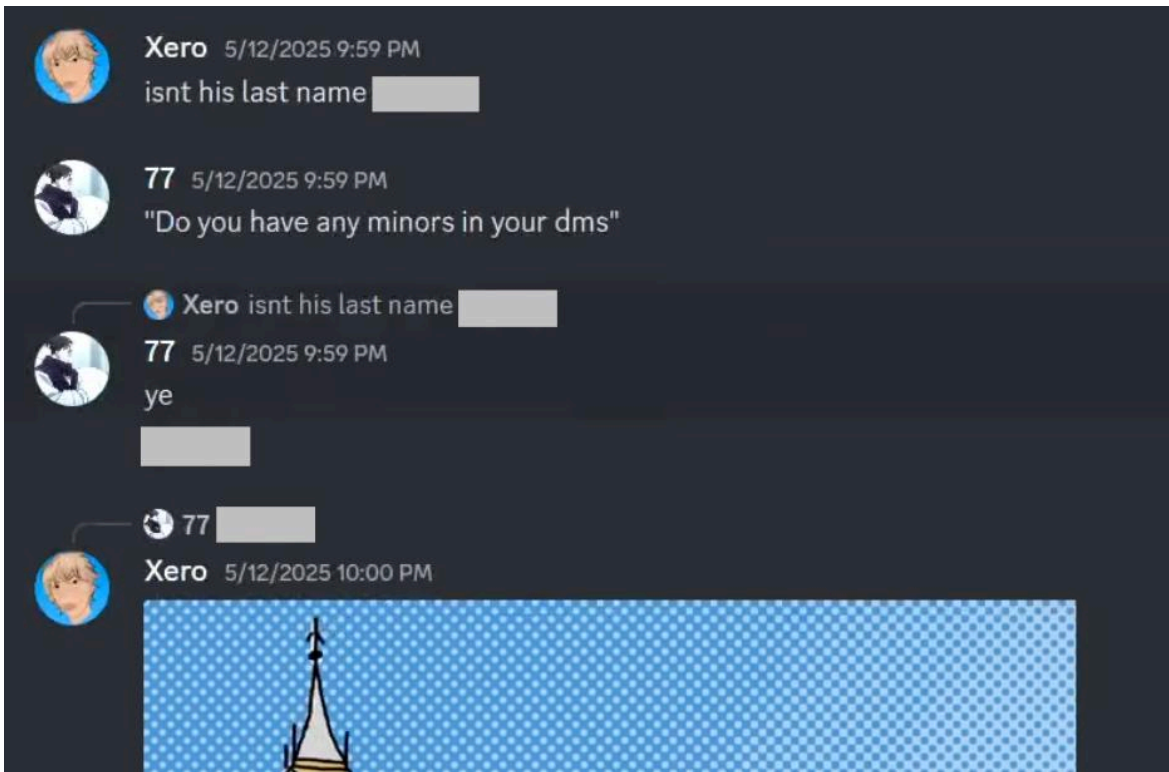

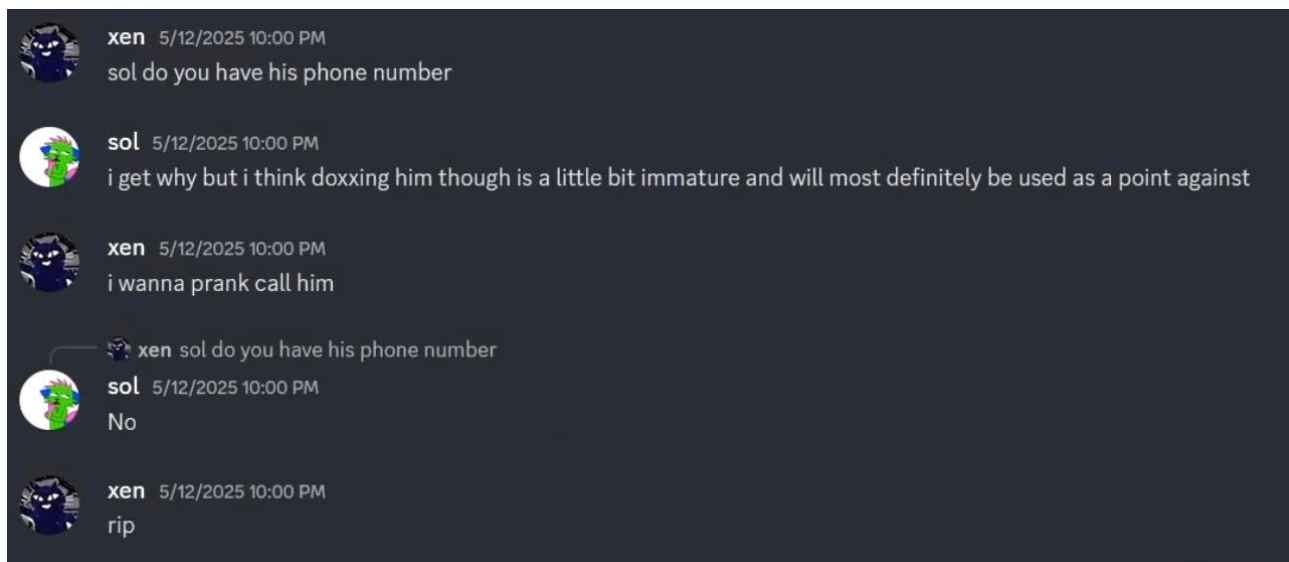

This entire conversation has now demonstrated that it was far detached from any 'heroic callout on Parlo', as it evidently has bled into an immature and borderline sociopathic stalker-like group chat with numerous users with vendettas attempting to decipher and obtain my personal information.



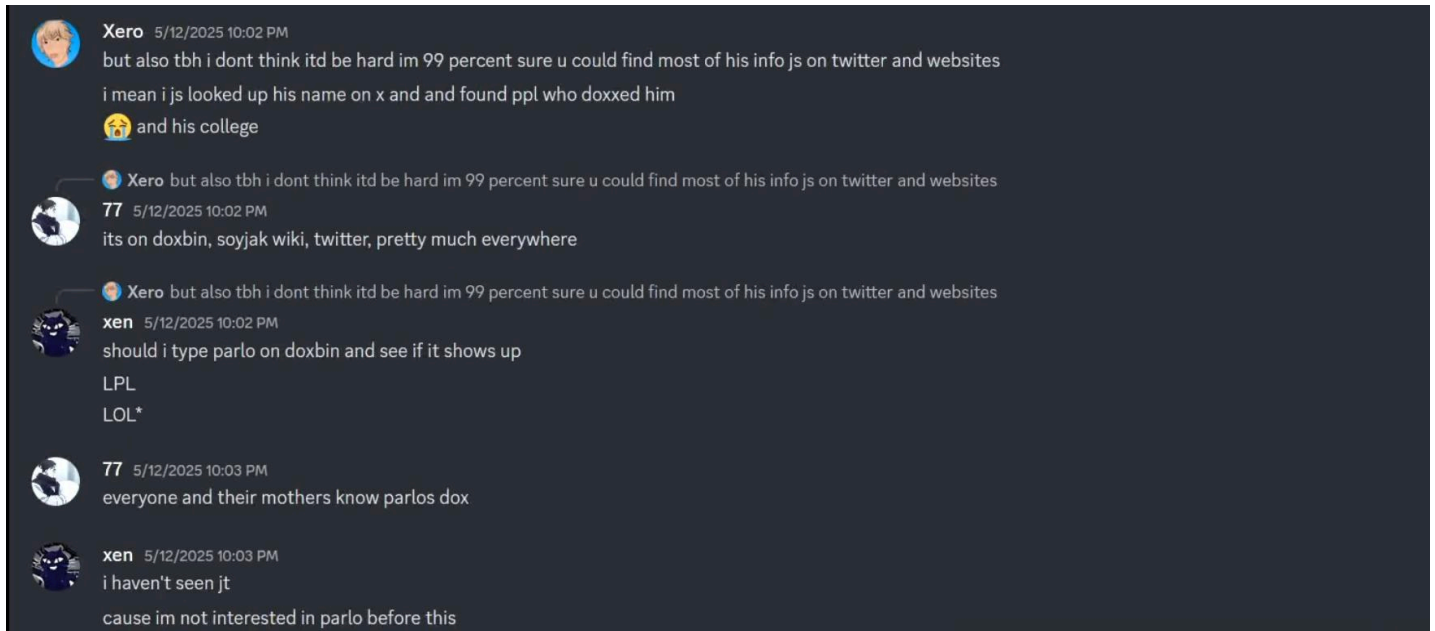

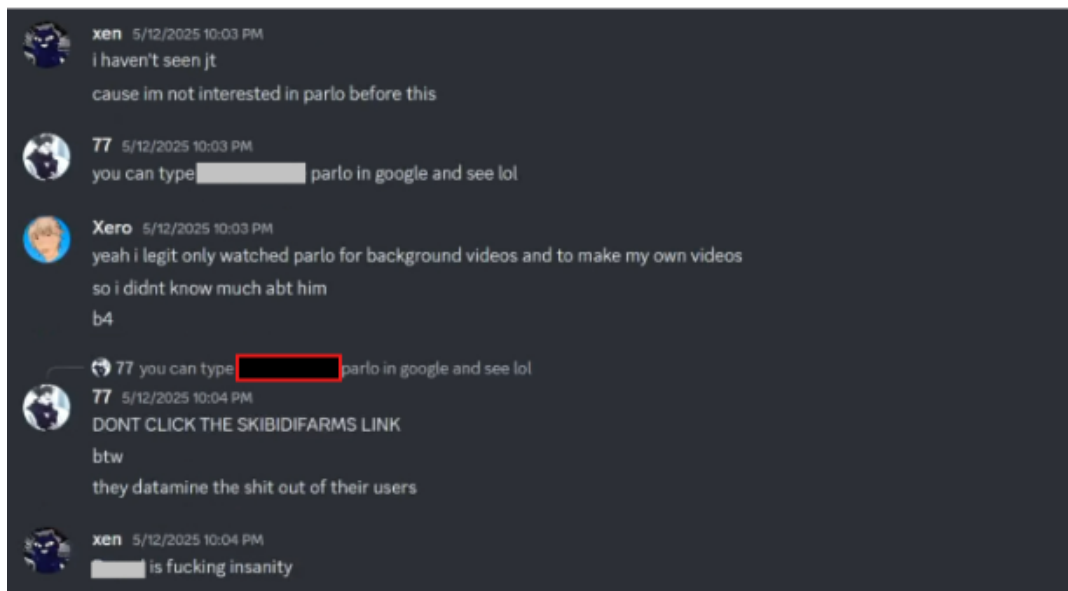

Xen is seen not being dissuaded and stating that he wished to prank call me, with Dupe stating he didn't have my phone number.

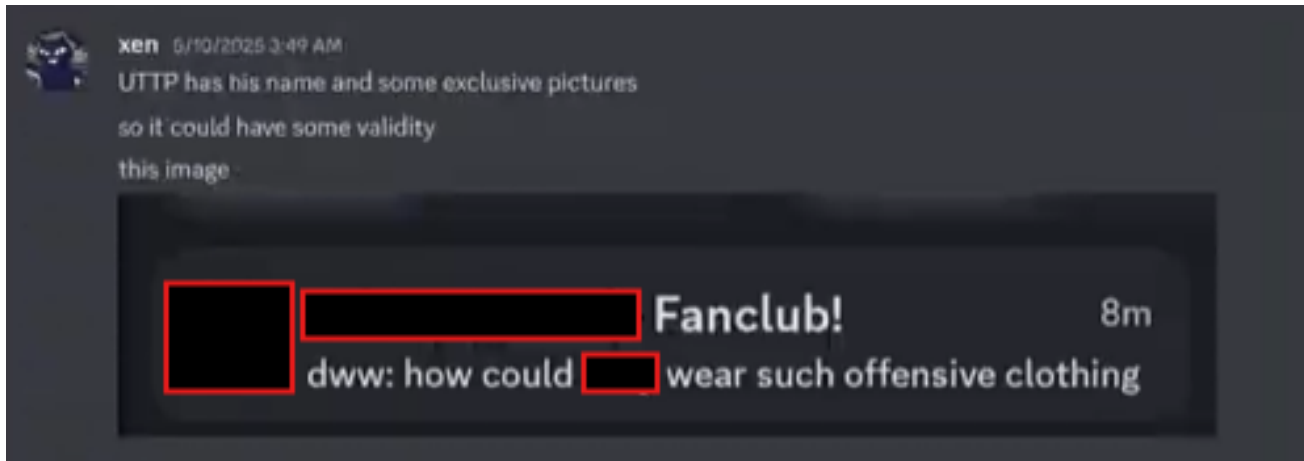

Which fundamentally changed nothing whatsoever, they were still sending images of my face, 77 was leaking my full legal name to Xen and Xero, 2 minors who did not know about this personal information pertaining to me. 77 was even instructing Xen who was a 16 year old minor on where to find my personal information alongside my family's personal information. This was after Xen made it known that he wanted to make a false report against me, prank call me and intimidate me.

Doxxing (or "doxing") is the act of revealing someone's private/identifying information (e.g., full name, address, phone number, workplace) with **malicious intent** or **reckless disregard for their safety**. Even if the information is *technically* public (e.g., found through 'legal' means), sharing it in a context that could lead to harassment, stalking, or harm **qualifies as doxxing**.

## Why This Still Counts as Doxxing (Even in a Private Discord GC with Minors)

1. Doxxing Isn't Just About Public Exposure
  - Many people assume doxxing only "counts" if the information is blasted publicly (e.g., posted on Twitter). This is false.
  - Doxxing includes privately sharing someone's personal details with others who didn't previously have that information, especially if it could lead to harassment, stalking, or other harm.
  - The fact that it was in a private group chat with minors doesn't make it less dangerous—it actually makes it more reckless, as minors may not fully grasp the consequences of misusing that information.
2. The Act of Teaching Minors How to Dox is Itself Harmful
  - Even if the minors didn't act on the information, 77:
    - Normalized invasive behavior (teaching them how to essentially stalk someone online).
    - Put me at risk (one of the minors was open about sending governmental figures to my house via false reports).

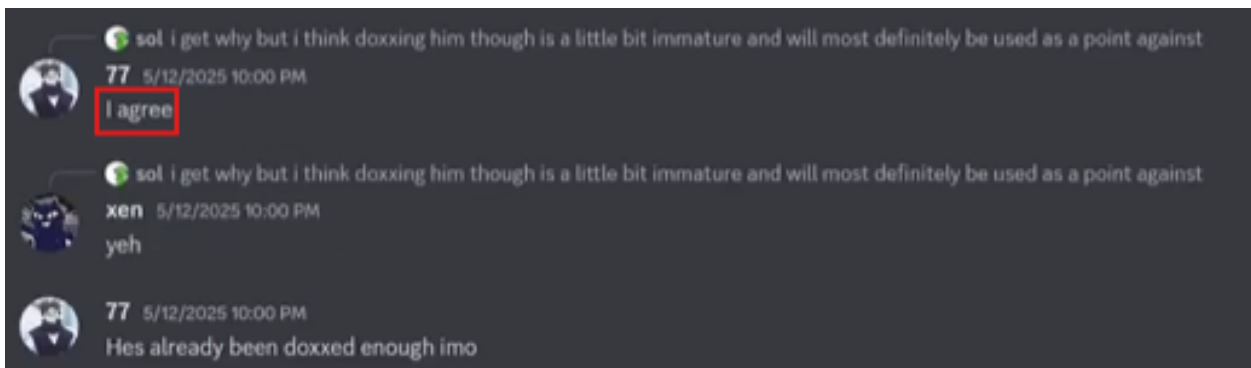
- This is like handing someone a weapon and saying, "I'm not telling you to use it, but here's how." The act of distribution is the problem.
3. The Information Was Shared Without Consent
- My Full legal name was disclosed without my permission to other minors who were present in this GC. Even if it was "findable" online, compiling and sharing it in a targeted way is what makes it doxxing and 77's intentions have been made clear.
  - If the minors didn't know this info before, 77 actively expanded the circle of people who could misuse it.



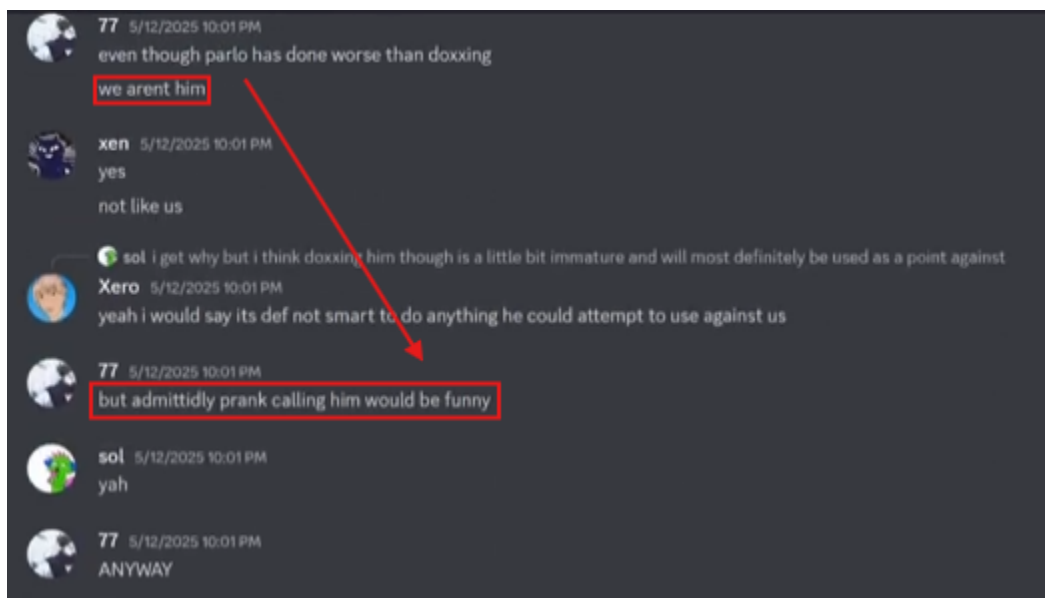
## Why It Was Immoral (Beyond Just the Doxxing Itself)

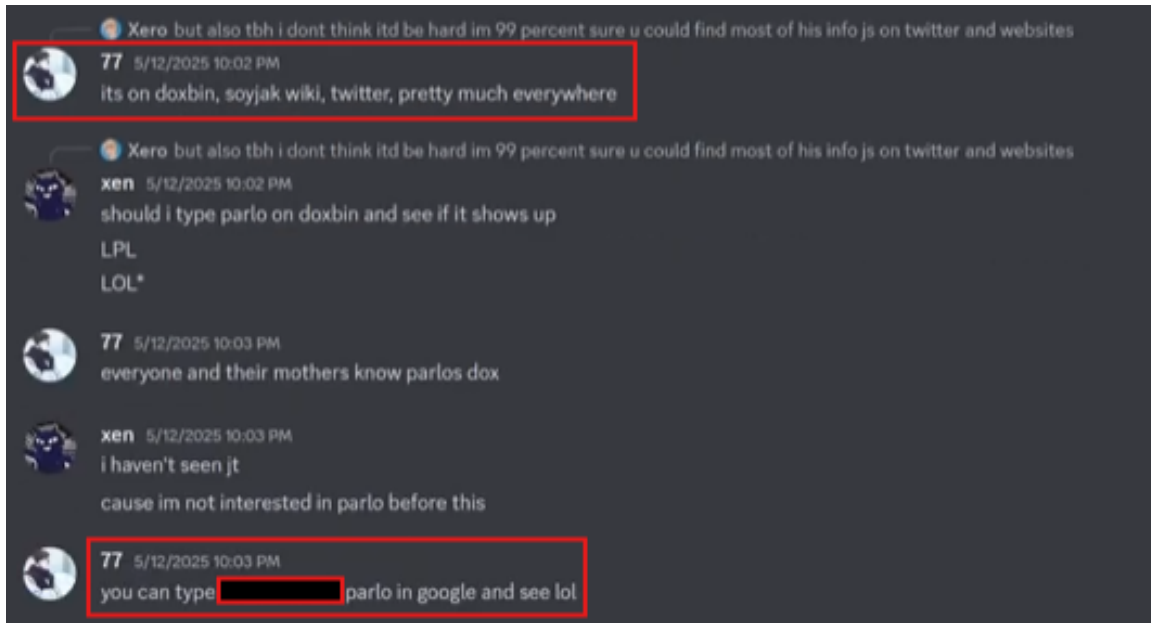
1. A 13-Year-Old [Dupe] Shouldn't Have Been the One to Enforce Boundaries

  - If the 13-year-old hadn't spoken up, could the others have thought, "*This is normal?*"
  - The irresponsibility of exposing young teens to doxxing methods is a separate ethical violation and is deeply hypocritical as 77 attempted to weaponize my situation with SC99 & Soulless, despite completely stripping that situation of all necessary context.



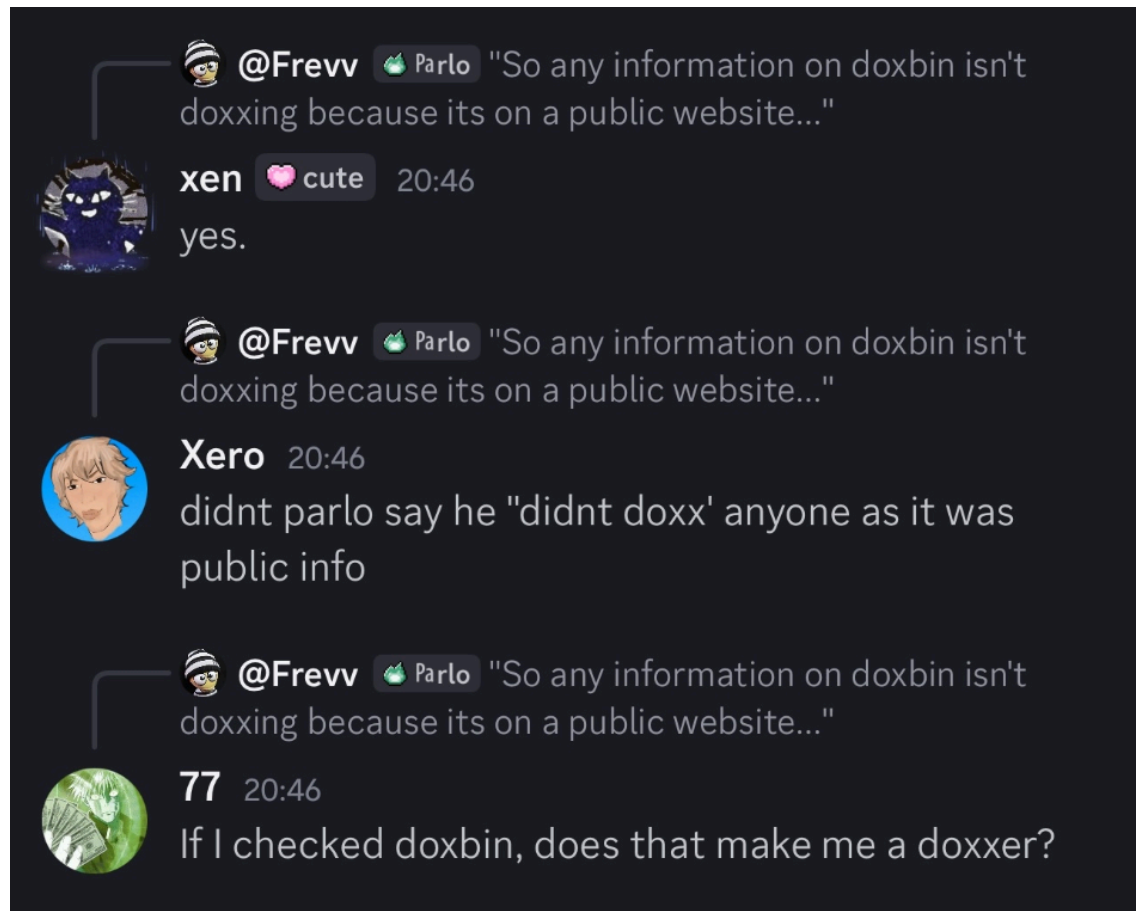
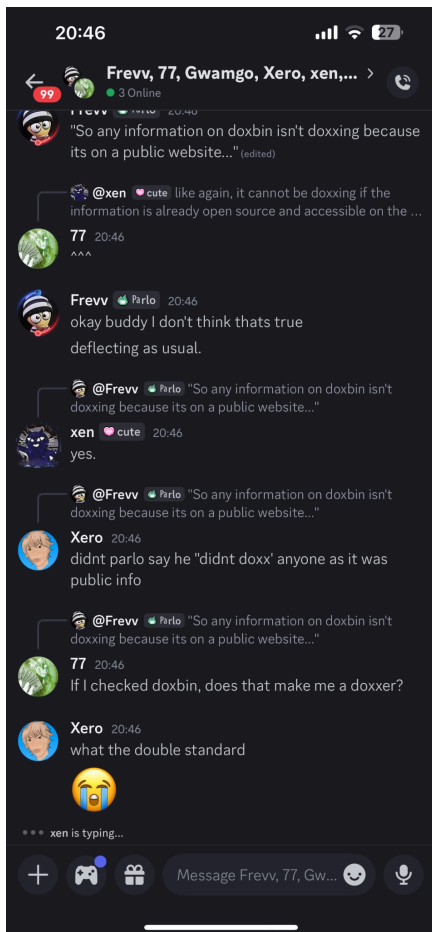

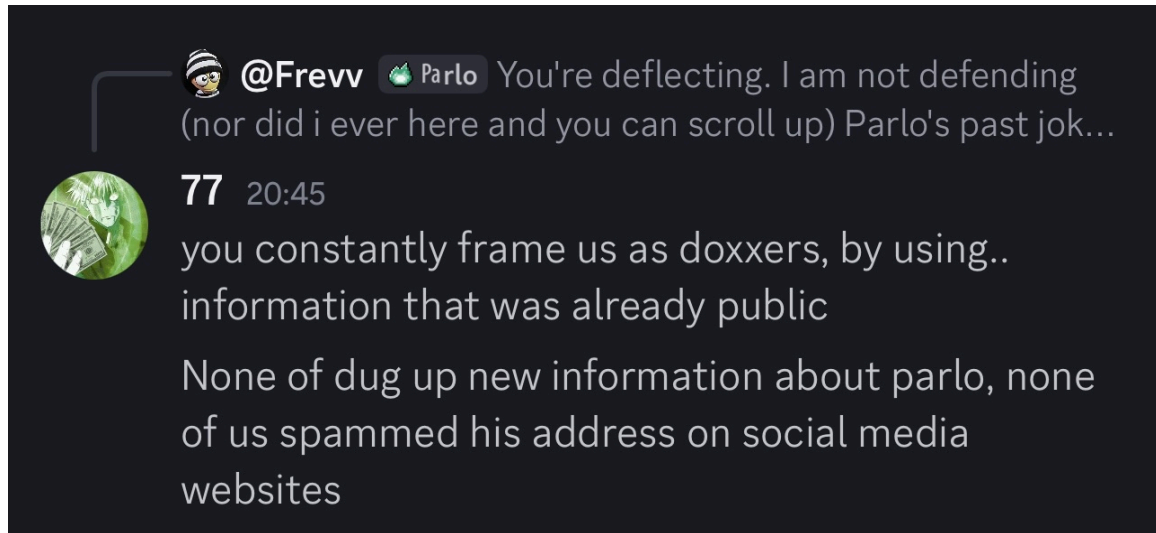




This was then followed a minute later by 77 telling and informing 2 minors who did not currently know my dox and personal information at the time, how to effectively find it, as well as stating my full legal name to them.

77's entire defense and argument is redundant, in fact if you analyse the logs it makes him look worse, he actively knew the ramifications behind his actions and that engaging in doxxing me was immoral, yet he continued regardless. A 13 year old had to be the voice of partial reason.





77's defense after being caught redhanded in private doxxing me, making threats and other egregious claims, was laughably terrible. Attempting to justify his actions of encouraging minors to search for, and find my personal information.

## 1. 77 Committed Doxxing—Even in a Private Chat

*"It's not doxxing because the info was public and we didn't spam it everywhere."*

Doxxing is not defined by publicity alone—it's defined by:

- Intent: Sharing personal info to enable harassment (e.g., Xen's threats to send law enforcement).
- Audience: Giving your details to people who didn't have them (Xero & Xen).
- Method: Directing them to doxing websites (Doxbin) and teaching them how to stalk you.

- Cyberstalking Laws (U.S./U.K./EU): Criminalize intentionally exposing someone to harassment, even via "public" data.

77 didn't just share my legal name and how to obtain my information—he armed my harassers with it.

### **3. "Doxbin Is Public, So It's Fair Game" – Categorically False**

*"We used Doxbin, so it's not doxxing."*

- Doxbin is a known harassment hub. Using it as a source proves malicious intent.
- Personal info is still "doxxed" even if leaked elsewhere first. Otherwise, every stalker could say: *"But it was on Whitepages!"*
- Platforms ban linking to doxing sites (Discord/Reddit will suspend users for *mentioning* Doxbin).

If I steal your Social Security number from a hacked database and DM it to your enemies, *"But it was already leaked!"* isn't a defense.

### **4. "77's" Hypocrisy on Privacy**

Ironically 77 claims *"we didn't dig up new info"*, but:


- He still spread it to 2 minors who openly did not know my personal information (Xero/Xen).

He cites a private Discord group chat joke about prank calling him as evidence of a "sociopathic stalker ring."  
But, this is a **deflection**. Me and others *joking in poor taste* doesn't negate any evidence about Parlo's actions.

No jokes made change the facts that:

- **Parlo emotionally confided in a child**
- **Parlo lied and contradicted himself about cutting off Dupe**
- **Parlo's inner circle has harassed victims and whistleblowers, Dupe being one of them**

**One out of context screenshot doesn't undo 100 pages of consistent pattern documentation.**

## Debunking 77's Hypocritical Defense: A Masterclass in Deflection

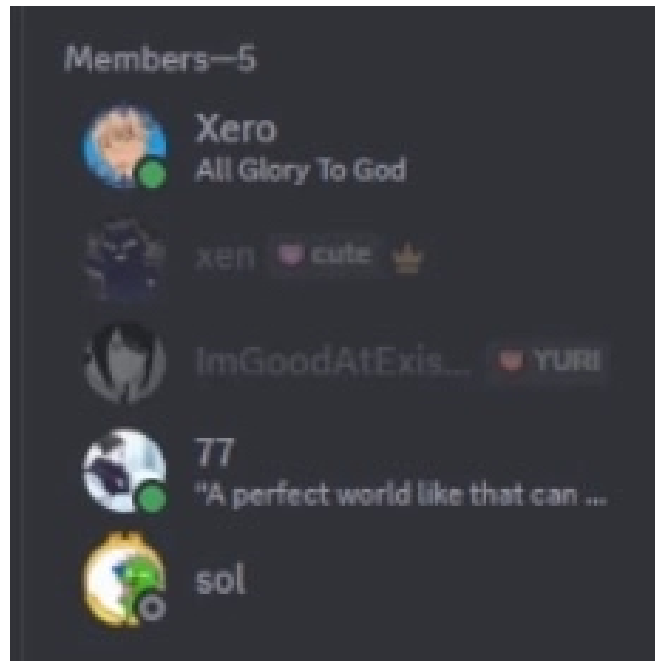
Conclusion:

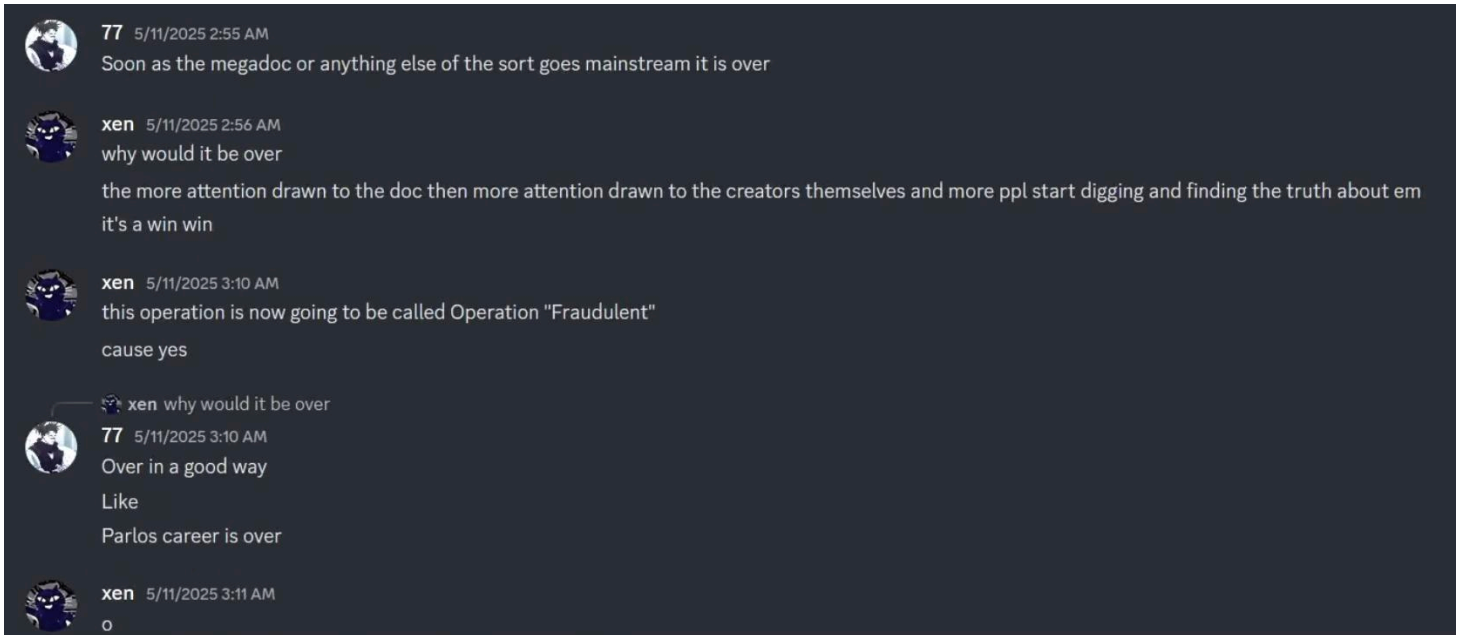
Key Takeaway:

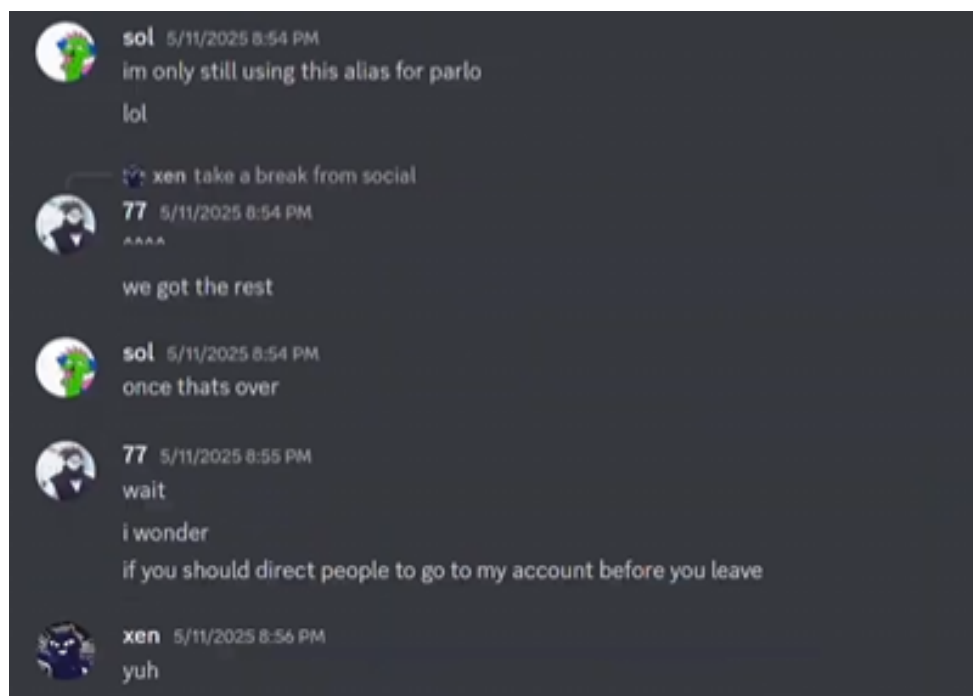


## 77 incentivises clout

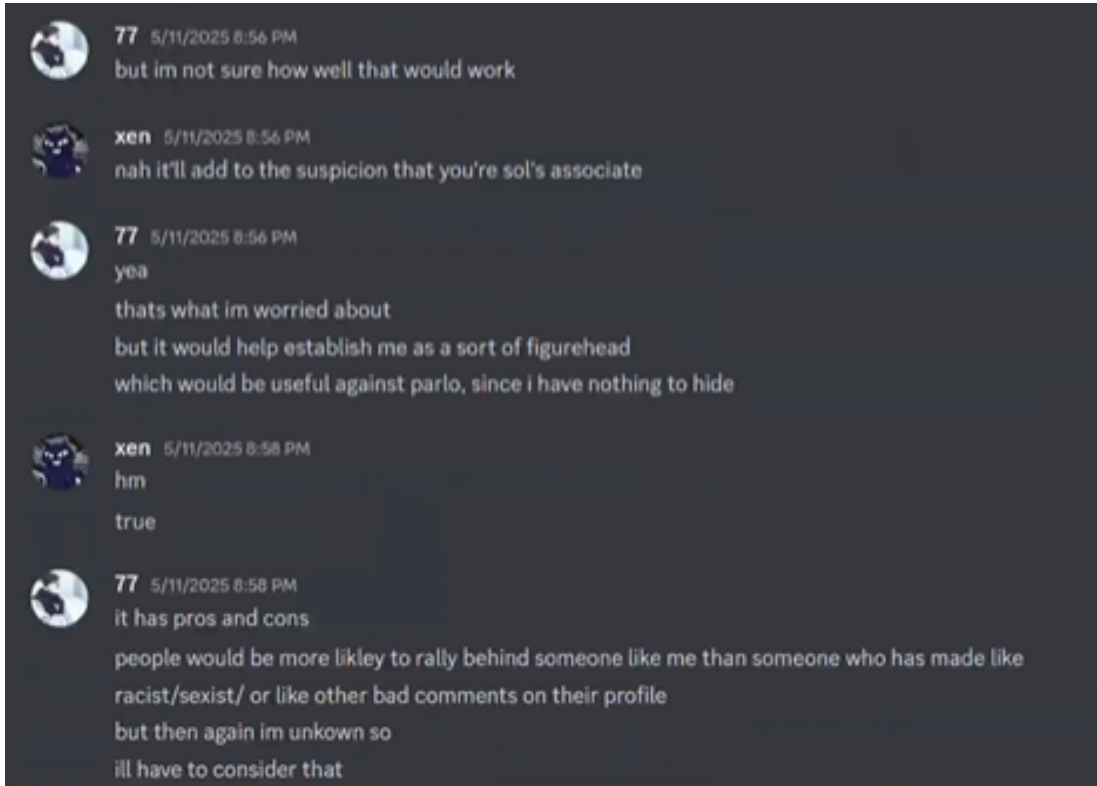

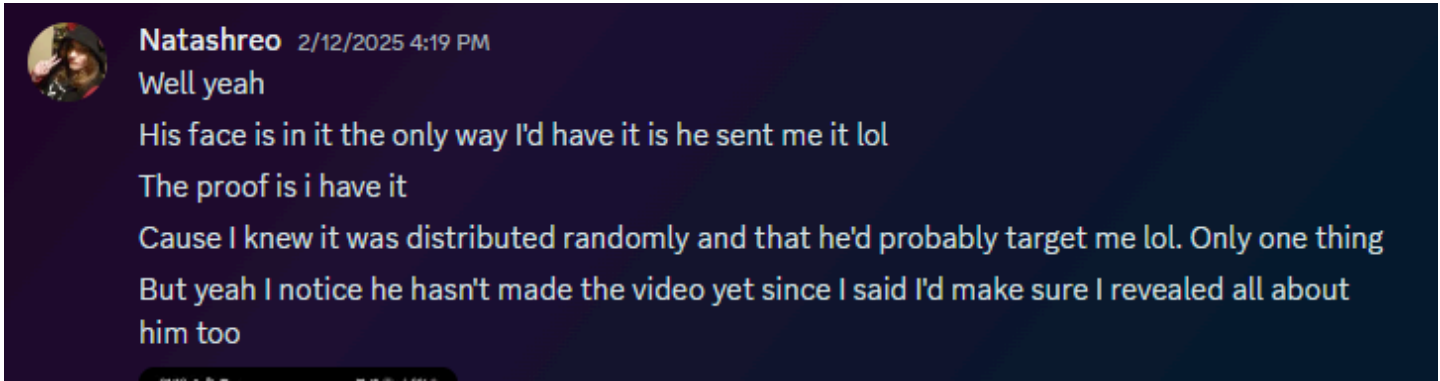
## 77 making threats + Nathorix Situation

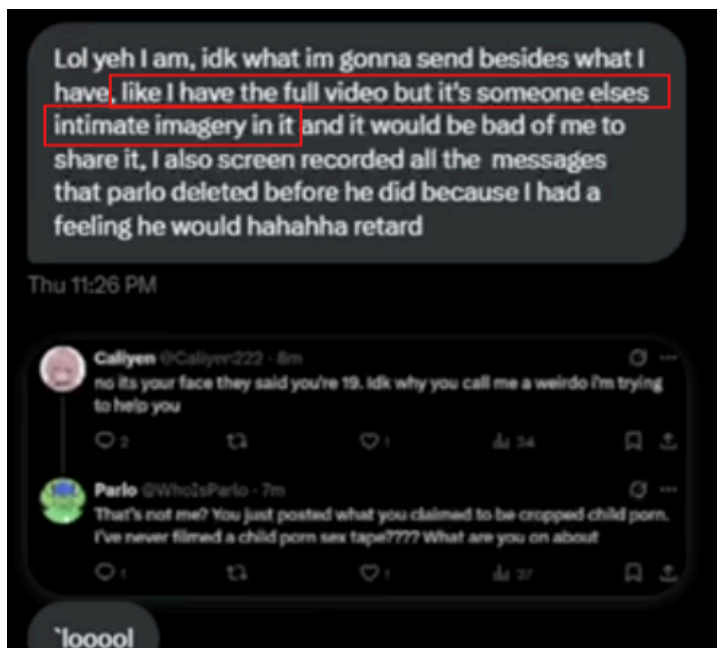


Mr R under this account is seen covering for the fact that Nathorix had originally shown them aspects of the content because she was the only one who has access to it.

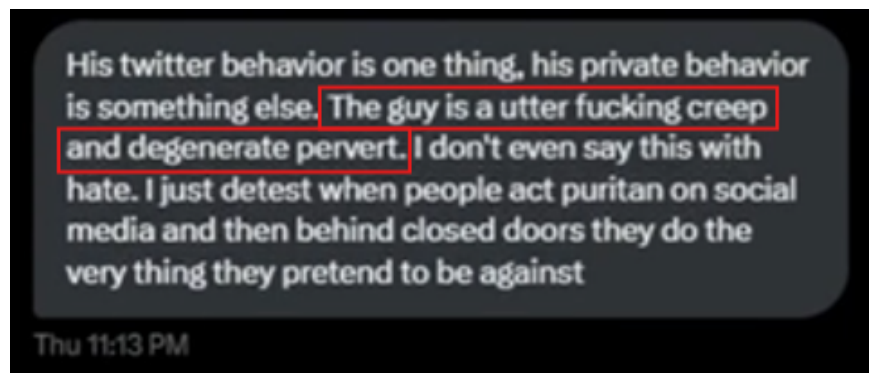
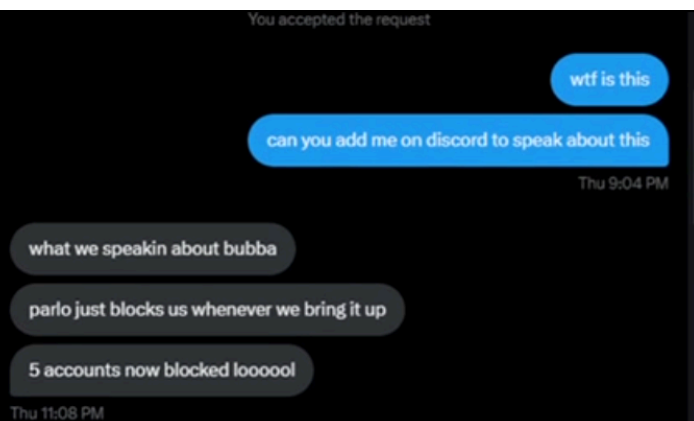

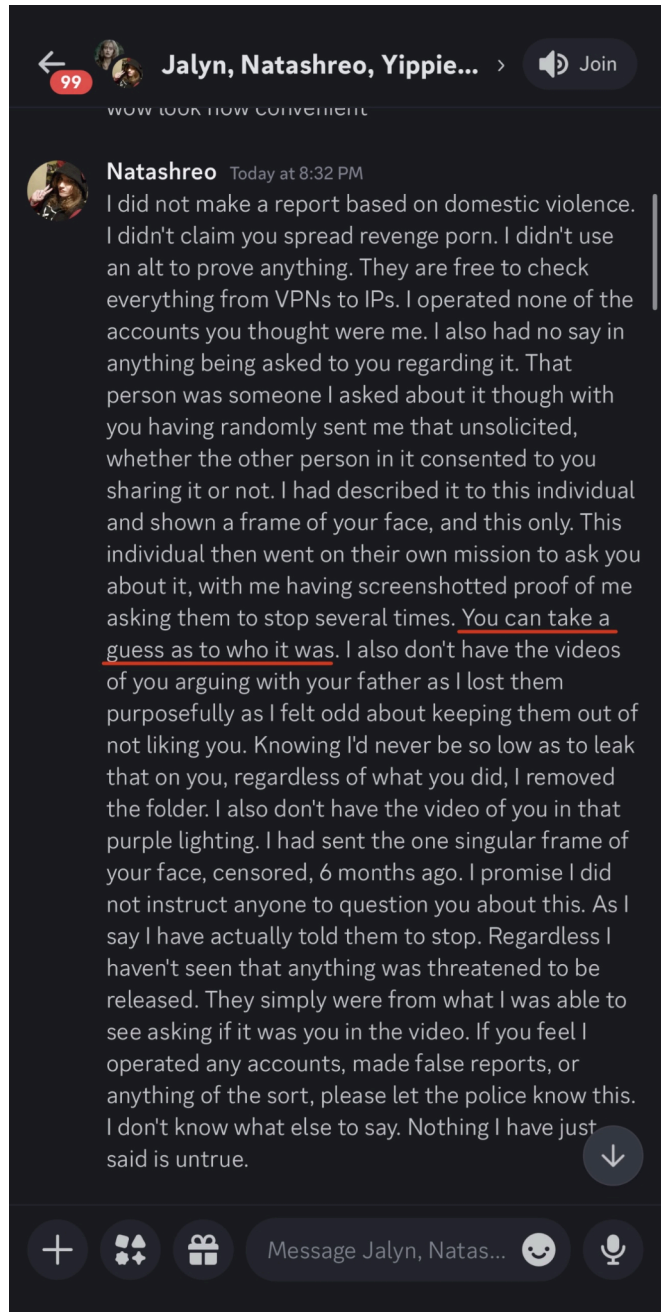
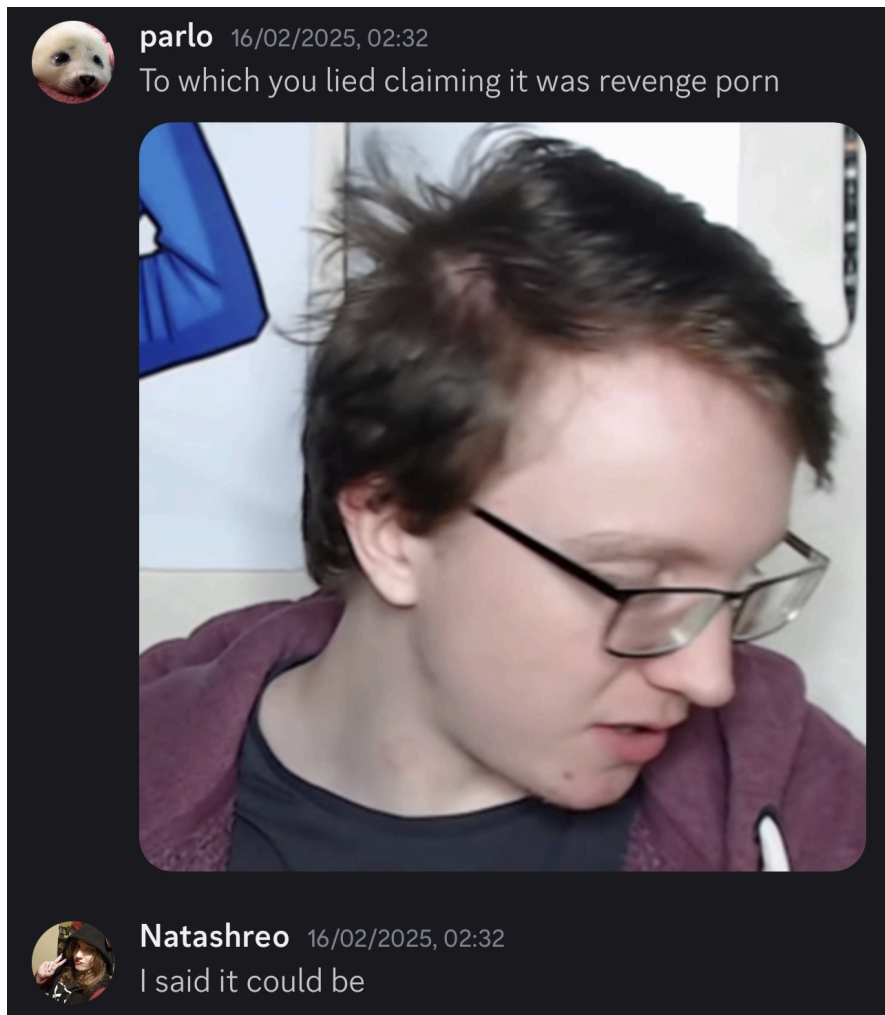
I was being threatened with revenge porn by coming out about the grooming I experienced from Nathorix when I was 16-17, and she was 21-22.

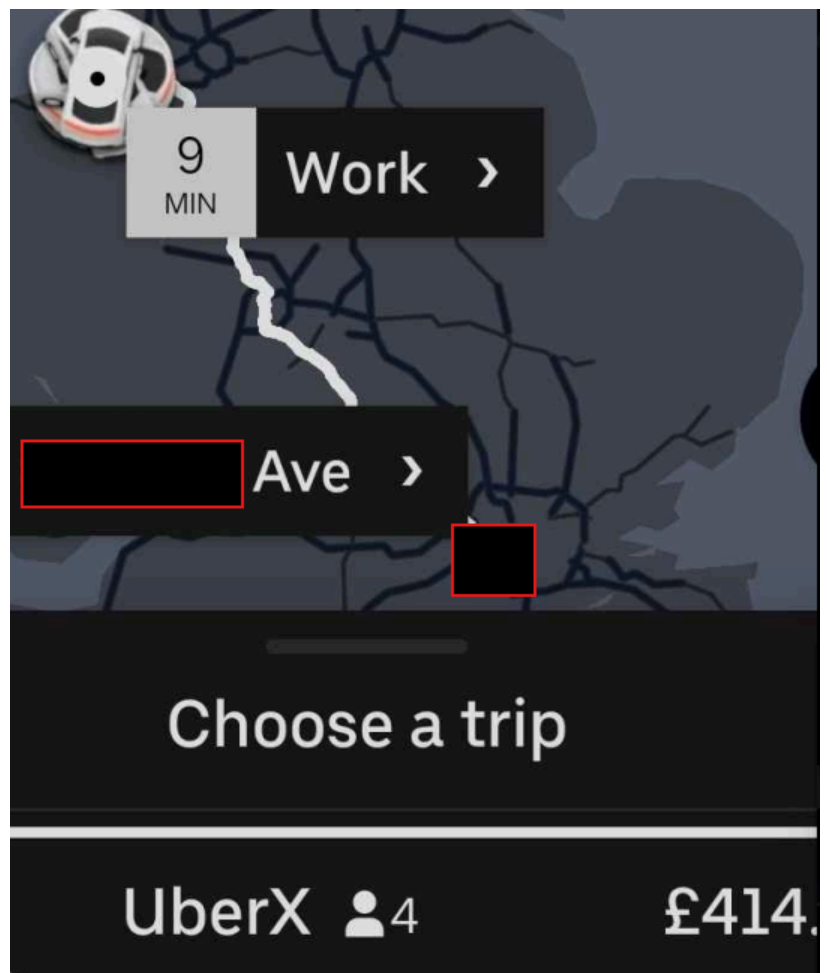
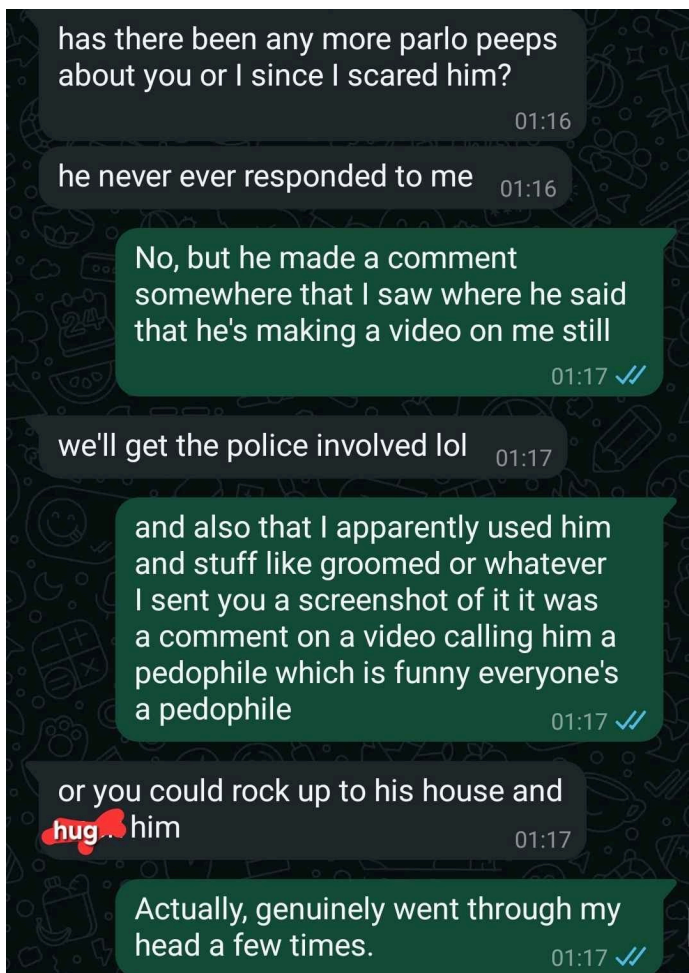

I contacted the user who was in the video, and they confirmed that they did not care in the slightest and said that it was 'chill'.

Therefore proving that what I had posted was NOT revenge porn, it however, was a blatant attempt at Nathorix using blackmail against me to scare me into silence with whatever she has at her disposal.

There is no need for her to have done this if she had nothing to hide. She used Mr R as a proxy to do this, and sat idly by as he was using these accounts to harass me, with the accounts all magically deactivating once I cracked on that it was him.

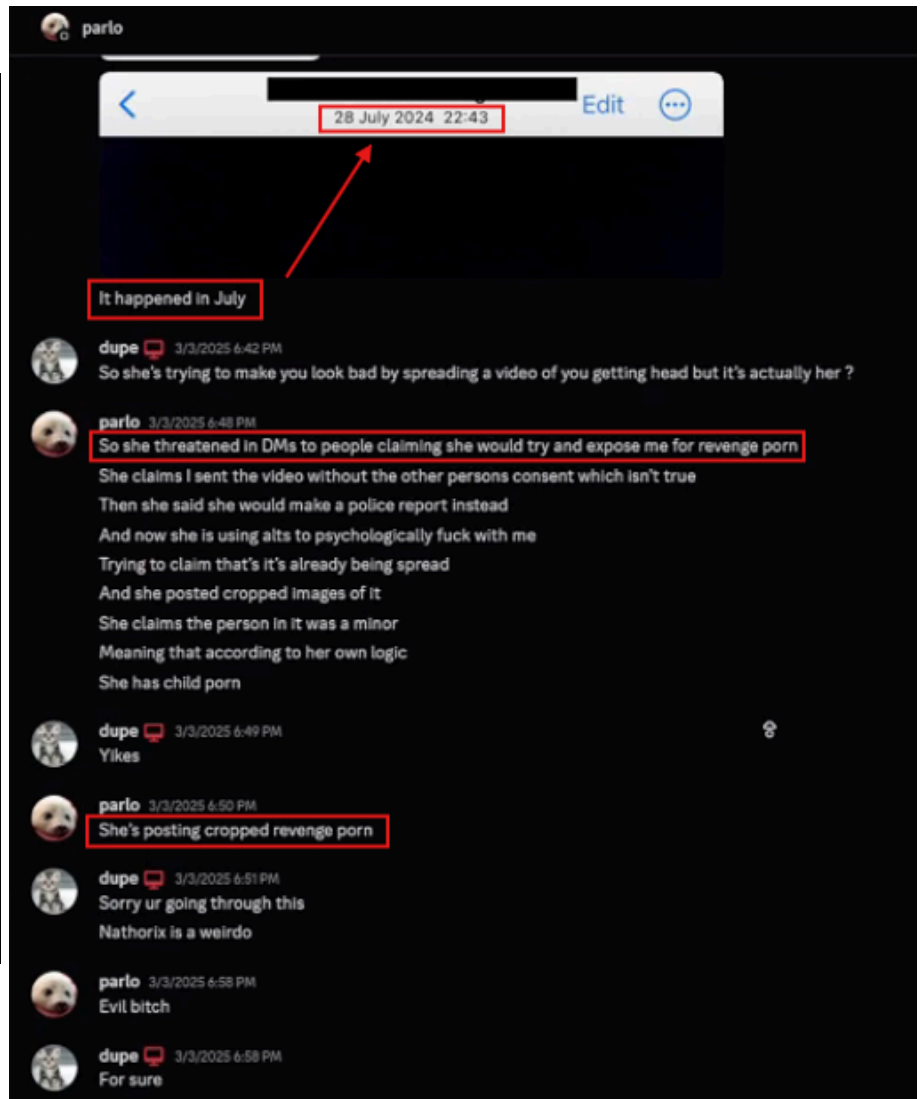

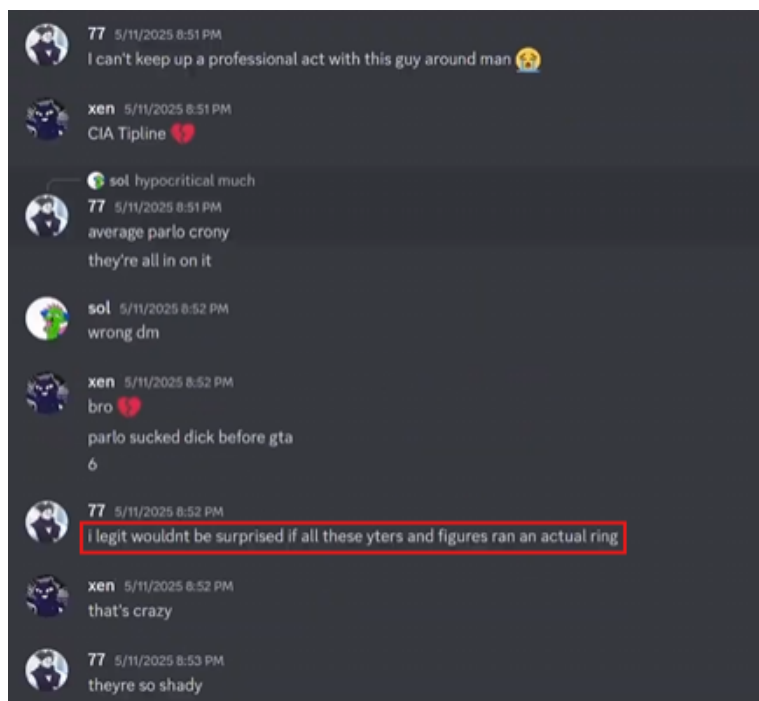

77 is seen not discouraging Xen from making such flagrantly disgusting and aggressive comments and even encouraged it and engaged with such conversations.

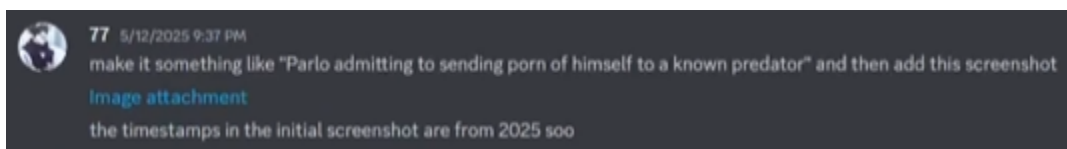

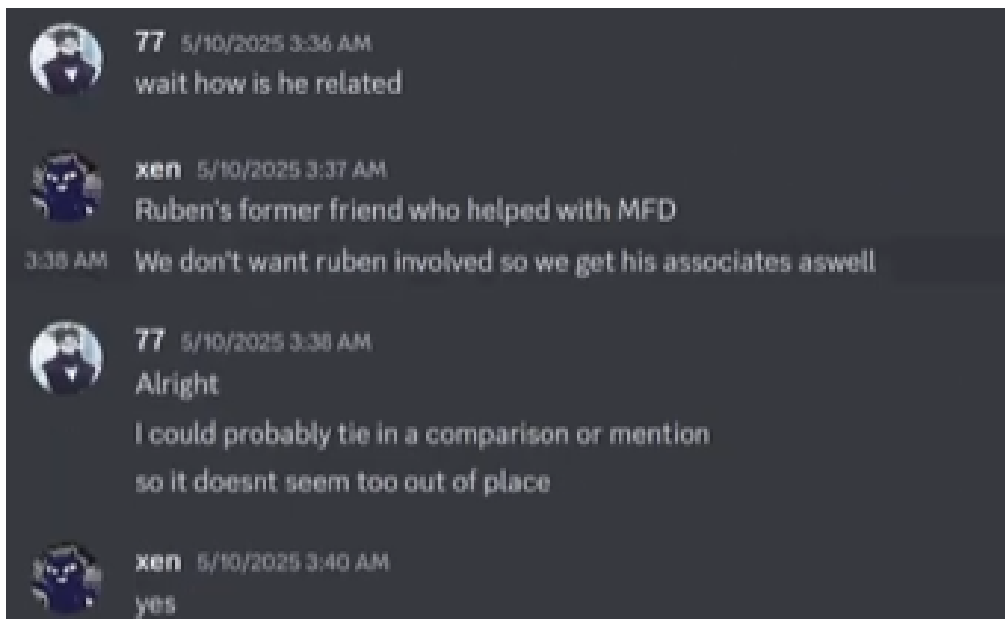




## **77 animosity towards Ruben Sim**

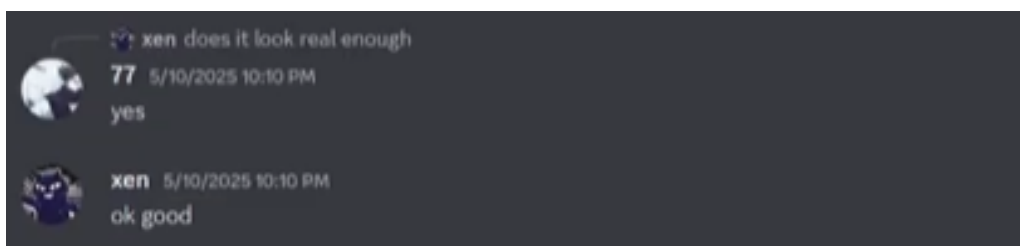
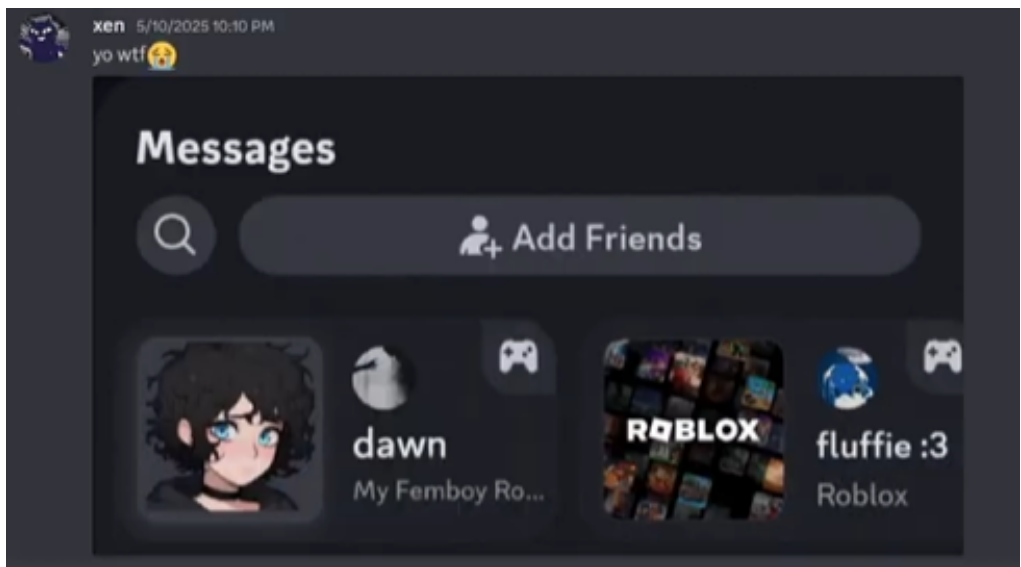
YouTube solely for the money, there

are a multitude of factors. Pinning and trying to compare and contrast these messages which have months of change and development between them is inherently malicious and bad faith.

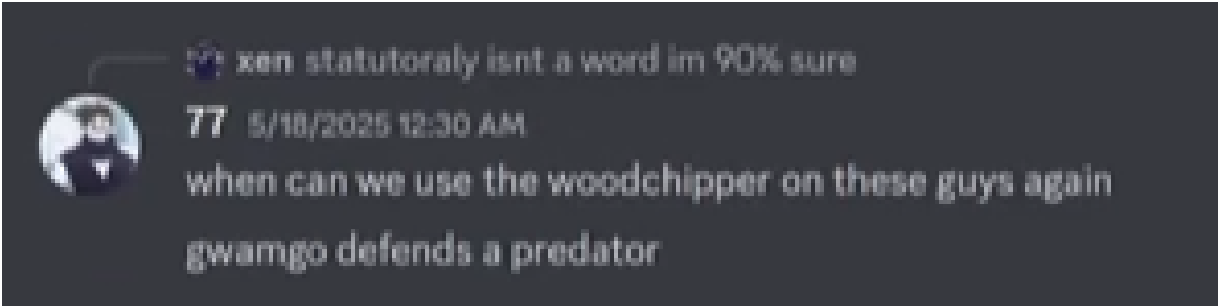

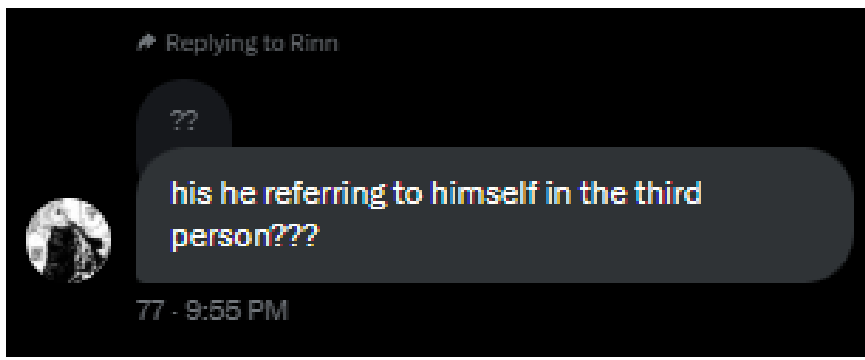
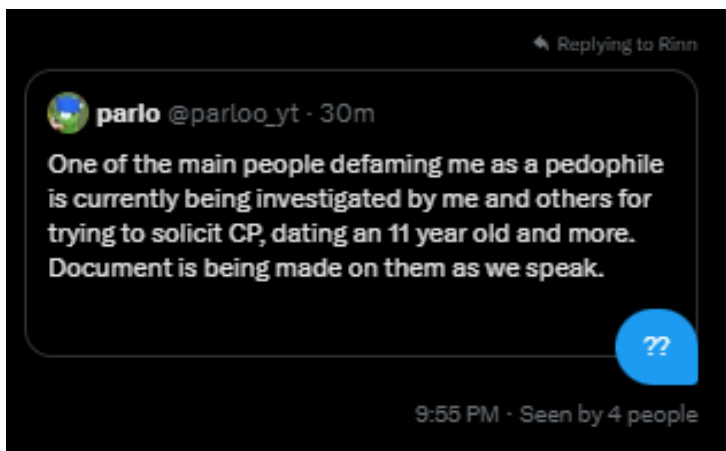
Xen is seen having faked proof against a user in discord and had openly told 77 that he edited it. He then asks 77 if it looks real enough to which 77 states 'yes' with Xen stating good. This is proof of Xen forging evidence and 77 being complicit in knowing about this, but having no problem with him doing this regardless.

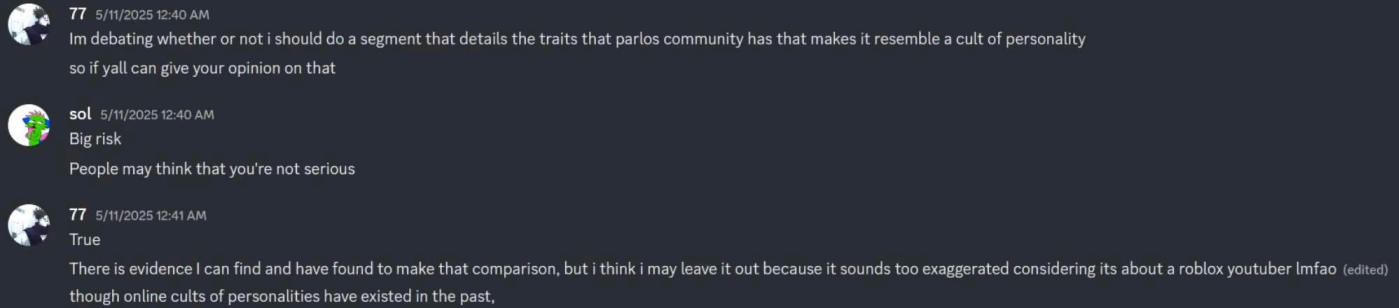

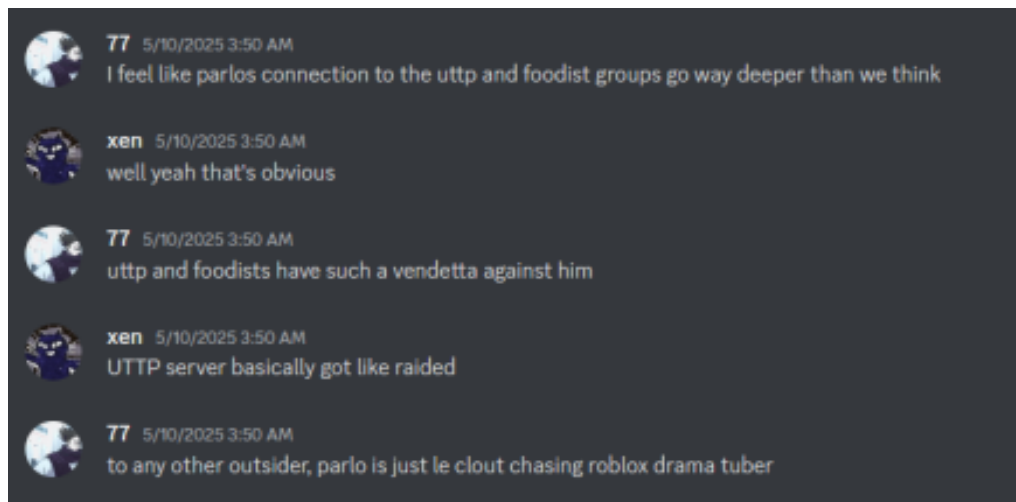

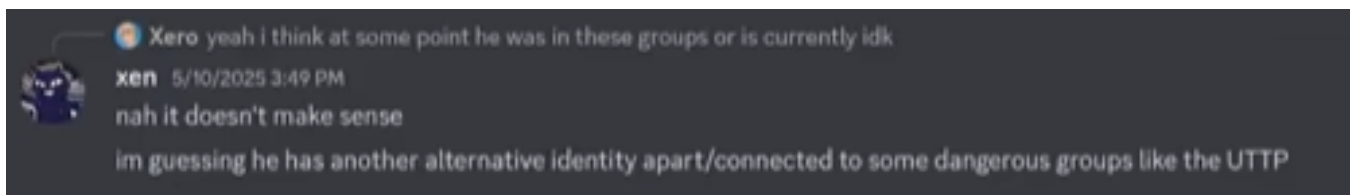
## **77's unsubstantiated claims**

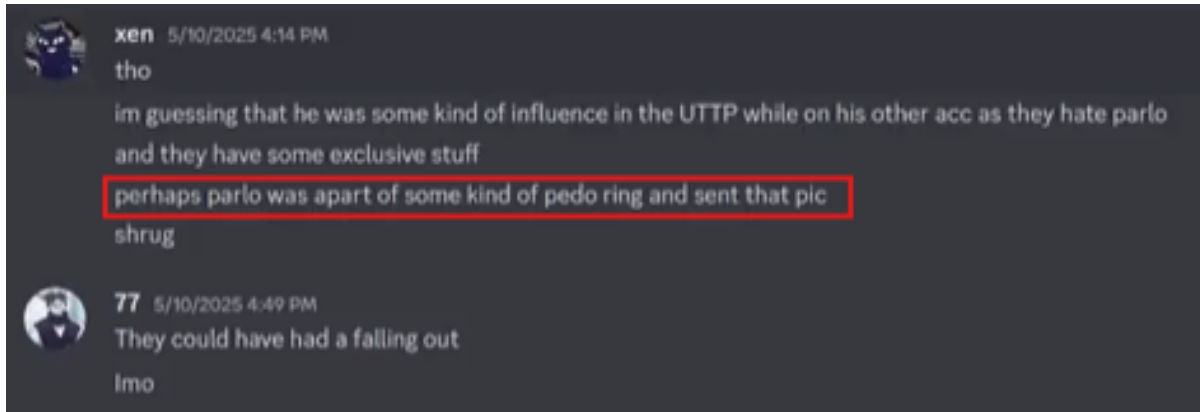

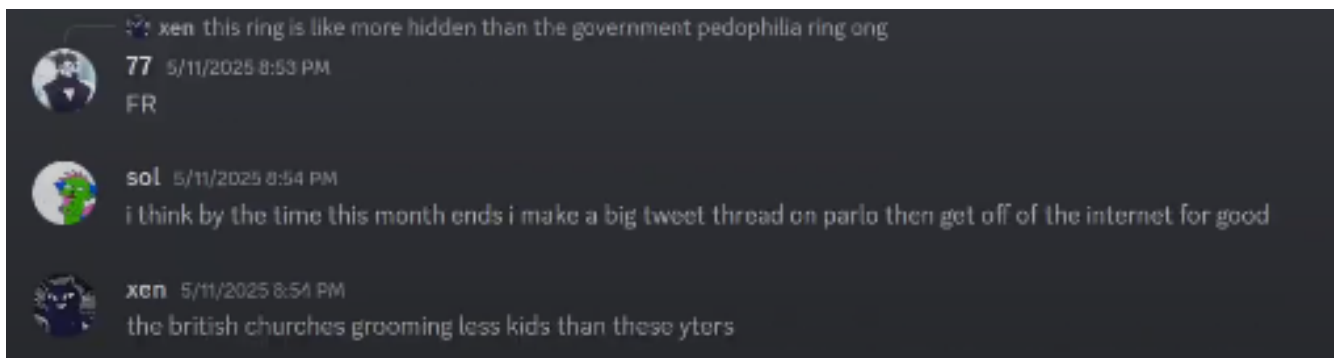

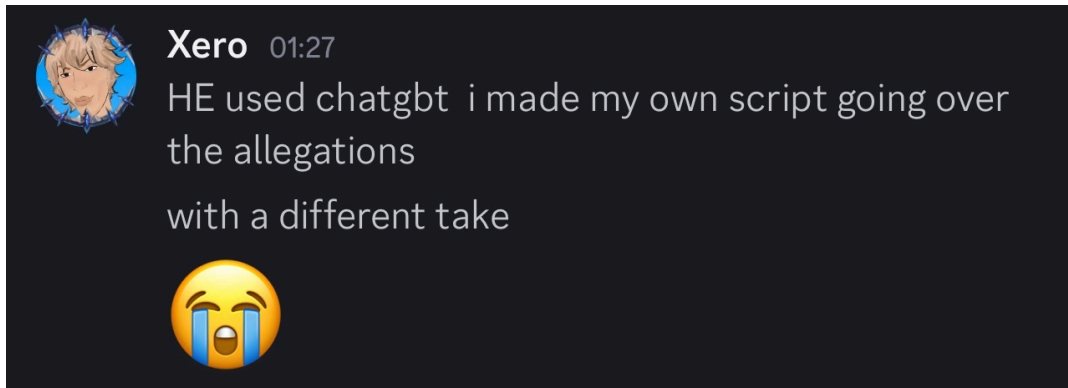


77 seen making comments alluding to many Roblox YouTubers and figures along with my associates, being part of some predator ring.

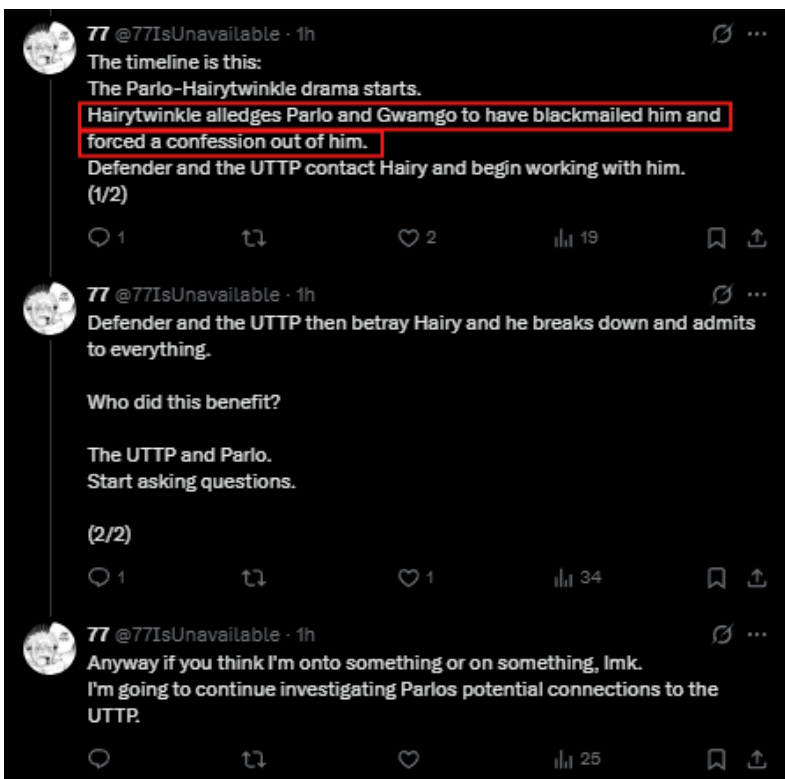


Followed by Xen stating that this ring is; 'more hidden than the government pedophilia ring', to which 77 is seen entirely agreeing with.

77 is seen forwarding wild, speculative allegations with extreme consequences and he does so in order to poison the well against me. It is done intentionally.

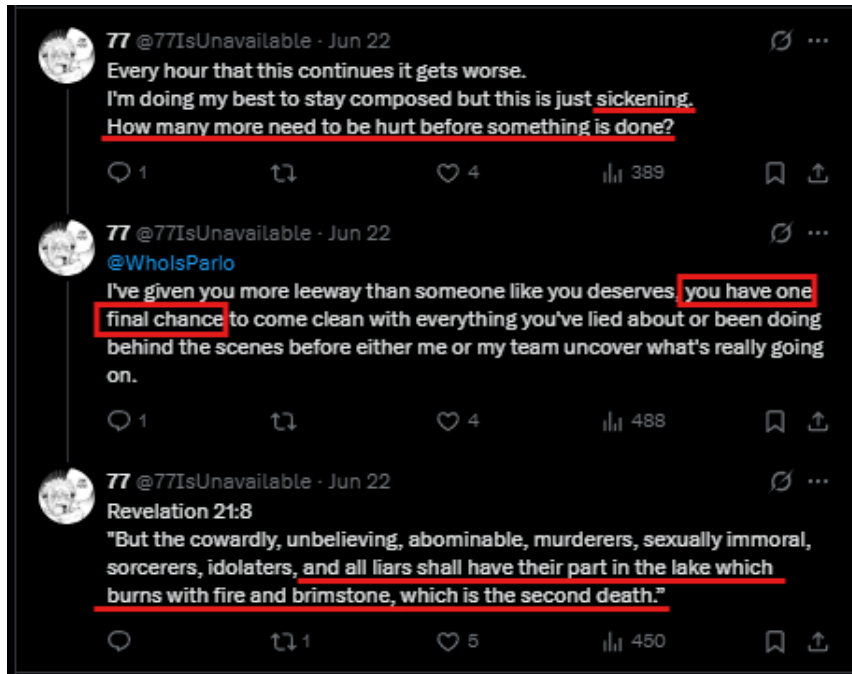
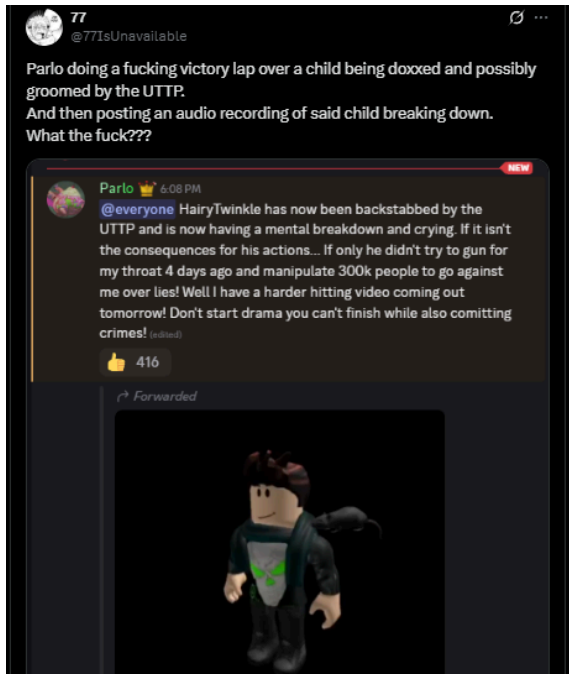
This is all while someone who prides himself on calling out objectively disgusting people, is seen consistently victimising someone who has harassed numerous minors, posted gore and created CP art.



**77 victimising & defending HairyTwinkle**



77 is seen recommending a video with misinformation, stating that it was a 'good video' covering the situation. He follows up by feigning the idea that he is neutral, but then stating 'you know what side is clearly worse'. Heavily alluding that HairyTwinkle is the victim in this situation and comparatively I am worse, despite it being open knowledge that Hairy attempted to solicit numerous examples of CP from underaged girls, threatened to harm and abuse people, doxxed numerous minors and openly worked with the UTTP. 77 was then seen using buzzwords describing me as 'callous and barbaric' for the announcement post clearly calling out HairyTwinkle for having engaged with the UTTP who are affiliated with terrorist organisations under surveillance by the FBI. Empathy is something in which 77 hypocritically lacks when he is seen gaslighting and manipulating a 13 year old named Dupe into thinking that him disseminating self harm of me was **not something that was inherently morally bad**. 77 neglects to mention that empathy was given to HairyTwinkle for his other apologies before he is seen immediately going back on them and committing federal crimes once again, and then only apologising to manipulate his impressionable viewers into thinking that he is a victim.

This is painfully ironic coming from the same individual who has made it more than known that they don't actually care about minors who they claim to be victims, only using them as a chess piece for their own personal game of catching relevance - such as 77 disregarding Kirb and Dupe.

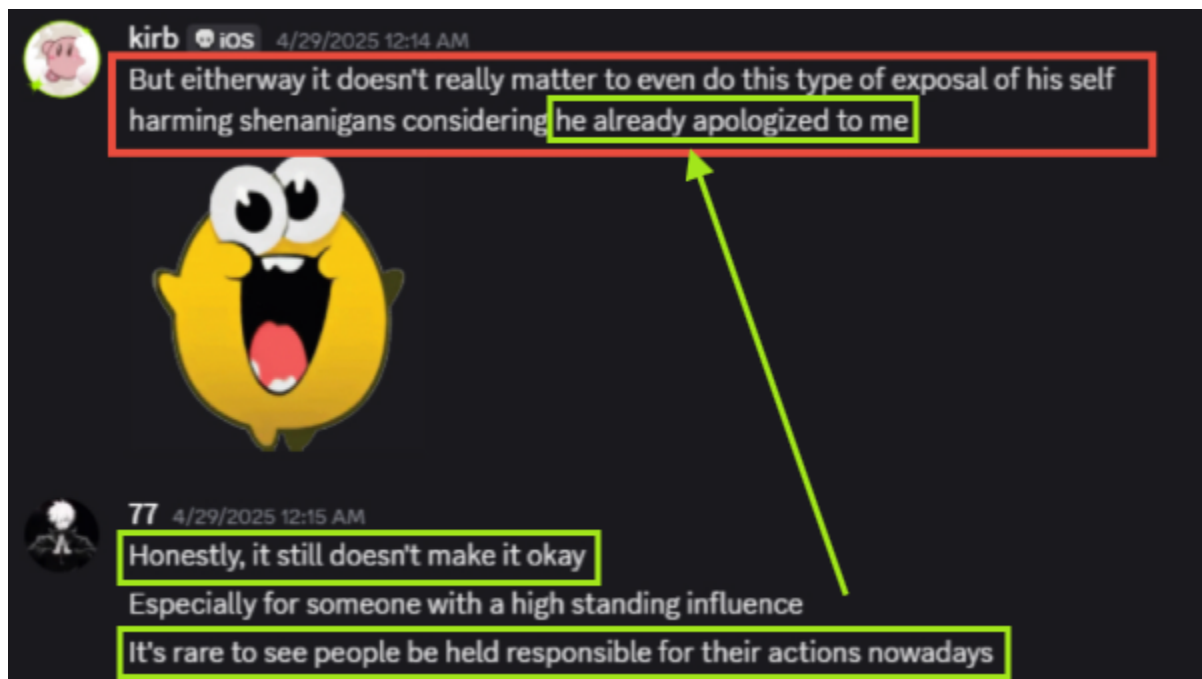

Once again conflating these quotes with a serious situation with actual victims, showing his lack of maturity and extremely biased and malicious undertones and intent in pushing forward this situation.



This is painfully ironic coming from 77 as he has attempted in the past, to utilise AI programs to cast as much doubt as possible on the sincerity of my apologies to both Dupe and Kirb.



77 also attempted to hypocritically cast doubts on my apology to Kirb and claimed that 'regardless it doesn't make it okay', along with the fact that 'it's rare to see people be held responsible for their actions nowadays'. Ironic when considering 77's belittlement of Hairy's crimes and the fact he attempts to parade Hairy's hastily made apology acting as if that exonerates his horrific actions towards numerous minors and the mistreatment of his victims.

Hairy has had a long documented history of openly apologising and then going back on it only days later, he has admitted he has a habitual lying problem and yet 77 necessitates the idea that he was remorseful and guilty in this video, as if that suddenly detracts from the severity of his crimes. 77 should know that HairyTwinkle's actions are far beyond being excused, but he is almost seen here attempting to legitimize his defense.

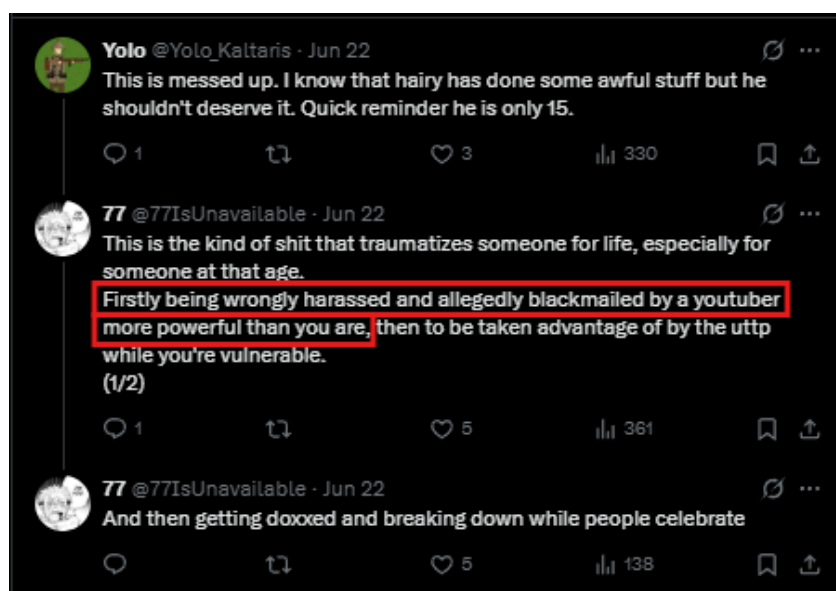
77 believes that he can personally vet and determine which apologies should be accepted and which ones shouldn't. This is ironic because he doesn't have a say in this situation, nor the ones pertaining to Dupe or Kirb. Only the ones affected can judge the sincerity of an apology, not someone from the outside attempting to interject to make a name for themselves. I accepted Dupe's apology from May 26th 2025, as he accepted my apology regarding the self harm situation from February 2024. Kirb accepted my apology due to my conduct from March 2022. 77 appears however to not like how this abrades with his own narrative and will attempt to do anything in his power to invalidate them.

Once again he pivots to the false pretense that he is not defending his actions, to which is objectively doing so therefore he is openly lying, but he attempts to latch on to a false strawman claim that he was 'groomed' [no evidence provided]. 77 strips all context away once again, does not inform his followers on the malicious actions of Hairy or what exactly he did to warrant numerous videos being made on him, and this is done deliberately.

If 77 is able to consistently waterdown situations, strip all the context away that does not best fit his narrative, he is able to bend any malleable situation to his benefit to make whoever he dislikes appear to be considerably more malicious than they actually are.

The post was made to address how actions have consequences, Hairytwinkle was warned by his own friends about being associated with high level UTTP members, and he engaged with them nonetheless, it is hard to feel pity to someone who knew how egregious their actions were and went back on numerous past apologies. It is also hard to sympathise with someone who harasses minors, posts gore and slanders people. 77 doesn't even highlight the mental turmoil caused by HairyTwinkle's videos on me which initiated a 4 day long harassment / misinformation campaign against me.



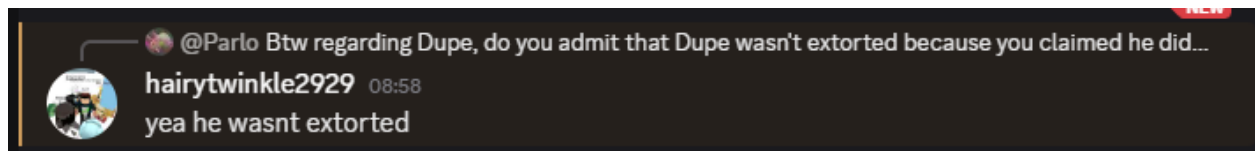

Once again 77 uses the 'power dynamic' buzzword term to make the situation appear far more insidious too.



77 has over utilised the word and definition of 'manipulation' to the point where it is objectively laughable, his use of overusing AI and openly lying numerous times to multiple individuals paints an entire narrative of how nefarious and malicious his intent really is in this situation.

77 is on record openly belittling and playing down the actions of HairyTwinkle2929, by using the fact that he is a minor and autistic, to neutralise and minimize the illegal actions in which he openly committed.

He maliciously negates to mention that HairyTwinkle2929 openly sought contact with the UTTP, and used them as a basis and platform to raid innocent users, harass people he did not like, as well as used them to post neo-nazi content, cat gore and dox people critical of him. ### **77 aids DAGames' fans**

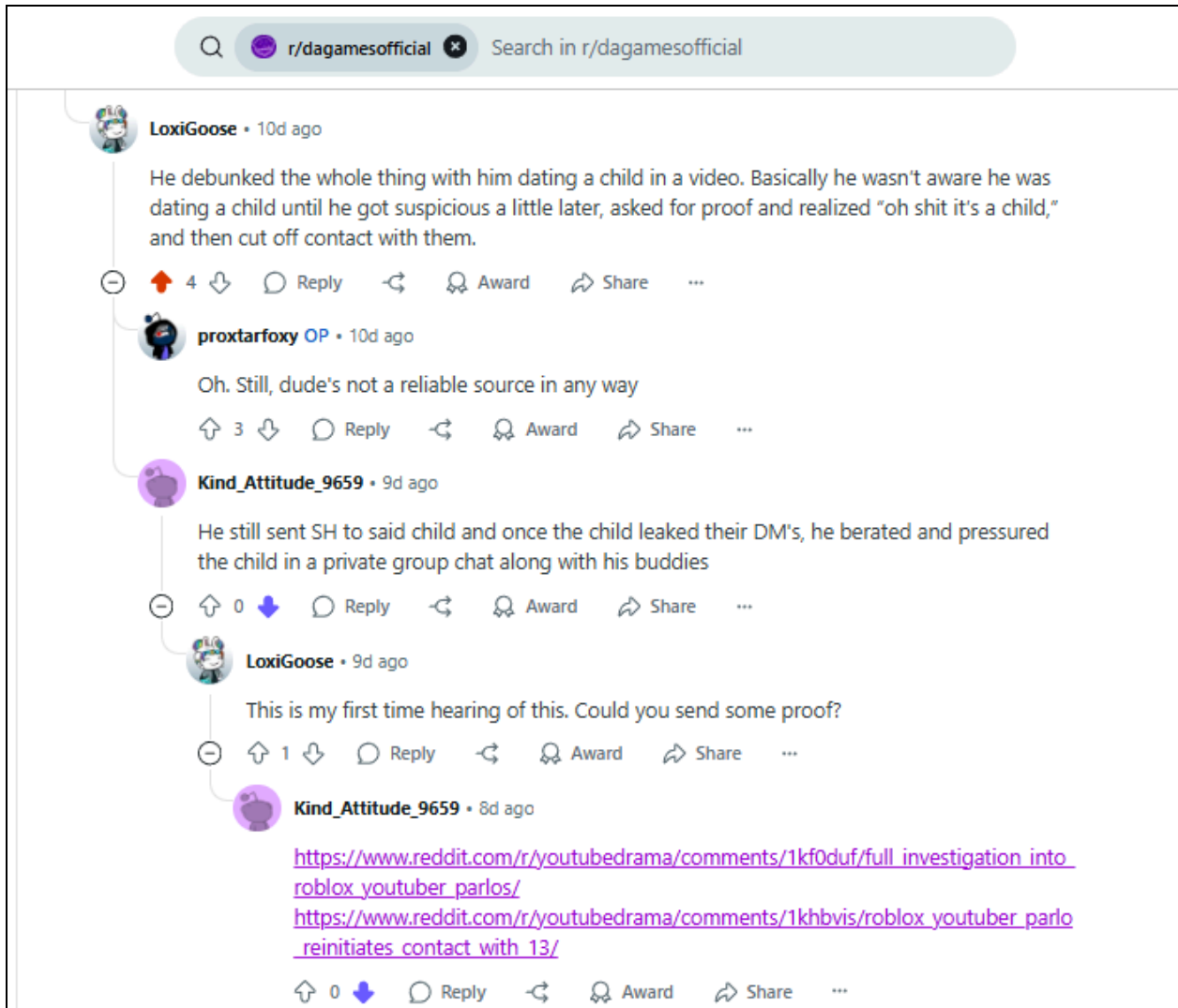

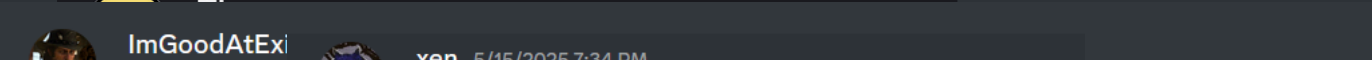
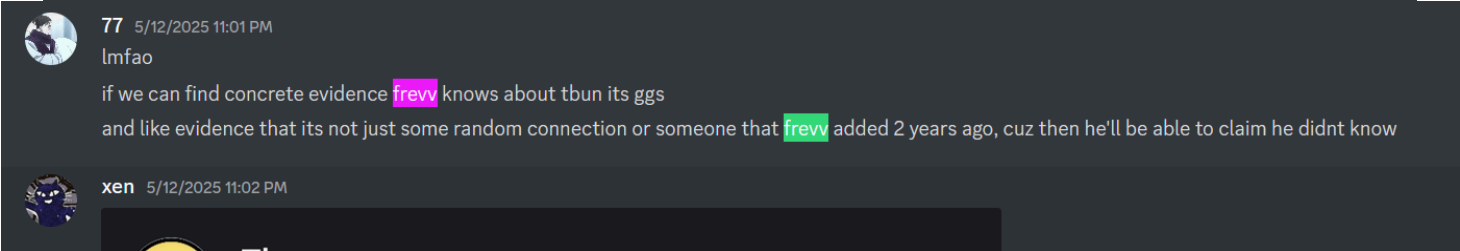


## 77 slandering Frevv

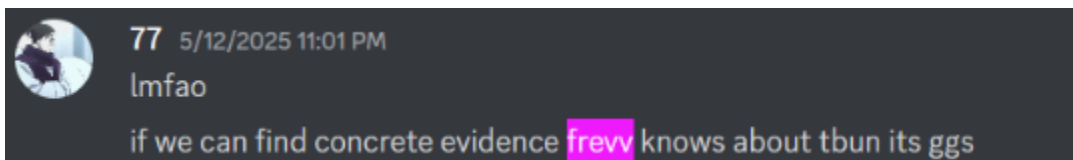


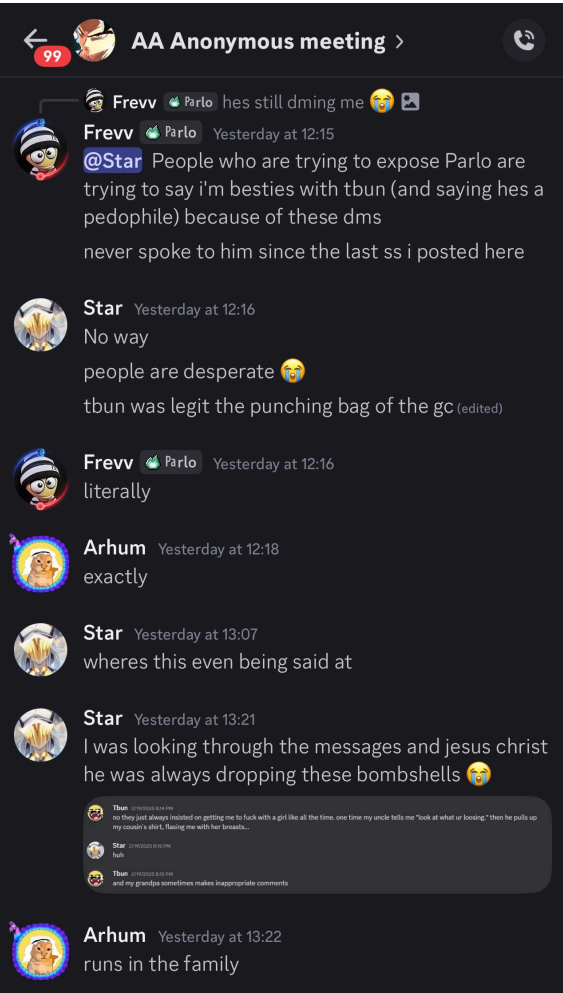

There is absolutely no proof that Frevv ever knew TBun was a predator and had him friended regardless, because it simply is NOT true.

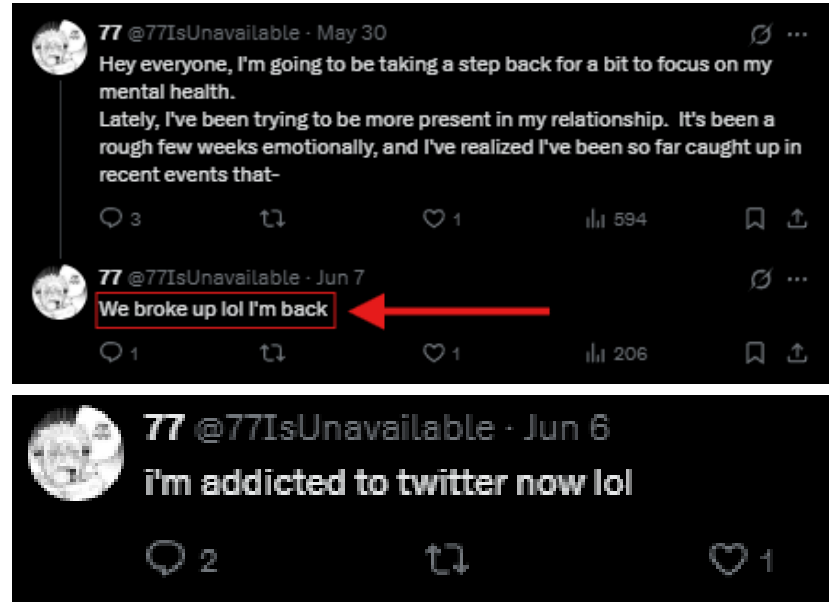
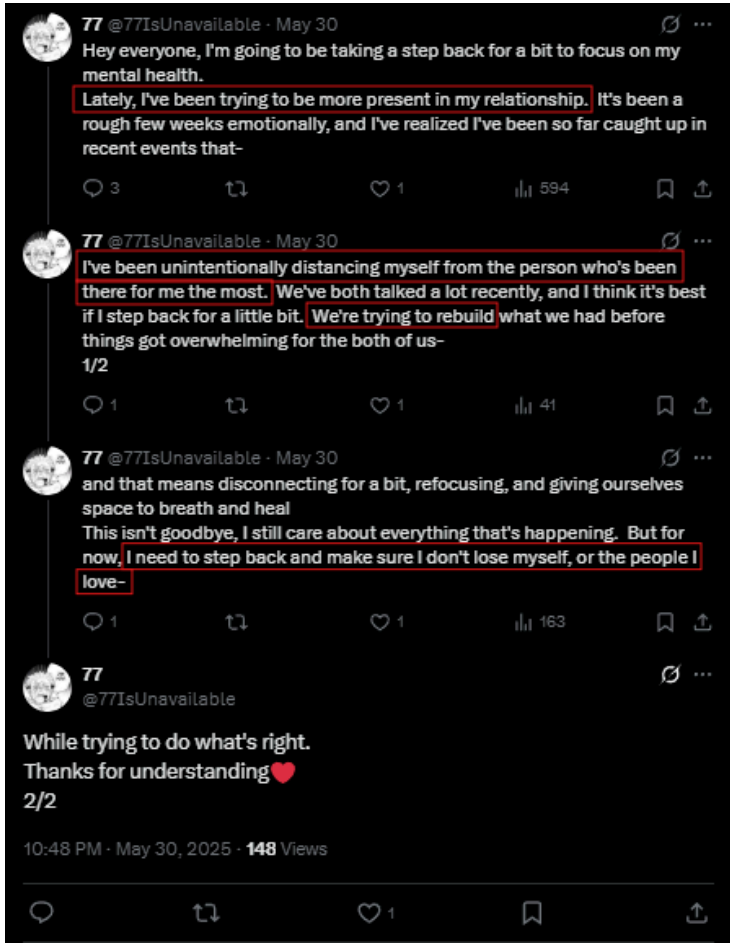

## Natz / Natzpop

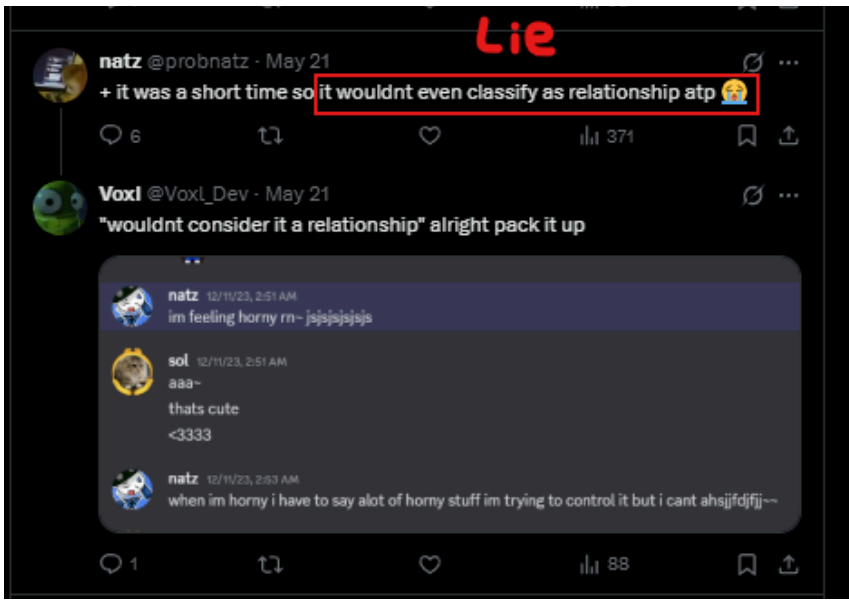
