There is no guarantee that you will be admitted to your first choice, especially for the highly requested May Vancouver PLTC session. If you request the May Vancouver session as your first choice, select your second choice wisely. You will receive the official confirmation of registration six to eight weeks after the application deadline.</p>
