Said, a Greyhound security officer called 911 to report that a male had pulled a knife on him. The suspect was described as a black male in his twenties wearing a black baseball cap, a white/gray sweater, black pants and white tennis shoes. The suspect was last seen walking northbound on 6 Av S from the location.

Moments later Carlos R. Dillard (07-15-1992) called 911 to report that he was the male who had just left the Greyhound and provided his location to await officers.

Upon arrival I contacted Abdalla at the Greyhound station. He pointed to a male standing north of the location on 6 Av S. The male was later identified as Carlos Dillard. Abdalla advised me that the situation began when the suspect missed his bus, became upset and started a disturbance with Greyhound staff. Abdalla escorted Carlos out of the station. During the escort Carlos turned and spat on Abdalla. The spit landed on his jacket, but did not make contact with any part of his body. Abdalla was upset because in his culture spitting on

Carlos was subsequently booked into KCJ.]
