TERMS AND CONDITIONS OF SUPERVISION

The following are general terms and conditions of supervision under Community Sanctions adopted by this Court pursuant to Chapter 2951 of the Ohio Revised Code. The following terms and conditions shall apply to all persons placed under the supervision of the Shelby County Adult Probation Department by this Court and shall be requirements and conditions of supervision under Community Sanctions from the date of filing, namely:


1. Probationer shall not violate any federal, state or local laws and shall obey all rules, regulations and orders of the Shelby County Common Pleas Court.
2. Probationer shall not associate or communicate with any person who has a felony record, a substantial criminal record or is known to be involved in criminal activity.
3. Probationer shall contact their Probation Officer no later than 24 hours or the next business day after they have been arrested or have had contact with a law enforcement officer. Probationer shall not enter into any agreement or other arrangement with any law enforcement officer or agent which might place Probationer in the position of violating any law or condition of their supervision.
4. Probationer shall be employed regularly. When out of work, or changing jobs, Probationer shall notify their Probation Officer immediately. Probationer shall secure advance approval before changing jobs, taking on an additional job or quitting a job.
5. Probationer shall follow the instructions and advice of their Probation Officer(s) in all matters during the entire period of their probation and shall answer all questions honestly and completely.
6. Probationer shall not enter any place where alcoholic beverages are sold or dispensed in any manner to be consumed on premise, such as Casinos, pools halls, bars and sports bars (ie. Wingers, Buffalo Wild Wings, & Fricker's).
7. Probationer shall not own, possess, or have under their control any firearms, dangerous ordnance, or weapons of any type.
8. Probationer shall not possess, have, or procure any alcoholic beverage \_\_\_\_\_. (initials)

9. Probationer shall not possess, have, or procure any recreational marijuana \_\_\_\_\_. (initials)
10. Probationer shall abstain from the use of any drug of abuse. If Probationer is attending drug or alcohol counseling Probationer is to abstain from the use of recreational marijuana, mind altering substance, or alcohol consumption.
11. Probationer shall not possess, use, sell, distribute, or have under their control any illegal or illicit narcotic drugs as defined in the Ohio Revised Code, harmful intoxicants or mind altering substances and any instruments for administering them except on prescription of a licensed physician or pharmacist. Additionally, Probationer shall take all medication(s) as prescribed.
12. The Probation Officer has the right to visit Offender at home or elsewhere. Probationer will be subject to a search of person or property by a Probation Officer. Any electronic device, including, but not limited to, cell phones, computers, and tablets, in Probationer's possession or to which Probationer has access is subject to search by a Probation Officer. If any such device is password or otherwise protected, Probationer shall take the steps necessary to provide Probation Officer access to the electronic device, including turning over the password or other information necessary to access the electronic device.
13. Probationer shall submit to random periodic urinalysis testing as required by a Probation Officer to determine the presence of illegal drugs, medications, or alcohol at a cost of \$10.00 per drug test.
14. Probationer shall submit to DNA testing through the Adult Probation Department.
15. Probationer shall make regular payments as directed by the Shelby County Adult Probation Department on Restitution, Fines, Court Costs and Drug Tests.
  - *A \$25.00 monthly probation supervision fee is due no later than the 10<sup>th</sup> of each month. If the Probationer is, or becomes employed, he/she may be required to have payments withheld from their regular pay in an amount determined by a Probation Officer.*
16. Probationer shall report to their Probation Officer as determined by their Probation Officer or the Adult Probation Department.
17. Probationer shall not enter upon the grounds of any county, state or federal correction facility nor attempt to visit any prisoner without the written permission of a Probation Officer, nor shall Probationer communicate with any prisoner without first informing their Probation Officer of the reason for such communication.
18. Probationer shall establish a permanent residence and shall report it to their Probation Officer immediately. Probationer shall not change their place of residence without permission by their Probation Officer during the entire period of supervision.
19. Probationer shall observe a daily curfew of 11:00 p.m. to 6:00 a.m.
20. Probationer shall have written approval to leave the state of Ohio.

The foregoing conditions are ordered filed in the Miscellaneous Records of this Court. Any modifications or restrictions of these terms and conditions shall be journalized by proper entry in each individual case.

I understand that the Court may change the aforementioned conditions, or reduce the period of supervision, and at any time while under supervision of the Adult Probation Department, may revoke the supervision due to a violation which has occurred during this period.

Should I be arrested for a violation of this supervision, I hereby waive my right to an extradition hearing and grant permission to the Shelby County Adult Probation Department to have me returned to this Court for a Violation Hearing.

I understand that I have been placed under supervision to the Shelby County Adult Probation Department for a period of 5 years. I hereby acknowledge receipt of a copy of these Terms and Conditions of this supervision and hereby agree to be bound by them.
