Hi Milo,

I'm reaching out to share a personal account involving a public figure that I was directly exposed to through my proximity. I understand some aspects of this have been reported previously, but there are additional details I believe may be relevant.

In 2021, there was an incident involving inappropriate physical contact with a colleague at a theater, which became public at the time. Separately, during my time around him, I became aware of multiple extramarital relationships involving individuals connected to his professional and political circle. I can explain the basis for this knowledge if you'd like.

I also witnessed ongoing issues with alcohol use. Over an extended period, he frequently appeared intoxicated during workdays and professional travel. I'm aware that he has previously attended AA. I'm sharing this as firsthand observation, not as a diagnosis.

I've included a short excerpt from a longer recording that relates to these issues. It's provided only to demonstrate relevance, not as a complete representation. I'm happy to explain the context or provide the full recording for independent review if you decide to pursue this.

I'm sharing the existence of the recording for context. I'm not requesting or encouraging its publication, and I understand editorial decisions are yours.

Finally, I have personal knowledge of verbal and emotional behavior toward his spouse that I found concerning. I'm being cautious here due to the sensitivity involved, but I can explain what I observed and why it affected me.

I'm not seeking to influence whether or how this is reported. I wanted to share my experience and make the material available for your independent assessment. I understand if you decide not to pursue it.

Some of this is easier to explain verbally than in writing. If you think it's worth discussing, I'm open to a call.

Alright fuck it.

This is what I know and believe to be true. I don't represent anyone but myself.

The affairs. These have been non-stop. He's been travelling to El Salvador this last year, and when he's out there he's getting hookers and escorts. He's been doing the same in Florida too. Any woman that came to the studio he was hitting on. With all the female talent he'd bring around, it was his intention.

This is going way back, but during that Blaze time he slept with Isabella Moody. This happened at AmFest same as EmilySavesAmerica. I believe it was an affair, not just a ONS. Isabella eventually got with Josiah Moody (Elijah's producer). But he was enjoying the fact that Elijah was sleeping with Isabella. Apparently he (Josiah) likes swinging. Isabella basically fucked all those guys at Blaze, John Doyle included.

One thing that I know for sure is that Elijah likes anal play.

He's talks about it when he's drunk. I've seen an electric dildo that belongs to him (not as a joke or anything, like something from his bedroom)

And he talked about getting hookers/escorts to use their fingers when they would blow him. Excuse my language.

Brittney Venti has also talked about his pegging fetish too. I've heard similar stories. For some reason, he tries to hide this, vehemently, with anyone outside his circle.

Elijah is an alcoholic and was black out drunk like 5-6 day a week when I was around him. This is a big thing. He organized the company around a schedule where he could get drunk 24/7 and party. When I say alcoholic, I mean it. Getting black out drunk every time he drinks. Puking every night. You could have conversations with him and he'd forget everything. He'd run his mouth and share all the secrets. Sure, it was hard to separate fact from fiction, but he'd often brag about the affairs, and other industry secrets, which I've since verified. He has dirt on a lot of the other freaks in the industry, and that's probably why he's survived this long.

The drinking goes hand in hand with his affairs. He'd get blasted and then try to hit on anything that moves. Taking his ring off when he goes out.

His wife is trying to divorce him right now. No one knows this, and he is trying to hide it. She knows out about the affairs and wants out. They have been sleeping in separate beds for over a year. For the last six months, he was constantly complaining about her not wanting to sleep with him. Who can blame her. I believe they have been living separately now for a couple of weeks.

There has also been ongoing verbal abuse when he's drunk or angry, like in the recording. Threatening to take her kids away and leave her without financial support if she leaves. Really ugly stuff. He's been so quiet lately because he's trying to figure out how to spin it for the public / hoping it will blow over.

He has a blackmail folder on everyone he works with and his "friends." So he'll try to implicate people in all the stuff that he does so that no one can talk. He records people and builds up evidence on them so that if they ever talk about him, he can hold that over them. Employees have caught him trying to record them on nights out. He also made everyone sign the most insane NDAs. They can't talk about him forever. A non-disparage that lasts forever. I have a copy of this contract.

Basically, he will involve his circle in the sex, drugs, drinking, and then they are all held to silence. When people discover that it's *not* just a bit of fun but actually deep addiction and evil, they realize they are trapped. This is why I believe no one has spoken out in any serious way.

The company (RIFT) has entirely fallen apart. Everyone has quit. He had been lying about the finances and the state of the company for months. Some people quit when he tried to force the NDA and others after AmFest. None of the talent seem to want anything to do with him. He was selling investors on all these shows that just didn't materialize and were never going to happen. Some talent were embarrassed by him and his drunken behavior (crashing out on Twitter every night) and the employees were angry with him for lying and over-promising. A total shit-show.

He also sold off pieces of the company at some totally over-valued figure (\$5M). I don't know how those investors will ever get their money back. And I don't know where that money is, no one knows except Elijah. And apparently he is broke so...

On top of that, he's a walking pharmacy, he's on all these peptides, TRT, uppers and downers, hair pills. That's known, but everyone suspects something more. I don't know if it's illicit or prescription, or simply the combination that I mentioned. I don't know.

His immediate family has cut him off entirely. The only person that still supports him is his dad. Brothers and sisters don't want anything to do with him because he's a major liability.

I know of another story that implicates another conservative influencer (an affair, of course) which eclipses everything I've spoken about, but I'm not 100% just yet. But it's incredible.

Okay,

I wanted to share a little more, and I've provided recordings which back up the story I'm about to tell you.

**Before I get into the affair I want to talk briefly about Elijah's past.**

He has admitted to having a "Twink" phase before he got married. I don't know how someone switches from Twink to straight, but this is an era that he is very insecure and protective of and that he's only admitted to a few very close "friends." There are almost no details I could dig up. There was one rumor that mentioned he left the church (he was a youth pastor) because it was discovered he was sleeping with another man. This is probably the reason why he found and married a woman as quickly as possible when he entered conservative politics.

There was another interesting detail which is hard to place. He apparently grew up with Benny Johnson, there was a time they went to the same church or youth group. I also heard that when Elijah was younger, he'd have sleep-overs at Johnson's house. Calvary Chapel. Given there are gay rumors about both these individuals, I wonder about their shared history.

**Okay, let's talk about the affair.**

Elijah Schaffer and Sarah Stock were having an affair for about half a year. This was in 2025. This began in February and immediately after Sarah joined the company. Sarah says that they slept together in DC at CPAC the very first time they met. (She was very drunk).

You can hear the rest in the recording below.

That's Sarah's side of the story, which has a few holes.

I've heard a little different, that the affair was a 5-month relationship where they saw each other and travelled numerous times together. There is public record of them travelling. She would come out to Florida a week at a time every so often. They apparently confessed their love to each other, and briefly considered starting a family together. Elijah considered (allegedly) leaving his wife and kids to be with her. I've also heard that Elijah was heartbroken when they broke it off. There were pregnancy scares. It ended when Sarah got engaged to her boyfriend, now husband.

(It would be good if this info above remains between us for now, I only provide that for context. Sarah didn't tell me this directly, therefore all I am only supposed to know her side of the story. I don't want to implicate any other party in this.)

She recently got married, and has just arrived back from the honeymoon. Her husband has met Elijah on multiple occasions. Elijah even took the couple to dinner once in LA while the affair was still going. At AmFest, Elijah kissed Sarah's husband on the temple?? (this was after the affair). Sarah quit right after AmFest.

After the affair ended, Elijah wouldn't shut up about how slutty Catholic girls are (in reference to Sarah Stock).

He would constantly question her faith, hinting that she had a sexual past. This was around the same time he started pretending to be Orthodox and purchased a big cross to wear everywhere.

I *do* think the husband should know. It's only fair, he thought he was marrying a virgin or something. No refunds.

I included another recording of Sarah describing Elijah's relationship with Nick Fuentes. Privately, Elijah is disparaging towards Nick and resents anyone who supports him, publically he seethes but is very nervous to get on Nick's bad side. He always wants to give the illusion that he supports Nick and that they are close. But like Sarah says in the recording, Elijah is spreading rumors about him privately, claiming that Nick is "gay." Unfortunately, this seems to be Elijah's go to accusation, he has made similar claims about employees that stood up to him, accusing them of secretly being gay. So it's impossible to tell if he says this out of jealousy / insecurity or because he actually knows something.

Regarding the divorce.

The wife initiated the divorce in Texas. But get this: since he's so scared about losing that "TRAD" image, he went and filed for divorce in Florida so it would look like he was the one to initiate it.... Now he's trying to get to the kids because it's the only way to the wife. He refuses to acknowledge any wrongdoing at all, denying the affairs and the drinking. His whole thing is like, "I'm a Christian now, and I've stopped drinking. How could you divorce me when it's the first time I'm actually changing?"

He's also trying to threaten her back into a relationship. "This is going to bankrupt us." "You're under demonic influence," "Think about the kids" that sort of stuff.

He sent her a fake cease and desist that he made using AI to scare her. It was just crazy "legal" jargon, and he added some deadline to "rectify the situation" otherwise he'd press charges or something.

Someone from the company spoke to an investor recently, just giving the guy a heads up, and he's been crashing out lately because of that, making all sorts of allegations against the employee. You can hear him complaining about this on the show and suggesting "his life is in danger" and that people are trying to kill him. Or that the FBI has got to us and that's why we are acting this way.

He's also started talking about his stolen BMW again, trying to implicate one of his employees. Suggesting one of us gave his keys to thieves or something. I was at his house the night of the crime. He got blackout drunk, had his employee drive him home, and then probably left his keys in the car (which he's done many, many times) and the thieves could have just opened his door and drove off. He was acting so suspicious in the morning when he discovered the car was gone, I even offered to accompany him to another part of town where he thought it was, but he wouldn't let me. There have been multiple occasions when he traveled when he'd just leave his car unlocked at the office, and I'd open it and go to his center compartment and find his Glock. Then I'd message him and be like, "Dude, there's a gun in your car. Do you know you didn't lock it?"

I can send you some of the texts, but you can't post them; this is just for context to show how badly he is spiraling atm.

**TEXT to his wife:**

*"The sooner I can divorce you the better. You and your family are insufferable narcissistic demons and I hate my kids are exposed to your witchcraft. I cannot fathom why you want to bankrupt the both of us in a bitter court battle unless you are demonically influenced.*

*All I asked for was to see our kids and you chose to go to war with your ex-husband at the expense of our kids. Nobody will win, everyone will suffer. May God forgive you for your sins against our children - them being split between two houses one week with you, one week with me (or Saturday-Sun & mornings wasn't my ideal idea), which sucks cause we could have had such a peaceful split, they could have stayed in one home and just seen me during the day like I begged and begged for, but you let bad advice control you from day 1. Your family is such a destructive force for evil and are making our kids pay for your*

*bitterness. Repent while there is time and reconsider the damage you are about to do to them. You could choose to do what's right still. 9:00am tomorrow - you should get 3 legal notices*

*I get why you're mad at me. But intentionally damaging our children? Kezia, you are at your lowest of low and no affirmation from your family will change the reality of how much in the wrong you are. Bad company corrupts good character. You are surrounded by foolish adults and acting like a child and it's not going to stand in court. I wish you had just spoken to me like I requested and had smarter counsel around you. Just glad they aren't advising me. This is going to go so terribly. It's our kids, Kezia. This is all avoidable and so sick. You should get evaluated because you are clearly twisted in the head right now and not thinking straight*

*If you need a psychiatrist I will pay for it on our insurance and suggest you seek help. I mean this sincerely. Yes, I'm angry because you're messing with our children in a way that negatively impacts them beyond what is necessary. But I'm not low impulse control and going to knock out your dad or something. I play to win and you think this is a game. You can still talk to me until 9am tomorrow. Feel free to call tonight or right now. We can make this right and not let judges and attorneys decide our access to our children, but that's where we're headed on top of the other court battles in the works."*

*(Again pls don't quote this)*

I had a few more things to add about the SS thing that I remembered.

- He took the team out for a company "get together" when Sarah started and slept with her that night in a hotel in Boca Raton. I remember him desperately wanting to go to the beach that day. He was working out a lot so that he could impress her with his physique (in hindsight I see this)
- He would describe her vagina as "fishy" or "smelled like fish."
- He would get very defensive if anyone in the office suggested that Sarah was "mid." There was this ongoing conversation where many of the guys would be confused at all the online simping, and he would step in to sing her praises, which was mocked by everyone, because she was extremely asexual and child-like.
- He and Sarah met in NYC one time (I think it was when their talk got cancelled and they did Gavin's show), he took her out for some fancy date to give her an example of "how she should be treated" and also dropped a ton of cash on new clothes for her.
- He fucked her one time when she was on her period, and he got some blood infection. I remember him writing about it in the company chat, using it as an excuse, not where he got it from. I wish I saved the screenshot.
- When he visited LA where Sarah lives, I believe Sarah got her husband to get her an Uber to Elijah's hotel, where they slept together. So the husband was paying for that shit to happen right under his nose. Gross. I believe he was under the impression they were "waiting until marriage."
- Elijah would describe Sarah as, "the best he's ever had."
- Basically Sarah could get away with doing as little work as she wanted since she was fucking Elijah. And Elijah would run around bending over backwards to please her. He would be nagging all of us in the office to message her to do her work because he didn't have any power over her.
- Funny, I think her fan-girling for Nick Fuentes was a huge nuke to their relationship. It made him incredibly jealous, because she would always side with Nick over Elijah even though they were fucking.
- I believe the only reason he's doing the Orthodox grift was because his relationship with Sarah ended. Before that he was saying he was "Catholic," to impress her, I guess. But once it ended, he had to switch teams because Catholics are "too slutty."

I attached some screenshots of him thirsting over college girls, nothing crazy but just to prove that I'm not making shit up. Plus I added the Instagram of a hooker he fucked in El Salvador. She messaged the company IG asking to be paid lol.

Oh, and he bought some hooker in El Salvador a ton of clothing too from the US, and a dildo. So he was, like, flying out clothing and sex toys to some hooker in a third-world country. I think the dildo must have gotten missed because it's the one I found at his house, something I believe he was using on himself.

I'll add more as I continue to remember.

So I kind of mentioned this but I want to impress the point. One thing that is consistent is that women are often repulsed by Elijah. Within minutes of meeting them he will ask them strange sexual questions like "would you have a problem if your boyfriend/husband got a hand job at a massage place or lap dance?" Something along those lines. And with married women he is always focused on reminding them how thankful they should be for not working (husband provides for them). I found it very inappropriate, that's their relationship and it's not his business the deal they have. He'd be like "only 10% of women can stay home, you're very lucky, you should be thanking your husband everyday."

I'm not exaggerating here, all the women who were partners of people in the office were repulsed by Elijah and thought he was gross. Some of them out right hate him. They've been to dinners with Elijah and his wife and they all say "I feel sorry for the wife." Every women has had some issue it's kind of crazy. And his wife can't be friends with any of them because they all hate Elijah and want to stay as far away from him as possible. Even now, his Assistant's wife was messaging Elijah calling him a "faggot" or something. It's a reoccurring theme.

He even tried to come on to a guest's girlfriend. This was his buddy's girlfriend and he was talking all sexual and trying his luck. There's a Ring camera recording of Elijah showing this guy nudes of some woman he's sleeping with. His wife caught him on the camera. She was in Australia with the kids. He started disabling the cameras at the house after that. His excuse to his wife: "I was showing nudes of you." Of course it wasn't.

I've spent a lot of time around Elijah and one reason I stopped associating myself with him outside of the office was because he'd be trying to hit on every woman he came in contact with. He would hit of the real estate agent, the receptionist, the waitress, the bar tender, random women at the store. It was gross and embarrassing, you're with this married guy preaching about Christianity and always calling women whore but then he's trying to fuck anything that moves. And also you know his wife and kids.

Switching topic a bit. He constantly talks about this moment where "God spoke to him on a plane." From what heard this was when he was on a plane with to or from El Salvador. And at that time I was told he had a third pregnancy scare with Sarah stock. Remember in El Salvador he's out there fucking hookers and binge drinking. He did stop drinking shortly after that, I think it's because he just had too many scares and his wife was hinting at divorce and realised he was screwed. He was scared she wouldn't come back from Australia.

It's funny because from what I've heard he has threatened his wife with divorce many many times. You heard part of the recording, in it he threatens to take the kids. He would use that as a tactic to scare her, you know she doesn't work she's been a stay at home wife for a while, she has no means to provide and he leverages that. In fact, he brags about it to everyone, "I know my wife will never leave because I pay for everything." So I think it was a shock when his wife mentioned the idea to him. He realised the con was up. Same time as the Alexis Wilkins lawsuit.

I would suggest watching the last two shows he did. Because he's crash out over this stuff and this info I'm

I believe he's a compulsive liar. That's not an exaggeration. It's actually incredible dealing with Elijah because he cannot admit to doing wrong ever. Even if you catch him in the act. Everyone in the company has a story about this. I have countless. When confronted he'll gaslight or just keep lying. For example I confronted him over his investigation with Candace Owens and Max Blumenthal into Charlie Kirk. He claimed he knew everyone at the Hampton meeting and so I was like "well tell us this is huge cause not even Candace is saying it." And he was like I have the full list right here on my phone. Okay share it. Then he starts listing names and it's like "Emily, Xavier, Bill Ackerman" and we are like "no shit, everyone knows that." And then he just made up some bullshit that Max was going to send the list later and walked off.

We confronted him multiple times on the drinking and he'd be like "I don't even have a problem" and I'd be like "here's your puke, we had to take down a stream, and I had to drive you home and watch you hold your crying 2 year old while puking at 2am." And he'd just laugh it off and pretend it never happened.

Another thing, you've got to be careful what you say, because if there's even the slightest mistake he'll fixate on that and make the whole conversation about that instead of the actual issue. So people say "you fled to Australia because you groped a woman" and he'll respond "these people are so stupid I didn't flee I actually have family there."

He is a master at weaselling out of things. So when I raised issues about the drinking at work, he started telling the employees that I was a drug addict and also the real alcoholic. When I confronted him he was like "we are even because you said the same thing" (I have a recording of this). This is how his mind works. He will escalate everything, it doesn't matter how, he'll accuse you of fucking a minor with no proof, just make it up to match the allegations on him. In his mind there is no concept of honesty.

A lot of the guys actually think he believes his lies. Like he will reframe reality and then say it so many times that it's true for him. Therefore he's an impossible person to reason with. I've many times come to him in good faith trying to help "let me know what you need how I can help so you don't have to act this way etc etc" he will then take that conversation, twist it in his head, and then start accusing me of stuff. At some point you realise, "oh he'll never change despite how bad it gets, despite how helpful or selfless you are, he's soulless"

Oh yeah, I was thinking more on Sarah Stock. I was a little hesitant to share the recording because I thought maybe she didn't need to be dragged into this cause she's young. But when I listened to her explanation, I realised she has no remorse at all, she has no issue keeping that a secret and ruining her husband's life. She didn't even sound upset or regretful. She had no regard for the wife and she wanted to encourage Elijah to leave his wife. That, on top of the catholic girl thing, makes my skin crawl. How can you be so nonchalant about fucking a married man while in the process of marrying another. Does that not weigh on her soul? I guess not enough to come clean. It's probably happened a ton of times. I've heard she tried to fuck Kevin Prosobiec too. Can't confirm if it happened but that's a rumour too. She certainly tried her best. Then thinking back I remember she worked for Seth Dillon and apparently he was in love with her too, he was always hitting up her phone, I wouldn't be surprised if they also slept together.

I have thought about telling the husband but then I wonder if he'd even care. He'll probably believe whatever she says "I got drunk and it was a one off." All these guys are such cucks it's impossible to know how they'd react. Like Sarah is mid, she's not even attractive. Elijah would bend over backwards to impress her and look after her. And she wouldn't even show any gratitude. It's hilarious actually.

The thing is for all his sexual exploits, he has zero game. I think he's just so forward and drunk that some other freak would eventually come through. Or his political clout would help. But talking to women? Dude is a nerd. A gross nerd. Within 10 mins bringing up sexual stuff. I've been told by multiple people that he would scare away the girls in the club, they didn't want to be around him because he was creepy. That's why he's going to a third world country. He can pay for sex in privacy. And even then he's still a simp.

Another thing, he doesn't have any friends. Or should I say people are only there for the small favours he can offer. It's impossible to have a friendship with him because he's not interested in anything outside of himself. So having a casual conversation is insufferable. It's him talking at you for an hour and you saying "damn that's crazy." He doesn't listen to anything anyone says and can't have a back and forth conversation. He gets jealous if he's not the centre of attention. No one can be funnier or more interesting, he will talk over them or just go on his phone until he makes everyone uncomfortable. You can't make fun of him. I remember fucking with him one time when he was exaggerating something and he got so aggressive. He said something like "you ruin everything you should just die" — so like teenage girl shit all because he was the butt of the joke. It's autistic shit. And on top of that he's like the least interesting person I've ever met. I've never had a fun time with him. You are just there to watch him perform, he needs an audience, you are like the extra in his movie. I remember trying to speak with a guest who I found interesting and before they could answer he would be speaking over them and changing the subject to something about him. I realised I couldn't even talk to someone else around him. If he gets the notion they you're enjoying a conversation he has to interrupt.

The guys that hung around him were being paid. So all the social gatherings are described as "work meetings" that way the employees feel obligated to hang around him. He'd take employees away from work to run errands with him or gym or babysit or listen to his therapy sessions or drive him to the airport or go to Costco. Just like tasks that he doesn't want to do alone and something maybe a friend would tolerate, but he has none so it's someone being paid to tolerate him. And if you have the misfortune to accompany him on one of these outings he'll drag it out and waste time to keep you around, making it as long and complicated as possible. And he'll treat you like his assistant. And on top of that he's talking at you for hours looping on the Jews or whatever drama he's dealing with, and when he senses your patience wearing thin he will hit you with some sob story about how he was molested as a child or had no friends or that he doesn't understand why everyone leaves him.

This was like our biggest frustration with the show. He couldn't have a conversation with the guest. He didn't care. He's so self consumed that he couldn't even interview someone without making it about him. You have like a guest and he's bitching about his stolen BMW or getting fired or his wife not sleeping with him. I remember writing scripts for him and he'd read one line then start ranting about the most uninteresting topics. And I'd be like "I spent 2 hours writing that, you told me it was perfect, don't ever ask me to write again it's a waste of time." His response was like "maybe we should get an earpiece so you can tell me everything I should say" — he was serious. That's what the script is for... the only solution to him not following procedure is more work for everyone else.

An example. He hired a "chief of staff" because he couldn't get me to sign an NDA. He hired a full time employee to somehow get me to sign an NDA and manage me... the guy was like an ex-firefighter or something. Just a random dude off Twitter. This is at a time when we are in the red we have no money left and I'm sounding the alarm that we need to get shit together. Elijah hires a full time employee, paying him more than everyone else (probably) to manage me, while we are desperately trying to get Elijah to stop crashing out online and produce one good show. He just needed another friend who was gullible to believe everyone else was the problem and not him. This is what he constantly does, as soon as people start to catch on to his con he brings in new people, and makes up some story about how he's the victim and then kicks everyone else out. Rinse and repeat. "The company failed because my team was useless and the FBI is targeting me...I don't know why everyone hates me, I've done nothing wrong, I did so much for those people and this is how they treat me?"

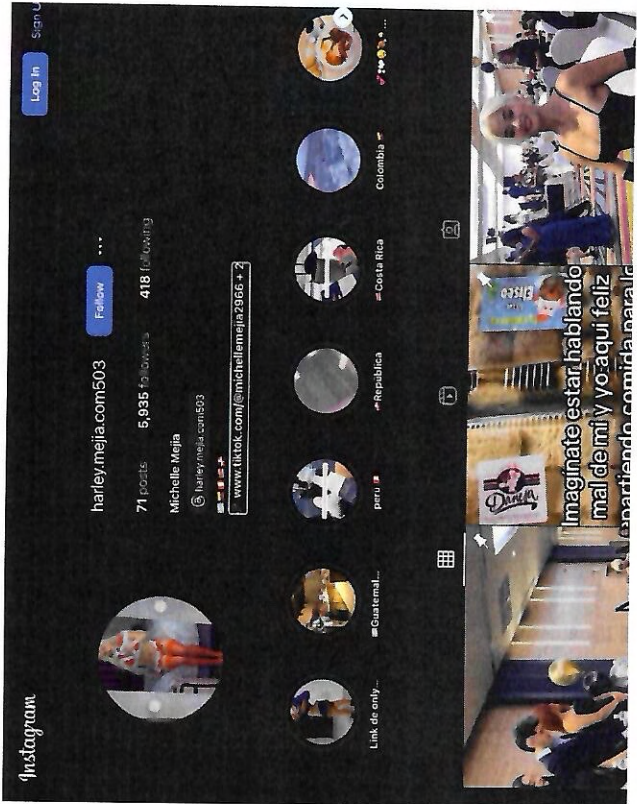
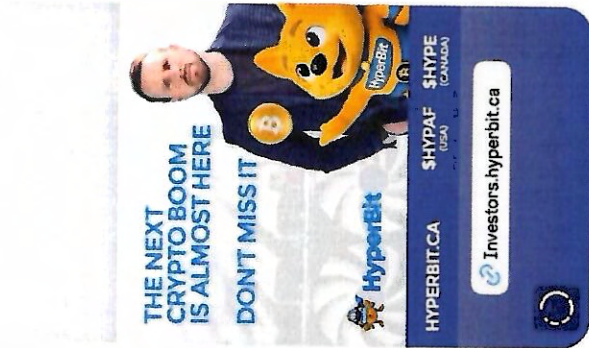

I know this on account of a few things.

Number one Elijah has a big mouth and blabs to everyone.
