Before I start this video, I want to show how quickly Spete's opinion changed on FNF HD from the time it came out til the controversy from a 2 days ago.

Spete is a YouTube drama channel that primarily focuses on Friday Night Funkin' drama. Usually the drama is already settled, but he uploads it anyways because he doesn't have a better way to gain money. I had my first encounter with him back in mid to late May, when I got into controversy for talking down on a person with cancer due to them dissing FNF HD. I worded myself really badly and, rightfully so, got lots of shit for it from both fans and strangers. The situation had already settled hours before I contacted Spete, where he made a tweet implying he'd make a video on the controversy.



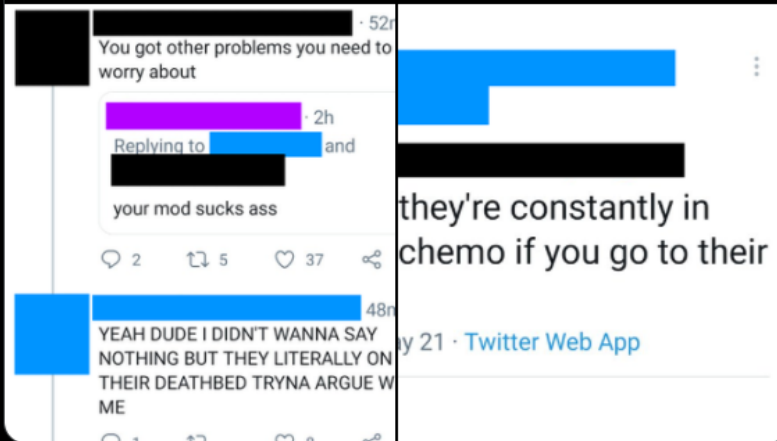

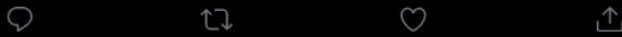

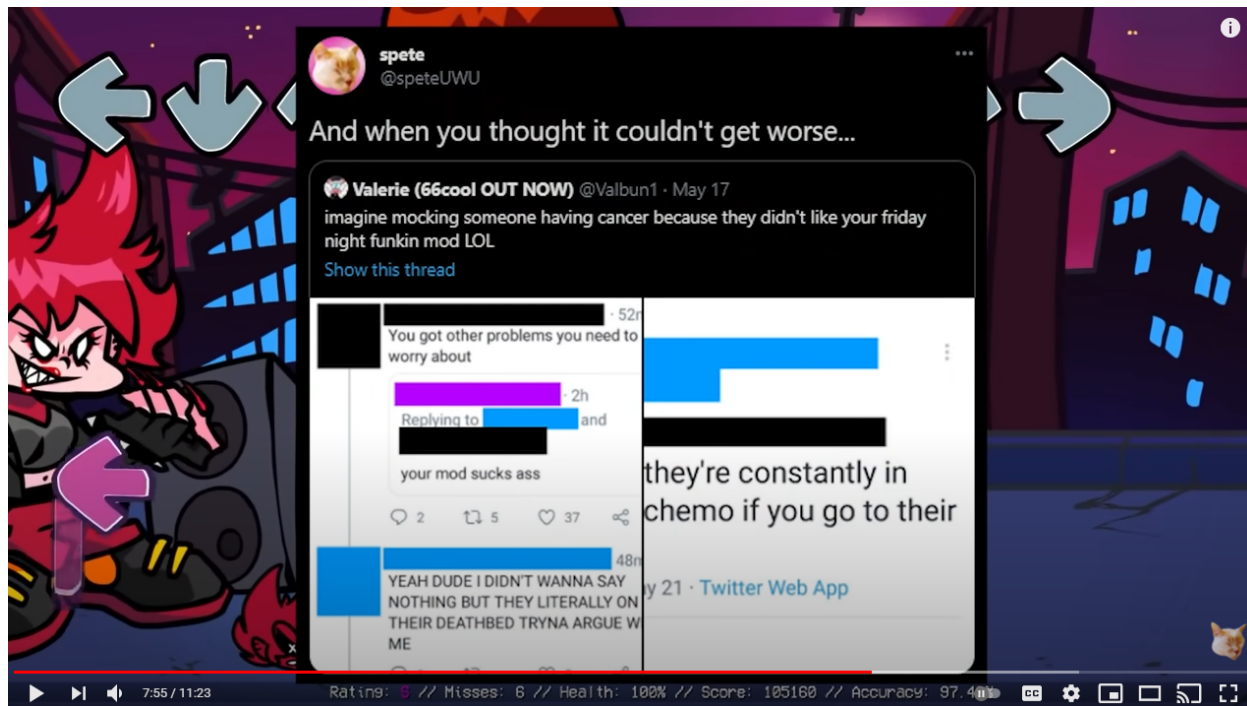
These screenshots show him not only agreeing to credit my art properly, but to also not bring up the situation with the cancer patient because it was already settled.

Fast forward to June 6th, where user Ramen Noodles we accused of saying slurs he couldn't reclaim, and faking death threats that were being sent to him. I had just woken up and saw the controversy on my timeline after it was coming to a close. I decided to say something about it, as I wanted to keep the community safer from potentially harmful people. In hindsight, this wasn't a good idea, as it led to a lot of people to believe the Ramen was actually faking death threats and sending people to harass others. Someone who knew Ramen better than I did came forward and told me the truth about the situation, and that Ramen was innocent. In response to this, I deleted my initial post, and spread around the one that was true.



After all of this, I thought the situation was handled. Bbpanzu and I had apologized to Ramen and deleted our respective posts, and everyone went on with their day. I was watching the Paul v. Mayweather fight when Kade texted me about a new Spete upload video

that mentioned not only me, but him and also bbpanzu and Ramen. I knew it had to be about the situation from earlier that day, and I was correct. But I soon found out that he went further.

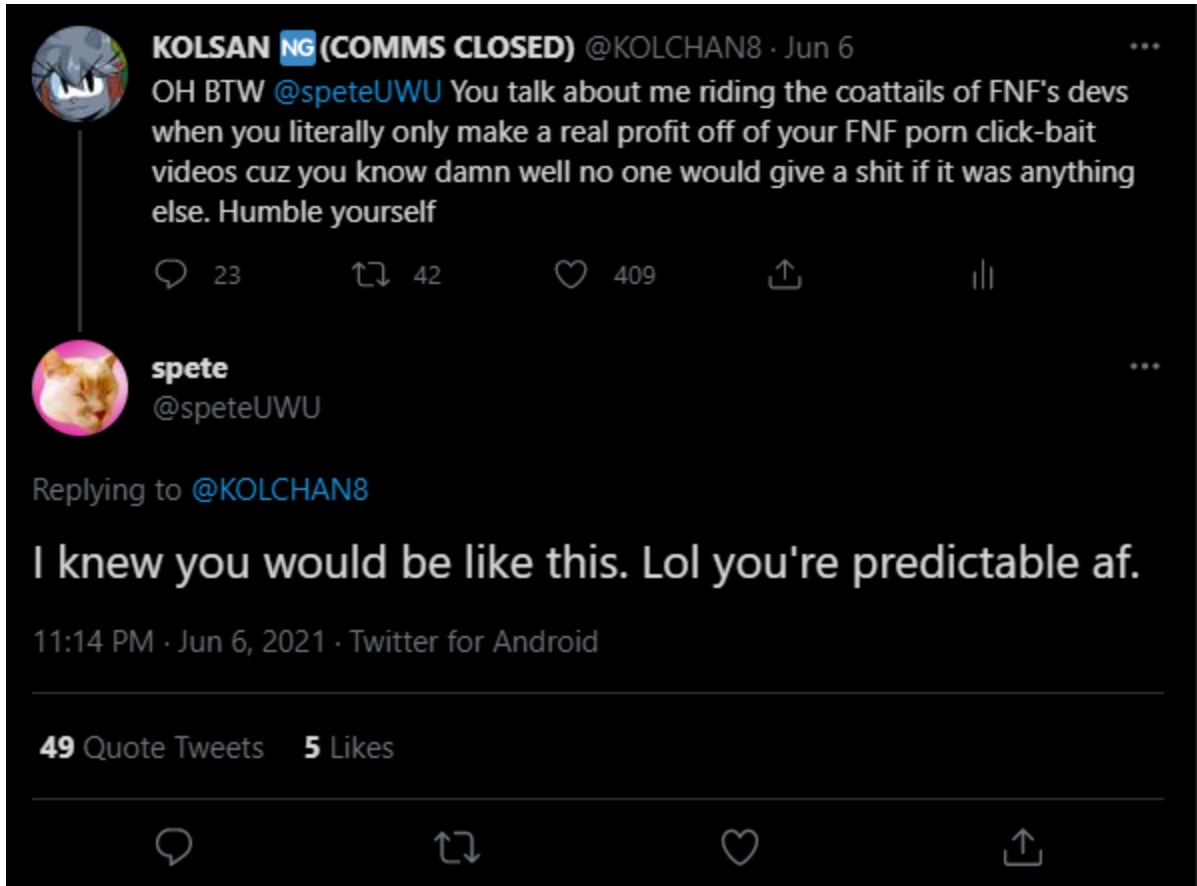


He went against my word and talked about the situation. His reason? Because he said that I "sent my fans to harass Ramen, meaning he's learned nothing from the last incident, so he deserves some backlash." One thing you'll notice throughout this video is that Spete's definition of harassment is very loose and really just a way for him to throw dirt on mine and other people's names.

I took the situation to Twitter because I was pissed off. Spete went against his word and started back up unnecessary drama that everyone had already put behind themselves.



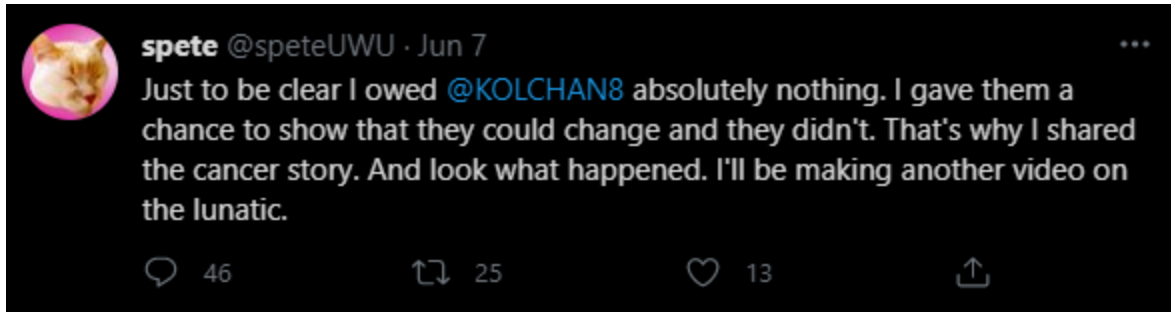
He would then go on to admit to knowing I was going to get mad at him, as if it's surprising that someone would be pissed off after you not only slander them, but lie to them about not bringing up resolved drama up again.



After that we'd have a few more interactions, with him stating he'd take more things I said to him to use for his video against me. He also referred to me calling him out as "weaponizing" my audience against him. Mind you, this is the same person who literally told people in his video that I deserved backlash because of the Ramen and cancer situations; two situations that were both resolved very quickly without the need of another copy-paste drama video.



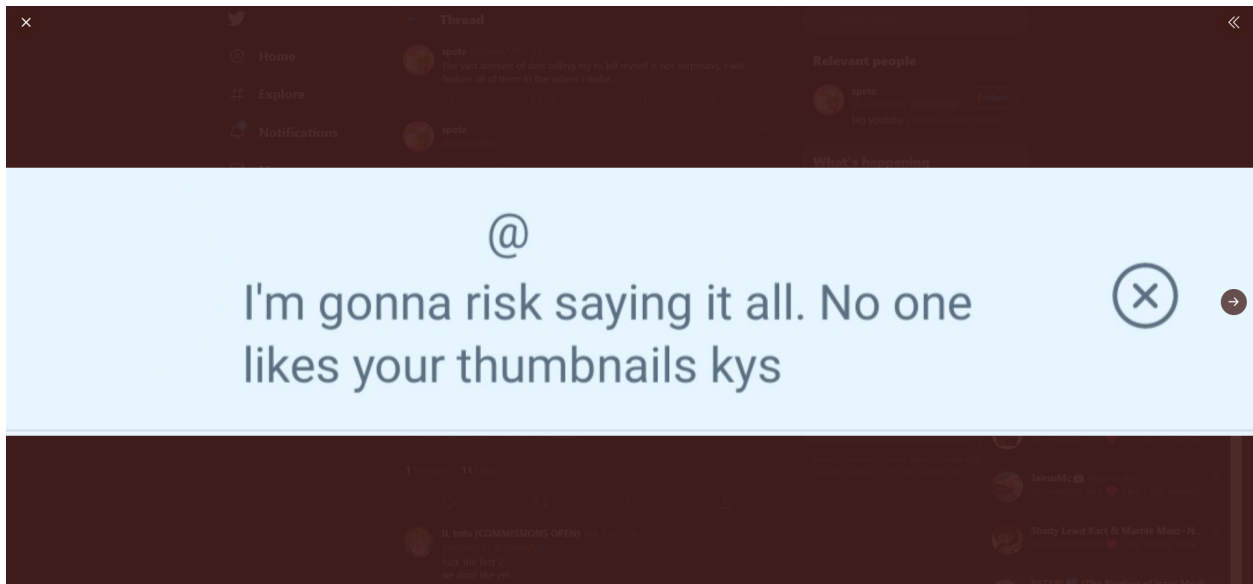
After this he makes a tweet saying that he didn't owe me anything. He says that I didn't change at all, because somehow being misinformed on a situation equates to shit-talking someone for having cancer in his eyes? I personally think it was just an excuse to make one part of his video a discussion on the Ramen situation, and another on the cancer situation, so he can get that sweet sweet ad revenue. Speaking of ad revenue, if you go to his video at the time of writing, he has an ad placed right in the middle of the video during the footage of Ramen breaking down and crying over being sent death threats and harassment. Such a swell guy who cares sooo much about the community he profits off of.



Well, that's enough about the situation in terms of where Spete and I stand. Both still at each other's throats and still going to upload our videos. So what we've seen so far is:

- Spete hiding evidence to make himself look better
- Going against his word for the sake of being a drama-hungry freak
- Trying to play victim and claiming my fans harassed him when all they did was scream "ratio"
- Showing that, even after I rightfully called him out, he will continue to make another video on the matter so that he can make more profit off of the community.

With the third point, he's posted screenshots of people sending him death threats in his DMs. I won't deny this, and I won't deny they're messed up, but at the same time, he'll probably try and act like I told my fans to send him death threats. I get that Spete is a gross pos, but if you're sending him death threats then you seriously need to tone it down a dial.



Anyways, onto the next part: Twisting the truth for his own gain

So as you know, drama channels don't intend on giving you the 100% truth. Their goal is to tear eachother apart and watch chaos ensue. Spete sure does a great job of that, seeing as he's willing to lie about almost anything he can and use it for content. For starters, let's take it back to twitter with this screenshot of him claiming that I sent people to harass him. Now it seems bad at first glance, right? It's a reply that can be taken VERY easily out of context.



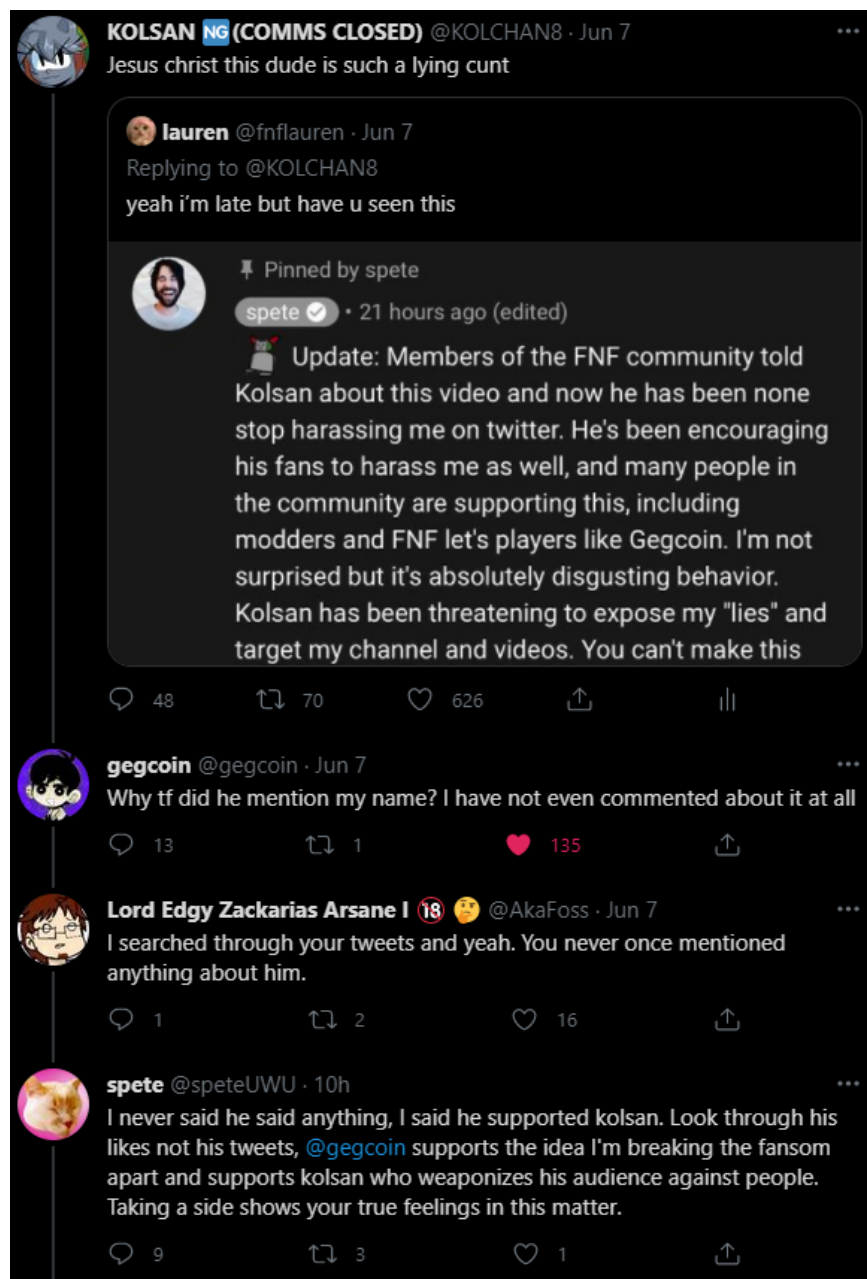

Gegcoin has maintained his innocence throughout all of this. The only reason he was brought in was because Spete believes that Geg liking my tweets meaning he endorsed them. For all we know, geg couldn't have wanted to remain completely neutral on the situation. But Spete insists that geg liking a tweet means he's also harassing Spete. I truly believe that he's just digging himself in a lie that he can't turn away from, because ain't no way in hell someone's THIS fuckin' incompetent.



He tried to take a jab at me and my HD crew saying that we sent our fans after him, and gegcoin asked again why he was brought up in a situation that didn't even concern him. This was the reply:



He says I harassed him for 24 hours when most of my tweets were calling him out on his hypocrisy and blatant lying. This is what happens when you refuse to believe that you can do any sort of harm. He claims that I'm weaponizing my audience, when he literally does that exact thing by telling me he's going to make content on me. Alright moving on: The response from Ramen

Ramen reactivated his Twitter some time on June 7th and addressed the situation almost immediately. He made a thread where he agreed that

the whole situation should've been kept private or just on an entirely different video.

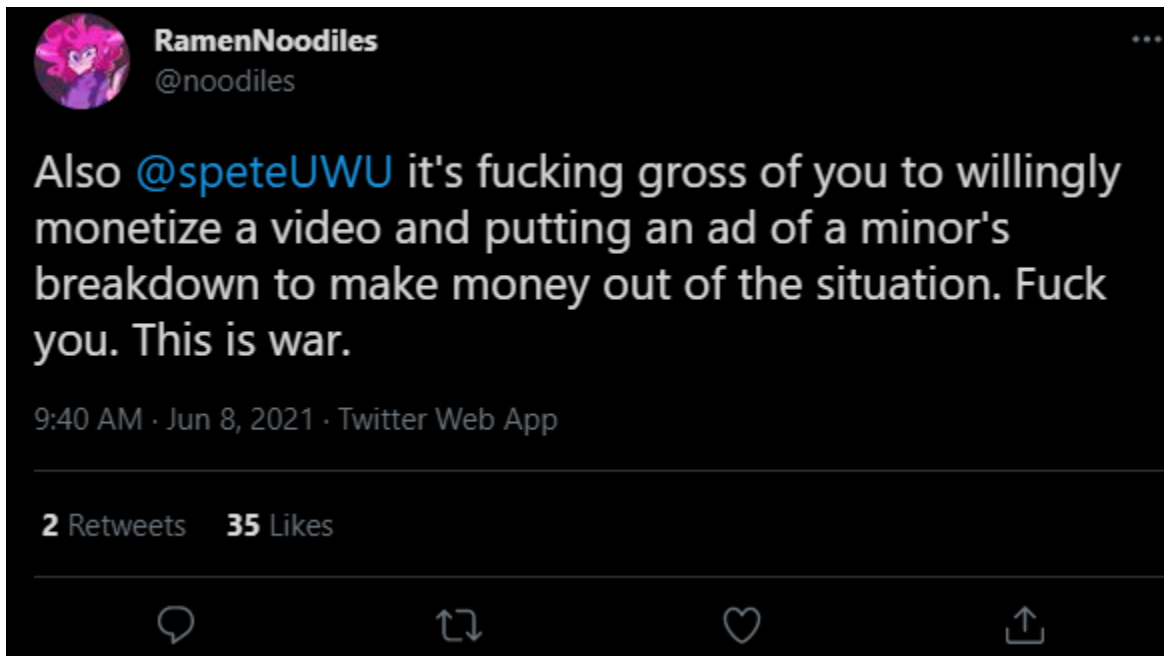
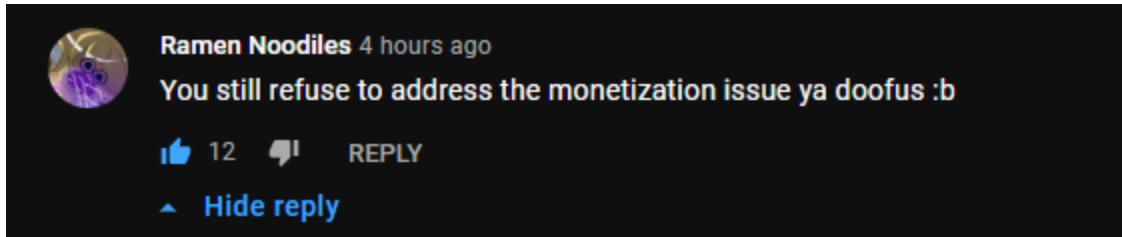

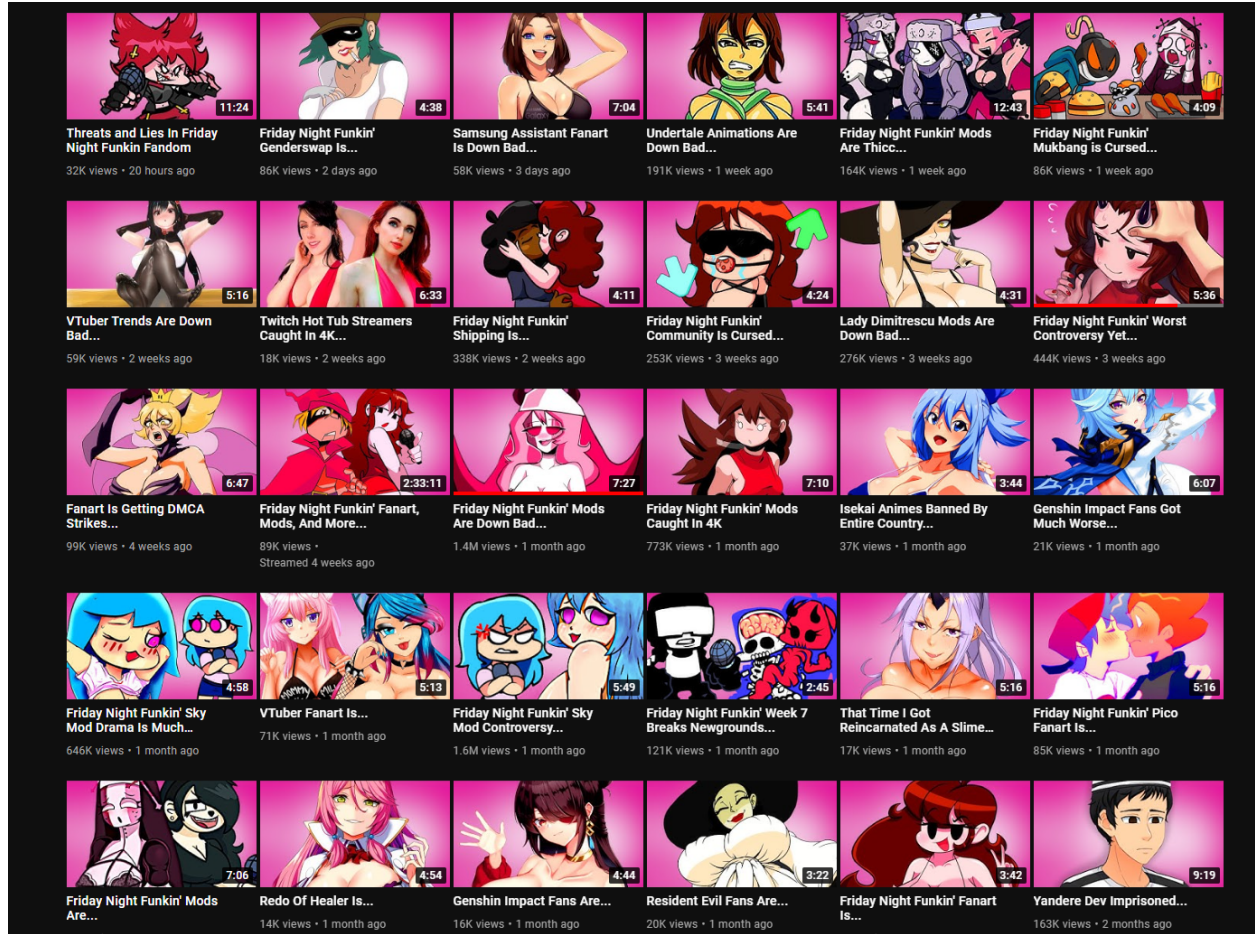

Ramen would go on a live stream the next day to talk about the situation with Spete, where he mentioned the advertisement conveniently placed in the middle of Ramen's breakdown footage. Ramen asked Spete about it multiple times, but he's still yet to answer as of writing.



Ramen has basically joined the Spete hate train, I'm surprised Spete hasn't tried to bring them back into this considering how he loves taking shit out of context for his own gain.
