What: Valerie DuPont Vukelich first visited St Luke's on Nov 6, 2022. When I introduced myself before service, she said she was a lapsed catholic attending church for the first time in over ten years. I said that she was probably baptized and if she felt inclined, she might take communion. She did and stayed for a tour of the future preschool, coffee hour and the 10:30 service. I believe at coffee our I learned that she was out of the air force and studying cyber security.

That same week she stopped by the office with puzzles for the future preschool. There might be fingerprints on the puzzles. My fingerprints are certainly there. I do not recall if she made an appointment.

Valerie asked about how to draw closer to God. This is not unusual. I told her to attend church regularly, directed her to Bible study app, asked her to consider images of God that pleased her and talked to her about the use of bells. I think the book I wanted for her was gone but I gave her another about the history of the Episcopal Church. The administrative staff collected her phone number, address, email and date of birth. None of this is remarkable.

The important part of the conversation is that she wondered if she could fit in at St. Luke's. She said that people can be so judgmental. When she was speaking, she could not maintain eye contact. She said that she met a person while she was in the military that she thought might be her spouse, eventually. Maybe the location was Iowa? I asked how long she had felt this way. She said about a year. And went on to say that the problem was that the person was almost 16. This means that a 19- or 20-year-old service person may have been interested in a 14-year-old. I told her it was not a matter of being judgmental but of legality. I said there is an inherent power differential between people who are vastly different in age. That is why it is illegal. She said that he was careful to avoid exerting pressure on this person. It was not clear to me if this was a boy or a girl. I asked her if there had been physical contact. I told her that would be a very serious and that I did not know the age of consent in Iowa (?). She said because the person lived in another state there was no possibility of physical contact. I asked if the parents knew about this relationship. She said that very soon she planned to meet the parents and get permission to offer a promise ring. I said a promise ring might be age appropriate for a teen. I failed to say that an adult out of the service might want to hang out with people her own age.

A couple of days later Valerie made a donation to the turkey box fund via Venmo. Her Venmo handle was Valerie Sappho. I sent a thank you message via the Venmo app. The icon she used for herself was a cartoon animal with fiery eyes. The animal was unclear. Maybe it was a rat? I thought it was unusual for an adult. This let me know that Valerie was probably a lesbian, and that the child was probably a girl. The Episcopal church openly welcomes gay and lesbian members. It is not a problem that Valerie is a lesbian.

A couple of weeks later, Valerie proudly showed me a black silicone ring which she said was a promise ring in the foyer of the church before service. I think it was 8:00 service on Nov 20 But I am not confident about that date. I asked if she had met the parents. She said, "Yes she had." I said, "My best friend, Heidi, met a man older than herself when we were 16. It was illegal. Her mother did not approve. Heidi was not one to defy her mother. She kept the phone number of the man *until she was of age*. The man had no contact with her. When she turned 18 she called him. They have been married for almost 30 years." Valerie said, "That is the hope right? Thank you for telling me this story." I said, "But right now this child cannot consent to an aspirin. You know that right?" She did not answer but went to sit down for church.

I did not see her again in person.

On Nov 23 2022 8:53 pm my Administrator was contacted anonymously to say that Valerie was a dangerous person. She paid little attention because this person was a stranger and called after hours. This occurred twice more. My staff person did not mention it to me. On Dec 19, 2022 at 9:45 am our

digital person in charge of streaming noticed a comment on the Nov 6, 2022 stream. It might have been there for some time. The comment was from Duncan MacDougal of Kiwifarms. It said

“From 36:00-39:00 this video features infamous internet pedophile-zoophile Connor Roundy, AKA Sappho in the back row. Connor lives nearby and is actively hunting prey. Warn the neighborhood. Info here, but warning for vulgar content not for casual viewers.

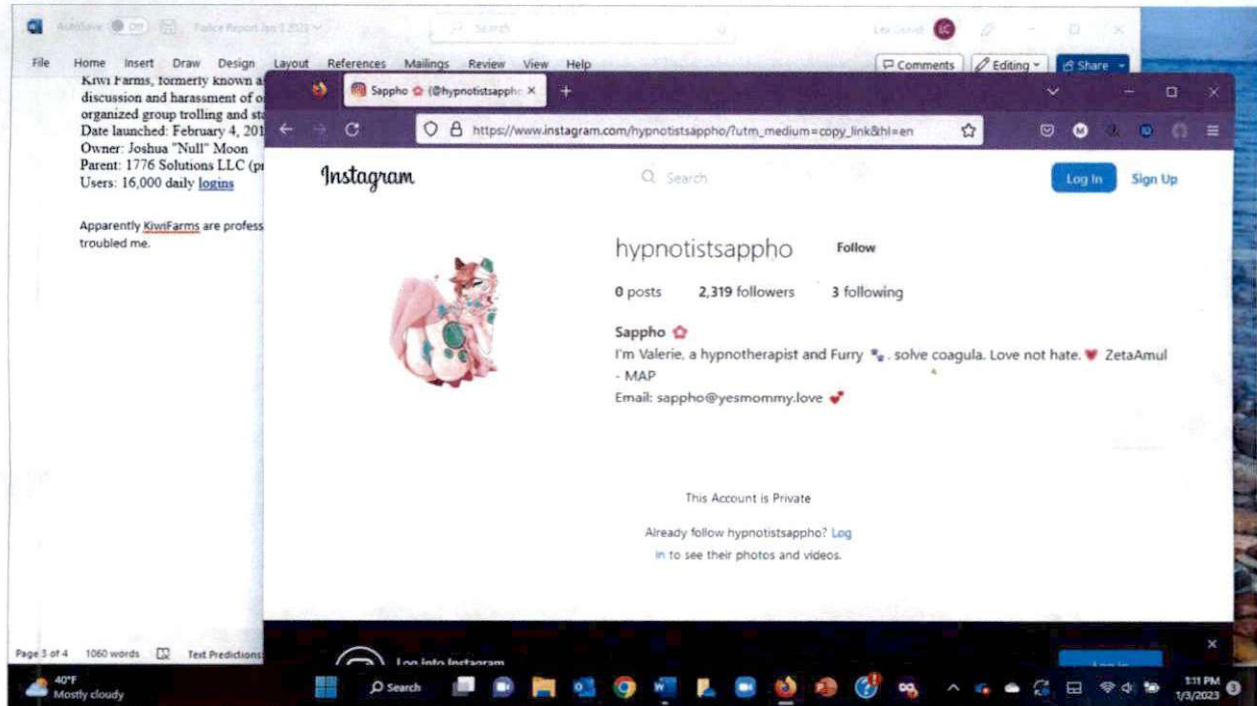

Apparently KiwiFarms are professional trolls. They often harass trans people. Not a great source of reliable data but the Sappho part troubled me.

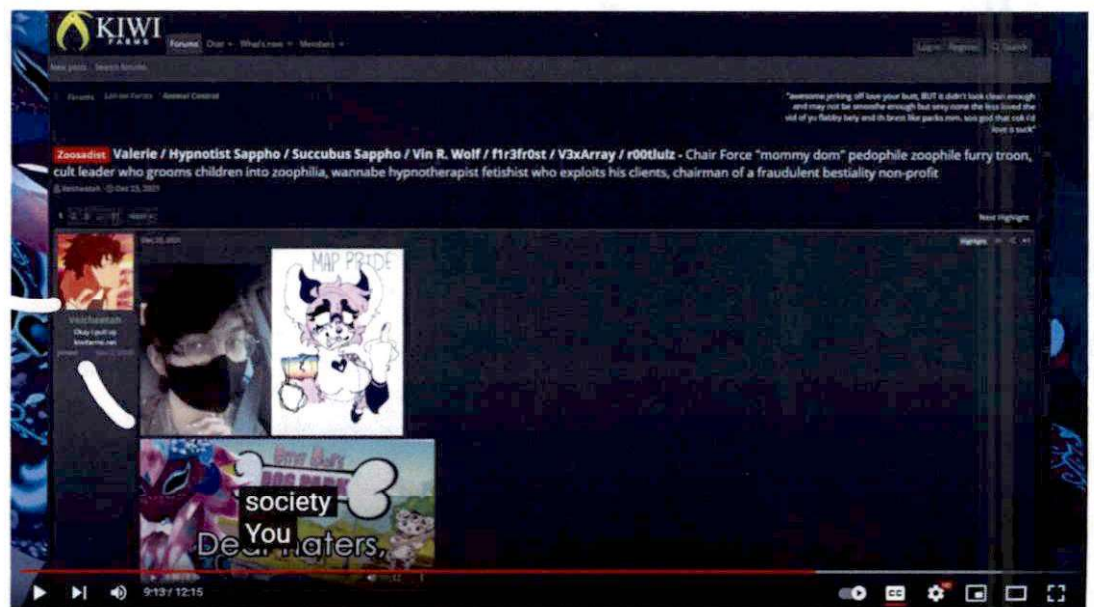
I found this identifier. MAP is a minor attracted person or pedophile. I had to look that up.

I texted my boss, Bishop Jos Tharkan and told him my concerns on Dec 19, 2022 at 3:23. I asked the church lawyer (Chancellor Lauren Murdock) for council on Dec 28, 2022 at 4:19 pm. I am aware of statutory rape laws. I did not know that digital grooming of a minor is a crime. I think it possible that Valerie might be a registered sex offender, have been discharged from the military for conduct unbecoming. I am a mandated reporter. I did not know how to go forward with aliases. I was not sure if calling the police would be slander. Chancellor Murdock told me it would not.

I will certainly ask Valerie not to attend. I do not know what to do if she shows up anyway. I need advice. I would not want to alert her to an investigation.

I believe other churches should be informed. If it is lawful for me to do so, I would like advice on how to proceed and even happier to delegate this to the police. Valerie has military training and could be armed. I would like advice on security.

I am reporting this potential of crime as accurately as possible.
