ENFORCED BY JUDGEMENT AND IS GOOD IN ANY COURT OF QUALIFIED VENUE
OR JURISDICTION).IF THE CHILD IS BORN WITH DEFECTS, IS STILL BORN OR IS
ABORTED THE DEBT IS CANCELED.IF THE CHILD IS BORN ALIVE AND HEALTHY
THE DEBT IS VALID.

TERMS & CONDITIONS

1.THIS CONTRACT STARTS ON _____AND IS VALID FOR ONE YEAR FOLLOWING
THAT DATE. DURING THIS TIME ALL SEX BETWEEN THE MAN AND WOMAN IS CONSIDERED TO BE FULLY
CONSENTUAL

2.SHE STATES SHE IS NOT MARRIED AND CANNOT BE UNTIL THE CONTRACT IS EXPIRED. NO CHARGE OF RAPE
CAN APPLY.THIS DOCUMENT CANNOT CONFER ANY BOND OF MARRIAGE WHATSOEVER.SHE ALSO CONFIRMS
WHETHER OR NOT SHE HAS EVER BEEN MARRIED

3.THIS DOCUMENT OVERSHADOWS OR SUPERSEEDS OR HAS PRIORITY OVER ANY OTHER DOCUMENT OR
LAW.

4.THE WOMAN MUST FURNISH THE MAN COPY OF THE BIRTH OR DEATH CERTIFICATE AS SOON AS POSSIBLE.

5BOTH PARTIES AGREE TO FURNISH EACH OTHER RESULTS OF AIDS OR STD OR POSTIVE PREGNANCY TESTS
AND OTHER RELEVANT DOCUMENTS AS SOON AS AVAILABLE.

6THIS DOCUMENT HAS PRECEDANCE OVER ANY AGREEMENT PREVIOUSLY IN FORCE.

7 WOMAN HAS FULL OWNERSHIP OF AND ALL CLAIMS TO THIS BABY AND HAS THE FULL POWER
OF PARENTHOOD

8 THOUGH FATHERS NAME MAY BE ON BIRTH CERTIFICATE ALL(PARENT) RIGHTS STILL RESIDE WITH THE
WOMAN.(INCLUDING THE RIGHT OF ABORTION)

9 IF WOMAN DOES NOT SHOW UP FOR REGULAR ATTEMPTS (VISITS) TO BECOME PREGANT TO THE
SATISFACTION OF MAN, NOT TO EXCEED 10 HOUR SHE CAN BE DROPPED FROM THE CONTACT

10.THE WOMAN AGREES TO LET THE MAN SEE THE CHILD AT BIRTH AND TAKE PICTURES AND GET ALL
REVELANT DOCUMENTS RELATING TO THE BIRTH.THE STUD SHALL NOT BE ALLOWED TO TOUCH THE CHILD

11. IF THE MOTHER SHALL BE ALLOWED TO CONFER ANY OF THE MARRIAGE RIGHTS TO THE FATHER AT ANY
TIME IF SHE SO WISHES..
