

The Manipulative Snake Pit

You asked for this, Delta. You forced my hand to do this. After half a week of going through helping Zengo cleaning up the mess that his detractors have been causing, it's time I put an end to this.

You may be questioning what's going on with Zengo in recent days and some people tried to push for false pedophile allegations because of the Google doc Delta added in and pushed it so far to the point of causing a few individuals to quickly jump against Zengo (essentially what I call the ProJared Fiasco).

I ask you to read this documentation in entirety as it covers more about the situation than the detractors who put so much fluff without any strong counter claims to back them up.

Without further ado, let's get started.

The False Claims against Zengo Oshiba (and debunking them)

Just to give you a short run of the story. Zengo's been falsely accused of asking for CP. The issue was: He heard about the situation regarding the Spaicy Project on March 7, 2022 and asked an individual what happened.

The callout in question was made by DSAI (MaxXandrew) on Twitter calling out the Spaicy Project. Complaining about grooming minors, sexual abuse, etc. The documentation in question was translated from Spanish to English and it's been filled with accusations. Less severe ones such as tracing art, but more damning are going to a Japanese school building and Lou allowing minors into the server to see NSFW. Much of the actions were done by the mods and staff in it (and their Facebook group). Zengo (in his OWN admission) was not one of them.

Even Lou said Zengo never worked for the Spaicy Project while that controversy was going on. Lou claims the allegations have been malicious and fake.

As it turned out, He hasn't done anything that his detractors would want you to believe. Zengo admitted it was a poor choice of words at the time. But the fact of the matter is the individual (Toxic Cookie) lives in Spain and uses a Spanish app that translates to English which causes inconsistent claims in her age and time periods (we'll get to that shortly)

Despite this, some of his detractors (namely Delta225 since he chose to break his word. I'll get to him later) took it out of context and tried to paint it as if he's doing heinous things when it's not the case.

I have the thread in the link for further context (and Lou said Zengo was never their Mod to begin with). 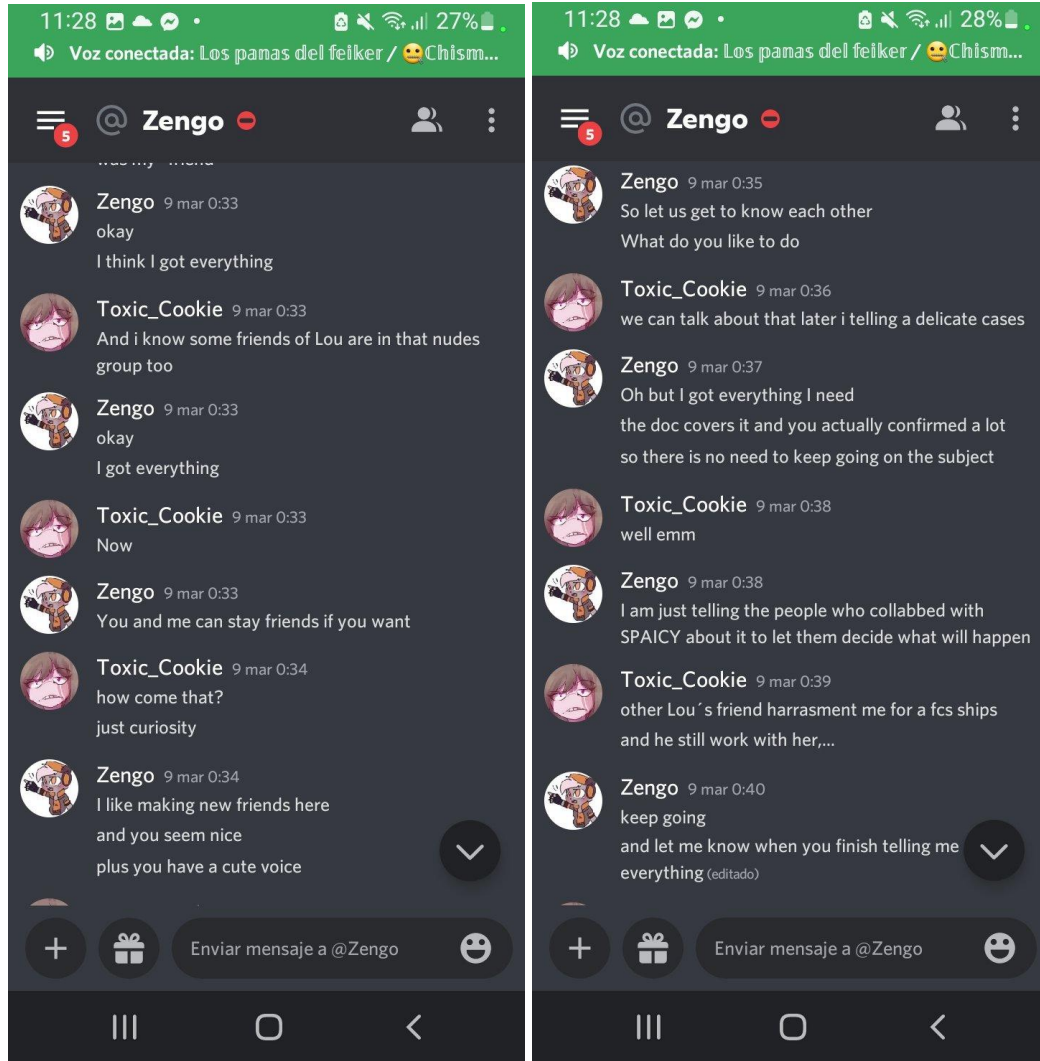
The Thread breaks down specific details regarding one screenshot of MaxXandrew accusing Zengo for a false CP allegation which Delta and his goons use this information to twist into their sick and perverted claims (I hope you appreciate the headache I got for this).

The chat logs in the Twitter Thread showcase the inconsistencies of the language barrier at the time. Toxic Cookie was using a Spanish App that allows her to translate into English. Throughout them, she's made disjointed dates of her age and actions done by these SP Mods. This was confusing to connect the dots in these time periods.

Again, Zengo was NOT a mod at the time and never was to begin with.

One thing to note in the next two screenshots is that Toxic Cookie (and Delta blissfully used to make up another false allegation) and Zengo talked. They had a voice chat together at that time and he commented about her voice being cute.

This would be a problem if Toxic Cookie wasn't 19 at the time. If an individual was below the age of 18, that would be brought into question and Zengo would've been behind bars by now. He even admitted Toxic Cookie was 19 at the time of their conversation. So any attempts to twist this information is moot.



So there you have it. Zengo was never a mod of the Spaicy Project to begin with, nor have there been any proof of him doing these heinous acts his detractors claimed.

But you may be asking: "Is Delta225 the only known accuser for spreading this nonsense over content?" Well, the content part, yes. Overall, no.

The Narcissistic Astra Ahina

This is where Astra Ahina comes in.

I'll start this off with how I met Astra. Back in December 2021, I met him after Zengo helped him over an issue with people going on about Astra. I did art commissions with him from that point until the end of March of this year.

Zengo warned me about Astra's suspicious behavior in how he's been sending him tweets and replies about Zengo's persona (we'll get to that in a moment). It's also noted he's tried to get back with Florae Fempyro, a very infamous individual who has stalked Zengo for over 6 years now.

Florae originally left Astra over their political differences (Astra supposedly being a Trump supporter, though I doubt it's relevant to this topic. And someone like me who is a Centre-Right Conservative, I think this is preposterous. But I digress). Point is, they've been back and forth because both hated Zengo over petty reasons.

After learning about Astra's occasional lash outs at Zengo on Twitter, I had to block him to avoid getting into his arguments (thus, this ends my business with Astra).

Sometime at the start of June, Zengo made a PSA going into Astra Ahina. The video goes into Astra's narcissistic behavior in replying with doom and gloom replies and doesn't like to have fun unless it caters specifically to him.

Another part of what makes Astra quite unhinged at points is he does not like his OCs to be compared, specifically if you're pointing out cultural references or just critiquing their attributes (even calling one of his OCs -- a Dragonball Cat Goddess -- a Mary Sue). Astra would throw fits over bits he's called out for.

Now, I have to interject by saying that it's a bit preposterous that people tend to get unhinged when their OCs are referenced to cultural links. Especially if it's pointed out positively. But again, I digress.

The Foolish Comic Relief of Delta 225

Moving on, after the video on Astra was made, Delta225 made his response at Zengo and was making complaints over his interactions with him. Saying Zengo doesn't stick to his word, putting out DMCA claims, etc.

On a slightly unrelated, yet relevant note: Delta -- in his Google Doc that was released shortly this month -- took a picture of Zengo interacting with Toxic Cookie from long ago and tried to paint it as if he's wanting CP. Now, this part I already went over (feel free to scroll back up to refresh your memory if needed).

Rewind a bit. Zengo, WackyZebra, Delta225 and I had a call on Discord discussing the takedown on Delta's video (and TyrakatheDragonFan specifically for the Shantae Model Pack when Astra got blacklisted for attempting to send models out for free when it goes

against the rules after paying a donation and it was for specific donors until the Pack was done).

And while Delta has been claiming Zengo doesn't take this matter seriously while the former is willing to laugh and chuckle over the discussion during a serious matter. You'd think that any Adam Sandler movie would be the worst comedy movie, but this tops it.

To touch on the bit with the Models, I'm sure you're aware of the War in Ukraine. Because much of Russia's exports were cut off, this also meant payment processors were not so easy to transfer. and thus, having to easily request refunds is completely out of the question.

And yet -- after coming to an agreement that Delta would not talk about me, Zengo or Wacky on everything, after Zengo promised to lift the strike on Delta's video lifted and not bring up each other again -- guess what happens? Delta broke his word and decided to upload it because he was still crying about Zengo where he himself would have just moved on with his life.

Fast-forward to where we are, Delta uses the false claim that Florae Fempyro was also using to get her petty revenge on Zengo over a live stream she had no business in taking control of and was whining about for years.

But what does Astra have to do with all of this? Astra has been trying to team up with Florae (his former GF) and a few others to spread lies about Zengo and damage his reputation over false allegations. He's ultimately the one who has been using these lies to get his petty revenge. In fact, this is what got me to resent Astra and his folks this time around because I had to stick my neck out for Zengo and clean the mess they caused us. Me, Zengo and our audience.

Obviously, Delta doesn't realize that he's guilty of the same thing he claimed Zengo to be doing (which bears no fruit in hindsight).

WackyZebra. For shame...

WackyZebra took Delta's side after being coerced back into Galaxy Trail if buys into the false allegations.

Initially, Wacky stuck his neck out for Zengo and tried to help him. This results in the GT folks attacking him and even discarded his contributions because he made a Twitlonger post saving him.

I stepped in to help Wacky to explain why these people have been trying to bribe him back right after THEY threw his sprites and works. GT knew they threw out Wacky's works if he were to side with Zengo. They just didn't care.

But fast forward, Wacky (along with Lord Genie Julius, Jojo/AnthemSpirit74, GhostofTime1 and LizzieRatcicle) back-peddled and stabbed Zengo in the back when Delta got him to his side for believing in the false allegation.

I wanted to give Wacky the benefit of the doubt. He just didn't think twice about this incident taking place. But I have yet to see any authenticity from his betrayal; either by accident or deliberate.

The Unhinged Sindroom

To make matters worse, Sindroom (who lives in Russia) doesn't want to work with Zengo because of these false allegations. I tried to step in to be the one in charge of the Model Pack. However, Tyraka tried to take over and said only 1 model gets canceled and another released publicly for free (two of which being Zengo's models he paid for personally).

Keep in mind, Zengo paid for 5 of his personal models (not for the Shantae Mega Wish Pack, mind you). Only 2 Models were for the Model Pack and donated by people in full.

2 Freedom Planet OCs he owns:

-Random Female Fox model

-Kuaka, Shantae's Mother (my OC)

-Fusion of Shantae (WayForward) and Neera (GalaxyTrail)

The 2 models that were in the Model Pack which were paid off were Sky and Harmony with Squidsmith having only \$45 towards her at the time.

I tried to warn Sindroom that releasing one of Zengo's models publicly for free and scrapping another would be a disastrous mistake on his end but wouldn't listen. Chances are some Donators (a few being those who submitted OCs) would potentially have Zengo take action to get their money back but he previously expressed to said individuals that refunds were not possible.

And thus, resulted in the Shantae Model Pack coming to a halt. He tried to get away with the money that Zengo paid Sindroom for his personal models, but Zengo called his Bank and Paypal to sort out the refunds. Sindroom did try to counter-claim the refunds and called Zengo's attempts to get the money back as if he was on the wrong side.

Ironic that Sindroom -- being a top-quality modeler at a decent price -- turns out to be an unhinged lunatic. Not only trying to cut ties but also willing to abuse the rules in the Model Pack as both Astra and Tyraka tried to (even letting them do so in the process).

Tyraka the Dragon Wimp

Tyraka is a Spyro fan who makes a series known as the Saga of Spyro. Something Legend-themed but a bit more realistic, yet somewhat cartoony like Reignited.

While Tyraka's part is very small compared to overs, his attempts to take over the Shantae Model Pack.

He and Sindroom tried to run off with the models and the former tried to claim ownership of Zengo's OCs, and mine (Kuaka, Shantae's Mother).

Tyraka, of course, jumped the gun and took Delta's word for it without even looking into details. It's very funny that someone like Tyraka pulled this stunt due to his own stupidity when he made a post about a different situation.



Keep in mind, Tyraka is the same guy who hates NSFW works, and yet made one with over-sexualized Five Nights at Freddy's animatronics in the form of anime-styled models... that have corpses of children stuffed inside them...

Tyraka, I ask you. Are you really Christian? If so, do you recall Matthew 7:2? You claim you're against NSFW, yet you made a FNAF post about it? You also said that there is only one special kind of dragon style. Yet, you are willing to use a cartoon-styled Spyro model (a more detailed one, but still within the style itself).

Take the time to remove the scale off of your own skin before removing someone else's.

The Florae Vampire

Saving the absolute worst sinner for the best, Florae Fempyro.

I will leave a video Zengo made regarding this degenerate of a human being she really is.

Florae Fempyro was a TF2 player and started out being friends with Zengo on Steam back in 2016.

Things were starting to go downhill when Zengo did a livestream on YouTube. Florae threw a fit over the fact he did so without her (which she had no business – of any kind – in doing so). Now if Zengo had asked if she would join, it would've been different. But he didn't.

Since she fell out, Florae has been stalking Zengo for 6 years.

If you thought Robert Hayden Simile stalking MisAnthro Pony for over a year because he said bad things about the Last of Us Part II was really stupid on Robert's end (even going as far as attacking his family members), it's still bad. But 6 years over a live stream and sabotaging his fanbase for false reasons is petty revenge.

Everything that ties into Astra Ahina's narcissism, Delta's clout-chasing nonsense, Wacky's out-of-left field fallout, Sindroom's unhinged madness and Tyraka's pathetic hypocrisy. All that is tied to Florae's petty revenge because she couldn't control Zengo's YouTube channel.

How difficult is it for YOU, Florae, to grasp that no one on this planet is obligated to coddle your feelings. Zengo is entitled to use his YouTube channel. Him streaming on the channel? He's entitled to do so without anyone to control him.

On November 2021, I got a DM by Florae who has been telling me of TBone2004's stupid video on Zengo. Making false claims about payment issues and false pedophile allegations that have ZERO connection to anything.

After I told Zengo about this, he told me to block her and that's because she's been stalking his fans to betray him. Some she managed to snatch, others not so much.

Fact of the matter is, Florae has created 6 Twitter accounts (Her @/FloraeLuvsGreen one was changed into a different name before being deleted from Twitter). The others tend to range from 6 to about 50, but not enough to warrant a widespread cancel culture.

I think Buttons and Florae would make good friends for being the toxic pieces of human waste they are if you ask me.

My Experience

Zengo and I have been friends since April 2020 when I was still new to 3D Modeling. He tends to be awkward at times, but doesn't seem to be all that bad.

Yes, he has autism (and would occasionally make outbursts when things don't go too well). But it's not something I would take an issue with.

That said, I should go over some things.

“Well first of all those accusations are not false, there is literally evidence backing up my claims, and asking for CP regardless of context or intent is illegal.”

What specifically did Zengo do to ask for CP? If you just glossed over the screenshots that debunks your false allegations, you should double check.

“Second, it's clear you have not actually read the document for yourself. I recommend you read it before coming to any conclusions.”

I don't need to read your document if it's full of misinformation. Cope.

“Third, When you do read it, you'll know that Zengo himself cannot uphold his own agreements, so why should we uphold any agreements he proposes?”

I'll admit, Zengo has a weakness of going back to things (and I sincerely do not approve). Funny how you broke your word on not speaking about him.

“Really all we're trying to do is get you away from Zengo. We're trying to save you from him. We recognize that you, Obscured Titan, and Zengo, are two separate entities, and it would be best if you didn't have to deal with him anymore. I know you've been through a lot of headaches.”

Firstly, I don't care if Zengo says mean words on the internet. For as long as he does not cross specific moral barriers, I DON'T care if he's mean. It's reality. I'm not near that, but I have my reasons.

Secondly, those headaches were caused by Sindroom when I offered to fill in Zengo's place to run the Shantae Model Pack. I spent 3 TO 4 HOURS of talking to this guy and resolving this issue and ruined Shantae's 20th Anniversary. Take the L, please.

"If not, then fine, call me out publicly. Unlike Zengo I won't falsely copyright strike the video, instead I'll maybe make a commentary on it countering every point."

Oh, trust me. It's happening. But I hardly doubt you'll have anything to back up with the claims I have here. Double L.

Also, to those of you who followed me on Twitter know full well I called out Netflix Cuties back in August 2020. It was a French film that happens to be a girl story of fitting in with the crowd with the girls – ranging from 11 to 12 – being sexualized. France's age of consent is 15, and that should've been a red flag to you.

I deleted my Netflix profile to not support a company that would endorse the film. Granted, they didn't make it (just a distributor), but they still allowed it on their platform.

I am against CP, and so is Zengo. You want to know who you should be furious at? Mr. Girl.

Matter of fact, I wish you were more furious over Ellie Godellia who has been ousted as an actual pedophile instead of Zengo saying mean things about OCs.

I have to admit something before going any further. I used to jump the Projared bandwagon. I didn't look into what was going on with him in 2019. He was falsely accused of predatory actions when it was all fabricated (and the nudes Projared got were consenting adults).

This is a mistake I do not intend to repeat.

Zengo only knew about the Spacy Project's controversy when hearing about it and looked into details from what was happening. He was never a mod of SP to begin with. Don't believe me?

Lou confirmed this to Zengo and asks to take it as an advice:

"Look, I'm sorry you are going through this and all the stress that goes with it, but believe me, what I learned from all of this, is that the only way to stop this situation is to leave the topic aside and block those who harass you. Just don't talk about it anymore, because the more you do it, you will only generate more drama content.

You already made it clear that you were never a mod or that you asked for CP, that's enough. If people don't believe it, that's their problem, not yours. Besides, there is no proof of that, only rumors and screenshots out of context.

So you should be calm knowing the truth, and just go on with your life and creating content, it's not worth stressing and wasting your time with it.

End of statement, I don't want to touch this topic again."

That's it. This should be the end of it all. I have spent months now getting so many of Zengo's detractors off his back.

If anyone on Delta's side reading this, know that I am not changing my position based on YOUR moral values. Getting upset over mean words and twisting the Spacy Project situation to paint Zengo as if he was a predator and even going so far as to put me in a place where I'm the only one to do all of this work.
