NARRATIVE

On 04/30/2026, Sarasota County Sheriff's Office Deputies met with Livia Kuhn in reference to a dispute she wanted to report that had taken place with her boyfriend (now ex-boyfriend), Mason Hull.

Kuhn advised she and Hull have been in a romantic relationship for approximately eight months. Over the past several weeks she stated she had the inclination Hull had been cheating on her. On the morning of 04/30/2026, she decided to go through Hull's cell phone while he was sleeping. Kuhn advised while looking through his phone, she found an application on the device, Telegram, which appeared to have been recently used.

Inside the Telegram application, Kuhn advised she discovered several chat messages where Hull is communicating with several different people. The content of those messages included dialog where Hull is sending "confirmation of payment" in exchange for child pornography. Kuhn, using her own phone, took photos of some of the messages. She advised she viewed links and photos/videos within the chats that contained child pornography. Kuhn provided the screenshots to deputies.

Your Affiant was contacted after Kuhn made the report and was made aware of the incident. Your Affiant contacted Kuhn and set up an interview with her on the same day.

Your Affiant met with Kuhn on 04/30/2026 at the Sarasota County Sheriff's Office Headquarters. During the interview, Kuhn agreed to participate in a controlled phone call with Mason Hull.

Mason Hull answered Livia Kuhn's phone call but was hesitant to speak. He stated he was unsure if she was truly alone and if he was being recorded. He did tell Kuhn that he had already spoken with her earlier in the day about the conversation and did not want to speak about it again over the phone.

Your Affiant responded to Mason Hull's residence after Kuhn's interview. Hull answered the door and stated he would speak to me regarding the incident. Mason Hull was read his Miranda Warnings. He waived and agreed to speak with me. The following is a summary of the interview and not verbatim: Hull advised he has been using the Telegram application on his cell phone to access child pornography. He stated he recently decided to "try something new" and sought out a type of pornography that was taboo. He stated there were at least two separate occasions in which he spent money to be provided with links to access child pornography. When asked about the age range of the children involved, he stated the children were between the ages of 8-15 years old.

NARRATIVE CONTINUED

Following the interview with Mason Hull, his cellphone was seized. The following day, 05/01/26, the Honorable Judge Brewer signed a search warrant for Hull's cellphone.

On 05/05/2026, the forensic download of the device was completed. Your Affiant reviewed the contents of the device. Fifteen (15) videos of child pornography were located within the device, some of which are described below:

Filename "f63.mp4" contains a 17 second video of a female child between the age of 8-10 years old. The female child is on her back with her knees bent back to her elbows. Her wrists are tied to her ankles using a purple-colored leather bondage device. The female child's vagina is penetrated by an adult male's penis through the duration of the video.

Filename "f71.mp4" contains a 13 second video of a female child between the age of 6-8 years old. The female child is naked and laying on a bed on her side. The female child's vagina is being penetrated by an adult male's penis during the video. The female child at one point begins covering/grabbing her face and starts crying.

Filename "f66.mp4" contains a 46 second video of a female child between the age of 8-10 years old. The female child is laying on a bed wearing only a pair of pink socks. At approximately 12 seconds into the video, a naked male gets onto the bed with the female child and spreads her legs open. The adult male inserts his penis into the female child's vagina and begins having intercourse. The female child is screaming and crying through the duration of the video.

On 05/05/2026, your Affiant contacted Mason Hull via phone and requested a follow-up interview. Mason Hull agreed to meet at 1400 hours. Later in the afternoon, your Affiant was contacted by Hull and was advised he would not be meeting.

Based on the aforementioned, probable cause exists to charge Mason Isaac Hull (DOB:07/04/2007) with 15 separate counts of the possession of child pornography, a violation of FSS 827.071(5a).

Furthermore, because the defendant possesses more than 10 images/videos and one or more of the images/videos depicts sexual battery involving a child, this is a violation of FSS 775.0847(2)(a) & (b) & (3)(a) which enhances each charge to the next degree higher.

This incident occurred in Sarasota County, Florida.
