**PLAINTIFF'S EMERGENCY EX PARTE MOTION FOR TEMPORARY  
RESTRAINING ORDERS**

Now comes Plaintiff Tyler Martin (hereinafter "Plaintiff"), by and through counsel,  
hereby submits this Emergency Motion for Temporary Restraining Orders pursuant to  
Mass. R. Civ. P. 65.

1. As set forth more fully herein, and as supported by facts set forth in the Affidavit of Tyler Martin, attached hereto as Exhibit A, Plaintiff is entitled to a Temporary Restraining order against Defendant, Lionel Frederique Target (hereinafter "Defendant").
2. On or about February 20, 2024, Defendant published Plaintiff's residence address and photos of his home in at least one public Discord server with the caption, "Check out Xenosys Vex's house! This is Tyler Martin's house & address. Pretty neat!"
3. Shortly after publishing Plaintiff's residence address and photos of his home publicly on Discord, Defendant began sending Plaintiff a series of threatening direct Discord messages which contained, among many other things, threats to

“slit [Affiant’s] throat,” “gut [Affiant] like a fucking fish,” and to “break into [Affiant’s] room and spend 20 minutes stabbing [Affiant] to death,” and stated that Defendant would “rather bash [Affiant’s] mothers skull into mush.”

4. Plaintiff submits that, unless enjoined by order of this Court, Defendant will continue to threaten, harass and/or abuse Plaintiff, and that Plaintiff will suffer irreparable harm, for which he has no adequate remedy at law.
5. Plaintiff submits unless enjoined by order of this Court, Defendant will continue to threaten, harass and abuse Plaintiff via Discord, for which he has no adequate remedy at law,
6. Plaintiff submits unless enjoined by order of this Court, Defendant will continue to post images of Plaintiff’s home and personal address on Discord and/or like social media sites, and that he will suffer irreparable harm for which he has no adequate remedy at law.
7. Plaintiff further requests that the Court specifically waive the requirement of Rule 65(c) of the Massachusetts Rules of Civil Procedure since Defendant will not incur costs or damages as a result of being enjoined from threatening, harassing, abusing or doxing the Plaintiff;
8. Plaintiff submits that he understands that the temporary restraining order expires in ten (10) days and will not be extended unless during that 10-day period, good cause is shown to the Court or the party(s) against whom the order(s) is made consents to an extension.

WHEREFORE, Plaintiff respectfully prays for relief in the following manner:

1. Judgment granting him *ex parte* restraining orders enjoining Defendant from threatening, harassing or abusing Plaintiff;

2. Judgment granting him *ex parte* restraining orders enjoining Defendant from threatening, harassing or abusing Plaintiff on any social media site in particular, Discord;
3. Judgment granting him *ex parte* restraining orders enjoining Defendant from posting images of Plaintiff's home and personal address on any social media site, in particular, Discord;
4. Judgment granting him *ex parte* restraining orders enjoining Defendant from publishing any personal information pertaining to the Plaintiff's residence;
5. Judgment ordering Defendant to remove any and all posts disclosing the Plaintiff's personal home address;
6. Judgment waiving the requirement of Rule 65(c) of the Massachusetts Rules of Civil Procedure that Plaintiff provide security for the issuance of the abuse Order(s);
7. Judgment granting him such other relief as this Court deems fair, just and equitable, including but not limited to, costs of these proceedings.

ss. **AFFIDAVIT IN SUPPORT  
OF RESTRAINING ORDERS**

Affiant, Tyler Martin, being first duly sworn, deposes and says that he is the Plaintiff in the within action; that the Defendant, Lionel Target ("Defendant"), has threatened his life and has posted Plaintiff's residential address and photos of Plaintiff's home to Discord, all of which has put him in fear of his safety; and that unless Defendant is enjoined from continuing such conduct, he will suffer irreparable damage for which he has no adequate remedy at law.

Affiant further states that on or around February 20, 2024, he discovered that Defendant (using the username "The Mystic", "midnight daydreaming"), publicly posted Affiant's residence address and photos of his home to a public Discord server. A true and correct copy of Defendant's post publicly identifying Affiant's home address is attached hereto as Exhibit 1.

Affiant also discovered that Defendant posted a series of death threats against Affiant in Discord. For example, Defendant threatened to "slit [Affiant's] throat," "gut [Affiant] like a fucking fish," and to "break into [Affiant's] room and spend 20 minutes stabbing [Affiant] to death," and stated that Defendant would "rather bash [Affiant's] mother's skull into mush." Defendant also threatened to "stab [Affiant's] eyes out" and "rip [Affiant's] teeth out with pliers." A true and correct copy of the threatening messages sent by Defendant to Affiant is attached as Exhibit 2.

Affiant further states that, amidst Defendant's threats to assault and kill him, Defendant posted 13 images of his personal residence and address.

Such posts place Affiant in fear for his life because, unlike the statements that form the basis for this lawsuit, which primarily were indirect threats and false statements about Affiant, Defendant has now directly and explicitly threatened Affiant's life, including specific threats that he will enter Affiant's home while Affiant sleeps and stab him to death, and has attempted to incite his online followers by publishing Affiant's residence address and photos of Affiant's home publicly along with those threats.

Affiant believes that Defendant is capable of harming him because Defendant has made these threats explicitly in response to Affiant's legal action against him, rather than defending himself in this matter, stating "If I receive another letter from your lawyer, I will kill you. If you attempt to rob money from me for telling the truth I will kill you. I will deliver you your father's severed head[.] Years of harassment [.] You had your faggot fan write me a fake version of your lawsuit with slanderous lies 'restraining order' and then you cry about being doxxed you really do deserve to die. . . . 1. You will not receive a cent 2. You *literally* will die before you would receive a cent." The hearing on damages and injunctive relief in this matter is scheduled in a matter of weeks, and Defendant has clearly expressed his refusal to accept responsibility for his conduct and instead has threatened to kill Affiant if this Court grants the requested relief.

WHEREFORE, this Affiant respectfully requests that this court issue *ex parte* restraining orders consistent with this Affidavit.
